Dear Members of the Judiciary Committee of the United States Senate:

We are partners in the law firm Jones Day. It is with great pleasure that we deliver this letter, which expresses our enthusiastic support for the United States Senate's confirmation of our former partner, Sparkle Sooknanan, to the United States District Court for the District of Columbia.

Jones Day ranks among the most accomplished law firms in the world, and has more than 2,400 lawyers in 40 offices across five continents. Our current and former partners have served the United States in various capacities, in each branch of the government, in Democratic and Republican Administrations, for more than 100 years. Many of our country's most esteemed jurists had their start at Jones Day. In October 2014, after her Supreme Court clerkship, Sparkle joined Jones Day in the Issues & Appeals practice in Washington, where she quickly established herself as a standout. As an Issues & Appeals lawyer, Sparkle proved a natural at the appellate skills of writing, analysis, and oral advocacy. She routinely crafted persuasive arguments in clear, elegant prose, often in remarkably short timeframes. She is a terrific oral advocate and often argued for Firm clients in both district and appellate courts.

Sparkle is well acquainted with the effort required to prepare for district court litigation. During her time at the Firm, Sparkle oversaw complex litigation teams and managed every phase of a case. She prepared pleadings, managed discovery and other fact development in large cases, worked with lay and expert witnesses and handled relationships with clients, co-counsel, and opposing counsel in skillful and exemplary fashion.

In a practice group full of extremely talented lawyers, including many former Supreme Court clerks, Sparkle distinguished herself through her extraordinary intellect, her stellar writing skills and her unparalleled work ethic. For several years, Sparkle headed a team handling a complicated bankruptcy matter that required her to manage multiple litigations proceeding through several different courts at the same time. The matter also required Sparkle, who was then an associate, to craft and make sophisticated and novel legal arguments. She performed well beyond her years, as evidenced by the fact that Sparkle appeared for argument in the First Circuit and prevailed over more experienced partners and seasoned Supreme Court advocates.

Sparkle brought the same energy and skills to representing pro bono clients. Sparkle spearheaded the defense of Charlottesville city council members who were sued for voting to remove Confederate monuments at the center of political violence there; represented indigent criminal defendants in a number of contexts; and participated in the Firm's Laredo Project, which provides representation to individuals in immigration detention at the border. She passionately embarked on these important pro bono matters on top of her substantial and time-consuming work for paying clients.

Sparkle's intellectual gifts are matched perhaps only by her work ethic and interpersonal skills. Sparkle left her home in Trinidad and Tobago at the age of 16 to attend college in the United States and worked her way through law school while maintaining a 4.0 grade point average. And Sparkle showed that she is just as skilled at listening, understanding other points of view and connecting with everyone with whom she interacts. Throughout her time at Jones Day, Sparkle was known as someone who could

appreciate all sides of an argument and make people feel heard. Sparkle formed strong relationships and worked with colleagues across the Firm, finding common ground even in areas of disagreement. In addition, Sparkle consistently used her talents and skills to mentor other lawyers. Even in the most demanding periods of work at the Firm, Sparkle took a special interest in helping more junior lawyers develop their own skills and judgment, guiding them in growth opportunities.

It likewise has been no surprise, but nevertheless a source of pride for the Firm, that Sparkle has had such a distinguished career in senior leadership roles at the Department of Justice in the past several years—first serving as Deputy Associate Attorney General in the Office of the Associate Attorney General and most recently as Principal Deputy Assistant Attorney General in the Civil Rights Division.
