In this case, twenty-seven defendants were charged with participating in numerous acts of violence in connection with the MS-13 street gang, including 11 murders. There were two separate trials. Defendant Adalberto Ariel Guzman was convicted after trial of charges relating to the murder of a 19-year old woman and her 2-year old son. Guzman was sentenced to life imprisonment. Defendant Heriberto Martinez was convicted after trial of, among other offenses, three murders. Martinez was joined for purposes of trial with Carlos Ortega (No. 12 Cr. 0293), who was convicted of two murders. The remaining defendants all pleaded guilty. Defendant Martinez was sentenced to a mandatory sentence of life plus 60 years' imprisonment, and defendant Ortega was sentenced to a mandatory sentence of life plus 35 years' imprisonment.

2. *United States v. Alvarenga*, No. 12 Cr. 0063 (E.D.N.Y.).

In this case, seventeen defendants were charged with participating in numerous acts of violence in connection with the MS-13 street gang, including five murders. One defendant, Edwin Hernandez, was convicted after trial of assault with a dangerous weapon and discharge of a firearm during a crime of violence. Nine defendants have been sentenced, and the cases of the remaining defendants are still pending. Defendant Hernandez was sentenced to 25 years' imprisonment. The Second Circuit affirmed this sentence on appeal. *United States v. Hernandez*, 894 F. 3d 496 (2d Cir. 2018).

In re Tender Loving Care Health Servs., 377 B.R. 798 (E.D.N.Y. 2007), *rev'd*, 562 F.3d 158 (2d Cir. 2009). This was a bankruptcy appeal involving a calculation error of over \$500,000 by the bankruptcy court due to improperly including post-petition interest. I affirmed the bankruptcy court's decision reconsidering its calculation, concluding that the reconsideration was not time-barred and that cause existed for reconsideration of the order containing the undisputed calculation error. The Second Circuit reversed and remanded. It concluded that, given that the debtors initially filed an objection to the creditor's claim in the bankruptcy proceedings, the claim was time-barred because it was not "entered without a contest" within the meaning of the one-year limitation for bringing motions for reconsideration.

Holster v. Gatco, Inc., 485 F. Supp. 2d 179 (E.D.N.Y. 2007), *aff'd*, 2008 U.S. App. LEXIS 23203 (2d Cir. 2008), *rev'd and remanded*, 559 U.S. 1060 (2010), *aff'd on other grounds*, 618 F.3d 214 (2d Cir. 2010). In this diversity jurisdiction case, I concluded that state substantive law applied to the plaintiff's Telephone Consumer Protection Act claims, and that New York's statutory bar on class actions (unless authorized by an underlying New York statute) divested the Court of jurisdiction. The Second Circuit affirmed my decision in a summary order. The United States Supreme Court vacated and remanded for reconsideration in light of their intervening decision in *Shady Grove Orthopedic Associates, P.A. v. Allstate Insurance Co.*, 559 U.S. 393 (2010). On remand, the Second Circuit again affirmed on alternative grounds – namely, because of the unique nature of the federal action the TCPA created, Congress intended to let a state determine which causes of action lie under the TCPA and, thus, New York could bar class actions for statutory damages under the TCPA.

United States v. Meszaros, No. 06 Cr. 0290, 2008 WL 5113425 (E.D.N.Y. Nov. 11, 2008), *aff'd in part, rev'd in part, and remanded*, 381 F. App'x 55 (2d Cir. 2010). In a summary order, the Second Circuit affirmed my decision that the wire fraud counts were properly joined and affirmed the defendant's 108-month sentence, except the sentence on Count Two (which was fully concurrent to the other counts). With respect to that count, the Second Circuit concluded the sentence should have been limited to the statutory maximum at the time of the offense – specifically, 60 months. Thus, the case was remanded for that correction on Count Two, which did not impact the total sentence.

United States v. Magner, No. 09-cr-0748 (no written decision), *aff'd in part and vacated in part*, 455 F. App'x 131 (2d Cir. 2012) and 518 F. App'x 36 (2d Cir. 2013). On February 7, 2011, I sentenced the defendant to 108-months' imprisonment and a five-year term of supervised release for receiving child pornography. In a summary order, the Second Circuit held that the 108-month sentence and five years' supervised release was procedurally and substantively reasonable. However, the Second Circuit held that, although there was no objection at the time of sentencing, the supervised release

condition prohibiting the defendant from accessing any website with images of nude adults or children was unwarranted. Following the Second Circuit's decision, I entered an order modifying the supervised release restriction consistent with the Second Circuit's summary order. In the second appeal, although again no objection was made at the resentencing, the Second Circuit held that it was error to impose a supervised release restriction on texting, and that the restriction should be stricken.

New York v. Shinnecock Indian Nation, 523 F. Supp. 2d 185 (E.D.N.Y. 2007), *vacated and remanded*, 686 F.3d 133 (2d Cir. 2012). After concluding that jurisdiction existed and conducting a month-long bench trial, I held that the Shinnecock Indian Nation was enjoined from building a casino in the Town of Southampton because the Nation's aboriginal title to the land at issue had been extinguished and the proposed development was barred by the *Sherrill* doctrine. The Second Circuit reversed and held that federal subject matter jurisdiction did not exist because the complaint did not raise an issue of federal law and the substantial federal question exception to the well-pleaded complaint rule did not apply.

United States v. Bailey, 468 F. Supp. 2d 373 (E.D.N.Y. 2006), *aff'd*, 652 F.3d 197 (2d Cir. 2013), *rev'd and remanded*, 568 U.S. 186 (2013), *aff'd on other grounds*, 743 F.3d 322 (2d Cir. 2014). I held that the stop and subsequent detention of the defendant after he left the residence that was about to be searched was permissible pursuant to *Michigan v. Summers*, 452 U.S. 692 (1981). I alternatively concluded that the stop and detention were supported by reasonable suspicion and were therefore lawful under *Terry v. Ohio*, 392 U.S. 1 (1968). The Second Circuit affirmed that decision. However, the Supreme Court reversed and remanded, holding that the *Summers* rule is spatially limited to the immediate vicinity of the premises to be searched. On remand, the Second Circuit affirmed the conviction on alternative grounds, holding that (1) the stop and detention was supported by reasonable suspicion and (2) although the district court erred in ruling that the handcuffing of defendant was permissible under *Terry*, the admission of defendant's subsequent statements was harmless.

Wurtz v. Rawlings Co. LLC, 933 F. Supp. 2d 480 (E.D.N.Y. 2013), *vacated and remanded*, 761 F.3d 232 (2d Cir. 2014). I concluded (following the reasoning of the Third, Fourth, and Fifth Circuits) that the plaintiffs' claims (seeking to enjoin insurers under New York General Obligation Law Section 5-335 from obtaining reimbursement of medical benefits from plaintiffs' tort settlements) were preempted by ERISA and that, because the plaintiffs had not exhausted their administrative remedies and because the terms of their plans allowed for reimbursement, the claims could not proceed. The Second Circuit reversed, concluding that the Class Action Fairness Act provided a basis for federal subject matter jurisdiction and that the plaintiffs' claims were neither expressly nor completely preempted by ERISA.

Paulsen ex rel. N.L.R.B. v. Remington Lodging & Hosp., LLC, No. 13 Civ. 2539, 2013 WL 4119006 (E.D.N.Y. Aug. 14, 2013), *aff'd in part, rev'd in part, and remanded*, 773 F.3d 462 (2d Cir. 2014). I held, in relevant part, that an injunction under Section 10(j) of the National Labor Relations Act ordering the immediate reinstatement of certain

discharged employees was unwarranted because of the delay in seeking the injunction and because the defendant had already offered (or would soon offer) reinstatement to the discharged employees. The Second Circuit concluded that I should have granted the injunction, but that the injunction was unnecessary by the time of the Second Circuit's decision because each of the eligible employees had been offered reinstatement. However, the Second Circuit concluded that it was error to decline to order the reinstatement of a specific employee (or re-employment on the same terms and conditions as her prior employment) who, at the time of the motion for a preliminary injunction, had not been offered reinstatement and was not within the group of employees that the defendant intended to offer reinstatement.

Fishman ex rel. Fishman v. Daines, No. 09 Civ. 5248, 2014 WL 4638962 (E.D.N.Y. Sept.16, 2014), *rev'd sub nom. Fishman v. Paolucci*, 628 F. App'x 797 (2d Cir. 2015). In this case, Medicaid recipients brought an action against New York State officials alleging that the termination of their benefits without post-default notice violated the Due Process Clause of the Fourteenth Amendment and the Medicaid Act's fair hearing provision, 42 U.S.C. § 1396a(a)(3). In denying plaintiffs' motion for a preliminary injunction, I concluded, *inter alia*, that the standard for determining whether plaintiffs were likely to succeed on the merits was the same under the Due Process Clause and the Medicaid Act's fair hearing provision. The Second Circuit concluded that I erroneously held that the standards were the same, and remanded for a determination as to whether the scope of the Medicaid Act's provision was broader than the Due Process Clause with respect to the immediate dismissal of appeals and termination of benefits when a beneficiary defaults.

United States v. Martinez, 978 F. Supp. 2d 177 (E.D.N.Y. 2013), *aff'd in part and vacated in part sub nom. United States v. Prado*, 815 F.2d 93 (2d Cir. 2016) and *United States v. Prado*, 634 F. App'x 323 (2d Cir. 2016). The Second Circuit affirmed the convictions of two defendants for, *inter alia*, murder in aid of the MS-13 street gang, with the exception of one firearm count because the jury instruction on that count was erroneous in light of the United States Supreme Court's intervening decision in *Rosemund v. United States*, 134 S. Ct. 1240 (2014).

Zarda v. Altitude Express, Inc., No. 10 Civ. 4334 (oral decision), *aff'd*, 855 F.3d 76 (2d Cir. 2017), *rev'd en banc*, 883 F.3d 100 (2d Cir. 2018). Consistent with binding Second Circuit precedent (*Simonton v. Runyon*, 232 F.3d 33 (2d Cir. 2000)), I held that claims based on sexual orientation cannot be brought under Title VII of the Civil Rights Act of 1964, 42 U.S.C. § 2000e, *et seq.* The Second Circuit affirmed, and noted that *Simonton* could be overturned only by an en banc determination to do so. The Second Circuit also affirmed my decision to deny the plaintiff's motion for a new trial on his state law sexual orientation discrimination claim (on which the jury found in favor of the defendant). The Second Circuit then granted rehearing en banc, overturned *Simonton*, and held that Title VII prohibits discrimination based on sexual orientation.

Conte v. County of Nassau, No. 06 Civ. 4746, 2013 WL 3878738 (E.D.N.Y. July 26, 2013), *aff'd in part and vacated in part*, 596 F. App'x 1 (2d Cir. 2014), *on remand* 2015

WL 1529787 (E.D.N.Y. Apr. 2, 2015), *vacated and remanded*, 647 F. App'x 13 (2d Cir. 2016), *on remand* 2017 WL 837691 (E.D.N.Y. Mar. 3, 2017), *rev'd and remanded*, 895 F.3d 168 (2d Cir. 2018). After a jury found in favor of plaintiff, I granted the defendants' Rule 50(b) motion, finding that one defendant was entitled to judgment as a matter of law on a false arrest claim and other defendants were entitled to judgment as a matter of law on tortious interference claims (on statute of limitations grounds). The Second Circuit affirmed my decision with respect to the false arrest claim, but reversed the decision on the tortious interference claims because the defendants' "late-raised statute of limitations defense" required factual questions to have been submitted to the jury. The Second Circuit concluded that "because the defendants do not raise any reason for a new trial on appeal, we see no reason to deprive [Conte] of the benefit of the jury's verdict," and remanded for the district court to consider plaintiff's motion for a new trial on damages. On remand, I denied plaintiff's motion for a new trial on damages and declined to consider defendants' other Rule 50 arguments challenging the jury's verdict because they were waived and were beyond the Second Circuit's remand directive. On appeal, the Second Circuit affirmed the denial of plaintiff's motion for a new trial, but concluded that I should consider defendants' remaining Rule 50 arguments. In concluding that I erred in finding that the mandate was limited, the Second Circuit noted that "the district court's confusion is understandable given the drafting and arguable resulting ambiguity of our summary order." On remand, I denied defendants' remaining Rule 50 arguments because defendants had waived them by not raising them with specificity during the trial. On appeal, the Second Circuit reversed and held that plaintiff had waived the waiver argument, and that the evidence at trial was insufficient for the jury to rationally find (1) that defendants acted with the purpose of inducing third parties to breach the contracts at issue or (2) that, but for their actions, the third party contracts would not have been breached.

Leskinen v. Halsey, No. 12 Civ. 0623, 2013 WL 801128 (E.D.N.Y. Mar. 5, 2013), *aff'd on other grounds*, 571 F. App'x 36 (2d Cir. 2014). I adopted a report and recommendation from the magistrate judge assigned to the case, which recommended that the case be dismissed for lack of subject matter jurisdiction. The Second Circuit concluded that subject matter existed, but affirmed on the grounds that the plaintiff had failed to state a federal claim for relief and that diversity jurisdiction was lacking.

In this case, the plaintiff brought claims against the defendant, Cornell University, under Title VII of the Civil Rights Act, the Age Discrimination in Employment Act, and various state laws. The district court granted the defendant's motion for summary judgment. In my opinion vacating the district court's decision in part and remanding the case for further proceedings, I determined that the non-renewal of plaintiff's employment contract was an adverse employment action, that the plaintiff had established a prima facie case of age and gender discrimination, and that the plaintiff had raised genuine issues of material fact regarding discriminatory pretext.

My court has available an “automatic” electronic recusal system by which my docket can be monitored to assess whether any of the cases assigned to me involves a party who is listed on a standard recusal list because of a financial or personal relationship. However, because I have owned no stock during my judicial tenure and have no relatives who are attorneys, this system is of limited value in my situation and, therefore, I have not utilized it. Instead, I review each case that is assigned to me to determine whether there is some basis for recusal. I recuse myself in any case where I have a significantly close relationship or other association with an attorney, a party, or a witness (whether personal or business). This includes relationships that exist based upon my adjunct teaching positions at area law schools, as well as my position as a Catholic Deacon in the Diocese of Rockville Centre. Almost all of these recusals are *sua sponte* based upon my own review of the case.

In preparing this application, I have searched for recusal orders and formal recusal motions in our electronic court filing system. If an informal request for recusal was made in a case, I have no mechanism (other than memory) by which to identify such requests among the over 4,000 cases that I have presided over. If I had a memory of any such requests, I included them in the list. Moreover, we are not required to state the reason for recusal in the recusal order and, for one of my *sua sponte* recusals, I cannot identify from the docket (or my own memory) what the basis was for my *sua sponte* recusal. However, it would have fallen into one of the categories identified above.
