I was elected presiding judge of the 95th Judicial District Court in Dallas County, Texas, in November 2000 for a four-year term that began January 1, 2001. I was reelected unopposed in November 2004 for a second term beginning January 1, 2005. I served all eight years of the two terms. The 95th Judicial District Court has been designated as a court of original jurisdiction only for civil matters, including cases involving contract, tort, declaratory judgments and injunctive relief. In 2007, I was elected by my fellow civil district judges to serve as the presiding judge of the Civil District Judges of Dallas County, Texas. In 2013, I was appointed to serve on the Tenth Court of Appeals panel by commission signed by the Governor of the State of Texas in Case No. 10-13-00009-CV; however, I did not author the opinions for that case.

I have presided over many thousands of cases spanning an eight-year period that have gone to verdict, judgment, settled (with a later signed judgment), nonsuited and/or have been dismissed. Of those cases, I estimate I have tried over 100 jury cases and hundreds of bench trials (including prove-up default judgments and name changes). I have answered below based on my best estimate of jury and bench trials (not including default judgments and name changes).

As a Texas state trial court judge, I did not author opinions. My rulings on various matters were entered via orders or judgments that nearly always were supplied by the party being afforded the relief being granted in the order or judgment.

This was a complex and highly contentious breach of contract and business tort case involving the dissolution of a business partnership between an individual and multiple corporate entities. I presided over a summary jury trial by agreement of all parties which did not result in a settlement. Thereafter, a jury was empaneled, and the case was tried for three weeks from May 14 through June 8, 2001. The charge was extensive. After deliberations, the jury returned a defense verdict.

This was a medical malpractice case involving allegations of negligence and gross negligence against a doctor for an improperly performed abdominoplasty. 7. *Mainwaring et ux. v. USAA*, Cause No. 01-03833

This was an insurance bad faith case involving the denial of full payment of a claim for a roof leak by the defendant under the plaintiffs' homeowner's policy. As a Texas state trial court judge, I did not author opinions. My rulings on various matters were entered via orders or judgments that nearly always were supplied by the party being afforded the relief being granted in the order or judgment.

Shih v. Tamisiea, 306 S.W.3d 939 (Tex. App.—Dallas 2010, no pet.). I granted summary judgment for plaintiff's former attorneys in this professional negligence suit. The appellate court affirmed my summary judgment in favor of appellees on the client's claims for violation of the Texas Deceptive Trade Practices Act and breach of fiduciary duty. The court reversed my summary judgment ruling that attorney's fees paid in a prior lawsuit are not recoverable damages, because the Texas Supreme Court overturned the Dallas Court of Appeals on that issue in *Akin, Gump, Strauss, Hauer & Feld, L.L.P. v. Nat'l Dev. & Research Corp.*, 299 S.W.3d 106, 118-19 (Tex. 2009), after my decision was entered. Based on the decision in *Akin*, the court reversed and remanded this issue.

Nautilus Ins. Co. v. Steinberg, 316 S.W.3d 752 (Tex. App.—Dallas 2010, pet. denied). This appeal arose from a bench trial in which I concluded that the insurer failed to show that the theft exclusion in the policy's vandalism coverage provision applied to bar coverage. The Dallas Court of Appeals reversed and remanded, finding that I erred in my construction of the policy and application of the law to the facts of this case. The court further concluded that, because of this mistaken construction, I failed to make a necessary finding of fact.

Zenith Insurance Co. v. Ayala, 325 S.W.3d 176 (Tex. 2010). In this case I affirmed the decision of the Division of Workers' Compensation, which awarded benefits to the appellee due to the insurance carrier's failure to dispute compensability within 60 days after it received notice of claimant's initial injury. The Court of Appeals affirmed. The Supreme Court of Texas reversed, holding that the statutory deadline did not apply and the carrier's preauthorization of treatment did not preclude the carrier from disputing the extent of injury.

Centex/Vestal v. Friendship West Baptist Church, 314 S.W.3d 677 (Tex. App.—Dallas 2010, pet. denied). In this case I vacated the arbitration award and the contractor appealed. The Dallas Court of Appeals reversed, finding that the arbitrator did not exceed his authority, under the arbitration agreement between the church and general contractor, to consider the validity of pass-through claims for subcontractors.

Proctor v. Buell, 293 S.W.3d 924 (Tex. App.—Dallas 2009, no pet.). In this case I denied appellant's special appearance disputing personal jurisdiction. The appellate court reversed and rendered judgment, dismissing the appellant from the case for lack of personal jurisdiction. The court found that the appellant met his burden to negate the appellee's allegation that appellant was subject to specific jurisdiction.

Dallas Central Appraisal Dist. v. Mission Aire IV, L.P., 279 S.W.3d 471 (Tex. App.—Dallas 2009, pet. denied). I entered summary judgment for tenants, concluding that the evidence established conclusively that the town owned certain improvements. The appraisal district appealed, and the court reversed and rendered, finding that the evidence established conclusively that the tenants

owned the improvements for the duration of their leases.

State, Texas Dept. of Transp. v. Allodial Ltd. Partnership, 280 S.W.3d 922 (Tex. App.—Dallas 2009, no pet.). I denied the Texas Department of Transportation's (TxDOT's) plea to the jurisdiction on the grounds that there were fact issues "inextricably intertwined with both the issue of jurisdiction and the merits of the case." TxDOT appealed, arguing sovereign immunity barred Allodial's claims, Allodial lacked standing to bring the claims, and there was no affirmative act by TxDOT giving rise to the claims. The Dallas Court of Appeals affirmed as to my denial of the plea to the jurisdiction on Allodial's takings claims, and remanded for further proceedings. The Court found that I erred in denying TxDOT's plea to the jurisdiction on Allodial's breach of deed covenants claims. The Court overruled TxDOT's issue as to Allodial's takings claim, but sustained TxDOT's issues as to all other claims asserted by Allodial.

Ferguson v. Building Materials Corp. of America, 295 S.W.3d 642 (Tex. 2009). I granted summary judgment in favor of defendants, asserting that the personal injury suit was barred by judicial estoppel because plaintiffs failed to identify their claims as assets in their bankruptcy schedules. The plaintiffs appealed and the El Paso Court of Appeals affirmed. The Texas Supreme Court reversed and remanded, holding that failure to include a personal injury suit on a schedule of personal property and in the bankruptcy plan did not judicially estop plaintiffs from pursuing the suit.

Town of Addison v. Thielsch Eng'g, 05-08-01723, 2009 WL 1579214, at *1 (Tex. App.—Dallas June 8, 2009, no pet.). In this case, the appellate court had before it the parties' agreed motion to set aside my judgment and remand for rendition of judgment pursuant to the parties' settlement. The appellate court granted the motion, and set aside my judgment without regard to the merits, and remanded the case for rendition of judgment in accordance with the settlement agreement. Unpublished opinion supplied.

Burney v. Citigroup Global Markets Realty Corp., 244 S.W.3d 900 (Tex. App.—Dallas 2008, no pet.). In this case I entered summary judgment in favor of the holder of a note to foreclose on petitioner's property. Petitioner appealed, arguing that the grant of summary judgment was in error because the statute of limitations for such foreclosure action had run. On rehearing, the Court of Appeals held that the holder's cause of action for foreclosure accrued when the maker received the notice of the prior holder's filing of an application for expedited foreclosure, and thus the foreclosure was outside of the limitations period. The court accordingly reversed and rendered judgment for Burney.

French v. Henson, No. 05-06-01036-CV, 2008 WL 2266119 (Tex. App.—June 4, 2008, no pet.) On cross-motions for summary judgment on the settlement issue in a motor vehicle collision case, I granted summary judgment in favor of Henson and denied French's motion. On appeal French contended I erred because the

evidence did raise a fact issue regarding the existence of an agreement, as there was no meeting of the minds on whether to include French as a payee. The appellate court agreed and reversed and remanded for further proceedings.

Aboud v. Citicorp Vendor Fin., Inc., 05-07-00338-CV, 2008 WL 345448, at *1 (Tex. App.—Dallas Feb. 8, 2008, no pet.). The parties jointly filed a motion to vacate my judgment and dismiss the appeal pursuant to their settlement agreement. The court granted the motion and vacated the judgment without regard to the merits. Unpublished opinion supplied.

City of Dallas v. VRC, LLC, 260 S.W.3d 60 (Tex. App.—Dallas 2008 no pet.). I denied the city's plea to the jurisdiction and the city appealed. On appeal, the Court of Appeals held that VRC could not plead a valid regulatory takings claim, and thus did not overcome the city's governmental immunity, and the trial court lacked jurisdiction over the takings claims. The court accordingly reversed my order denying the city's plea to the jurisdiction and rendered judgment dismissing VRC's takings claims.

County of Dallas v. Wiland, 216 S.W.3d 344 (Tex. 2007). I entered partial summary judgment against the county as to liability, entered judgment on the jury's damages award, awarded attorney's fees to the deputies, and denied the county's motion for a new trial. The county appealed, and the Dallas Court of Appeals affirmed. The Texas Supreme Court reversed and remanded, holding that the deputy constables did have a procedural due process property interest in continued employment, that interest did not terminate automatically, remand was required as to damages, and the deputy constables had no substantive due process right in continued employment.

Parsons v. County of Dallas, 197 S.W.3d 915 (Tex. App.—Dallas 2006, no pet.). I granted the county's motion to dismiss the lawsuit as frivolous under Chapter 14 of the Texas Civil Practice and Remedies Code. On appeal the Dallas Court of Appeals reversed and remanded, holding that I erroneously based the dismissal upon a failure to comply with the procedural requirements of Chapter 14 and further concluded that I erroneously determined the inmates' argument for immunity was frivolous as a matter of law.

In re Lejia, 05-03-01693-CV, 2004 WL 260570, at *1 (Tex. App.—Dallas Feb. 13, 2004, no pet.). I granted a motion for new trial setting aside a default judgment taken after service was effected on the wrong individual. The Dallas Court of Appeals ordered that I vacate my order granting new trial and setting aside the default judgment, and enter an order denying the motion for new trial.

Dallas County Democratic Executive Committee v. County of Dallas, No. 05-02-01686, 2002 WL 31439451 (Tex. App.—Dallas Nov. 1, 2002, no pet.). I granted appellees' plea to the jurisdiction and dismissed appellant's cause of action after finding that procedural bars had not been met to vest the court with jurisdiction to

enjoin violations of the Texas Election Code. The Dallas Court of Appeals reversed and remanded finding that an ongoing election does not deprive the district court of jurisdiction to enjoin violations of the election code, as long as the relief awarded does not delay, cancel, interfere with, or inquire into the validity of the election. Unpublished opinion supplied.

Forte v. AmeriPlan Corp., No. 05-01-00921-CV, 2002 WL 576608, at *1 (Tex. App.—Dallas Apr. 18, 2002, no pet.). I denied petitioner's motion to compel arbitration against AmeriPlan Corporation. The two documents at issue were the Manual and Agreement. The Manual required arbitration, but the Agreement also contained a provision requiring mediation and then court remedies, rather than arbitration. Based on the foregoing, a divided appellate court held that the Agreement was ambiguous, and reversed my order denying the motion to compel finding that the contract was unambiguous, and remanded the case for further proceedings. The case settled thereafter and was dismissed. Unpublished opinion supplied.

Russell v. Murphy, 86 S.W.3d 745 (Tex. App.—Dallas 2002), *rev'd* 167 S.W.3d 835 (Tex. 2005) (per curiam). I dismissed a patient's Deceptive Trade Practices Act, breach of contract, and battery suit for failure to comply with requirements of the Medical Liability and Insurance Improvement Act governing health care liability claims. The patient appealed, and the Court of Appeals reversed and remanded. On petition for review, the Texas Supreme Court held that the battery claims required an expert report and the DTPA claims were health care liability claims for which the patient was required to provide an expert report, and thus reversed the Court of Appeals and dismissed.

In every case before me as judge of the 95th Judicial District Court, I complied with the Texas Rules of Civil Procedure governing recusal of judges, as well as the applicable disciplinary and ethical rules of the State of Texas. While judge, I was highly attentive to the issue of conflicts at all stages of a case.

During 2001 and 2002, my first two years in office, my staff was required to review every case upon filing in my court to identify any cases involving Andrews & Kurth, LLP, where I was a partner immediately preceding my election to the bench. In 2008, my last year in office, my staff would also identify any cases involving Jones Day, where I was interviewing for and ultimately accepted an offer to be a partner in their Dallas office. Also, for all my years on the bench, 2001 through 2008, my staff would identify any cases involving the Winstead law firm, where my former husband was a partner. On all cases involving those law firms during those time periods, I would automatically recuse myself.

In addition, my practice during all the years I was a judge would be to personally review each file before any ruling or hearing. If there was a reason to recuse, I would recuse sua sponte. I believed in erring on the side of caution in disclosing any potential conflict to parties and their counsel, in particular relating to Texas Rule of Civil Procedure 18b(b)(1) on matters in which "the judge's impartiality might reasonably be questioned." If any party expressed any concern regarding my impartiality after disclosing a potential conflict, I would recuse immediately and voluntarily. Nearly always, however, the parties would urge that I stay on as the presiding judge. In those cases, I would state the potential ground for recusal

on the record and then all counsel would have to waive the potential ground on the record or in writing after consulting with their clients, before I would continue to preside.

I have not kept copies of my recusal orders. All records generated prior to 2011 by the office of the Presiding Judge of the First Administration Region (where all motions to recuse were referred from my court) have been destroyed. Without manually going through the records of every one of the thousands of cases I presided over as judge of the 95th Judicial District Court, I am unable to provide the information requested above on every recusal order I signed. I can, however, attest that I strictly adhered to the grounds set forth in Texas Rules of Civil Procedure 18a and 18b for disqualification and recusal, as well as the guidelines I established for myself and my staff in handling recusals as set forth above.

I can recall only two motions to recuse filed against me in cases I declined to recuse. I referred both motions to the Presiding Judge of the First Administrative Judicial Region for hearing:

McInnis v. Wells, M.D., Cause No. 98-03340, wherein the asserted ground in the motion for recusal filed by the plaintiff post-trial was that my former husband, a transactional lawyer, and his law firm represented medical practitioners which allegedly created an appearance of impropriety or bias in favor of the medical profession. The motion to recuse was denied. The case settled thereafter.

Lanvera Ltd. v. USFI, Inc. and Sage Telecom, Inc., Cause No. 06-04346, wherein the ground asserted in plaintiff's motion for recusal was that one of my sons had previously held a part-time summer job in the records department at Locke Lord years before, thus allegedly creating an appearance of impropriety because one of the defendants was represented in the case by Locke Lord. The motion was filed just weeks before a firm trial setting and well over a year after the parties waived the potential conflict on the record after I disclosed it. The motion to recuse was denied. The case proceeded to trial as scheduled, and the jury found in favor of the plaintiff/movant, awarding a substantial damage award.

This case was brought by the pro se intended death benefit beneficiaries of a deceased relative's annuity against the decedent's financial advisors. Allegations included professional negligence, fraud and breach of fiduciary duties. I mediated this case in 2014, and it settled.

2. *Dallas Area Rapid Transit et al. v. Amalgamated Transit Union Local No. 1338*, No. 05-04-00208-CV in the Court of Appeals, Fifth District of Texas at Dallas

This was an appeal from the trial court's order denying the defendants' plea to the trial court's jurisdiction. The underlying case was an alleged breach of contract and declaratory judgment action arising from a 2000 settlement agreement between a governmental rapid transit authority and the local transit union. The disputed issues related to the existence and waiver of governmental immunity. I mediated this case in 2014, and it did not settle.

3. *WLS Surgical Associates, PA v. Globalcomm, Inc. et al.*, Cause No. 11-13101 in the 68th District Court of Dallas County, Texas

This was a contentious business dispute between a medical provider specializing in bariatric surgical procedures and a company providing consulting services for communications and information technology systems. The causes of action included claims for injunctive relief, breach of contract and violation of the Texas Harmful Access by Computer Act. I mediated this case in 2014 over several days, and it settled.

4. *Helo v. Mock et al.*, Cause No. 13-14810 in the 116th Judicial District Court of Dallas County, Texas

This was a contract case between the owner of a tire store and former employees. The allegations between the parties included breach of contract, tortious interference with contract and conversion. The parties sought injunctive relief, damages and attorney's fees. I mediated this case in 2014, and it settled.

5. *Vickery et al. v. Careington International Corporation et al.*, AAA Case No. 01-14-0001-2539

This arbitration involved a business dispute arising out of a contractual relationship relating to the solicitation of prospective clients by the claimants for the respondent's dental care programs and plans. The allegations among the parties included breach of contract, fraud and breach of fiduciary duties. I was a member of a three-judge panel. The case settled in 2015 after our panel issued rulings on multiple motions for summary judgment filed by all parties prior to the final hearing.

6. *United Commerce Centers, Inc. et al. v. The Travelers Lloyds Insurance Company*, Cause No. 14-04967 in the 95th Judicial District Court, Dallas County, Texas

This was a breach of contract and insurance bad faith case arising out of the handling by the defendant insurance company of a hail damage claim filed by the plaintiffs. The plaintiffs' allegations against the defendant included violations under the Texas Insurance Code, breach of contract, breach of duties of good faith and fair dealing, fraud and bad faith. I mediated this case in 2015, and it settled.

7. *Henry v. Agius, et al.*, AAA Case No. 01-14-0002-0684

This arbitration arose out of an agreement executed between the parties for the sale and purchase of the claimant's mystery shopping company and a resulting agreement for the consulting services of the claimant to respondents. The parties alleged breach of contract against each other and sought damages and attorney's fees. At my suggestion and the

parties' agreement, this case was mediated before the arbitration hearing was to begin on the first day. The case settled in 2015.

8. *Morrison & Morrison, Inc. et al. v. United Commerce Centers*, Cause No. 15-CV-0757, in the 122nd Judicial District Court, Galveston County, Texas

This was a mediation of multiple lawsuits regarding disputes that arose from the distribution of the proceeds received in a mediated settlement between the defendants and their insurance company. The parties who asserted breach of contract claims against the defendants included a roof construction and restoration company, their former lawyer and a public insurance adjuster. I mediated these cases in 2015, and they did not settle.

9. *Vasquez v. Builders FirstSource*, AAA Case No. 01-14-0001-6281

This was a non-subscriber workers' compensation case arising out of an on-the-job injury. Several windows fell on the claimant during the course of his employment with the respondent. The claimant's allegations included negligence for failing to maintain a safe work environment. Although I was appointed as the arbitrator for this case, all parties agreed to mediate before me prior to the final arbitration hearing. I mediated the case in 2015, and it settled.

As I progressed as an associate, my practice became increasingly more specialized in the product liability area. By the

time I left to join Andrews & Kurth LLP in 1996, I estimate that well over 50% of my work was in connection with defending manufacturers in serious product liability litigation. Thereafter, I continued to handle product liability cases on a first chair basis, but my work expanded to include more commercial litigation matters until I took the bench in 2001.

After I stepped down from the bench and returned to private practice in 2009, I joined Jones Day as a partner in its complex tort and product liability section. There, my time was split between working as a member of a national coordination team defending a product manufacturer in a large multi-district litigation based in Kentucky, and representing a variety of clients as their lead counsel in the Dallas area on significant commercial litigation matters.

In 2014, I joined Carter Scholer PLLC as a named partner. Since then my law practice has covered a wide variety of litigation matters, representing clients in business tort disputes and some personal injury cases on both sides of the docket. I also have accepted many appointments from the state and federal courts to serve as a mediator and umpire. While I have not maintained specific records of time spent, I estimate that I have spent in excess of 100 hours a year most years (and in many years in excess of 200 hours) volunteering my time and resources to help others.

From 1992 to 1994, I co-chaired Attorneys Serving the Community ("ASC"), a group of women lawyers who combine their resources and talents to raise money and awareness for non-profit organizations whose programs benefit women, children or families. During those years, this group of women named themselves ASC and went from raising approximately \$40,000 each year to more than \$100,000 for the selected non-profit beneficiary. While active in leadership roles in ASC, I estimate that I spent well over 300 hours every year raising public awareness and money for non-profits Bryan's House

(1992), Victims Outreach (1993), Camp John Marc (1994), Dallas CASA (1995), Literacy Instruction for Texas ("LIFT") (1996), Nexus (1998) and The Housing Crisis Center (1999). Each of those non-profit organizations exist to benefit the disadvantaged.

I have also actively served on multiple non-profit boards of directors and committees serving the disadvantaged. For instance, I served on the executive board of Camp John Marc for approximately 14 years from 1996 through 2009. This organization is dedicated to serving kids faced with chronic medical and physical challenges with conditions such as cancer, spina bifida, AIDS, and sickle cell anemia. It provides them with medically supervised, high quality, often life impacting camping programs without charge. All of the children are disadvantaged physically and many are disadvantaged economically. For Camp John Marc, I chaired many committees, raised substantial money and went to the the camp location to lay bricks, paint, clean and help however I could. I also served on the board of directors for LIFT from 1995 to 1997. LIFT is a non-profit organization that offers free and easily accessible classes so that functionally illiterate adults can learn to read and write English. Since its founding, over 45,000 low-literate adults have learned to read at LIFT. While on the board at LIFT, I successfully worked to get it to be the 1996 ASC beneficiary, which ultimately raised over \$100,000 for the organization.

I have spent countless hours on many other fundraising efforts and campaigns to assist the disadvantaged. Examples of this would include my service on the board of directors of the Dallas Women's Foundation and as chair of the Dallas Bar Foundation Fellows.

I served for several years as the coach for high school students at the Health Professions High School, which draws many of its students from low income areas, in the annual Dallas Bar Association's mock trial competition. Additionally, I have served multiple times as a judge in mock trial and moot court competitions for Southern Methodist University, the University of Texas and the National Asian Pacific American Bar Association.

Texas. On January 26, 2015, I met with Senator Cornyn and Senator Cruz and their counsel in Washington, D.C. On July 9, 2015, Senator Cornyn's office advised me that my name would be submitted to the White House for consideration for the position of United States District Judge for the Northern District of Texas, Dallas Division.

On April 25, 2015, I submitted an application to the Federal Judiciary Evaluation Committee established by Senator Cornyn and Senator Cruz for the position of United States District Judge for the Eastern District of Texas, Sherman Division (Plano). On July 31, 2015, I was interviewed by the Committee in Dallas, Texas. On September 14, 2015, I met with Congressman Marc Veasey in Dallas, Texas. On November 13, 2015, I was interviewed by Congresswoman Eddie Bernice Johnson and her screening committee in Dallas, Texas. On January 16, 2016, I was notified by the White House Counsel's Office that my name was sent to the Department of Justice to begin formal vetting. From January 16, 2016, I was in contact with officials from the Office of Legal Policy at the Department of Justice. The Senate Judiciary Committee did not hold a vote on my nomination, and on January 3, 2017, my nomination was returned to the President under the provisions of Senate Rule XXXI, paragraph 6 of the Standing Rules of the Senate.

On February 14, 2017, I submitted an application to the Federal Judiciary Evaluation Committee established by Senator Cornyn and Senator Cruz for the positions of United States District Judge for the Eastern District of Texas, Sherman Division, and United States District Judge for the Northern District of Texas, Dallas Division. On March 16, 2017, I was interviewed by the Committee in Dallas, Texas. On April 6, 2017, I met with Senator Cornyn and Senator Cruz and their counsel in Washington, D.C. On May 19, 2017, I was advised by Senator Cornyn's office and Senator Cruz's office that my name was being submitted to the White House for consideration for the position of United States District Judge for the Northern District of Texas, Dallas Division. 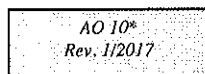

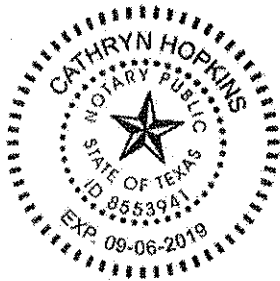
