In the first impact litigation from a partnership I forged between Dechert LLP and the Public Interest Law Center of Philadelphia (“PILCOP”), I brought a class action lawsuit in the United States District Court for the Eastern District of Pennsylvania on behalf of a class of approximately 1,600 students with autism in the School District of Philadelphia. The complaint sought injunctive relief and challenged the School District’s transfer of these students from school to school without adequate notice to parents or opportunity for parental input as a violation of the Individuals with Disabilities Education Act and related federal and state statutes. I supervised a team of associates and coordinated with PILCOP co-counsel in developing strategy, filed the complaint and motion for class certification, handled discovery and motion practice, including expert discovery, and prepared the motion for summary judgment. In February 2013, after two years of litigation, the District Court granted our motion for class certification and, in relevant part, granted our motion for summary judgment. The Court denied defendants’ motion for reconsideration on August 19, 2013, and the parties are proceeding to a remedy phase of the litigation.
