The fact that I was a minority Hmong woman and consistently mistaken as a court reporter or interpreter by judges and other attorneys contributed to more to the self-doubt.

Judge de Alba's compassion taught me I was not alone as a minority in the legal field. Without hesitation, I was immediately taken under Judge de Alba's wings as a mentee. Judge de Alba taught me the importance of having confidence in my knowledge and ability as an attorney. Because of her support and guidance, I obtained the confidence needed in my career as an attorney. I also learned how to be cognizant of my own biases to prevent others from experiencing what I had experienced. Her relentless effort of guiding and coaching has taught me how to positively handle the biases against minorities like me in the legal community. Most importantly, she taught me how to be an ethical, confident, compassionate, professional attorney. I have continued to look to Judge de Alba for leadership and guidance.

Judge de Alba is an exemplary jurist who is an excellent choice for the Ninth Circuit. Throughout the years that I have known Judge de Alba, she exhibits vast knowledge, passion, and respect for the law and the judicial system. She has always had a diligent and tireless work ethic in all that she does. I have witnessed her due diligence in handling important tasks by not only completing the task, but ensuring that all the procedural steps taken to complete the task are properly and ethically complied with. Although I have not appeared before Judge de Alba, those
