Dear Senators Rosen and Cortez Masto:

On behalf of the over 3,500 members of the Las Vegas Police Protective Association Metro, Inc.(LVPPA), a proud member of the National Association of Police Organizations (NAPO) who represent more than 241,000 sworn law enforcement officers across the United States, I am writing this letter to make you aware of our severe concerns with the nomination of Adeel A. Mangi to be a judge on the U.S. Court of Appeals for the Third Circuit.

Mr. Mangi, although a recognized lawyer, has never been a judge at any level and now is nominated to the bench a level below the Supreme Court. While we appreciate that some view his nomination as “historic,” a person with no relevant experience should not be given a judgeship at the second highest level of our judicial system due to uniqueness without legal ability to hold that position.

Furthermore, his work as a Board Member of the Alliance of Families for Justice itself should be disqualifying. The Alliance was founded by Kathy Boudin, convicted for her role in the 1981 Brink’s robbery by the Weather Underground that left two police officers executed in cold blood. The Alliance has and continues to advocate for the release of at least six other cop-killers - Sundiata Acoli, Mumia Abu Jamal, Mutulu Shakur, Russell Maroon Shoatz, Jamil Al Amin, Kamau Sadiki – referring to them all as “elder freedom fighters.”


The fact that the Alliance of Families for Justice, of which Mr. Mangi is an Advisory Board member, raises these cop-killers as leaders to follow and is calling for their release is an affront to the men and women who have dedicated their lives to protecting our communities as law enforcement officers. It is profoundly tone-deaf to the cries for justice from citizens of all walks of life, suffering from mayhem and violence in our streets. Above all, it is an insult to the victims of their heinous crimes and similar crimes against law enforcement: the family and friends of officers who have made the ultimate sacrifice.
