As I have watched my friend build her career, we often come back to how we found each other in the woods, coordinating packs of kids to build forts or fill coffee cans with blackberries on any given day. It is with distinct pleasure and pride to know that a woman whose leadership style first emerged in the mountains of Appalachia is a nominee to serve in the federal justice system.

Oak Ridge has a unique place in history, one that taught us early on how powerful ideas could impact the world. My grandfather had a sixth-grade education and was recruited from Narrows, Virginia to work at the Y-12 National Security Complex, aware only that his skills and aptitude were essential to the war effort. We grew up where it didn't matter where you came from or what your parents did for work, just that every person's contribution mattered. Judge Lee embraced this culture of collaboration and community as an athlete, an academic and student government officer. Her boundless energy and ability to get a bunch of teenagers to focus and make decisions was magnetic and motivational. As an adult in the business world today, I would describe Judge Lee's style then and now as servant leadership, guided by the outcome that will deliver the most benefit for the greater good.

Because of this, I have not been surprised by the trajectory of Judge Lee's career, her association work, and helping others navigate a path in the legal profession. Her ability to balance her career, community work, family and friends is also not surprising, she's always been great at it.
