- From 2005 to 2010, I also participated in multiple “parolee forums” in the Chicago area as part of the Project Safe Neighborhoods (PSN) initiative. These meetings occurred at various community centers located in various City of Chicago police districts, which were locations on the city’s south and west sides (7, 9, 10, 11, and 15). Key attendees at these forums included (1) individuals on probation or recently on parole in the State of Illinois; (2) law enforcement representatives from the U.S. Attorney’s Office, Cook County State’s Attorney’s Office, and Chicago Police Department; and (3) various representatives from community organizations designed to help former offenders find jobs. One of the primary messages delivered to the parolees / probationers at these forums is that they should “not pick up a gun,” thereby avoiding those on the law enforcement side of the table, and instead seek help from the community organizations in the room. As the U.S. Attorney’s Office representative, my role was to describe the federal prosecution of possession of firearms by a felon. Copy not available.

While serving as an AUSA from 1999 through 2010, from time to time I provided interviews and answered questions for TV, radio, and/or newspaper reporters on primarily two topics: (1) specific charged cases, including verdicts and sentences imposed by the Court, as well as other details already in the public record; and (2) various anti-violent crime initiatives in the Northern District of Illinois, including the Project Safe Neighborhoods initiative and, generally speaking, the joint efforts of Federal, State and local law enforcement to identify and prosecute offenders of gang and gun crimes. The charged cases set forth below all attracted some media attention, with *United States v. Joseph Miedzianowski, et al.*, *United States v. Broderick Jones, et al.*, *United States v. Epps, et al.*, and *United States v. Albert Span* being most noteworthy. These cases, however, are not an exclusive list of all such cases in which I was involved, and I may not have provided comment on all of these cases. Judicial Clerk to the Hon. Michael S. Kanne (September 1996 – September 1997):

I served for one year as one of Judge Kanne's law clerks, where I conducted legal research and assisted the judge in preparing for appellate oral arguments and in drafting judicial opinions.

Associate, Kirkland & Ellis LLP (October 1997 – May 1999):

After clerking for Judge Kanne, I worked for nearly two years as an associate at Kirkland & Ellis LLP in Chicago. During that time, I performed legal research, writing, and document review tasks typical of a young associate at a large law firm, and primarily worked on product liability litigation matters.

Assistant United States Attorney, NDIL (May 1999 – June 2010):

In May 1999, I began working as an AUSA in Chicago. As an AUSA, I led grand jury investigations and prosecutions involving violations of various criminal statutes, including RICO conspiracy; drug conspiracy; mail, wire, bank, bankruptcy, and tax fraud; robbery and extortion; alien smuggling; and firearms possession. I continued to handle investigations, trials, and appeals throughout my 11 years as an AUSA, and over time, the size and complexity of the cases increased.

General Crimes Section

I spent my first 2-3 years in the office's General Crimes Section, working on a variety of fraud and narcotics cases. In addition, I also worked on large, more complex prosecutions, including the Joseph Miedzianowski

police corruption investigation and Ari Kirschenbaum health care fraud investigation (both of which resulted in convictions).

Narcotics & Gangs Section; Public Corruption Section

I then moved to the office's Narcotics & Gangs Section for a short time before joining to the Public Corruption Section. Generally speaking, the types of cases I handled became more complex, including complex narcotics-related gang cases, police corruption cases involving racketeering charges, and other public corruption matters.

In October 2005, I became a Deputy Chief in the office's Narcotics & Gangs Section. Even though my supervisory duties became a much more prominent part of my job, I continued to carry my own caseload of investigations, and continued to charge and try cases while serving as a supervisor.

During my 11 years as an AUSA, I tried twenty-one criminal jury cases involving RICO conspiracy, drug trafficking, robbery, extortion, tax fraud, wire fraud, obstruction of justice, bank robbery, document fraud, alien smuggling, and firearms offenses.

In addition to these trials, I also handled appeals before the United States Court of Appeals for the Seventh Circuit, briefing ten such cases and arguing eight of them.

Deputy Chief / Anti-Gang Coordinator

In my role as a Deputy Chief in the Narcotics & Gangs Section, which began in the fall of 2005, I supervised several AUSAs on all matters, including investigations and prosecutions involving organized criminal street gangs and other drug trafficking organizations, fraud schemes, and corrupt public officials. I also provided counsel to AUSAs, federal agents, and other law enforcement officers on all aspects of investigations and prosecutions, including at the grand jury, indictment, guilty plea, trial, sentencing, and appellate stages. In this regard, I regularly provided direct, day-to-day supervision over six to ten AUSAs, which number varied over the years depending on the size of the section and number of supervisors. In addition, I played an advisory role on all gang investigations and prosecutions in the office, and in doing so supervised dozens of additional AUSAs.

In addition to being a Deputy Chief, I also served as the Anti-Gang Coordinator for the Northern District of Illinois. In that role, I worked with multiple federal agencies, state and local police departments, and federal and county prosecutors to develop and implement a unified strategy to investigate and prosecute organized criminal street gangs in the Chicago area.

Partner, Kirkland & Ellis LLP (June 2010 – present):

I returned to Kirkland & Ellis LLP in June 2010 as a partner. I am a member of the Government and Internal Investigations group, and of the firm's overall Litigation group.

Since that time, my practice has focused on internal investigations, government enforcement defense, and other litigation matters. For example, my experience includes representation of companies and individuals on a wide array of matters before various governmental entities, including the following:

- I represented BP in connection with government investigations and related litigation resulting from the *Deepwater Horizon* oil rig explosion and oil spill, including resolution of criminal charges with the DOJ and management of post-resolution obligations.
- I conducted an internal investigation and represented a corporate client before the DOJ and SEC regarding alleged violations of the Foreign Corrupt Practices Act.
- I represented an executive in connection with a U.S. Attorney's Office's investigation involving environmental crime and securities fraud allegations.
- I have conducted confidential internal investigations for companies, boards of directors, and audit committees into a variety of matters, including allegations of fraud and other misconduct.
- I have advised a variety of entities, including both publicly-traded and private companies, with regard to managing crises involving potential criminal and civil litigation risk, assessing other regulatory risks, conducting due diligence for potential corporate transactions, and providing anti-corruption and other compliance guidance and training.

In addition to my other responsibilities, I am also a member of the Associate Review and Attorney Recruiting committees at the firm.

My legal practice has always been heavily focused on litigation, and I have appeared in court on numerous occasions over the past 20 years. While I do have civil litigation experience in connection with my work at Kirkland & Ellis LLP as both an associate and a partner, the overwhelming majority of my litigation experience involves federal criminal matters. All of my criminal litigation has been in the federal court system, including both on the prosecution and defense side. As an AUSA from 1999-2010, I tried more than 20 criminal cases in federal District Court; I appeared in District Court for contested hearings, sentencings, and status conferences on numerous occasions; and I argued 8 criminal appeals before the Seventh Circuit Court of Appeals.

Since returning to Kirkland in 2010, I have been involved in federal criminal matters involving the Department of Justice, including various United States Attorney's offices and the Department of Justice's Fraud Section in Washington D.C. Generally speaking, I have represented companies (and on a couple of occasions individuals) before these various prosecutor's offices. Most of these representations have been confidential -- that is, they involve matters in which charges have not been brought against my client. I have not tried any criminal cases since returning to private practice in 2010.

I have tried twenty (20) criminal jury cases to verdict (and had another jury trial result in a mistrial due to a hung jury). These cases involved RICO conspiracy, drug trafficking, robbery, extortion, tax fraud, wire fraud, obstruction of justice, bank robbery, document fraud, alien smuggling, and firearms offenses. All of these criminal trials were in federal court in the Northern District of Illinois while I served as an AUSA between 1999 and 2010. As is custom in the U.S.

Attorney's office in Chicago, all of these trials involved at least two prosecutors. I was the lead prosecutor in approximately half of these cases, and second chair in the remaining half.

I also tried one criminal bench trial as an AUSA in the Northern District of Illinois (*U.S. v. Edward Coburn*, 01 CR 845 (NDIL) (Kocoras, J.)), which involved a stipulated set of facts and an insanity defense. I was sole government counsel in that case. As an AUSA, I also argued 8 criminal appeals before the Seventh Circuit Court of Appeals.

During my brief tenure as an associate at Kirkland between 1997 and 1999, I participated as a member of a trial team representing General Motors in a civil trial in the Circuit Court of Cook County.
