Dear Senator Grassley,

It is with gratitude that we acknowledge the tireless efforts that you, the other members of the Senate Judiciary Committee, and its staff have done in exposing the ties between Nazis and Swiss banks during both World War II and its aftermath. It is of great historical importance for better understanding of the era; but of greater significance is the enhancement of our ability to hold accountable those financial institutions that indirectly made possible both the atrocities of the war (including the Holocaust) and the evasion of justice by those who fled Europe after Germany's defeat.

You have helped the American people to deepen their understanding of the lies and obfuscations which even now Swiss banks are trying to put forth to prevent a full rendering of the historical record and avoid responsibility for their actions. At a time when many would seek to cover up the murderous work of antisemites and their allies and minimize the tremendous violence that has been and continues to be directed at Jews worldwide, your work in a breath of fresh air that declares that the light of truth is the best response to works of darkness.

The hearing planned for February 3rd, entitled "The Truth Revealed: Hidden Facts Regarding Nazis and Swiss Banks," is a further step in the direction of accountability that we applaud. The opportunity to set the historical record straight, and in the process to further education of young people and others about the Nazis and their allies' war on the Jews, is exceptional.

At the same time, it is also an opportunity to remind those who would continue that war under whatever guise—as happened, for instance, on October 7, 2023, that there will be a reckoning, and that truth and justice will win out, regardless of the efforts of those who would seek to deny or obliterate it.

As an organization that has helped lead the effort to protect Assyrian Christians and others persecuted for their faith in Iraq and the larger Middle East, helping thousands in the wake of the ISIS invasions and its aftermath, we at Iraqi Christian Relief Council are especially sensitive to the sufferings of our Jewish brothers and sisters. Thank you again for your leadership on this issue.

This letter is submitted with the support of additional signatories who join us in affirming the importance of truth, accountability, and moral clarity.
