Dear Director Wray,

As the Senate Judiciary Committee continues to investigate matters related to the Justice Department's and the Federal Bureau of Investigation's handling of the Crossfire Hurricane investigation, concerns have been raised about how some of the personnel involved in that investigation have subsequently been promoted or rewarded despite their participation in Crossfire Hurricane. These promotions or rewards were bestowed even though there are still serious lingering questions regarding the abuse of the Foreign Intelligence Surveillance Act that occurred as part of that investigation. Rather than deserving of incentives, these abuses should result in significant disciplinary action and perhaps even criminal prosecution.

To better understand the current status of the personnel involved with Crossfire Hurricane, I request that the FBI provide the following information for the individuals listed on the charts on pages 81-83 of the DOJ Inspector General report, *Review of Four FISA Applications and Other Aspects of the FBI's Crossfire Hurricane Investigation*:

1. Their current ranks or titles and whether they were promoted or demoted during or since the conclusion of Crossfire Hurricane, or whether they were terminated or resigned.
2. For those who resigned or were terminated, please provide their last rank or title and whether their departures are final or whether there are legal actions pending for reinstatement or other remedies.
3. The name or identifier for any personnel listed on the charts who received any type of cash award, or other award or recognition, during or after Crossfire Hurricane, and a description of the award.
