Beginning in 2005, I served at the Department of Justice as a Counsel to the Attorney General. My role was mainly advisory and involved primarily civil matters. I also did some appellate work.

I then served on a detail for approximately eight months, from 2006 to 2007, as a Special Assistant United States Attorney in the United States Attorney's Office for the Eastern District of Virginia. Most of my work consisted of handling misdemeanor cases before magistrate judges. I also handled preliminary hearings, detention hearings, and a grand jury proceeding. I helped brief two appeals in the Fourth Circuit in criminal cases. I was also part of a trial team that tried a four-week jury trial against a physician for drug trafficking involving prescription drugs.

In 2007, I joined Bartlit Beck Herman Palenchar & Scott LLP in Chicago. I worked there for close to ten years, first as an associate (from 2007 to 2010) and then as a partner (from 2010 to 2017). My practice at Bartlit Beck involved complex civil litigation in a variety of areas, including contract, tort, and intellectual property, in state and federal courts and in arbitrations, in large and small matters. If confirmed, I will recuse myself from any litigation where I have ever played a role. For an appropriate period of time, I anticipate recusing in all cases where my former firm, Bartlit Beck Herman Palenchar & Scott LLP, represents a party. I will evaluate any other real or potential conflict, or relationship that could give rise to the appearance of a conflict, on a case by case basis and determine appropriate action with the advice of parties and their counsel, including recusal where necessary.

students about the Program and the resources it provides to address substance abuse disorders and mental health issues in the legal profession. While at Bartlit Beck, I helped moot a student from the Federal Criminal Justice Clinic in preparation for an appellate argument on behalf of a criminal defendant.

Outside the law, I have served on the Board of Trustees of St. Ignatius College Prep since 2016. In 2011, I served as a tutor to a student assigned through Literacy Chicago, an organization that promotes adult literacy.
