On February 2, 2026, I sent an open letter expressing my support for the presence of law enforcement when any member of the Kansas Legislature participates in a public speaking event. Copy supplied.

b. Describe:

- i. the general character of your law practice and indicate by date when its character has changed over the years.

I started my legal career in January 1995 as an assistant DA handling felony traffic cases. I moved from traffic into felony property crimes, and then felony drug crimes, and then person crimes. My practice consisted of being in court every day, trying approximately one case a week. After about two years in this role, I joined the Criminal Division the Kansas Attorney General's Office where I was assigned to handle arson and explosives cases across the state. My caseload consisted of cases from around the state, and it involved mostly difficult and complex investigations, often in the rural counties in the state. After I had spent approximately two years in this role, the office obtained a federal grant (the HIDTA grant – High Intensity Drug Trafficking Area) that would fund a position for a state prosecutor to embed in the U.S. Attorney's Office (USAO) as a Special Assistant United States Attorney (SAUSA) to prosecute cases involving clandestine methamphetamine laboratories.

I entered the U.S. Attorney's Office in 1998 as a SAUSA to prosecute meth lab cases. After a little more than a year in this role, the USAO offered me a position as an Assistant United States Attorney. In this new role I began handling other drug cases, along with gun cases, violent crimes, some general criminal cases, and because of my prior experience at OAG, even some arson/explosives cases. But over time, an increasing number of my cases were complex drug trafficking cases from the Organized Crime Drug Enforcement Task Force (OCDETF). I became the Deputy OCDETF Chief for the office. I continued to handle other cases, but the majority of my cases were large and complex drug trafficking cases – with all the associated issues, like firearms and gangs and money laundering and RICO charges.

In 2006, DOJ asked for volunteers with complex case experience to deploy to Iraq and assist the Iraqis with prosecuting members of Saddam Hussein's regime for war crimes and atrocities. I volunteered for a six-month assignment with the Regime Crimes Liaison Office (RCLO) in Baghdad. I concluded my service to the RCLO in September 2007. I returned to the USAO in Kansas and took over a major crimes and drug crime portfolio in the office. I also handled the capital litigation for the

office, working in particular on a gang-related drug and racketeering case in Wichita where two informants had been killed. I handled another capital case where a drug dealer in Salina, Kansas, fashioned a silencer from a two-liter soda bottle and then used it to murder a rival drug dealer. I also began handling the national security matters for the office.

In 2008, the Department of Justice's National Security Division (NSD) requested prosecutors with complex case experience to assist with the prosecution of the 200+ detainees being held at Guantanamo Bay. I volunteered for this assignment and was selected. I spent more than four years as the lead prosecutor of the capital case against the al Qaeda operative sent by Osama bin Laden to Yemen to commit what ultimately became the attack on USS COLE (DDG 67), which killed 17 United States Sailors and seriously injured dozens of others.

In April 2013, I returned to the USAO in Kansas. I shared the assignment of handling the national security cases, while also picking up other cases as time allowed. During this time, I also served a term on the Attorney General's Capital Case Review Committee, which consists of federal prosecutors from USAOs across the country with capital case experience, who review prospective federal capital cases and advise the US Attorney General on whether to seek the death penalty.

In 2016, was assigned the position of National Security Prosecutor for the District of Kansas. In this role, I assisted the FBI in investigating all national security cases in Kansas, including counter-intelligence and counter-espionage cases, as well as counter-terrorism cases. Counter-terrorism consisted of both international terrorism cases, such as al Qaeda and ISIS-inspired violent extremists, and domestic terrorism cases, such as cases against militia members who intended or attempted to commit acts of violence. In addition to working with the FBI and other agencies in investigating these cases, I also prosecuted the cases, usually along with a prosecutor from DOJ.

I retired from DOJ in November 2020, and took a position as in-house counsel for Medcor, Inc., a corporation that provides on-site workplace healthcare to clients across the United States and Canada. My practice consisted mostly of providing legal guidance directly to the organization, specializing in navigating strict regulatory landscapes like HIPAA and the Affordable Care Act, managing legal risks, drafting contracts, handling employment issues, overseeing compliance with healthcare regulations, and acting as a strategic partner to business leaders.

Since January of 2023, I have been the Director of the Kansas Bureau of Investigation, leading an organization that provides investigative resources

and forensic laboratory resources to the entire state, along with serving as the criminal justice information repository for the state.

- ii. your typical clients and the areas at each period of your legal career, if any, in which you have specialized.

As an Assistant District Attorney and Assistant Kansas Attorney General, I prosecuted violations of state statutes and my client was the people of the State of Kansas. As a federal prosecutor, I spent roughly the first half of my career in a traditional prosecutor role, prosecuting violations of the federal criminal code and federal drug statutes, and roughly the second half focusing on the investigation and prosecution of national security cases. As a federal prosecutor, my client was the United States.

As counsel for Medcor, my client was the company. I handled internal legal matters for the company, as well as providing legal guidance and acting as a strategic partner to the leaders of an organization that operated within strict regulatory landscapes.

In my current role, I don't have a client *per se*, but I am responsible for running a 427-person state law enforcement agency with an annual budget of approximately \$75 million and a mission to keep our state safe.

I estimate that I handled dozens of trials over my almost thirty years as a prosecutor. I handled a large number of trials early in my career, and even the most consequential trials

were relatively short. Most of my trials at the federal level tended to be long and complex. I did not keep track of my numbers of trials over the years, but I estimate that I tried to completion at least 50 cases with juries.

- i. What percentage of these trials were:

Early in my career (as an intern in the DA's Office), the majority of my trials were to the court (and there were a great many of those). Once I became an Assistant DA, and then as an Assistant AG and as an AUSA, it was very unusual for me to have a non-jury trial. I can think of only a handful I did as an ADA, I don't believe I did any as an AAG, and I remember doing only one in my 22 years in federal court.

1. *USS COLE: Abd al-Rahim Al-Nashiri* (Military Commissions Trial Judiciary) (Colonel James Pohl, Chief Judge of Military Commissions) (Representation: 2008 – 2013)

My second deployment as a civilian was to the Office of Military Commissions from 2008 to 2013. I was initially assigned as one of three attorneys on the COLE team (the other two were O-6 JAGs), but after six months I was asked to take over as the lead prosecutor of this capital prosecution at Camp Justice, Naval Station Guantanamo Bay. For more than four years, I led a joint military/civilian team of attorneys (mostly JAGs), agents (FBI and NCIS), paralegals and intelligence analysts prosecuting the high-ranking al Qaeda operative sent to Yemen by Osama bin Laden to conduct the attack on the USS COLE that resulted in the death of 17 American Sailors and the serious injury of dozens

of others. The Rules for Military Commissions are a synthesis of federal criminal code, the Federal Rules of Criminal Procedure, the Uniform Code of Military Justice, and the international laws of armed conflict, so it was a challenging legal environment. The challenge was heightened by the constant coordination required between federal civilian law enforcement (primarily the FBI), military law enforcement (NCIS), the Department of Justice, the Department of Defense, the State Department, and the Intelligence Community. In addition to supervising the entire team, and representing the team (and the case, and often the office) when dealing with those “external” partners, I participated in more than 250 witness interviews, I personally drafted the charging document, and I briefed and argued countless motions and responses on issues that frequently involved constitutional interpretation, were often novel, and were almost always complicated and nuanced.

2. *US v. Curtis Allen et al*, Case No. 16-CR-10141-EFM (D.Ks.) (Senior Judge Eric F. Melgren) (Representation: 2015 – 2020)

I led the lengthy and complex FBI investigation and federal prosecution of three southwest Kansas militia members who called themselves “The Crusaders.” They conspired to use 400 pounds of homemade explosives to blow up an apartment building in Garden City, Kansas, and to slaughter the more than 100 Somali-Muslim refugees who lived there. The case culminated in a five-week trial in federal court in Wichita, with dozens of witnesses and hundreds of exhibits. The jury convicted all three defendants on charges of attempting to use a weapon of mass destruction and conspiracy to violate civil rights. All three defendants were later sentenced to terms ranging from 25 to 30 years of imprisonment. This case was the subject of a documentary on Hulu entitled “The Informant; Fear & Faith in the Heartland.”

3. *US v. Terry Loewen*, Case No. 13-CR-10200-MLB (D.Ks.) (Senior Judge Monti Belot)
(Representation: 2013 – 2015)

I led another lengthy and complex FBI investigation and federal prosecution of a Vietnam-era Marine veteran who radicalized online, joined al Qaeda, and tried to drive a vehicle-borne improvised explosive device (VBIED) onto the tarmac at the Wichita airport at the height of Christmas travel season to kill as many people as possible. We used an informant and then an undercover to disrupt the plot, and an FBI SWAT team arrested Loewen as he attempted to drive the VBIED onto the airport grounds. After months of pretrial litigation, including extensive litigation under the Classified Information Procedures Act (CIPA), Loewen ultimately pled guilty to attempting to use a weapon of mass destruction. Under his plea agreement, he will likely spend the rest of his life in federal prison.

4. *US v. John Booker*, Case No. 15-CR-40030-CM (D.Ks.) (Judge Carlos Murgia) (Representation: 2014 – 2017)

I led a lengthy and complex FBI investigation and federal prosecution of an 18-year-old who radicalized online, joined ISIS, and then joined the US Army with the specific intent to be a “sleeper agent” until he had the opportunity to commit a Fort Hood style attack (he idolized Major Nidal Haasan). He originally plotted to drive a trash truck filled with explosives onto Fort Riley and blow up the base hospital. Following the play book we developed in the Loewen case, we used an informant and an undercover to disrupt the plot. Booker was arrested by an FBI SWAT team at the edge of Fort Riley as he armed the VBIED. Like Loewen, this case involved months of pretrial litigation, including CIPA litigation. Booker ultimately pled guilty to attempting to use a weapon of mass destruction. He was sentenced to 30 years in federal prison.

5. *US v. Feng “Franklin” Tao*, Case No. 19-CR-20052-JAR (D.Ks.) (Senior Judge Julie A. Robinson) (Representation: 2018 – 2020)

I, along with a Trial Attorney from CES, led an FBI investigation and initiated the federal prosecution of a chemistry professor from the University of Kansas (KU) named Franklin Tao, who had applied for and accepted millions of dollars in grant funding from the Department of Energy (DOE), the National Science Foundation (NSF), and KU, to conduct advanced research into the field of catalysis (a critical part of the process of creating renewable energy). During the process of applying for that funding, and spending the millions of dollars he received, he failed to notify DOE, NSF, or KU that he was also being paid by a university in China to operate a research laboratory that had

been funded by the Communist Chinese Party to research catalysis. In one of the very first prosecutions under DOJ's "China Initiative," we charged Dr. Tao with wire fraud, grant fraud, and program fraud. I retired from DOJ before this case went to trial.

6. *US v. Timothy Cline (a/k/a "Pony") et al*, Case No. 00-CR-40024-SAC (D.Ks.) (Senior Judge Sam A. Crow) (Representation: 1999 – 2007)

Early in my career as a federal prosecutor, I led a lengthy and complex DEA investigation and federal prosecution of an outlaw biker ring that was manufacturing extremely high-quality methamphetamine (the first 100% pure meth we saw in the United States) and distributing it across the country. After a months-long wiretap, we indicted 42 defendants – 28 in Kansas and the others in two neighboring federal districts (Northern Oklahoma and Western Missouri) – on drug conspiracy and related charges. The case culminated with a seven-week jury trial of two defendants, with both convicted and sentenced to lengthy prison terms (one of which – the leader of the outlaw motorcycle gang – later had his sentence commuted by then-President Biden). I also handled the appeals to the Tenth U.S. Circuit Court of Appeals.

7. *US v. Albert Banks et al*, Case No. 13-CR-40060-DDC (D.Ks.) (Senior Judge Daniel D. Crabtree) (Representation: 2013 – 2020)

Just as I returned from the Military Commissions, the KBI was wrapping up a months-long investigation of a crack cocaine distribution ring in Junction City that involved numerous undercover purchases by KBI agents followed by months of wiretaps. I volunteered to prosecute the federal component of the case. I prosecuted 22 defendants in federal court, and more than 75 others were prosecuted by our counterparts in state court. The case culminated in a three-week trial of six defendants in the federal courthouse in Kansas City, Kansas. I also handled the appeals until my retirement.

8. *US v. Troy Barker et al*, Case No. 02-CR-40157-JAR (D.Ks.) (Senior Judge Julie A. Robinson) (Representation: 2002 – 2007)

In late December 2002, DEA agents seized 564 pounds of marijuana from a private jet as it refueled at the airport in Salina, Kansas. Agents arrested the two individuals who were transporting the drugs. The following day, agents in California seized \$852,405 from a different private jet that had just landed at Van Nuys airport. A lengthy DEA investigation connected those two flights with each other, and with an organization operating from the Los Angeles area that consisted mostly of members of a Jamaican family and their close friends. I indicted a total of eleven defendants in Kansas. All pled guilty but two, who were tried by jury almost two years later and convicted, then sentenced to lengthy terms of imprisonment for conspiring to distribute controlled substances. I also handled the appeals of the convictions and sentences.

10. *United States v. Jarrett Smith*, Case No. 19-CR-40091-DDC (D.Ks.) (Senior Judge Daniel D. Crabtree) (Representation: 2019 – 2020)

In March of 2019, the FBI received information that a Facebook account belonging to the defendant, Jarrett Smith, a soldier in the United States Army, had disseminated guidance to others on how to construct Improvised Explosive Devices (IEDs) and spoke to others

via social media about his desire to travel to Ukraine to fight with a violent, far-right paramilitary group. In September of 2019, by which time Smith had been transferred to Fort Riley, Kansas, he engaged with an FBI Undercover Employee (UCE) on social media and, during these online discussions, provided specific instructions for constructing an explosive device. Later in that same conversation, Smith provided the UCE with a recipe for creating improvised napalm. Smith provided both the instructions for the IED and the napalm recipe with the intent that the information be used for the attempted use of a weapon of mass destruction. Smith plead guilty to two violations of 18 U.S.C. § 842(p), distributing information related to explosives, destructive devices, and weapons of mass destruction

a. *KBI Capital Improvements*

Kansas government officials are prohibited from engaging in lobbying activities, but I spend a significant amount of my time advocating to the Kansas Legislature on behalf of the KBI. One area in which I have advocated for significant improvement is the agency's physical infrastructure. In the past two legislative sessions, the Kansas Legislature and the Governor have authorized the expenditure of \$80 million for the KBI to build a new headquarters in downtown Topeka, the expenditure of just over \$2 million to move the KBI's Wichita office into new leased space, and the expenditure of \$40 million for design, development, and construction of a consolidated regional law enforcement center and crime laboratory in Pittsburg, Kansas. The Pittsburg building will be constructed on the edge of the Pittsburg State University (PSU) campus and will serve not only as the KBI's regional office, but also as the 24/7 headquarters for the campus police department, a substation for the Crawford County Sheriff's Department, and a zone office for the Kansas Highway Patrol. It will provide a satellite KBI Forensic Laboratory for two chemists and a fingerprint examiner. It will provide dedicated desk space for the United States Marshal Service and the Federal Bureau of Investigation when their deputies and agents are operating in that part of the state, along with providing office space for prosecutors from the Kansas Attorney General's Office. It will serve as a regional training hub for the Kansas Law Enforcement Training Center, it will provide classroom space for the PSU Criminal Justice program, and it will have a five-lane indoor firing

range available to area law enforcement agencies for their firearms training. This collaborative project will have a generational impact on an area of the state (and multi-state region) that has been underserved for decades.

b. *KBI Resource Enhancements*

Similarly, since becoming Director in 2023, I have convinced the Kansas Legislature and the Governor to fund Child Victim Units (CVU) in all three investigative regions of the state, meaning the entire state now has CVU coverage for the investigation of internet crimes against children (ICAC) cases, most of which involve either the trafficking of children or the distribution of child sexual abuse materials (CSAM) or both. Cases involving ICAC/CSAM are the fastest-growing type of case law enforcement is seeing today, and Kansas is now better-positioned to investigate these cases against some of the most vulnerable members of our society. Under my leadership, the KBI has also added the Joint Fentanyl Impact Team (JFIT), a statewide initiative partnering with KHP, along with both federal and local agencies that has contributed to the dramatic reduction of the availability of drugs (especially fentanyl) in Kansas. Finally, in the three years I have led the agency, we have grown from approximately 350 people and a \$48 million annual budget to more than 425 employees and an annual budget of approximately \$78 million, all while decreasing the employee vacancy rate from >25% to <7%.

c. *1991 Intifada (Uprising) Case*

My first deployment as a civilian was in 2007, when I served as an Attorney/Advisor for the Regime Crimes Liaison Office (RCLO) in Baghdad. The RCLO advised the Iraqi attorneys (judges, prosecutors, and defense counsel) that made up the Iraqi High Tribunal, a war crimes court established to try members of Saddam Hussein's regime for war crimes and atrocities. My specific role was to advise and assist the team of four Iraqis who were prosecuting the 1991 Intifada (Uprising) case, which involved the Iraqi military response to an uprising in the Basra Province of Iraq in 1991 (referred to as "one of the ugliest crimes ever committed against humanity in modern history."). By the time we tried this case, Saddam Hussein had been convicted in three other war crimes cases and executed. Our lead defendant was Saddam's cousin, Ali Hassan al-Majid ("Chemical Ali"). He and 12 others were ultimately convicted, and al-Majid was later executed as a result of this conviction. Trying a massive and complex war crimes case inside a war zone during an active military conflict was not just a fascinating experience, it was a formative experience for me – as a prosecutor, as a lawyer, and as a person – to play a small role in assisting a society in implementing the rule of law after generations of dictatorial rule.

d. *Allison Fluke-Ekren*

Ekren was a Kansas native who married a Turkish citizen, converted to Islam, radicalized, moved to Syria, and ultimately became the leader of the ISIS Female Brigade. Ekren was successfully prosecuted in the Northern District of Virginia. I handled the matter of Ekren's daughter, who was 14 at the time she was located in a refugee camp in Syria, pregnant with the child of an ISIS fighter. She was repatriated to the United States, returned to Kansas, and reunited with her grandparents. This was the most factually complex and nuanced case I ever handled, as this pregnant teenager was a

witness (we called her before a federal grand jury in Topeka to testify against her mother), a victim (her mother coerced her to marry an ISIS fighter, who was later killed, and who raped and impregnated her), and a potential target (her mother's role as the leader of the ISIS Female Brigade was to recruit "sleeper" agents willing to travel to the United States and surreptitiously lay in wait for months before committing a suicide IED attack inside the US, and we had to be concerned this young woman was a sleeper agent sent into the country by her mother for the purpose of committing such an attack).

e. *National Security Coordinator of the District of Kansas*

For the last several years of my career as an AUSA, I served as the National Security Coordinator for the District of Kansas. In this role, I supervised dozens upon dozens of national security investigations conducted by the Kansas City Joint Terrorism Task Force. Many of them were very high-profile and public, such as Loewen, Booker, Tao, Jarrett Smith, and the Crusaders (Curtis Allen *et al*). Others had to be kept secret until they were concluded, like Fluke-Ekren. Countless others received no notoriety, ranging from school threats to threats against political officials and so on.

f. *Deputy OCDETF Coordinator for the District of Kansas*

Earlier in my career, before my deployments and before my career shifted into the national security arena, I was the Deputy Chief of the Organized Crime and Drug Enforcement Task Force. In this role, I prosecuted numerous cases against high-level drug trafficking organizations (like the "Operation Renegade" case). All of these cases were large (often involving a dozen or more defendants, most of whom were from outside of Kansas and even outside the United States) and complex, and they involved not only huge amounts of illegal narcotics but also significant amounts of money, along with the seizure of cash, bank accounts, and both real and personal property.

g. *Association of State Criminal Investigative Agencies (ASCIA)*

Since becoming KBI Director in 2023, I have been involved with ASCIA, the national association for state law enforcement agencies like the KBI. I was elected to the Board in 2024 as the Secretary, and I currently serve as Vice President of the association. In that role, I have represented ASCIA in various meetings with both elected and appointed federal officials.

- a. Trial Advocacy at Washburn University School of Law (2000 – 2007, 2013 – 2025)
During many of my years of practice, I have taught (or co-taught, or helped teach) trial advocacy classes at the Washburn University School of Law. When I started participating, I was one of a handful of practitioners who together taught a semester-long class. When the university started a week-long intensive trial advocacy class, I joined other practitioners in teaching the entire course. As I've gotten busier, I've limited my participation to one day, and sometimes even just one session. The past two to three

years, I've taught just the section in closing argument, using as an example the closing argument I gave in the Crusaders case in 2018. I teach this class *pro bono*.

- b. Comparative War Crime Prosecutions Course at US Army JAG College (2021 – 2025)
In recent years I've taught just a two-hour session at multi-branch course on comparative war crimes prosecutions. I share my observations having prosecuted cases in Article III courts, military courts, and an international war crimes tribunal, and compare/contrast the three different systems under which war crimes, genocide, and atrocities cases can be brought to justice. I teach this class *pro bono*.

I am the principal of a small company called Sweetwater Investments (discussed in response to Question 6), which partially owns two small self-storage facilities, one in Lawrence, Kansas, and the other in Topeka, Kansas. I am attempting to sell both facilities.

I earned a pension in the Federal Employees Retirement System (FERS) after more than 20 years of service to the United States Department of Justice. I have also earned a small pension in the Kansas Public Employees Retirement System for my service prosecuting at the state level and my years at the Kansas Bureau of Investigation.

I have no such plans, although I will continue to run Sweetwater Investments until both storage properties are sold.

I would like to continue to teach trial advocacy classes to law students and new lawyers.

If confirmed, I will recuse myself from cases involving the Kansas Bureau of Investigation and the Kansas Attorney General's Office for a period of two years. I also have been retired from the United States Attorney's Office for the District of Kansas for more than five years, but I would recuse from any case that I personally handled while in the office. For any other matters, I will evaluate any other real or potential conflict on a case-by-case basis and determine the appropriate action, to include recusal when necessary.

b. Explain how you will resolve any potential conflict of interest, including the procedure you will follow in determining these areas of concern.

If confirmed, I will carefully review and address any real or potential conflicts by reference to 28 U.S.C. § 455, Canon 3 of the Code of Conduct for United States Judges, and any other laws, rules, and practices governing such circumstances. In situations that present actual conflicts of interest based on my prior positions at the Department of Justice or the Kansas Bureau of Investigation, I would recuse myself from any cases in which I was personally involved as a prosecutor or supervisor. In situations involving potential conflicts of interest, I would disclose all relevant information to the parties, allow the parties to be heard, and then rule on any recusal motion based upon the application of all relevant authorities and guidance.

25. **Pro Bono Work:** An ethical consideration under Canon 2 of the American Bar Association's Code of Professional Responsibility calls for "every lawyer, regardless of professional prominence or professional workload, to find some time to participate in serving the disadvantaged." Because I have spent the vast majority of my career as an attorney for the government, my ability to engage in the outside practice of law is limited. My teaching has been *pro bono*, and I have volunteered in numerous activities ranging from coaching youth sports (for my own children and others) to community service activities on behalf of organizations such as the Federal Bar Association (one example would be reading a portion of the United States Constitution at Constitution Day activities). In my current role as KBI Director, I have spent many hours

speaking to community organizations about the dangers of fentanyl. On September 23, 2023 (estimated date, based on newspaper coverage), I gave my fentanyl presentation to every junior high and high school student in the entire Hays, Kansas, school district. Similarly, on November 21, 2023, I spoke to every high school student in the Osborne, Kansas, school district.

Kansas does not have a selection commission. In approximately January through March of 2025, I had conversations with both Kansas U.S. Senators about my interest in this position. I discussed the matter with both Senators occasionally over the following months. I was told that my name was one of several sent to the White House in the summer of 2025. I was interviewed by members of White House Counsel's Office on August 29, 2025. After that interview, I continued to have conversations with both Senator Moran and Senator Marshall about the process. On Saturday, February 14, 2026, Senator Moran informed me that I was being recommended by the Senators for one of the three open positions on the federal bench in Kansas. On February 17, 2026, President Trump called to tell me that he intended to nominate me for this position. Since that time, I have been in contact with personnel from the Department of Justice's Office of Legal Policy.
