I have served as the Public Defender for the State of Rhode Island since July 2012. I was appointed to that position by Governor Lincoln Chafee on March 14, 2012 and confirmed by the state senate. I have never run for elective office, and I have not been unsuccessful in any nomination for appointed office.

Although I was not very actively involved in the organization, to the best of my recollection, I participated

in efforts to encourage young people to register to vote and to become involved in the political process and support the electoral efforts of Democratic candidates.

In 1993, I joined the law firm of Tate and Elias in Providence, Rhode Island as an associate attorney. Tate and Elias is an insurance defense firm focused on representation of doctors and hospitals against medical malpractice claims. As the only associate attorney, I handled depositions and the motion calendar, and I assisted partner attorneys during trials. I also prepared discovery responses and was responsible for researching and writing motions.

From 1994 to 2006, I served as an Assistant Public Defender for the State of Rhode Island. I began representing indigent defendants accused of misdemeanors. Thereafter I represented people charged with probation violations and, for the majority of those years, I primarily represented individuals charged with felonies ranging from simple drug possession to murder.

From 2006 through July 2012, I served as an Assistant Federal Defender in Rhode Island. During those years I was engaged exclusively in the defense of indigents charged with crimes in federal court.

Since 2012, I have served as the Public Defender for the State of Rhode Island. While I still handle a few individual criminal cases, my primary responsibilities are to run the agency. I am the chief financial officer responsible for budgeting and spending. I also act as general counsel for the agency.

While at Tate and Elias, I represented doctors, medical professionals and hospitals engaged in malpractice lawsuits. In addition, I handled a few clients in other matters, including educational advocacy. In both the state and federal public defender offices, I represented indigent criminal defendants in trial courts. I represented people charged with crimes ranging from misdemeanors to murder. I served as either lead or sole counsel on a range of criminal cases. In addition, in federal court I handled a few appeals.

As the Public Defender for the State of Rhode Island, I handle fewer criminal cases now, and instead represent the agency generally. As the

chief administrative officer, I am responsible for developing and implementing policy, ensuring ethical and high-quality representation, and overseeing training and personnel decisions with respect to approximately 100 employees, of whom 93 are full-time. I have also represented the agency in an unemployment case by a former employee and represented individual attorneys at post-conviction hearings.

For the majority of my career I have been engaged exclusively in litigation. For the first year of my career I was a litigation associate in an insurance defense firm. As an Assistant Federal Defender from 2006 to 2012, I appeared in court several days per week. For the past three years, as the head of a statewide public defender agency, I am in court less frequently. I appear in court on occasion to handle some criminal matters as well as matters related to the business of the Rhode Island Public Defender's Office.

2. *State v. Dearmas*, Case No. P1-2001-2621A (R.I. Super. Ct), *rev'd*, 841 A.2d 659 (R.I. 2004).

I represented Mr. Dearmas, who was charged with two counts of first degree child molestation. The State moved to seize a blood sample from the defendant in order to test the DNA to see if it matched the evidence in the case. I objected on behalf of Mr. Dearmas, challenging, among other things, the power of the court to issue such an order. After a hearing, the trial court granted the motion and issued a blood seizure order, but stayed the execution of the warrant to allow an interlocutory appeal. The Rhode Island Supreme Court reversed, quashing the order of the superior court, although I did not handle the appeal. This case ultimately caused a change in Rhode Island law as it relates to the authority of the superior court to issue warrants.

3. *State v. Garcia*, Case No. P1-1999-2635AG (R.I. Super. Ct.), *aff'd*, 883 A.2d 1131 (R.I. 2005).

I acted as lead counsel for the defendant in this case involving a first degree murder charge. Ms. Garcia was accused of shooting Ms. Smith in the back and shoulder. Ms. Garcia admitted that she had shot and killed Ms. Smith, and claimed self-defense. At trial, the defense challenged the admissibility of ballistic evidence and presented evidence that the decedent was in fact the aggressor. The trial court refused to admit character evidence to support the self-defense argument, and Ms. Garcia was ultimately convicted and sentenced to life in prison consecutive to a 74-year sentence she was already serving in Virginia. 4. *State v. Tabor*, Case No. P1-1998-3839A (R.I. Super. Ct.).

I represented Mr. Tabor, who was the night manager of a U-Haul rental agency in Providence. During a store closing one evening, a co-worker put a gun that he had bought for protection on the counter. At some point, Mr. Tabor picked up the gun and it discharged, killing another employee. The State charged Mr. Tabor with manslaughter, on the theory that he had acted negligently in handling the firearm. At trial, the defense showed that the firearm in question had an extremely light trigger pull, and the jury acquitted Mr. Tabor. I acted as lead counsel for Mr. Tabor and handled jury voir dire and selection, opening statement and closing argument, the cross examination of most of the State's witnesses, and the presentation of defense witnesses.

I represented Mr. Hatch through hearing, sentencing, appeal and a petition for certiorari to the United States Supreme Court. Mr. Hatch had been previously convicted of tax evasion and filing a false tax return in 2006. I acted as sole counsel for Mr. Hatch when he was summoned to answer a charge that he had violated the conditions of his supervised release arising from that conviction, by failing to file amended income tax returns and pay all taxes that were due. As the Rhode Island Public Defender, I have convened a working group to address the issue of incarceration without representation in Rhode Island's municipal courts, which do not provide counsel for all indigent defendants facing incarceration. I have negotiated with the cities of Providence and Cranston to address this issue in their municipal courts, and am working with other members of the working group to compile a list of all municipalities and their practices for the provision of representation. In addition, I serve on the Justice Reinvestment Working Group, a panel formed by Rhode Island Governor Gina Raimondo on July 7, 2015, to study and recommend criminal justice reforms with the goals of protecting public safety, reducing recidivism, analyzing racial disparities, and reducing costs. The group is currently working on reform of the state's probation system. As part of my responsibilities as Public Defender, I have advised legislative officials on funding issues for indigent defense in the state.

While I have approved our legislative liaison's proposals to support or oppose pending legislation as part of the Rhode Island Public Defender's legislative package over the past three years, I have never performed lobbying or registered as a lobbyist.
