After my clerkship, I was an associate for the Washington D.C. law firm Covington & Burling. My work spanned multiple practice areas of litigation and government enforcement, but I principally worked on legal analysis, fact development and review, and witness interviews.

I joined the Department of Justice in 2015 as a federal prosecutor. In that role, I led and supervised over a hundred criminal investigations in which I managed multi-agency investigative teams, strategized how to build a federal prosecution, conducted extensive grand jury investigations, applied for and obtained search warrants, interviewed witnesses, and other investigative actions. These investigations concerned numerous subject

matters, including public corruption, racketeering, national security, narcotics trafficking, fraud, and import/export controls.

I also prosecuted various categories of federal crimes in multiple United States Attorney's Offices, appearing in court regularly for preliminary proceedings (initial appearances), contested detention hearings, evidentiary hearings, suppression hearings, and trials. As Deputy Chief of Appeals for the United States Attorney's Office for the District of Maryland, I supervised, managed, and reviewed criminal appeals for the United States Attorney's Office and also served informally as ex officio general counsel to the United States Attorney for the District of Maryland.

During my tenure at the Department of Justice, I also served as Senior Counsel to the U.S. Deputy Attorney General and Counselor to the U.S. Attorney General. In both roles, I was on detail from the United States Attorney's Offices for the District of Maryland and for the Eastern District of Pennsylvania. In these roles, I served as an advisor to the Attorney General and Deputy Attorney General on various matters pursued by the Department, helped the Department formulate and implement its programs and policies as assigned, and served as a liaison for numerous United States Attorney's Offices.

In 2022, I went in-house to serve as corporate counsel to Amazon, where I defended the company against government investigations and enforcement actions brought by foreign, federal, and state regulators. This work involved structuring the compliance of multiple business lines, managing legal teams to gather facts, advocating the company's defenses directly to government attorneys, and negotiating settlements. I served in this capacity until I was appointed as the Interim United States Attorney for the Eastern District of Pennsylvania in March 2025. In this capacity, I am the chief federal law enforcement officer for the Eastern District of Pennsylvania, and I supervise and oversee all federal criminal prosecution and civil litigation in the district.

I represented Amazon while serving as in-house counsel. In this role, I defended the company against government investigations and enforcement actions brought by foreign, federal, and state regulators.

My legal team managed and oversaw the representation of Amazon in the ongoing landmark consumer protection case brought by the Federal Trade Commission alleging billions of dollars in damages. The case is regarded by some as the most significant consumer protection enforcement action in the history of ecommerce, and its importance will define permissible commercial marketing and subscription practices for years to come. The lawsuit spans several years and all aspects of the Amazon Prime business. In sum, the FTC alleges that Amazon knowingly deceived customers into enrolling into their Amazon Prime subscription program and then improperly thwarted customers from cancelling subscriptions. I supervised and directed the legal strategy and factual development of the defense of the company.

2. United States v. Terrell Plummer et al.,

Case No. 17-cr-223 United States District Court for the District of Maryland The Honorable George L. Russell III 2017-2020

I represented the United States in the prosecution of the Old York Money Gang, a Baltimore street gang responsible for murder, robbery, and drug trafficking. The case attracted significant notoriety as it originated from a horrific and infamous killing of a three-year-old child named Mackenzie Elliott. I led the investigation into the organization through a proactive targeting of the gang responsible with racketeering charges, and brought a comprehensive prosecution against nine defendants comprising the gang for various charges, including contract murder and the killing of Mackenzie Elliott. The killer of the child, Terrell Plummer, pled guilty and received a sentence of 25 years in prison. Most of the other defendants also pled guilty. The two leaders of the gang, Trevon Beasley and Darrin Mosley, were responsible for multiple murders and were convicted by a jury after a five-week trial. Beasley received a sentence of life imprisonment, while Bosley received a sentence of thirty years' imprisonment.

3. United States v. David Wise

Case No. 17-cr-132 United States District Court for the District of Maryland The Honorable Richard D. Bennett 2017-2019

I represented the United States in the prosecution of a robbery of a Federal Firearms License dealer in east Baltimore by an organization who subsequently sold the assault rifles and firearms on the streets of Baltimore. The case remains one of the most violent and destructive robberies of a FFL in the history of the Department of Justice as measured by firearms stolen, as the defendants locked one of the owners in a safe and left her to die. I led the investigation into the conspiracy, which led to arrests of all five defendants and the seizure of a majority of the firearms they took. I prosecuted and convicted five separate defendants under various robbery and firearm charges. All defendants were convicted and received sentences ranging from 12-20 years in prison.

4. United States v. Waymond Richard

I represented the United States in the prosecution of a nineteen-defendant violent fentanyl trafficking organization in west Baltimore (Pratt & Calhoun) responsible for operating an open-air drug market and numerous killings and violent crimes.

The organization operated an extensive, long-running open air-drug market that serviced hundreds of customers per day, acquired millions in revenue during the lifespan of the organization, and were responsible for at least one drug overdose resulting in death.
