In March 2017, I learned that the two Ohio Senators (Senator Rob Portman and Senator Sherrod Brown) had announced that they were accepting applications for a vacancy at the United States District Court for the Southern District of Ohio. I reviewed their press release and began to prepare my application. I submitted my application to Senator Portman's office in April, 2017.

There is a selection commission in Ohio to recommend candidates for nomination to the federal courts. I interviewed with the commission on August 23, 2017. At the end of its work, the Commission recommended my nomination along with five others to Senators Portman and Brown.

I interviewed with Senator Portman on September 17, 2017. On September 29, 2017, Senators Portman and Brown issued a press release in which they jointly recommended me for the vacancy in Columbus, Ohio.

In October 2017, I was contacted by the Office of the White House Counsel to schedule an interview in Washington, D.C. On October 12, 2017, I interviewed with attorneys from the White House Counsel's office and the Office of Legal Policy.

Since then, I have periodically communicated with individuals in the White House Counsel's Office and the U.S. Department of Justice. On April 12, 2018, the President submitted my nomination to the Senate.
