Lee for the office of Under Secretary for Intellectual Property and Director of the United States Patent and Trademark Office ("USPTO"), Department of Commerce. Ms. Lee is imminently qualified for this leadership role and would serve with distinction as the Director of the USPTO.

NAPABA is a national bar association representing the interests of Asian Pacific American attorneys, judges, law professors, and law students. Notably, she served as the USPTO Director of the Silicon Valley Office and, prior to that, as Google's first Deputy General Counsel and Head of Patents and Patents Strategy. In her capacity as the USPTO Director for the Silicon Valley Office, she oversaw the policy, operations, and outreach efforts of the USPTO in the Western United States. As Google's Deputy General Counsel and Head of Patents and Patent Strategy, Ms. Lee became an industry leader in handling large and highly complex patent disputes, helped shape the development of patent law by filing amicus briefs on patent issues before the Supreme Court and in the Federal Circuit, and played a key role in many legal and business The Honorable Patrick J. discussions concerning patent licensing, purchases, and sales. Currently, Ms. Lee serves as the Deputy Under Secretary of Commerce for Intellectual Property and Deputy Director of the USPTO and acting Director of the USPTO, where she advises the Administration on domestic and international intellectual property policy matters and provides extensive advice to Congressional members and staff on legislative proposals.

Ms. Lee's other achievements include recognition as a 2014 Top 50 Trailblazer in Intellectual Property by the National Law Journal, as a Silicon Valley/San Jose Business Journal "2012 Best IP Lawyer," and as a "2013 Women of Influence." Ms. Lee also has demonstrated a commitment to community service through her role as co-founder of ChIPs, a non-profit organization devoted to the mentoring, education, and promotion of women in patent and intellectual property related fields.

Given her excellent qualifications, experience, and proven abilities, Ms. Lee would make an outstanding and immediate contribution as the Under Secretary of Commerce for Intellectual Property and Director of the USPTO. Accordingly, the National Asian Pacific American Bar Association proudly supports the nomination of Michelle K.
