From 1997 to 1998, I served as a judicial law clerk, conducting legal research and writing and preparing draft opinions.

From 1998 to January 2018, I have been an attorney with the same civil litigation firm that typically has had approximately ten attorneys. After serving as a summer intern after my second year in law school, I began as an associate in the fall of 1998, preparing and arguing motions, writing briefs, taking depositions, doing appeals, and serving as second chair for jury trials and court trials. I became a non-equity partner in 2003. As my practice evolved and I began taking more of my own cases, I focused more on appellate law (both civil and criminal appeals), constitutional law, declaratory judgment actions, and legal writing. I continue to draft the briefs for and argue many of the substantial motions, particularly summary judgment motions, for the clients of our firm. I elected to become an equity partner of the firm on January 1, 2015.

From January 2018 to February 2021, I was the United States Attorney for the District of South Dakota. As U.S. Attorney, I was the chief federal law enforcement officer for a district comprising the entire State of South Dakota, including nine Indian Reservations. The district serves almost 900,000 residents with 32 Assistant U.S. Attorneys and more than 60 employees located in three offices in Sioux Falls, Pierre, and Rapid City. During my term, I served on the Attorney General Advisory Committee's Terrorism and National Security, Native American Issues, and Elder Justice Subcommittees.

From March 2021 to the present, I have been an attorney with the same civil litigation firm with which I have practiced my entire career. I elected not to become an equity partner and have slowed my practice down somewhat, primarily handling civil appeals in the South Dakota Supreme Court and doing research, brief writing, and motions practice for various cases handled by the firm.

My entire practice has been in litigation. During my time at the law firm, I have appeared fairly frequently in court to argue motions at hearings before trial courts and to present appellate arguments. The majority of my time is spent researching and writing legal briefs. I occasionally participate as counsel for a party at a trial or administrative proceeding. When I was the United States Attorney, in terms of litigation practice, I handled several oral arguments before the U.S. Court of Appeals for the Eighth Circuit, wrote a few briefs to the district

court and appellate courts, and represented the United States at several mediations of civil cases before the United States federal magistrate judges.

In October 2017, I was one of the attorneys for the State of South Dakota that filed a petition for certiorari to the United States Supreme Court in *South Dakota v. Along with co-counsel, I represented group of small farmers and landowners in a declaratory judgment action to enforce their constitutional private property rights to exclude general public from entering their private flooded farmland for purposes of hunting, fishing, and setting up ice fishing shacks during the winter and to prohibit the South Dakota Department of Game Fish and Parks (GFP) from facilitating access to those waters on private flooded land. We contended that the Executive Department, through the GFP, was violating the separation of powers established by the South Dakota Constitution because only the Legislature could authorize such access.

I authored the complaint, conducted all of the discovery, filed a motion for certification of a defendant class, successfully briefed and argued the class certification motion before the circuit court, filed a motion for summary judgment, and successfully briefed and argued the summary judgment motion before the circuit court.

After we prevailed at the circuit court, the state defendants appealed. I authored the appellee brief and successfully argued the case before the South Dakota Supreme Court. The Supreme Court substantially affirmed the injunction, resulting in a favorable decision for our clients. Subsequently, the Governor of South Dakota called a special session of the South Dakota Legislature, which then enacted substantial legislative protections for private property rights of owners of private flooded lands. The Governor signed the bill on June 12, 2017.

Initially, I was appointed by the United States Court of Appeals for the Eighth Circuit to assist the petitioner on an appeal by the United States from the federal district court's grant of his petition for federal habeas relief. I authored the appellee brief and attended the oral argument before the Eighth Circuit, which reversed the grant of relief on procedural grounds. See Engesser v. Doolev, 686 F.3d 928 (8th Cir. 2012).

Along with co-counsel, I was then court-appointed to represent the same petitioner in a state habeas action brought under a new state statute. After the state circuit court granted our petition, holding that our client was actually innocent and had been wrongfully convicted, the state appealed. I authored the appellee brief and successfully argued the case before the South Dakota Supreme Court, which held that our client was "actually innocent," resulting in the vacating of his conviction and his release from prison after serving more than ten years. This was the first South Dakota Supreme Court decision to recognize "actual innocence" as an independent basis for habeas relief under state law.

This was a multi-tiered, multi-jurisdictional litigation between our client, an Indianowned construction business, and the Oglala Sioux Tribe (OST), which hired our client to complete four construction projects. At various stages, the litigation was venued in the Oglala Sioux Tribal Court and Supreme Court, South Dakota Circuit Court, United States District Court, and the United States Court of Appeals for the Eighth Circuit, in addition to being the subject of an arbitration conducted by the American Arbitration Association. Our client contended that the OST had breached the contracts.

My role consisted solely in successfully briefing and arguing two different appeals to the Eighth Circuit. In the first appeal, the Eighth Circuit affirmed the federal district court's holding that it lacked jurisdiction over the Tribe's complaint seeking to enjoin the contractor from pursuing arbitration because its claims were not based on federal law. In the second appeal, the Eighth Circuit reversed the district court's entry of an injunction preventing the contractor from confirming the arbitration award in state circuit court, holding that by contracting to accept the American Arbitration Association's rules, the Tribe was required to abide by those rules authorizing confirmation of the award in the jurisdiction in which the arbitration occurred. After we prevailed in both appeals, the dispute was settled by the parties.

I represented the plaintiffs in this federal action brought in United States District Court, District of South Dakota, by the Livestock Marketing Association and a group of South Dakota and Montana cattle ranchers seeking declaratory and injunctive relief that the mandatory assessments on all cattle sales established by the Beef Promotion and Research Act, 7 U.S.C. 2901 ("beef checkoff") overseen by the United States Department of Agriculture violated the First Amendment rights of the cattle producers required to fund the program by compelling them to subsidize speech with which they disagreed. Our clients, United States beef producers, wanted to promote only U.S. beef and objected to the advertising funded in part by imported beef producers promoting it as a generic commodity.

I assisted in the drafting of the initial and amended pleadings, handled much of the discovery in the litigation, authored the summary judgment briefs, tried the case with one of my law partners, and presented the plaintiffs' closing argument to the district court. The district court held that the "beef checkoff" program was unconstitutional and granted a nationwide injunction prohibiting the USDA from collecting the mandatory assessments on cattle sales.

After we prevailed at the district court level, the United States appealed to the U.S. Court of Appeals for the Eighth Circuit. I authored the appellee brief before the Eighth Circuit and was present at counsel's table for the oral argument.

After we prevailed at the Eighth Circuit, the United States filed a petition for certiorari in the United States Supreme Court. I authored the brief in opposition to the petition. After the petition was granted, I assisted in writing the brief for respondents, although it was primarily authored by our co-counsel. I also was present at counsel's table for the argument before the Supreme Court. The Supreme Court reversed and held that the "beef checkoff" program was government speech immune from First Amendment scrutiny.

I have substantial experience in the civil arena. I estimate that I have been involved at various stages in several hundred cases litigated in the state and federal courts of South Dakota. I have prevailed in the South Dakota Supreme Court in an action seeking to enforce the private property rights of farmers and landowners, arguing that the State Games Fish and Parks Department was violating the separation of powers by facilitating access to member of the general public to waters located on private flooded land for the purpose of hunting and fishing. I successfully argued to the South Dakota Supreme Court that the administrative appeals process enacted by the City of Sioux Falls violated the due process rights of its citizens by reversing the burden of proof. In 2005, I appeared at counsel's table at the United States Supreme Court in a federal action involving the constitutionality of federal statute. See Johanns v. Livestock Marketing Ass'n, 544 U.S. 550 (2005) (authored by Justice Scalia). I was privileged to meet Chief Justice Roberts at the Eighth Circuit argument in that case, in which he represented the intervenors, and I believe it was one of his last appellate arguments before being sworn in as a Circuit Judge of the United States Court of Appeals for the D.C. Circuit. More than ten years later, I was able to speak with the Chief Justice about it briefly at the Eighth Circuit Judicial Conference in Arkansas.

In an interesting First Amendment case, I defended a website against a federal defamation action brought by actress Jane Fonda and former Senator Jim Abourezk arising out of the website's inclusion of them on its "Traitor List," resulting in a settlement of their claims for one dollar. *Abourezk v. ProBush.com*, No. 4:03-CV-04146 (D.S.D. 2004). In addition, for approximately five years I served as local counsel helping to defend American Broadcasting Companies, Inc., ABC News, Inc. and journalists Jim Avila and Diane Sawyer against defamation and agricultural products disparagement claims brought by Beef Products, Inc. in the South Dakota courts. The case settled midway through a scheduled eight-week trial.

In my appellate practice, I have handled more than one hundred appeals. Specifically, my work for clients has resulted in at least 35 reversals in their favor, including seven new trials. Before becoming U.S. Attorney in 2018, I agreed to take appointments for federal criminal appeals when called by the Eighth Circuit clerk to do so and occasionally have also done state criminal appeals. It allowed me to acquire experience in a variety of aspects of criminal prosecutions and I have litigated several issues involving the Fourth, Fifth, Sixth, and Eighth Amendments, as well as a number of federal criminal statutes and the United States Sentencing Guidelines.

With the approval of the Governor's Office, I served as co-counsel with the South Dakota Attorney General's Office representing the State of South Dakota in an appeal to the South Dakota Supreme Court in a declaratory judgment action involving the dormant commerce clause. Although I withdrew from the case upon becoming U.S. Attorney in 2018, the case was eventually heard by the U.S. Supreme Court and resulted in the overruling of *Quill v. North Dakota*. *See South Dakota v. Wayfair*, 585 U.S. 162 (2018) (holding that out-of-state seller's physical presence in taxing state is not necessary for state to require seller to collect and remit its sales tax). In addition, I have represented the National Governors Association and several other governmental organizations in authoring two amicus briefs for those entities in the United States Supreme Court.

Before becoming U.S. Attorney, I was able to form good relationships during interaction with Tribal officials over the years. For several years, I have represented the Flandreau Santee Sioux Tribe in a series of federal declaratory judgment actions regarding taxation and have a very good working relationship with their leadership and their Attorney General. I was court-appointed to represent a group of Lakota prisoners in a federal RLUIPA action involving their religious freedom, and was honored with a Star Quilt following the Eighth Circuit's decision upholding their religious rights. In addition, I have argued an election contest in a tribal appellate court for the presidency of the Flandreau Santee Sioux Tribe. And I have been involved in several federal cases, both civil and criminal, involving tribal jurisdiction.

During my term as U.S. Attorney, the work of the office was focused on doing everything possible to help keep tribal communities in South Dakota safe, prosecuting drug offenses, including the emerging problem of opioid abuse and fentanyl during that time, prosecuting violent crime, and upholding civil rights laws. During my term, I served on the Attorney General Advisory Committee's Terrorism and National Security, Native American Issues, and Elder Justice Subcommittees.

Since returning to private practice at my old law firm following the end of my tenure as U.S. Attorney, I have focused primarily on appeals in the South Dakota Supreme Court, legal research, brief writing, and motion practice in state and federal civil litigation.

The amount of time that I have dedicated to pro bono legal work has varied greatly from year to year. I do not have detailed records regarding these services. In particular, I have briefed and argued several appeals over the years for people who could not afford an attorney. Several of those pro bono appeals have resulted in published decisions by the South Dakota Supreme Court. A few examples include representing a retired military combat veteran in his claim that the administrative appeals process enacted by the City of Sioux Falls violated his procedural due process rights, representing a young Native American woman seeking to preserve the circuit court's expungement of her record, and representing a family in an action brought against them to enforce a city ordinance regulating the number and weight of their dogs.
