Re: Nomination of Rod J. Rosenstein - Deputy Attorney General

Dear Chairman Grassley and Ranking Member Feinstein:

I write to express my strong support for Rod J. Rosenstein's nomination to be Deputy Attorney General of the United States. While I am truly saddened to see him leave his current post as U.S. Attorney for the District of Maryland, I am confident that Rod will be an invaluable asset to the nation if confirmed by the Senate to be our next deputy attorney general.

I've had the privilege of knowing Rod for more than a decade, since President Bush appointed him as our state's U.S. Attorney in 2005. As Maryland's top federal prosecutor and the nation's longest-serving U.S. Attorney, Rod has rightfully earned the respect and admiration of leaders from both parties at the state and federal level for his unquestionable integrity, fidelity to the Constitution and our laws, and firm commitment to fighting corruption, violent gangs and criminal organizations, and financial crimes. Furthermore, he has built strong relationships with law enforcement agencies across Maryland, and the collaboration that his office and those agencies share has undoubtedly made our communities safer.

My agency, like most government agencies, has enjoyed a close working relationship with the U.S. Attorney's Office – especially as we continue to aggressively protect Marylanders from being victimized by tax fraud and identity theft. Working together, we have increased public awareness of these highly-sophisticated financial crimes and have worked collaboratively to bring financial predators to justice.
