Davis*, 533 U.S. 678 (2001). I ultimately recommended granting the petition because Respondents did not meet their burden to present evidence demonstrating that Petitioner was likely to be removed in the reasonably foreseeable future. This was a criminal case in which Defendant was charged with a violation of 18 U.S.C. § 3184. Brazil alleged Defendant sexually abused a minor in violation of the Brazilian Penal Code and sought his extradition. Defendant challenged his extradition, arguing that the evidence was insufficient and inconsistent, and that the victim was not credible. Following an evidentiary hearing, and consistent with the limited scope of review required from a magistrate judge in an extradition hearing, I certified Defendant's extradition because the crime charged fell within the plain terms of an extradition treaty and there was probable cause to believe that Defendant committed that crime. Although I found that the evidence of Defendant's guilt was not overwhelming, I emphasized that my role as the adjudicator of the extradition proceeding was simply to determine whether the government presented enough competent evidence to meet the relatively low probable cause threshold. A district court judge denied a subsequent habeas petition seeking Defendant's release.

This was a case brought by various corporations that participate in the hemp industry and individuals that use hemp products, challenging amendments to the State of Alaska's hemp regulations and seeking injunctive and declaratory relief. I granted Defendant's motion for summary judgment, affirming Alaska's sovereign authority to establish hemp production standards that were more stringent than those provided by federal law. I first determined that the amended hemp regulations did not violate the Supremacy Clause because they were not preempted by the 2018 Farm Act, making them a proper exercise of Alaska's historic police powers. I then determined that the regulations did not violate the dormant Commerce Clause because they were non-discriminatory and consistent with a legitimate state interest, requiring that I defer to Alaska's policy decisions underlying the amendments. Finally, I determined that the regulations did not constitute a regulatory taking in violation of the Fifth Amendment and were not void for vagueness.

After denying Defendants' late-filed motion for summary judgment, I issued a trial scheduling order and set the matter for an evidentiary hearing on Plaintiff's compliance with the Prison Litigation Reform Act's exhaustion requirement, as informed by *Perttu v. To date I have not had any opinions reversed, nor have I had any judgment affirmed but with significant criticism of the substantive or procedural rulings.

I have had three reports and recommendations rejected in part by the district court judge.

In *United States v. Haynes*, No. 3:25-cr-00057-SLG-KFR (D. Alaska Apr. 27, 2026) (copy supplied), *R. & R. adopted in part and rejected in part*, 2026 WL 1954304 (D. Alaska July 6, 2026), I recommended that a motion to suppress be denied, finding that law enforcement had a valid reason to initiate a traffic stop that led to the discovery of an unlawfully possessed firearm by a felon. Specifically, I found that law enforcement reasonably suspected that Defendant had both failed to stop and failed to yield. The district court judge adopted the recommendation that the motion be denied but limited the lawful basis for the stop to only Defendant's failure to yield.

In *Chow v. United States*, No. 3:22-cv-00258-SLG-KFR, 2023 WL 11918160 (D. Alaska Aug. 29, 2023), *R. & R. adopted in part and rejected in part*, 2023 WL 11918163 (D. Alaska Oct. 2, 2023), the district court judge adopted my recommendation "nearly in its entirety" that Plaintiff's Amended Complaint be dismissed with prejudice for multiple reasons, including the failure to meet the pleading standards of Federal Rule of Civil Procedure 8. The district court judge did not adopt my conclusion that dismissal was appropriate pursuant to *Heck v. Humphrey*, 512 U.S. 477 (1994).

In *Kanaway Seafoods Inc. v. Pacific Predator*, No. 3:22-cv-00027-SLG-KFR, 2023 WL 3034544 (D. Alaska Jan. 25, 2023), *R. & R. adopted in part and rejected in part*, 2023 WL 3720975 (D. Alaska May 30, 2023), I prepared a report and recommendation that the district court judge deny Defendant's motion to dismiss. The district court judge adopted in part and rejected in part this recommendation, disagreeing with me that Plaintiffs had adequately established jurisdiction pursuant to Supplemental Admiralty Rule D or the Preferred Ship Mortgage Act.

In *Lane v. Chelsea Gorup*, No. 3:22-cv-00132-SLG-KFR, 2022 WL 18587676 (D. Alaska Dec. 14, 2022), *R. & R. adopted in part and rejected in part*, 2023 WL 241479 (D. Alaska Feb. 25, 2025) (included with district judge's opinion), *R. & R. adopted in part and modified in part*, 769 F. Supp. 3d 913 (D. Alaska Mar. 7, 2025), the district court judge adopted my recommendation that Petitioner be released from custody but modified my recommendation that Petitioner's release be subject to "appropriate conditions" of supervision "to be determined by immigration authorities." The district court judge instead ordered that Petitioner's release be subject to the conditions of supervision that had been in place prior to Petitioner's detention.

In *Alaska Wildlife Alliance v. U.S. Fish & Wildlife Service*, No. 3:21-cv-00209-SLG-

KFR, 2023 WL 2986365 (D. Alaska Feb. 6, 2023), *R. & R. adopted in part and modified in part*, 2023 WL 2674760 (D. Alaska Mar. 29, 2023), *aff'd in part, rev'd in part*, No. 23-35299, 2024 WL 1169411 (9th Cir. Mar. 19, 2024), the district court judge “in large part adopted [my report and recommendation], with modifications and additional rulings[.]” The Ninth Circuit later reversed and remanded in part the district court judge’s order.

The District of Alaska employs a recusal system based on identified conflicts, like cases I was previously assigned or played a significant supervisory role in as an Assistant United States Attorney, my wife's place of work, and financial interests or holdings. I am required to maintain a conflict list that I must review and update. This system is managed by the Deputy Clerk of Court. I and my chambers staff also monitor my assigned cases for any conflicts.

I have recused myself in multiple cases involving convicted defendants who have returned to

federal court for violating their conditions of supervised release. These recusals occurred when I learned that I had appeared as an Assistant United States Attorney in that defendant's original prosecution. These matters were not flagged at the time of assignment because I was not an official attorney of record that had filed a notice of appearance. Rather, in these cases I appeared only for a single hearing while covering for a colleague. I have also recused myself in cases where I did not appear as an Assistant United States Attorney, but was nonetheless familiar with the defendant through prior investigative work that did not lead to a prosecution, or because the defendant had been a witness or interested party in an earlier case of mine.

I also recused myself in *Native Village of Unalakleet v. U.S. Department of Agriculture's Rural Utilities Service*, No. 3:24-cv-00100-SLG (D. Alaska). This case involved a dispute over funding provided by the United States Department of Agriculture to entities in rural Alaska for the purpose of installing broadband internet. My wife works for a government organization that has worked with Plaintiffs in their efforts to obtain this government funding. My wife was not directly involved in this work; however, in an abundance of caution, I recused myself from this matter.

In *United States v. Smith*, No. 3:24-cr-00040-ACP-KFR (D. Alaska), a self-represented criminal defendant filed a motion for my recusal, claiming that my handling of his complaints about his conditions of confinement and access to discovery created an appearance of partiality and demonstrated bias. In reviewing this claim I analyzed the relevant recusal statute at 28 U.S.C. § 455 and the relevant case law that requires the court to ask "[w]hether a reasonable person with knowledge of all the facts would conclude that the judge's impartiality might reasonably be questioned." *United States v. Holland*, 519 F.3d 909, 913 (9th Cir. 2008). I declined to recuse myself because the defendant's motion was based on purely judicial disagreements with prior orders in this case, and there were no facts that would lead a reasonable person to conclude that my impartiality in the case might reasonably be questioned.

Following a deployment to Saudi Arabia in support of Operation Southern Watch, I returned to Fort Bliss as Trial Counsel for the 31st Air Defense Artillery Brigade. In this capacity, I advised the command staff and managed all felony and misdemeanor criminal matters from investigation through court-martial, including a homicide investigation, major drug prosecutions, violent crimes, and sex offenses.

In 2002, I became Senior Trial Counsel for the 1st Infantry Division Headquarters at Leighton Barracks in Würzburg, Germany. I supervised eight officers and led military prosecutions in what was then the Army's largest court-martial jurisdiction. The following year, I was selected as Command Judge Advocate for Special Operations Command Europe. Transitioning away from military justice, my practice focused on advising command staff on the law of armed conflict, operational and fiscal law, regulatory matters, and personnel issues.

In 2007, I joined the United States Attorney's Office for the Eastern District of California, initially prosecuting criminal immigration cases involving defendants who illegally re-entered the country after felony convictions. By 2009, my caseload shifted to child exploitation, including child sexual abuse material and child sex trafficking. In 2012, I became the office's Project Safe Childhood Coordinator and regularly presented at Department of Justice training programs on investigating and prosecuting online child exploitation.

I maintained this focus upon joining the United States Attorney's Office for the District of Alaska. I again served as the Project Safe Childhood Coordinator before being promoted to Senior Litigation Counsel in 2018 and Deputy Criminal Chief in 2021. In these management roles, I helped develop and implement office priorities—including outreach in rural Alaska to assist with child sex offense investigations—while mentoring new attorneys and advising line prosecutors.

I initiated this investigation and was the sole prosecutor before becoming a United States Magistrate Judge. This investigation started after a 16-year-old girl was murdered at a popular Anchorage hiking location. During the investigation, law enforcement learned that Schillmiller, who lived in Indiana, had been communicating with a local woman online. During these communications, Schillmiller promised money to the woman in exchange for the murder. Schillmiller also conspired with the woman to coerce a minor victim to produce sexually explicit images, which the woman took and sent to Schillmiller. Working with State of Alaska investigators and prosecutors, I led a team that quickly obtained a criminal complaint and arrest warrant for Schillmiller, and a search warrant in Indiana for the search of Schillmiller's residence and seizure of his computer. Law enforcement arrested Schillmiller at the time of the search and he was ordered to be transported to Alaska. While Schillmiller was in federal custody, local prosecutors

worked to gather sufficient evidence to charge and prosecute him in state court, which they were ultimately able to do based in part on the federally seized computer evidence. The district court judge sentenced Schillmiller to 30 years in prison for his role in the production of child sexual abuse material. Schillmiller also received a 99-year sentence in state court for his role in the murder.

2. *United States v. Grant*, No. 3:19-cr-00003-RRB (D. Alaska) (Beistline, J.), Dkt. No. 363 (judgment). Representation: 2018 – 2021.

I was the lead prosecutor in this prosecution of a previously federally convicted, validated Anchorage gang member charged with sex trafficking of a minor; sex trafficking by force, fraud, and coercion; and production of child pornography. The joint federal and local investigation and prosecution of this case targeted Grant, a dangerous individual suspected of multiple gang related shootings in the Anchorage area during a time of increasing violence. At trial, my co-counsel and I presented testimony from multiple victims and law enforcement agents, as well as digital evidence that corroborated the victims' claims and established Grant's culpability. Due to delays caused by the COVID-19 pandemic, sentencing was continued until after my departure from the United States Attorney's Office. The court sentenced Grant to 420 months' imprisonment followed by a lifetime term of supervised release.

3. *United States v. Karjala*, No. 3:17-cr-00063-TMB (D. Alaska) (Burgess, J.), Dkt. Nos. 638 (Karjala judgment) and 640 (Miller judgment). Representation: 2018 – 2021.

I assumed the role of lead prosecutor in this case involving an Anchorage defense attorney accused of smuggling controlled substances into the local jail. Karjala coordinated with her client and co-defendant Miller to obtain packaged drugs from individuals in the Anchorage community. After receiving the drugs, Karjala abused her privileged access as a defense counsel to smuggle the drugs into the jail, passing them to Miller during meetings. This case involved extensive litigation, including multiple evidentiary motions, a motion by Miller to withdraw his guilty plea, and a motion to dismiss. These significant motions were all decided in the government's favor. Both defendants pled guilty. The court sentenced Karjala to approximately 38 months' imprisonment and Miller to approximately 50 months' imprisonment. This case was part of a larger investigation seeking to stem the flow of drugs and other contraband into the Anchorage Correctional Complex. In total, approximately 12 individuals were prosecuted as a result of that investigation.

4. *United States v. Peterson*, No. 3:17-cr-00008-RRB (D. Alaska) (Beistline, J.), Dkt. No. 119 (judgment). Representation: 2016 – 2018.

In 2016, four young men walked an Alaska teenager into the woods and executed him. Following the murder, the men drove to Peterson's house, where Peterson took possession of the weapons used to murder the victim, and provided gas cans to the group that they used to burn the victim's vehicle in an attempt to destroy evidence. Alaska State Troopers subsequently obtained a warrant to search Peterson's phone. During this examination, Troopers located a 10-second video showing the sexual assault of an incapacitated 15-year-old girl at a local party. During the party, Peterson gave the girl marijuana, contributing to her extreme intoxication and subsequent assault. Working with state prosecutors, I brought this case to ensure Peterson was held sufficiently responsible for his role in the teenager's murder and the minor victim's sexual assault. Following the denial of his motion to suppress evidence seized from his cell phone, Peterson pled guilty. The court sentenced Peterson to three years in prison followed by four years of supervised release. This sentence was ordered to run consecutive to Peterson's state sentence of six years that was imposed for his role in obstructing justice.

5. *United States v. Whitebread*, No. 4:16-cr-00005-RRB (D. Alaska) (Beistline, J.), Dkt. No. 236 (judgment). Representation: 2016 – 2019.

I was the lead prosecutor in the case. Whitebread distributed files of child sexual abuse material through an online file-sharing network. Following the execution of a search warrant at Whitebread's home, law enforcement found hundreds of images of child sexual abuse material that Whitebread had downloaded over the course of six weeks. At trial, Whitebread claimed that the computer had been used during the time of the downloads by a houseguest. However, a review of millions of lines of computer code by two computer forensic experts demonstrated that the downloads occurred when text messages showed Whitebread was in the house. In addition, the computer did not show any activity at times Whitebread was away from the house. The investigation also showed that Whitebread had previously been accused of inappropriately touching a minor child, and of having been engaged in a sexual relationship with a 15-year-old when he was in his 20s. The court sentenced Whitebread to 15 years' imprisonment followed by a lifetime term of supervised release.

6. *United States v. Keehn*, No. 3:16-cr-00004-TMB (D. Alaska) (Burgess, J.), Dkt. No. 113 (judgment). Representation: 2016 – 2021.

I was the lead prosecutor in this case involving an Alaska man accused of sex trafficking. During an investigation into Keehn's distribution of drugs, Alaska State Troopers identified several women Keehn had forced to work for him in the sex trade in and around Anchorage. Keehn targeted drug-addicted women and recruited them to work for him by promising safe shelter and help getting off drugs. In most instances, Keehn substituted methamphetamine for heroin to be able to better control his victims. In

exchange for lodging, food, and drugs, the victims worked as prostitutes for Keehn, providing him with money and sexual favors. Following a guilty plea, the court sentenced Keehn to 166 months' imprisonment followed by a 10-year term of supervised release.

I was the lead prosecutor in this case. During an FBI investigation concerning the online trading of child sexual abuse images, investigators discovered that Salard, a physician practicing in Wrangell, Alaska, was sharing images of child sexual abuse material. Law enforcement obtained a search warrant for Salard's house. Upon executing the warrant, Salard attempted to wipe his computer and destroy the digital evidence located on it. The trial lasted six days and included detailed evidence recovered by two computer forensic experts that described the incriminating data recovered from Salard's seized computer. The court sentenced Salard to 240 months in prison followed by a lifetime term of supervised release. Before the events in this case, Salard had been accused of but not prosecuted for committing a hands-on offense involving a minor in Louisiana. After Salard was convicted in Alaska, he was extradited to face charges in Louisiana. As a result of corroborating evidence recovered in the Alaska investigation, Salard was convicted of child rape and sentenced to life in prison.

9. *United States v. Torlai*, No. 2:08-cr-00329-JAM (E.D. Cal.) (Mendez, J.), Dkt. No. 128 (judgment). Representation: 2009 – 2011.

I was the lead prosecutor in the investigation and prosecution of a California farmer who filed multiple fraudulent crop insurance claims on property he owned in Central and Northern California. Between 2000 and 2005, Torlai filed claims for crop insurance benefits totaling approximately \$340,000 and made false statements about the extent of

his ownership interest in various farming operations and the types and number of crops planted. In support of his false claims, Torlai submitted falsified seed receipts in support of his insurance claims. During an 11-day trial, my co-counsel and I called more than a dozen witnesses, including an expert witness who used satellite data to rebut Torlai's claims. The jury found Torlai guilty. The court sentenced Torlai to 30 months' imprisonment and imposed a \$10,000 fine.

10. *United States v. Sekhon*, No. 2:06-cr-00058-FCD (E.D. Cal.) (Damrell, J.), Dkt. Nos. 618 (Jagprit Sekhon judgment), 492 (Jagdip Sekhon judgment), 600 (Rai judgment), 608 (Caza judgment), and 430 (Harmath judgment). Representation: 2009 – 2010.

This case involved the investigation and prosecution of a Sacramento-area law firm that engaged in a long-running scheme to defraud the United States Citizenship and Immigration Service by filing hundreds of false asylum claims in the early 2000s. The evidence at trial showed that Defendants, three lawyers (Jagprit and Jagdip Sekhon, and Rai) and two investigators (Caza and Harmath), filed asylum applications with fictitious stories of persecution that their clients had supposedly suffered in their home countries. These applications were often supported by doctor's letters, medical certificates, affidavits, and other documents that were fraudulent or counterfeited. After filing claims, the lawyers or investigators conducted preparation sessions with their clients to familiarize them with the false claims of persecution and coach them on how to answer questions during their asylum interviews. I joined the prosecution team after indictment and served as the third member of the trial team. The trial lasted three and a half months and involved testimony from dozens of witnesses, including seven former clients of the law firm. The court sentenced Jagprit Sekhon to 108 months' imprisonment, Jagdip Sekhon to 60 months' imprisonment, Rai to 30 months' imprisonment, Caza to 90 months' imprisonment, and Harmath to four months' imprisonment.

My role in this program involved communicating with Assistant District Attorneys for the State of Alaska assigned to prosecute child exploitation cases and identifying those cases that might qualify for federal prosecution. In

addition, I delivered training to rural law enforcement and social service providers on the identification and investigation of online child exploitation.

I have not performed lobbying activities for any clients or organizations.

I will continue to maintain and update my conflict lists and abide by the conflict rules found at 28 U.S.C. § 455; Canon 3 of the Code of Conduct for United States Judges; and all other laws, rules, and practices governing such circumstances.

I spent the majority of my time as a prosecutor handling cases involving the exploitation of minors and vulnerable individuals, working to keep communities safe and bring justice to victims of violent crime.

As I advanced within the Department of Justice, I mentored younger attorneys and was selected as the Senior Litigation Counsel for the United States Attorney's Office for the District of Alaska. In this capacity, I trained new prosecutors and advised on all criminal trials. I also volunteered as faculty at the Department's National Advocacy Center.

During my final three years as a prosecutor, I led efforts to combat violent crime and child exploitation in rural Alaska's most disadvantaged communities. Working closely with law enforcement and community leaders, we built cases that secured multiple convictions and protected vulnerable victims.

Since joining the bench, I have established and expanded the United States District Court for the

District of Alaska's civics education program. Through high school outreach, we bring students from all backgrounds into the courthouse to learn about the Constitution, federal law, and judicial careers. I also visit individual classrooms to teach civics directly to students.

Locally, I have served as a volunteer youth sports coach for several YMCA leagues and actively support my children's schools through classroom volunteering and the PTA to provide vital student enrichment programs.

I have received periodic updates from both Senators' offices about the status of my applications.

On June 5, 2025, I interviewed with attorneys from the White House Counsel's Office at the Eisenhower Building in Washington, D.C. Since July 15, 2026, I have been in contact with officials from both the White House Counsel's Office and the Office of Legal Policy at the Department of Justice in preparation for a nomination.

On August 18, 2026, President Trump called me to inform me that he planned on nominating me for a position on the United States District Court for the District of Alaska.
