Since 1987, my law practice has focused exclusively on international trade and investment agreements.

From 1987 to 1989, my law practice comprised providing counsel on the administration of the statutes within the jurisdiction of the United States International Trade Commission and defending Commission decisions before the United States Court of International Trade.

From 1989 to 1993, and since 2009, my law practice has largely comprised litigating disputes before tribunals formed under international trade agreements and negotiating international trade agreements.
