In general terms, I am a commercial litigator with more than 30 years of experience in federal and state courts, in arbitrations, and in administrative adjudications. I have been involved in hundreds of cases, trying 31 of them to final resolution (almost always as lead trial counsel) and arguing nearly 20 appeals, mostly in federal appellate courts.

I did appellate work (1987 - 1989) as an attorney on the appellate staff of the Civil Division in the United States Department of Justice. In my time at the Department of Justice I briefed two dozen cases and argued 14 of them, in seven different federal appellate circuits.

In private practice (1989 – present), I have been actively engaged in commercial litigation, in federal and state courts, in arbitrations, and in administrative proceedings. My time in private practice has been spent at two law firms, Kirkland & Ellis (1989 – 2009) and Jenner & Block (2009 – present). The majority of my work has been at the trial level, with a continuing appellate practice, sometimes as my cases have transitioned beyond trial. My role as a lawyer in private practice has gradually shifted over the years: starting as a mid-level associate (1989 – 1991) doing research and writing and taking depositions; progressing to a more senior associate (1991 – 1993) and junior partner (1993 – 1997) I was running

and managing cases; and maturing to a senior partner (1997 – present) I have been leading litigation teams and trying cases. For the past several years (2009 – present), I have been busy building a West Coast practice for my current law firm, Jenner & Block. I started Jenner & Block's Los Angeles office with one younger partner in 2009 and continued to build and manage its growth for the next decade.

In addition to my commercial litigation practice, I have tried a number of criminal cases and handled several pro bono matters.

I was lead trial counsel in this four-week jury trial. On a pro bono basis I represented Dietrich Canterberry, who was charged with murder. Our client was raised in South Central Los Angeles and graduated from the University of Nevada at Las Vegas, where he was the captain of the football team. He was involved in a street fight outside of a Hollywood nightclub, where he collided with the decedent as the decedent was running towards him after being punched and kicked by another man. The decedent fell to the ground after the collision, never regained consciousness, and passed away within an hour.

The prosecution pursued a charge of first degree murder (25 years to life).
