In 2009, I was elected to be the commission chair and served in that capacity until my term ended in 2012. As chair, I act in a judicial capacity, conducting contested evidentiary hearings with witnesses and exhibits. I ruled on objections, received evidence and drafted findings and conclusions, and recommendations to implement the commission's decisions.

From 2006 to 2007, I acted as lead counsel representing Washington Mutual Bank in this receivership action in federal district court. An individual named Mr. Stevens had committed fraud on several lenders by forging releases of trust deeds from property he owned so that he could obtain multiple loans secured by the properties. Mr. Stevens owed Washington Mutual approximately \$1.5 million, secured by a first-position trust deed that had purportedly been released by a forged reconveyance. The receiver pressed for a sale of the property free and clear of liens, with liens attaching to the proceeds. The receiver also argued that the proceeds of the sale should be distributed pro rata to all creditors, rather than to Washington Mutual as the first-position lien holder. We filed a motion for summary judgment, which I argued to Judge Dee V. Benson. The court referred the case to a Special Master, Michael Zimmerman, to consider whether an equitable pro rata distribution should be made. After an evidentiary hearing, he made a report and recommendation that the proceeds should go to Washington Mutual, which Judge Benson adopted. There was no appeal. I handled all hearings, argued motions, presented evidence to the Special Master at the hearing, conducted discovery and assisted in drafting motions and memoranda.

5. *Risinger v. Midtown Joint Venture, LC*, Case No. 20100533 (Fourth Dist. Ct. for Utah Cty.) (Judge Samuel McVey).

From 2008 to 2012, I was lead counsel for defendant Bank First and successor entities in a consolidated mechanic's lien foreclosure action. The case arose out of the failure of a \$90 million mixed-use real estate development in Orem, Utah. This case is significant for its sheer size and complexity. Bank First, as lead lender, made an \$80 million development and construction loan to Midtown Joint

Venture, LC (Midtown). A large number of lending institutions were loan participants with interests in the loan. The loan was intended to be sufficient to complete construction and to be secured by a first lien position trust deed encumbering the project. After a major downturn in the economy, construction cost over-runs and other problems, the loan went into default, construction was far from complete, and the contractors and suppliers claimed to be owed in excess of \$30 million. The contractors and suppliers filed mechanic's lien claims against the project and filed foreclosure actions asserting that the liens had priority over Bank First's trust deed. We conducted discovery and numerous depositions and filed a motion for summary judgment on the priority issue. Judge Samuel McVey determined that the mechanic's liens had priority because some work had commenced before Bank First's trust deed was recorded. We filed a motion for interlocutory appeal on the priority issue, which was denied by the Utah Court of appeals. After substantial investigation and work with expert witnesses, we postured the case for mediation. We held a mediation with dozens of attorneys and clients. After two days of mediation, we were unsuccessful at resolving the entire case, but we reached a partial settlement that ultimately enabled the settlement of the claims against our client.

6. *Utah School & Institutional Trust Land Administration v. Mathis*, Case No. 050700196PR, 2007 WL 7266357 (Seventh Dist. Ct. for Carbon Cty.) (Judge Douglas B. Thomas), *aff'd*, 223 P.3d 1119 (Utah 2009).

From 2007 to 2009, I defended the Mathis family in a lawsuit brought by the State of Utah School & Institutional Trust Lands Administration (SITLA). SITLA claimed that it was the owner of a 640-acre tract of land located in Carbon County, Utah. The parcel was originally a school trust lands section transferred by the United States to the State of Utah upon statehood by Utah's Enabling Act. The State sold the tract and issued a patent to a buyer in 1912. Carbon County subsequently sold the property at a 1932 tax sale to R. Mathis for back taxes. The Mathis family farmed the property for more than 60 years. In 1998, the Mathis family entered into a coal lease with Andalex Resources, which began extracting coal from a deep mine. As soon as royalties became payable under the coal lease, SITLA asserted that it actually owned the property and was entitled to the royalties. SITLA's claim was based on the 1918 U.S. Supreme Court decision in *United States v. Sweet*, which held that Utah's Enabling Act did not pass title to lands of known mineral character. Congress, however, passed the Jones Act in 1927 to resolve the confusion engendered by the 1918 Supreme Court decision on title to school trust land parcels that had been previously conveyed. We filed a summary judgment motion in the trial court, which I argued to Judge Douglas B. Thomas. Judge Thomas granted the motion based on a statute of limitations defense and based on the Jones Act. I assisted in drafting the appeal brief and

argued the appeal to the Utah Supreme Court. The trial court summary judgment was affirmed, resulting in some \$6 million in royalties being disbursed by Andalex Resources to the Mathis family.

7. *Haik v. Sandy City*, Case No. 20090451 (Third Dist. Ct. for Salt Lake Cty.) (Judge Sandra Pueller), *aff'd*, 254 P.3d 171 (Utah 2011).

From 2009 to 2011, I represented plaintiff Mr. Haik and several other individuals in an action to resolve ownership of valuable water rights. The plaintiffs owned property in Little Cottonwood Canyon in Salt Lake County, Utah. To provide water to their properties so the properties could be developed, the plaintiffs purchased high priority water rights at the mouth of the canyon with the goal of moving the use of the water to their properties high in the canyon. Sandy City opposed a change application pursued by plaintiffs and in doing research discovered a 1977 unrecorded deed to the water from a prior owner naming Sandy City as grantee. Sandy City recorded the deed in 2004, a year after the plaintiffs' deed to the same water right had been recorded. The case presented unique water law issues under Utah's Recording Act. I took several depositions and conducted discovery to determine the history of the water rights and prior conveyances. Sandy City attempted to derail the case by seeking to have the Haik parties joined in a water adjudication involving a much larger geographic area. We successfully resisted a motion to dismiss the case pending the larger adjudication and filed a motion for summary judgment. I argued the summary judgment motion before Judge Sandra Pueller. Judge Pueller granted summary judgment and Sandy City appealed. I assisted in drafting the appeal brief and argued the case to the Utah Supreme Court, which affirmed the trial court's decision.

8. *Western Slope Holdings v. Persimmon Investments*, Case No. 100900696
(Third Dist. Ct. for Salt Lake Cty.) (Judge Joseph C. Fratto).

I was retained in 2011 by First American Title Insurance Company to represent plaintiff Western Slope Holdings in a lawsuit challenging the priority of a trust deed claimed by defendant Persimmon Investments. This case was significant as a test case for numerous lawsuits we were defending where Persimmon and others had made similar claims. Western Slope purchased a parcel of property after a foreclosure sale of a lender's trust deed that appeared to have been foreclosed in first position, wiping out a junior trust deed. Persimmon, however, claimed that the trust deed it had acquired was a prior interest based on the purchase money mortgage doctrine. This doctrine provides that a seller's purchase money mortgage will have priority over a third-party lender's mortgage in the same transaction regardless of the order in which the documents are recorded. The doctrine does not apply, however, where the purchase money lender agrees to a junior priority. Persimmon had acquired trust deeds on several properties claiming they were purchase money mortgages in an effort to force title insurance companies to respond to claims. We conducted discovery, including depositions, and filed a motion for summary judgment. Judge Joseph C. Fratto denied summary judgment, concluding that there were issues of fact regarding whether Persimmon's trust deed qualified as a purchase money mortgage or whether there was an agreement that the trust deed would be junior in priority to a lender's trust deed recorded in the same transaction. I conducted the trial, examined all of the witnesses and made the opening and closing arguments. Judge Fratto found in favor of my client Western Slope and awarded our attorney fees and costs. No appeal was taken.

9. *MKA Finance, Ltd. v. Clingo*, Case No. 090500522 (Dist. Ct. for Wasatch Cty.) (Judge Derek P. Pullan).

From 2009 to 2012, I represented defendant Mr. Clingo in an action filed by plaintiff MKA Finance, Ltd. concerning the ownership of 245.9 shares of water stock in the Spring Creek Irrigation Ditch Company. The case presented complex and unique issues under Utah water law. Mr. Clingo purchased the water stock for several hundred thousand dollars and took possession of the stock certificates (as stock certificates are treated as personal property under the Utah Uniform Commercial Code). MKA asserted that the stock was not personal property, but was real property appurtenant to a parcel of property on which it had foreclosed a trust deed. MKA claimed ownership of the water stock by reason of the foreclosure. I conducted several depositions, including the depositions of expert witnesses, prior owners and water company officials. I also argued a motion for summary judgment. The trial court concluded that there were issues of fact so we tried the case. I was lead counsel at the five-day trial. After trial, the trial court ruled in favor of my client, concluding that the water stock was personal, rather than real property, that MKA failed to perfect its security interest in the stock by not taking possession, and that Mr. Clingo was a bona fide purchaser of the stock without notice of MKA's claimed interest. No appeal was taken.

10. *Stenquist v. Harbor View, LLC*, Case No. 120100556 (First Dist. Ct. for Cache Cty.) (Judge Brian Cannell), *appeal pending*, Case No. 20150505 (Utah Ct. App.).

In April 2015, I tried this case before Judge Brian Cannell. My clients Mr. and Mrs. Stenquist made a \$300,000 loan to development company Harbor View, Ltd. Harbor View claimed that it needed the loan as seed money for financing it was seeking to develop a golf course community. Harbor View's principal convinced a property owner, whose property was to become part of the development, to pledge his property as security for the Stenquists' loan. The development failed, Harbor View defaulted on the loan, and the property owner claimed that he had been defrauded. I filed the case as a judicial foreclosure. The defendants counterclaimed, asserting that they had not actually signed the Stenquists' note, that the note was unenforceable and that they were entitled to recover for fraud and misrepresentation. We were able to resolve part of the case in summary judgment, but the court concluded there were fact issues regarding the validity of the transaction documents and the counterclaim for fraud and misrepresentation. After a two-day trial, the court ruled in my clients' favor. The court entered a judgment and decree of foreclosure in the full amount owed and dismissed the counterclaims. I took depositions, conducted discovery, argued summary judgment motions and tried the case. One of the defendants has appealed and the case is pending in the Utah Court of Appeals.

I would also recuse myself from any matters in which Parr Brown Gee & Loveless represents a party until such matters are resolved and an appropriate period of time has passed. I would also recuse myself from matters involving former clients until an appropriate time has passed.

- b. Explain how you will resolve any potential conflict of interest, including the procedure you will follow in determining these areas of concern.

If confirmed, I would carefully follow 28 U.S.C. 455 and Canon 3 of the Code of Conduct for United States Judges. I would also promptly review the parties, their affiliates, and the issues in all matters assigned to me so I could make a prompt and informed decision about the need for recusal.

25. **Pro Bono Work:** An ethical consideration under Canon 2 of the American Bar Association's Code of Professional Responsibility calls for "every lawyer, regardless of

During my private practice, I have devoted my time to several pro bono divorce and landlord-tenant cases and a few minor criminal cases. I have also supported Utah Legal Services, Disability Law Center and the Legal Aid Society of Salt Lake, agencies that serve the disadvantaged, through financial contributions through the “And Justice for All” foundation. I have participated as a volunteer at the “Tuesday Night Bar” program sponsored by the Utah State Bar Association, providing free legal advice and assistance to individuals.

As chair of my firm’s marketing and planning committee, I led a change from the firm’s traditional purchase of holiday gifts for clients to instead use the funds to make an annual contribution to the Utah Food Bank. I have also volunteered to package the food purchased with the firm’s contribution for delivery to needy families and in preparing and serving meals at a homeless shelter.

From 2000 to 2005, I served on the Board of Trustees for the Salt Lake Family Support Center, which provides assistance to families and children in distress by operating two crisis nurseries for children in peril, a residential village for low-income single mothers, and providing counseling services and job-training for low income and disadvantaged families. As the attorney on the Board, I regularly provided pro bono legal representation to the organization.

During my years in public service, I actively supported the Drug Abuse Resistance Education (DARE) program, by speaking regularly in elementary school assemblies and classes.

I also serve as chair of the Board of Trustees of CenterPoint Legacy Theatre. As Mayor of Centerville, I put together a partnership between two cities and a county to finance and construct the theater building, which was completed in 2011. In addition to a full season of community theater, CenterPoint sponsors a youth theater program and programs for children with disabilities.

On October 7, 2015, I received an email from the White House Counsel's office indicating that my name had been submitted for consideration. I spoke with officials from the Office of White House Counsel on October 8, 2015. I received a phone call from Senator Mike Lee on October 12, 2015 in which he indicated that he and Senator Hatch had submitted my name to the White House for consideration. Since October 12, 2015, I have been in contact with officials from the Office of Legal Policy at the Department of Justice. On December 1, 2015, I interviewed with attorneys from the White House Counsel's Office and the Department of Justice in Washington, D.C. On December 16, 2015, the President submitted my nomination to the Senate.
