Injured parties moved in their tort suit against an insured to disqualify the insured's counsel on the ground that his status as an in-house attorney employed by the insured's liability insurer meant that the insurer was engaging in the unauthorized practice of law. Another liability insurer moved to intervene, claiming an interest in the disqualification motion based on its practice of providing counsel for its insureds through a "captive" law firm. The trial court granted both motions, and a petition for emergency transfer to the Indiana Supreme Court was granted. The Court vacated the trial court's order, holding that: (1) a liability insurer does not necessarily engage in the unauthorized practice of law by using an in-house attorney to represent an insured; (2) such an arrangement also does not create an inherent conflict of interest; and (3) the name used by the intervening insurer's captive law firm was misleading.

3. Continental Basketball Ass'n v. Ellenstein Enters, 669 N.E.2d 134 (Ind. 1996).

Members of a Continental Basketball Association ("CBA") team sought an injunction against their team owner and the CBA to prevent them from excluding the team from the postseason playoffs. Litigation between the team owner, Ellenstein, and the CBA ensued – with the CBA seeking to enforce a franchise agreement with Ellenstein, and Ellenstein seeking damages from the CBA under the Indiana Franchise Disclosure Act and Indiana Deceptive Franchise Practices Act. The trial court ruled that Ellenstein's purchase of the team was subject to Indiana's Franchise Acts, and because the CBA had not complied with the Franchises Acts, the CBA could not enforce the franchise agreement. The CBA took an interlocutory appeal to the Court of Appeals, which affirmed. On transfer, the Indiana Supreme Court adopted the Court of Appeals' opinion finding that the contract between the CBA and Ellenstein was subject to the Franchise Acts, but held that Ellenstein's claims were contrary to law, and the contract between the CBA and Ellenstein was not void as against public policy.

A college student who was sexually assaulted by an alumni member of a local chapter of a national fraternity during a party at the chapter sued the chapter and the fraternity, among others, alleging negligence and Dram Shop violations. The trial court denied the defendants' motions for summary judgment, and they appealed. The Court of Appeals reversed. The Indiana Supreme Court granted defendants' petition for transfer, and held that: (1) the totality of the circumstances test determines whether a landowner has a duty of care to protect an invitee from a third party's criminal act; (2) the chapter, as landowner, owed such a duty to the student as invitee; (3) the chapter was not liable under the Dram Shop Act; and (4) the fraternity did not gratuitously or voluntarily assume a duty of care toward the student. The Court affirmed in part, reversed in part, and remanded.

6. Erie Ins. Co. v. George, 681 N.E.2d 183 (Ind. 1997).

An automobile insurer, which was subrogated to the insured's claim against a tortfeasor by reason of its payment of the insured's medical payments, brought a separate suit against the tortfeasor without notice to the insured and before resolution of the insured's suit. The trial court allowed the insured to intervene, permitted the tortfeasor's insurer to interplead for medical expenses, held that the insurer could not sue the tortfeasor in its own name until resolution of the insured's claim, and permitted the insured's attorney to seek fees. The Court of Appeals reversed, holding that a subrogated insurer was entitled to initiate its own action. On transfer, the Indiana Supreme Court remanded, holding that: (1) on issue of first impression, an insurer, as subrogee of some but not all of its insured's personal injury claims, could not sue independently to enforce a personal injury claim arising out of subrogation prior to resolution of its insured's attorney's role in obtaining recovery precluded determination of the attorney's entitlement to fees.

A high school student athlete sued the Indiana High School Athletic Association ("IHSAA"), seeking to enjoin enforcement of IHSAA's rules against him or his school. The trial court granted the injunction and the Court of Appeals affirmed. The Indiana Supreme Court granted transfer and reversed. Among other things, the Court recognized that Indiana common law provided for judicial oversight of

the IHSAA's decisions; that the common law would treat the IHSAA as a private membership organization for purposes of enforcement actions brought by member schools, but as a government agency for purposes of enforcement actions brought by students and other non-IHSAA members; and that there is no constitutional right or interest to participate in interscholastic sports that is protected by the state or federal constitutions.

A restaurant operator brought a defamation suit against the local newspaper, following the restaurant's closing, when a newspaper sub-headline inaccurately reported that a health inspector had found rats at the restaurant. The trial court granted summary judgment in favor of the newspaper, which was reversed by the Court of Appeals. The trial court later entered judgment on a jury verdict in favor of the restaurant operator. The newspaper appealed, and the Court of Appeals again reversed. On transfer, the Indiana Supreme Court affirmed the Court of Appeals, but wrote to clarify that the actual malice standard of proof required in defamation cases involving matters of public or general concern applies not only to public figures, but to private individuals as well – and in this case, the restaurant operator failed to prove actual malice.

A patient brought a medical malpractice claim against her physician for his alleged failure to diagnose and treat her breast cancer in a timely manner. The cancer had a substantial latency period, which prevented the patient from discovering the doctor's alleged malpractice within the two-year statute of limitations. The Indiana Supreme Court found that the medical malpractice statute of limitations was unconstitutional as applied to the plaintiff because it was not uniformly applicable to all medical malpractice victims and required plaintiff to file a claim before she was able to discover the alleged malpractice and her resulting injury, and therefore, imposed an impossible condition on her access to the courts and pursuit of her tort remedy.

The Tax Court determined that the "true tax value" system violated the uniformity provision of the state constitution, and ordered the State Board of Tax Commissioners to consider all competent, real-world evidence of valuation presented by persons filing property tax appeals on or after May 11, 1999. The Board appealed. The Indiana Supreme Court held that: (1) the statute governing the valuation of real property for tax assessment purposes was not unconstitutional; (2) cost schedules for valuing property lacked a meaningful reference to property wealth, and, therefore, violated the state constitution; and (3) the Board was not required to consider all competent evidence of property's wealth in individual tax appeals. I have conducted a number of mediations in health care matters as well as several arbitrations in commercial disputes and complex health care insurance matters. As the Director of State Health Policy from 1993 to 1994, I provided counsel to the Governor on health care policy on both state and federal issues and concerns.

As an Associate Justice on the Indiana Supreme Court 1995 to 1999, I presided over all cases coming before the Court. The Supreme Court is the highest court in the state and is a court of appellate jurisdiction.

As a partner at Ice Miller, LLP from 2000 to the present, my focus has changed somewhat. The question in this medical malpractice action was whether or not plaintiffs in a wrongful death action could pursue the claims as individuals, without having been appointed as personal representatives. The trial court denied defendant health care providers' motion for summary judgment, and that denial was appealed. The Court of Appeals reversed the denial of summary judgment, holding that the "parties eligible" requirement of the Indiana Wrongful Death Act applied in cases in which the alleged cause of death is medical malpractice. Although the decision was consistent with prior case law, it served to clarify the state of the law and the requirements for bringing a wrongful death action. I represented the defendant/appellant health care providers at both the trial and appellate level. I served as lead counsel at trial and was responsible for drafting major motions and briefs at both levels of courts. After the case was remanded back to the trial court, the parties settled.

2. GPH v. Giles, M.D., 578 N.E.2d 729 (Ind. Ct. App. 1991).

The patient appealed from an order of involuntary commitment based on a diagnosis of chronic paranoid schizophrenia and upon a finding that he was dangerous to himself and

others. The patient had been represented, over objection, by a court-appointed public defender. The patient appealed the commitment order, claiming that there was insufficient evidence to support his commitment, and that his right to assistance of counsel had been violated. The Court of Appeals affirmed the trial court's commitment order, holding that there was substantial evidence to support the commitment and that the patient's right of assistance of counsel was not violated. 3. Islami, M.D. v. Covenant Med. Ctr., Inc., 822 F. Supp. 1361 (N.D. Iowa 1992).

This case was an early test of the applicability of the immunity afforded under the Health Care Quality Improvement Act. A hospital suspended a cardiovascular and thoracic surgeon's medical staff privileges due to substandard patient care based on a chart review and analysis of his patient care. The physician sued on grounds of breach of contract, intentional interference with business relationship, intentional infliction of emotional distress and federal antitrust violations. The parties filed cross-motions for summary judgment. Plaintiff's motion was denied, and defendants' motion was granted in part and denied in part. 4. Kiracofe v. Reid Mem'l Hosp., 461 N.E.2d 1134 (Ind. Ct. App. 1984).

5. Liberty Landowners Ass'n, Inc. v. Porter County Comm'rs, 913 N.E.2d 1245 (Ind. Ct. App. 2010).

6. Menorah Med. Ctr. v. Heckler, 768 F.2d 292 (8th Cir. 1985).

This was a Medicare group appeal brought by several hospitals, challenging the validity of the Medicare rule requiring calculation of reimbursement for malpractice insurance premiums. This case was one of several similar appeals challenging the malpractice rule across several federal circuits. 7. Parkview Hosp., Inc. v. Debra Minott, Sec'y of Fam. and Soc. Servs. Agency, and the Methodist Hosps., Cause No. 02D01-1212-PL-443, 36 N.E.3d 1185 (Ind. Ct. App. 2015).

This case involved a hospital's challenge to a determination by the state Medicaid agency that the hospital was not eligible for a disproportionate share Medicaid reimbursement of over \$40 million. The administrative law judge denied the hospital's challenge on the grounds that the hospital did not properly submit all of the appropriate data. The hospital sought judicial review of the agency denial. The trial court affirmed the agency and held that the agency's decision was consistent with the Administrative Orders and Procedures Act. On judicial review, the trial court decided that while the Medicaid agency had violated federal Medicaid law in adopting and implementing certain procedures, such violation was not fatal to the state's disproportionate share formula. I served as lead counsel from the administrative law hearing through the judicial review in the trial court and on appeal to the Indiana Court of Appeals. In addition to leading the litigation team, an important aspect of my role was client counseling, as there was not a substantial likelihood of success and so there was a critical need to manage expectations. 8. St. Joseph's Hosp. of Kansas City v. Heckler, 786 F.2d 848 (8th Cir. 1986).

The case was filed as a group appeal by hospitals seeking to challenge the Medicare payment decision by the fiscal intermediary. The hospitals sought review by the Provider Reimbursement Review Board (PRRB) under a regulation authorizing extension of 180 days' time to file for good cause shown. The district court affirmed the PRRB's refusal to hear the case and concluded it had no jurisdiction to hear the case, as there was no final PRRB decision. The Eighth Circuit affirmed, concluding that the filing time period was a jurisdictional pre-requisite and, because the court lacked the authority to hear the case, there was no judicially-reviewable final decision. I was lead counsel in this Medicare group appeal, which was one of a handful of cases moving through the appeals process. 9. State of Indiana v. Cacdac, M.D., Cause No. 85 MLB 0030 (1988).

The Indiana Attorney General brought this action against the medical license of a board-certified Filipino neurosurgeon in Terre Haute, Indiana. The case was tried through final order before the Indiana Medical Licensing Board. The State's case consisted of over 32 individual patients and related surgical procedures, counseling, and care. The central theory of the State's case was that Dr. Cacdac's approach to certain neurosurgical procedures and surgeries was substantially different from what was considered standard in the profession. What began as a fairly straightforward unnecessary surgery case quickly turned into a multi-layered litigation involving many first impression issues concerning medical standard of care as well as due process and fairness issues across multiple tribunals. What was exposed through the hundreds of pages and several days of medical evidence, expert witness opinion evidence, and the like was nothing more than the difference in training as between different medical residency programs. However, the State's case advanced to the point of a full 15-day trial before the administrative law judge. I was second chair at trial and handled the direct and crossexamination of several witnesses and our expert. The administrative law judge ruled in Dr. Cacdac's favor and against the State of Indiana on all counts, and the Board affirmed and in a final order removed all restrictions on licensure.

I was appointed to chair the Indiana Supreme Court Commission on Race and Gender Fairness when it was established by the court in 2000. I continue to serve as the chair of this Commission today. The Commission was created to study and address race and gender fairness in Indiana's courts and legal system. The Commission's recommendations to the court have included: education and training of judges and lawyers to address perceptions of unfairness; programs to reduce barriers to full participation in the legal system; and coordination across judicial and legal organizations and entities to expand and enrich data and share best practices. The Commission's work has included broad-based implementation of these recommendations resulting in, among other things, an establishment of a statewide certified court interpreter program; a state-wide Legal Professions Diversity Summit; and a study on women in law, examining the issue of gender within the legal profession in Indiana. The work of the Commission continues in these areas as well as in the criminal and juvenile justice areas.

Ice Miller is a member of the United States Law Firm Group ("USLFG"), a network of 18 law firms from across the nation. Each firm has a substantial market presence in its headquarters city, and the firms meet through committees to share information about various legal developments as well as current topics relating to law firm management. I am the chair of the USLFG Diversity Committee, which consists of partners from each member firm and works to share best practices in law firm diversity and lawyer professional development.

I have not performed lobbying activities for any client or organization.

This course examined the Medicare and Medicaid systems and the regulation of health care providers participating in those programs. The course also provided an overview of the Medicare, Medicaid, and State Children's Health Insurance Program, as well as the administrative law framework for governmental decisions. No syllabus available.

In Fall 2011 and Spring 2012, I taught Food and Drug Law at the Indiana University Robert H. McKinney School of Law. This course surveyed statutes and regulations dealing with the production, distribution, and sale of food, drugs, cosmetics, and medical devices. The course focused primarily on administrative and procedural requirements of the Food, Drug and Cosmetic Act. Representative syllabus supplied.
