I was appointed to the Colorado Supreme Court in 2006 by Governor Bill Owens. Pursuant to the Colorado Constitution, a justice's initial appointment to the court is for two years. A justice who wishes to continue to serve on the court must stand for a retention election. All subsequent terms are for 10 years. My retention election occurred November 4, 2008. The results were 1,338,571 votes in favor of retention, 456,337 votes against retention. My current term began January 13, 2009 and expires January 8, 2019.

The Colorado Supreme Court is Colorado's court of last resort. The court has discretionary jurisdiction of cases from the Colorado Court of Appeals. The court also has direct appellate jurisdiction over cases in which a statute has been held to be unconstitutional, cases involving decisions of the Colorado Public Utilities Commission, writs of *habeas corpus*, cases involving adjudication of water rights, summary proceedings initiated under the Colorado Election Code, and prosecutorial appeals concerning search and seizure questions in pending criminal proceedings. All of these appeals are filed directly with the court, and, in these cases bypass the Colorado Court of Appeals. The court also has exclusive jurisdiction to promulgate rules governing practice and procedure in civil and criminal actions.

Because I have not been a trial judge or Chief Justice of the Colorado Supreme Court, I have not presided over any cases. As a justice on the Colorado Supreme Court I have participated in the disposition of more than 900 cases where the court has granted a petition for a writ of certiorari.

The Supreme Court reversed and held that the Act violated due process.

My judicial assistant, with assistance from other Court staff, screens for cases from which I am generally recused. The criteria for such recusals include cases involving the Colorado State Personnel Board during the time my husband served as director and cases where my husband’s law firm, Greenberg Traurig, is counsel to one of the parties. If such a case is identified, I take no part in that case (including the decision whether to grant certiorari).

After the initial screening, I personally review each case to ensure that I do not have an actual or apparent conflict of interest. As a result of this review I have recused myself *sua sponte* because of personal reasons, for example, when my daughter had surgery at a party hospital. I then take no part in that case.

I do not recall ever being asked that I recuse from a case.

When I first joined the Colorado Supreme Court in 2006, I recused myself for one year from all cases pending in the Colorado Attorney General’s Office while I was Solicitor General. During that period, for each case, my judicial assistant, with assistance from other Court staff, determined whether the case had been pending at the Attorney General’s Office. If it was, I was automatically recused from the case. After a year, I continued to recuse myself from any case in which I was personally involved as Solicitor General.
