This was a hate crime prosecution under 18 U.S.C. § 245. The proof showed that the defendant murdered an African-American Code Enforcement Officer, Mr. Wright, in 2001. Officer Wright wrote the defendant a warning citation for code violations at his car lot. The defendant became enraged and shot and killed Officer Wright and then took the corpse to a farm in rural Mississippi, where he dismembered and cremated Officer Wright's remains.

The murder remained unsolved for several years until investigators were able to identify the defendant as Mr. Wright's killer. State prosecutors had an extraordinarily weak case due to the lack of physical evidence and no eyewitnesses to the murder, and therefore allowed the defendant to plead nolo contendere to second-degree murder with an agreed-upon, 15-year sentence. Federal prosecutors from my office and law enforcement authorities explored the possibility of filing federal civil rights charges against the defendant. In 2008, the defendant was charged in a two-count federal indictment for the racially-motivated killing of Officer Wright.

I became involved with the prosecution and trial of this case in October 2010 and was personally involved with all aspects of trial preparation and

litigation strategy. The defendant pled guilty on the morning of trial. While preparing witnesses for the sentencing hearing, the prosecution team discovered that the defendant had committed another murder in 1998 on the same car lot as Mr. Wright's murder. I, along with the other two Assistant United States Attorneys on the case, confronted the defendant in prison and secured a confession of this newfound murder. The defendant admitted that he beat the victim to death with a hammer in a dispute over money. In July 2011, our trial team was able to secure a federal life sentence against the defendant and a concurrent life sentence in state court for the second murder.

This matter involved the murder of two postal workers at a rural U.S. Post Office in Henning, Tennessee. During a robbery, the defendant murdered one of the clerks, and his 18-year old son killed the second clerk. The defendant and his son then embarked on a several-month-long crime spree, which included bank robberies and carjackings. The spree ended on February 14, 2011, when, on their way to commit another armed bank robbery in western Tennessee, the son was killed in a shoot-out with police and the defendant was apprehended.

I was involved with every phase of this case, which required the issuing of over 350 grand jury subpoenas, interviewing over 250 witnesses, search warrants, court orders for telephone records and other evidence, and grand jury testimony from numerous witnesses. Because the case involved five different crime scenes, crimes in two districts, hundreds of pieces of evidence, and dozens of forensics reports, preparation of discovery was complex. Also, the case was not solved for four months, which resulted in hundreds of tips and possible leads, *Brady* review and substantial production.

The most difficult challenge our trial team faced was the defendant's claim that he was intellectually disabled and therefore not eligible for the death penalty pursuant to *Atkins v. Virginia*, 536 U.S. 304 (2002). The defense also used this issue as a basis to challenge the validity of the defendant's confession. My colleagues and I successfully disproved this claim at a five-week *Atkins* hearing, with 500 exhibits and five highly-credentialed experts. The hearing resulted in a 263-page order conclusively rejecting the defendant's claim. After a separate week-long suppression hearing, the court also rejected the defendant's claim that his confession should be suppressed and issued a 200-page opinion.

Two weeks prior to trial, the defendant pled guilty to the seven-count indictment. He was sentenced to consecutive life sentences without the possibility of parole.

As United States Attorney, I formed a dedicated Civil Rights Unit which has been highly successful in prosecuting public corruption, color of law, hate crimes, fair housing, damage to religious property and other civil rights related cases. The unit has also been a leader and nationally recognized in the area of sex trafficking prosecutions. The Western District of Tennessee was one of the first districts to be chosen as a Phase I Pilot District for the Anti-Trafficking Coordination Team (ACTeam) program, in which the United States Attorney's Office works in conjunction with the Civil Rights Division of the Department of Justice, Immigration and Customs Enforcement, the Federal Bureau of Investigation and the Department of Labor to identify, investigate, and prosecute human trafficking crimes.

In an effort to address the significant uptick in gang activity and associated violent crime within the District, particularly in Memphis and Shelby County, Tennessee, I worked closely with law enforcement officials to form a Multi-Agency Gang Unit in 2012. Working collaboratively across federal, state and local law enforcement lines, the Multi-Agency Gang Unit has been very successful in reducing violent crimes and gang activity throughout some of the worst neighborhoods in Memphis and Shelby County. The unit also frequently engages the community through outreach forums and implements prevention strategies, targeting middle-school students, on a frequent basis.

As United States Attorney, I have placed a significant interest in community outreach and emphasized to the staff, particularly Assistant United States Attorneys, the importance of engaging the community. I take as many opportunities as possible to speak to law enforcement personnel, community leaders, members of the religious and non-profit communities, students and even inmates – through our reentry and drug court programs. I use these opportunities to share the priorities of my office and to listen to and address concerns from a broad segment of members of the community.

While Assistant City Attorney, I was co-lead counsel for the City of Memphis on a team assembled by the City Attorney and City Director of Finance to bid and ultimately negotiate the full outsourcing of the City's entire information technology services for the first time. I am the immediate past Chairman of two highly productive and life changing non-profit organizations in Memphis, Tennessee: Knowledge Quest, Inc. and Shelby County Books from Birth. I devoted and donated my time, professional and financial resources to both of these worthy organizations as they both are committed to making a positive impact on the lives of young children in our community. Knowledge Quest provides after-school programming that promotes intellectual and character development, coupled with the cultivation of artistic talents, to children grades pre-K through eighth grade. The 38126 and 38106 zip codes that Knowledge Quest serves consist of Memphis's highest rates of poverty, school drop-out, substance abuse, teenage pregnancy, gang activity and youth violence. Knowledge Quest has been awarded the highest honor the United Way of the Mid-South bestows annually to an agency for outstanding service to the community. Shelby County Books from Birth is the local affiliate of Dolly Parton's Imagination Library and the State of Tennessee Governor's Books from Birth program. On January 23, 2015, I interviewed with the committee and Congressman Cohen in Memphis, Tennessee. On January 28, 2015, I received a call from Congressman Cohen, and he informed me that I received the committee's top recommendation to fill the judicial vacancy. On March 17, 2015, I received a call from Congressman Cohen stating that he had consulted with Senator Lamar Alexander and Senator Bob Corker and that my name would be submitted to the White House for consideration. Since March 18, 2015, I have been in contact with officials from the Office of Legal Policy at the Department of Justice. On May 12, 2015, I interviewed with attorneys from the White House Counsel's Office and the Department of Justice in Washington, D.C. On May 21, 2015, the President submitted my nomination to the Senate.
