1. *St. Clair County, Il. v. Scott Air Force Base Properties, LLC, Illinois Department of Revenue*, 11-MR-213 (Cir. Ct. St. Clair County, Illinois)

Case involved a series of agreements under the Military Housing Privatization Initiative. (10 U.S.C. §§ 2871-85). Defendant Scott Properties provided active duty military housing on federal property that was part of Scott Air Force Base. Scott Properties sought property tax exemptions based upon the federal government's ownership of the underlying ground. The Illinois Department of Revenue found the property to be tax exempt. The County appealed Department of Revenue's determination to the Circuit Court. In a companion case, the local school district also filed a declaratory judgment action seeking to take the properties because those residing therein were sending their children to that local school. *Mascoutah Community School District 19 v. Scott Air Force Base Properties LLC and IDR*, 11-MR-285 (Cir. Ct. St. Clair County, Illinois).

I reversed the determination of the Department of Revenue and found the properties were subject to local taxation because, while the federal government owned the land, Scott Properties held long term leasehold interests in the property so substantial as to make it taxable. Scott Properties appealed and my decision was affirmed. See 2014 IL App (5th) 120570-U. A copy of my order is supplied.

2. *Lake Environmental, Inc. v. Arnold & Illinois Department of Public Health*,
11-MR-226 (Cir. Ct. St. Clair County, Illinois)

Lake Environmental (Lake) was a licensed Asbestos Contractor. It was in the process of performing asbestos removal at a building at Scott Air Force Base. The Illinois Environmental Protection Agency issued an emergency stop work order for failure to properly prevent asbestos dust from leaving the site. Lake Environmental admitted fault, took corrective action and paid a large fine in exchange for the State of Illinois dismissing the Administrative action filed against Lake with prejudice. Two years later, the Illinois Department of Public Health (IDPH) notified Lake it intended to revoke its asbestos contractor license. When IDPH revoked the license, Lake filed a Petition for Administrative Review. In a complicated interplay of overlapping and redundant statutory regulations of multiple agencies, I found that the State erred in revoking the license, and instead found that IDPH's initial dismissal resolved all issues.

I declined Lake's request for sanctions without setting out specific reasons for the denial. The Fifth District Appellate Court reversed on appeal finding that I was required to specify my reasons for denying sanctions. See 2014 IL App (5th) 130109. The Supreme Court reversed the Appellate Court and remanded the case back to determine if the record supported my findings. See 2015 IL 118110. The Appellate Court thereafter affirmed my decision. See 2016 IL App (5th) 130109-UB. A copy of my order is supplied.

3. *Willey v. Minnesota Lawyers Mutual Insurance Co.*, No. 14-CH-144 (Cir. Ct. St. Clair County, Illinois).

Willey was an attorney licensed to practice in Iowa. He and his firm performed work with a Belleville property owner by the name of Floyd Schlueter who was trying to develop his property and Willey was assisting in helping Schlueter secure financing.

Schlueter placed a large sum of money with Willey to be held in his attorneys' escrow account to consummate a funding agreement. The funds were mishandled and Schlueter sued Willey in St. Clair County, Illinois. Willey tendered the defense to his malpractice insurer, Minnesota Lawyers Mutual Insurance Company. The insurer denied coverage and a duty to defend pointing to a clause in the insurance contract that denied coverage to Willey if he practiced law in either Madison or St. Clair County, Illinois.

I ruled that Willey was sued in his capacity as an escrow agent, not as legal counsel and, thus, Minnesota Lawyers Mutual Insurance Company had a duty to defend Willey. I was affirmed in the Illinois Appellate Court in *Willey v. Minnesota Lawyers Mutual Insurance*, 2017 IL App. (5th) 160452-U. A copy of my order is supplied.

4. *In re: Matter of Petition for Rejection of City of East St. Louis Election Law*, No. 11-MR-343 (Cir. Ct. St. Clair County, Illinois).

There was a citizens' initiative commenced to place on the ballot a proposition to eliminate the East St. Louis Board of Elections. There was no formal party or group that circulated the petitions. The circulators purportedly secured above the minimum number of required signatures to place the matter on the ballot.

The East St. Louis Board of Election Commissioners filed a formal objection claiming over 400 signatures were invalid. The first issue I had to decide was whether one of the circulators had standing to defend against the objections pro se. As there was no formal party or candidate filing the signatures, I allowed one of the circulators of the petition, Matthias Hawkins, to defend against the objections pro se.

Ultimately, I found the East St. Louis Board of Election Commissioners could not be an objector by statute and therefore the objection was dismissed and the proposition was placed on the ballot. A copy of my order is supplied.

5. *The Briars Property Owners Association v. Addison, et al.*, No. 13-MR-174 (Cir. Ct. St. Clair County, Illinois).

The Briars is an upscale residential development which created certain restrictive covenants to run with the land when originally platted. It also created an Owners Association that was responsible for the common areas and the maintenance of a lake.

Some years after the creation of the development, the dam along the lake required significant and expensive repairs. The Owners Association increased substantially the annual assessment on each property owner to cover the costs of repairs to the dam. The named defendants objected claiming their property did not abut the lake and that the restrictions created related to the lake were not signed by them and unenforceable. If their objections were sustained, all restrictive covenants would be unenforceable. I ruled against their motions to dismiss on December 3, 2014.

Thereafter, I recused myself on January 6, 2016, as I was being assigned to the Probate docket and believed that case should remain in Chancery Division. Judge Kolker was appointed to preside over the case. He reversed my ruling and granted defendants summary judgment. On appeal, Judge Kolker was reversed, with the Appellate Court finding I ruled correctly. See, *Briars, et seq v. Addison, et al*, 2018 IL.App. (5th) 160293. A copy of my order is supplied.

6. *Billhartz, et al v. Billhartz, et al*, NO. 12-MR-215 consolidated with No. 12-MR-218 (Cir. Ct. St. Clair County, Illinois).

Warren Billhartz built a banking empire in Southwest Illinois. He divorced the mother of his children in 1978. There was a property settlement reached in that divorce. Warren remarried and continued to grow his bank holdings. He drew up a trust in 1992 that provided money and stock for his children, wife and siblings. The trust had a clause that anyone who unsuccessfully challenged the terms of the trust would be divested of any assets or funds otherwise left for them. The value of the Warren Billhartz holding was greater than \$80,000,000. Three of Warren's daughters filed to challenge the enforceability of the trust and will. Multiple parties were joined.

Marcia Billhartz, individually and as trustee of the Trust, filed a motion to enforce a settlement agreement reached by the parties on March 1, 2013, after a lengthy mediation before retired Judge Patrick Hitpas. I took up the motion to enforce the settlement agreement first. Eventually only one person to that settlement agreement, Jean Billhartz, opposed its enforcement. After a lengthy hearing, I granted the motion to enforce the settlement agreement. A copy of my order is supplied.

On appeal, the Appellate Court found the settlement agreement was unenforceable as to Jean Billhartz. See 2015 IL App (5th) 130580. Upon remand, the parties were all faced with very substantial tax challenges and the children of Warren Billhartz now faced the prospect of being totally disinherited unless they proved a fraud by clear and convincing evidence. A settlement agreeable to all parties was reached and the case was dismissed. A copy of my order is supplied.

7. *U. S. Bank v. Rosewood Care Center, et al*, No. 11-CH-177 (Cir. Ct. St. Clair County, Illinois).

U. S. Bank filed a foreclosure action against a very large nursing home. Pursuant to the loan agreement, the bank asked that a Receiver be appointed to run or liquidate the facility and pledged assets. The Defendants strenuously opposed the appointment. I appointed a Receiver to take control of the nursing home. The Receiver in such a case reports to the judge. I made sure the facility was continuously operated and that no residents were moved against their will. 8. *Illinois ex rel. Edmonson v. Board of Trustees of Illinois Eastern Community Colleges*, No. 16-CH-198 (Cir. Ct. St. Clair County, Illinois).

Philip Edmondson filed an action under the Illinois False Claims Act against his former employer, Illinois Eastern Community Colleges. He claimed that the Colleges were defrauding the State by claiming that coal miners were taking mine safety classes at its facilities that they, in fact, never took. He also claimed that the Defendant received money from the State and that the Colleges were grossly overstating the amount of training some miners were getting. He sought damages on behalf of the State and the compensation that would be afforded him under the Act, should he be successful. The Illinois False Claims Act provides that “any person” is liable to the State if that person knowingly presents a false or fraudulent claim to the State.

Defendant filed a motion to dismiss asserting that since it was a State entity, it could not qualify as a “person” under the Act and that Plaintiff’s action would be tantamount to the State suing itself. The Illinois False Claims Act includes within its definition of “the State” state agencies and state community college districts. I found that the Act was designed to combat corruption and fraud that injured the People of Illinois. I concluded that its status as a state entity did not create for it a safe harbor from which it could avoid liability under this Act. I denied the motion to dismiss. I did grant a motion to certify the question to the Appellate Court. My decision was affirmed. See 2019 IL App (5th) 180333.

9. *People v. Schoppen*, No. 15-CF-1031 (Cir. Ct. St. Clair County, Illinois).

Defendant was charged with four counts of criminal sexual assault on a minor. In October, 2014, his stepdaughter, age 18, went to the O’Fallon Police Department and reported that her stepfather repeatedly molested her beginning when she was age 15 through age 17. A brief investigation resulted in no charges being filed.

In August, 2015, a 14-year-old neighbor reported to police that beginning in March of 2015, he molested her and then engaged in sexual intercourse. The Defendant waived a jury, and a bench trial commenced before me. The defendant's family testified that the stepdaughter later recanted her story and that the 14-year-old was a mentally unbalanced stalker who was infatuated with the defendant. Family members also claim it would have been impossible for the two to be alone together. Text messages between the defendant and the 14-year-old showed a definite romantic and intimate relationship existed between them. I found the defendant found guilty on all four counts. A copy of my sentencing order is supplied.

10. *Graves v. St. Clair County*, No. 10-MR-291 (Cir. Ct. St. Clair County, Illinois).

Gregory Graves was a Deputy of the Saint Clair County Sheriff's Department. While on duty, he responded to an emergency call requiring him to investigate an area adjacent to railroad tracks. There he found a decapitated body. While moving the body away from the tracks, he slipped on gravel and twisted his knee. He aggravated a pre-existing arthritic condition in his knee. He underwent some orthoscopic surgery and returned to work after some time off.

Sometime thereafter, while on duty, he was trying to restrain an individual who was attempting to run into oncoming traffic. During his struggle with that individual, he reinjured the same knee. He subsequently underwent two additional surgeries and was placed under significant work restrictions. Mr. Graves filed for benefits available to members of law enforcement who suffer "catastrophic injury" while on duty. The County opposed the claim, asserting that his condition was the result of degenerative changes in his knee and that none of the on-duty injuries were "catastrophic."

I found that Deputy Graves' line of duty injuries played a substantial roll in the degenerative changes in his knee to cause the disabilities he was suffering. I further noted that the Illinois Supreme Court has previously held that the term "catastrophic" in this particular Act did not mean very serious and sudden. Rather the term related to the nature of the impact it had on the officer's ability to work. I further held that a catastrophic injury could be cumulative in line of duty events and not just a single trauma. My decision was affirmed by the Appellate Court. See 2013 IL App (5th) 120252-U.

Price v. City of Belleville 2019 IL App (5th) 180312-U.

Petitioner filed a Freedom of Information Act request to secure the architectural drawing of a restaurant in the City of Belleville. The case was assigned a different judge who granted the City's Motion to Dismiss. The St. Clair County Circuit Clerk's Office did not send a copy of the order to the Plaintiff. Several months passed and Petitioner's counsel learned of the adverse ruling. The judge who entered the order denying the requested information had since retired and the case was assigned to me.

Petitioner's counsel filed a Motion for Relief from Judgment pursuant to State Statute. I granted that motion because not to do so would result in an injustice. I then considered the merits of the plaintiff's motion to reconsider the initial ruling. I denied the motion to reconsider. The Appellate Court ruled that the Circuit Court was divested of jurisdiction by the time the attorney discovered the original adverse ruling was entered. The Appellate Court vacated my order granting relief from judgment and dismissed the appeal.

In re: Estate of Melba Pruitt, 2019 IL App (5th) 180253-U.

I entered judgment on a will contest. A party that received an adverse ruling filed a Motion to Reconsider, albeit late. The Court still had jurisdiction over the parties and the estate. I denied the Motion to Reconsider. The Appellate Court held the Motion to Reconsider a final appealable order, was filed too late, and vacated my order denying the Motion to Reconsider, and dismissed the appeal.

People ex rel. Kelly v. McGlynn, Illinois Supreme Court # 124429 (2019).

The State's Attorney filed a Petition for leave to file a Complaint for Mandamus on January 19, 2019. He disagreed with a ruling I had made granting a second stage hearing for a Defendant in a post-conviction matter. The Supreme Court denied the motion on January 25, 2019. On February 6, 2019, the Court issued a supervisory order in that case with respect to ruling in question that I made in *People v. Williams*, 94 CF 529 (Cir. Ct. St. Clair County). Specifically, the Court directed the Circuit Court to determine whether Mr. Williams satisfied the cause-and-prejudice test to advance a successive post-conviction petition to the second stage. Copies of the orders denying the motion and the subsequent supervisory order are supplied.

In re: Guardianship of Lillian Burdge, 2018 IL App (5th) 170317

Adult children fought over whether their mother was incompetent and in need of a guardian. They also fought over who should be her guardian, where she should live and who would have visitation. I had determined that Lillian was grossly over-prescribed medication and it was likely that the daughter, with whom she lived, was herself using the medicines. I found that Lillian needed a legal guardian of both her person and her estate. I appointed two daughters who were trained nurses to serve as co-guardians. I did give the daughter with whom Lillian had been living, supervised visitation pursuant to a strict schedule as the siblings could not cooperate regarding visitation time. The court affirmed me on all issues except that it found it was "premature" to grant visitation to the daughter with whom she had been living exclusively for several years. It reversed my order setting a fixed visitation schedule and directed further hearings

Lahko v. Nisar et al., 2017 IL App (5th) 160141-U

Plaintiffs and Defendants entered into two real estate ventures in Florida. They formed two separate Florida corporations as part of these ventures. The operating agreements of both ventures contained a clause requiring all disputes were to be arbitrated. Plaintiff filed various fraud counts as well as a claim that the Defendant violated the Illinois Security Law of 1953. Defendants filed motions to compel arbitration. I entered an order enforcing the arbitration agreement and directed the parties to arbitration. The Appellate Court affirmed in part and reversed in part. The Court affirmed my order directing the parties to arbitration on the second venture, but reversed my order with respect to arbitration on the first venture agreement. The Court found that while the

parties were operating in accordance with the first venture agreement, the Plaintiff had not signed it and, therefore, the Defendants could not compel him to arbitrate claims arising out of that first venture.

E.H. v. State Farm Fire & Casualty Company, 2016 IL App (5th) 150249

Plaintiff filed a declaratory judgment action seeking that the insurer defend a minor against a complaint based upon sexual assault. At the time the Fifth Appellate District had no published opinion on the precise question. However, the Illinois Second Appellate District had issued an opinion on which appeared on point and, thus, I was obliged to follow. That case is *Country Mutual Insurance Company v. Hagan* 298 Ill. App.3d 495 (1998). The 5th District rejected the reasoning in *Hagan* and found differently. In so doing, it reversed my decision to hold off on ruling on the coverage issues until the underlying dispute was decided.

Billhartz v. Billhartz, 2015 Ill. App. (5th) 130580-U

This matter involved a dispute over a trust and a will created by Warren Billhartz that controlled assets of approximately \$80 million. All the parties agreed to mediate the dispute. The mediation was conducted by a retired judge. The parties agreed to settle. Thereafter, one of the daughter's changed her mind. A motion to enforce the settlement agreement was filed. After a lengthy hearing, I found that there was a meeting of the minds and entered an Order enforcing the settlement agreement. The Appellate Court reversed citing language in the parties' mediation agreement that required a signed writing. Since the one daughter did not sign it, the settlement could not be enforced as against her.

First Collinsville Bank v. Johnson, 2015 IL App (5th) 140081-U

First Collinsville Bank filed a foreclosure action naming Defendant as a party. Defendant had moved to St. Augustine, Florida, and was personally served in Florida with the complaint. Defendant did not dispute that he was served, rather, he asserted that there were technical deficiencies with the summons. I found that the Defendant had actual notice of the action and was served with the complaint. I found the deficiencies with the summons to be technical and not substantive.

The Appellate Court found the technical deficiencies made service ineffective even though he was served with a copy of the complaint. Thus, the Bank's effort to enforce a money judgment entered in Illinois was improper and the underlying judgment was to be vacated as against that defendant.

Illinois Insurance Guaranty Fund v. Chicago Insurance Company, 2015 IL App. (5th) 14033

Illinois Insurance Guaranty Fund filed a declaratory judgment action against the Defendant insurer seeking to determine whether its "claims-made" policy provided

coverage in a medical malpractice case filed naming its insured and an employee who was not expressly named as an additional insured. I found that under Illinois law which maintains that the duty to defend is broader than the duty to indemnify, the Defendant insurer had a duty to defend its insured clinic and the physician-employee in question. The Appellate Court reversed my interpretation of the insurance company.

CitiMortgage Inc. v. Adams, 2015 IL App (5th) 13047

I entered an order confirming a sale in a mortgage foreclosure action. Previously, I had delayed the sale for a number of months so that the parties could participate in the Circuit's Foreclosure Mediation Program. The bank objected because the homeowners failed to timely request a stay of the action so that they may seek mediation. Mediation was not successful. The homeowners appealed my order claiming that they had applied for assistance under the Federal Home Affordable Modification Program (HAMP). However, the homeowners did not inform me that they had applied for such relief until after I entered an order approving the sale. On appeal, the Appellate Court held that the parties should have informed me prior to the hearing on approval of sale that the homeowners had in fact sought such assistance. The cause was remanded for determination if there was any material violation of HAMP.

People ex rel. Kelly v. \$16,500 U.S. Currency, Warner, 2014 Ill. App. (5th) 130075

The Warners received a package at their address for an unknown addressee. Upon opening it, they found a large amount of cash. They turned it over to the police. The State filed a civil forfeiture action to seize the money. An order was entered declaring a forfeiture. Thereafter, the Warners filed appropriate pleading to set aside that order because they were not served notice as required by the Act. I vacated the order declaring a forfeiture and set the matter for a probable cause hearing upon a Motion filed by the Warners. The Appellate Court reversed, finding that even though the Warners were entitled to notice and not given proper notice according to the terms of the Act, they had actual notice and that was sufficient to trigger the deadline for them to file a verified claim for the money and a cost bond. The Appellate Court reversed and directed the original forfeiture order enforced.

Lake Environmental, Inc. v. Arnold Department of Public Health, 2014 Ill. App. (5th) 13109

On August 30, 2011, Lake Environmental, Inc. filed a Complaint for Administrative Review of an adverse ruling by an Administrative Law Judge for the Illinois Department of Public Health. The order in question let stand a revocation issued by the Department's Director of Plaintiff's Asbestos Contractor License. The revocation was imposed on the basis of an earlier transaction of events in which Lake Environmental was the subject of a stop work order at an asbestos removal project in Saint Clair County. The Department of Public Health asserted that Lake Environmental was not properly performing asbestos removal. On February 18, 2008, the Department imposed the emergency order. However, in September of 2008, the Department entered an order dismissing with

prejudice its earlier order and allowed Lake Environmental to continue removing asbestos at that particular project. The wording of the dismissal order absolved Lake Environmental of any wrong doing of violation of Illinois law. At the revocation hearing two years later, the Administrative Law Judge did not hear any evidence. Rather, the judge relied solely upon the assertions made by the Department when it originally issued the emergency stop work order.

I reversed the judgment of the Administrative Law Judge concluding that the Department's own dismissal order prevented the original emergency stop work order, or the circumstances leading to its issuance, as serving as a basis for any subsequent adverse action taken by the Department. I remanded the matter back to the Illinois Department of Public Health to allow for a hearing to establish any other basis that could justify the revocation of the license.

The Plaintiff believed the Department's actions were so egregious that the Department should be sanctioned. I explained to the parties in open court that while the procedure followed by the Department was improper, that did not mean that there could not be a separate basis to justify the revocation of the license and that the Department should be given the opportunity to present such evidence if it had it. However, my written order merely denied the request for sanctions.

The matter was appealed. The substance of my order was affirmed. However, the Appellate Court found that I should have stated my specific reasons for denying the request for sanctions. See 2014 IL App (5th) 130109. The Illinois Supreme Court reversed the Appellate Court, remanding it back for it to determine if the record in the trial court supported my ruling. See 2015 IL 118110. The Appellate Court then affirmed my rulings. See 2016 IL App (5th) 130109-U.

Peabody-Waterside Development, LLC v. Islands of Waterside LLC Regions Bank NA, et al, 2013 IL App (5th) 120490

This case involved breach of contract claims and determining priority of a mechanic's lien over a bank's mortgage interest. The Plaintiff borrowed money from Regions Bank to fund the development of certain real estate. It entered into a project with Islands of Waterside as a 50% limited partner. It then performed grading and site work on the property in question. It filed a mechanic's lien for \$4.5 million and argued that the mechanic's lien had a priority interest to the bank's mortgage lien. The funds loaned by the bank were used to pay costs associated with the development including site work.

Under Illinois law, an owner or co-owner of property may not claim a lien against his or her own property. This rule also applies to joint ventures. I found Peabody-Waterside Development, LLC's interest was substantial enough in the property that its lien could not trump that of the lending bank. The Appellate Court found that its status as 50% limited partner in the project was not substantial enough to defeat its right to assert a mechanic's lien with priority over the bank's lien. The Court found that my ruling was correct if Plaintiff was a "co-owner" instead of a limited partner.

Yates v. Board of Trustees of Police Pension Fund, 2013 IL App (5th) 12031- U

Lee Fields was an East Saint Louis police officer. He married Lorraine in 1979. In 1987 the two got divorced. In the marital settlement agreement, Lorraine expressly waived any right to Lee's East Saint Louis pension or benefits. In 1990, Lee and Lorraine remarried. Lee died in 2002, and for a period of eight years, the Board paid survivor benefits to Lorraine. In 2010, the Board determined that Lorraine was not entitled to benefits. The Board sent Lorraine notice of a hearing on the question of whether she was entitled to survivor benefits. She did not appear or otherwise contest the Board's determination to terminate benefits. Lorraine then filed a complaint for Administrative Review.

On appeal, the Appellate Court reviewed the decision of the Pension Board and found it was wrong. I had upheld the decision of the Pension Board because she did not marry Lee Fields until after he retired and 40 ILCS 5/3-120(a) states that "If a police officer marries subsequent to retirement ..., the surviving spouse shall receive no pension on the death of the officer." The Appellate Court reasoned that since the couple's first marriage predated his retirement, the statute in question did not apply.

People v. Sharp, 2013 IL App (5th) 110336-U

Daryl Sharp was charged with armed robbery of a retail establishment. He pled guilty to reduced charges. At the time of the plea, the factual basis set out that he and another man entered the establishment, armed with dangerous weapons and robbed the store and its employees and then fled in a car. Over a year after he pled guilty, he filed for post-conviction relief. He claimed his lawyer was ineffective because he failed to interview two witnesses that would have testified that Defendant was drunk and asleep in the getaway car during the time of the actual robbery. I dismissed the post-conviction petition at the first stage because the record at time of plea contradicted Petitioner's claim. Appellate Court reversed finding defendant's claim his lawyer failed to interview a potentially corroborating witness that he was asleep in the getaway car when offense happened, was sufficient to move petition to second state proceeding.

Dribben v. Lurbo Land Trust, et al, 2013 IL App (5th) 120579-U

The parties were neighbors and in the middle of a long-standing dispute over boundary lines and easement rights out of which swelled significant personal animosity. Wendy Dribben filed a petition seeking a Stalking No Contact Order against Geraldine Davidson. After a lengthy hearing, I found Wendy Dribben's testimony not credible. In denying the request for a No Contact Order, I wrote that no reasonable person would have interpreted the conduct of Davidson to constitute stalking. The Appellate Court reversed my finding holding that I applied the wrong standard in ruling on such a petition to the extent I applied a reasonable person for the victim. The Court remanded instructing that I should enter a No Contact Order.

Murphy v. East Saint Louis, et al, 2013 IL App (5th) 120313-U

Lance Murphy was an East Saint Louis police officer. Murphy was accused of criminal conduct and faced termination. On July 6, 2011, an administrative hearing was held regarding his potential termination. Just before the hearing began, Murphy and his lawyer accused the Board of being biased and prejudiced and decided to leave before the hearing commenced. Murphy did not present any evidence. The City presented evidence in favor of termination and the Board voted to terminate Murphy. Murphy filed a petition for administrative review. Defendant filed a motion to dismiss stating there was nothing in the record to support reversal. I granted the motion to dismiss.

The Appellate Court found dismissal was the wrong method to address the matter. Murphy was not required to participate in the hearing. To appeal, there needed only to be a final decision on the merits. Court reversed and remanded for further proceedings. Summary Judgment was subsequently entered in favor of the Police Board and against Murphy.

People ex rel Kelly v. 2002 Yellow Case 580, 2013 IL App (5th) 120553-U

State filed a petition for civil forfeiture of claimant's backhoe. It alleged it was used in the commission of a crime. After a hearing I found the State failed to prove that the piece of equipment in question was used to commit a crime. The State had charged the Claimant with a felony and Defendant asserted his 5th Amendment rights at the civil hearing. I held that the State should proceed with its petition and prove its case. The State filed a motion to stay the civil action until the criminal case was resolved. I refused to stay the proceeding finding that the delay would force an undue burden on Defendant and the civil forfeiture law directed prompt resolution of hardship issues. I also found that denying resolution of the issue while withholding his equipment gave the State an unfair advantage in the criminal case. The Appellate Court reversed, holding that I should have delayed the hearing until such time as the State could conduct discovery and call the Claimant as an adverse witness.

Fairchild Corp. v. Arrowpoint Capital Corp. et al, 2013 IL App (5th) 120362-U

This dispute involved several insurance companies who insured a manufacturer who was subjected to numerous products liability claims. One of the insurers filed bankruptcy. While there were many complex insurance coverage issues involved in this case, the appeal related to a grant of partial summary judgment, I granted a law firm for its attorneys' fees in some of the underlying cases. Fairchild filed bankruptcy and listed some of the other insurers in the underlying litigation as creditors in bankruptcy. However, Fairchild did not give notice to the attorneys as creditors nor sought to discharge its obligation to pay that firm its fees. The insurers worked out an agreement in the Bankruptcy Court as to the obligations between them. However, the attorneys were never given notice nor was any provision made with respect to the attorneys' fees owed.

The insurers took the position that Fairchild was the one responsible to pay the fees in question and that those obligations were discharged in bankruptcy. I disagreed and found

the obligation was not discharged because Fairchild failed to serve proper notice on the attorneys and that their interests were not protected at the creditors' meetings or before the Court. A divided court reversed my decision. The majority found that all of Fairchild's interests in the insurance contracts were transferred to a Liquidating Trustee, and that the attorneys should seek funds from the liquidating Trustee.

People ex rel Kelly v \$526.00 U.S. Currency & Ford Explorer, 2013 IL App 120525-U

The State had secured a warrant to search the residence of the owner of the vehicle and money in question. While at the residence, an officer noticed the Claimant driving his vehicle some distance away. The officer then made a stop of the Claimant and his vehicle. He did not articulate grounds to support a finding of probable cause that he had reason to initiate the stop. The warrant only applied to the residence and did not include the vehicle. I denied a petition to find probable cause for a civil forfeiture of a vehicle.

The Appellate Court reversed finding that probable cause was not necessary for purposes of the Forfeiture Act. Additionally, the Appellate Court found that the facts showed a sufficient nexus between the property in question and the alleged illegal drug activity that supported the search warrant for the residence. In this case, the Claimant was found to be in possession of a small amount of drugs while operating the vehicle, thus supporting forfeiture of the car and the money in his possession.

Petter Packaging v. Hutchcraft, 2012 IL App (5th) 110020-U

Defendant was a manufacturing representative selling Petter's products in a multi-state territory. The parties had a non-compete contract which by its express terms was to be governed by Kentucky law. Kentucky law holds that such contracts are not favored and must be strictly construed against the drafter of the contract; in this case Petter. Kentucky law also directed that if the non-compete terms were too broad or unworkable, the Court was to either refuse to enforce it or rewrite the terms to make enforcement fair and practical. I granted Petter Packaging's request for a preliminary injunction enforcing the non-compete agreement. However, I found that some of the restrictive terms of the contract, were overly broad and unworkable. I ruled that the terms of the contract would have to be rewritten to make enforcement fair and practical. The Appellate Court affirmed my order in all respects, except that it found that the contract should be enforced as written and modifications were not necessary to make enforcement fair and practical.

Goodman v Cody, et al, 2012 IL App (5th) 110175-U

This was a legal malpractice case regarding certain insurance funds of a minor that were dissipated by the minor's mother. When the minor reached age 18, the dissipation became apparent. The minor sued the lawyers that were involved in the creation of the trust to protect the funds for the minor. He also sued the Guardian ad Litem, who was appointed to protect the minor's interests. The trust documents were created by an attorney for the minor's mother. The Guardian ad Litem also participated in drafting the trust document. The trust document designated the Guardian ad Litem to serve as the

Trustee of the trust. The trust granted broad discretion to the Trustee, Dennis Watkins, as to how the trust funds were to be invested and paid out. It was anticipated that the mother would receive funds from time to time from the trust to help defray the costs of raising the minor child. The mother was single and had meager assets and income. The Trustee allowed most of the money to be given to the minor's mother over the years, who, it was alleged, did not spend it on the minor's interests.

The case before me was the malpractice case against the minor's Guardian ad Litem and the Trustee of the trust, Dennis Watkins. He also sued Daniel Cody, the attorney who represented the mother and participated in drafting the trust agreement. I granted summary judgment in favor of Cody ruling that he owed a duty to the mother and not a duty to the minor. I allowed the case to proceed against Dennis Watkins. As it turned out, attorney Watkins did not maintain malpractice insurance. On appeal, the appellate court reversed ruling that a question of fact existed as to whether the minor was a third-party beneficiary of the legal contract between Cody and his mother.

Eagle Marine Industries v. Union Pacific Railroad Company, 227 Ill.2d 337, 882 N.E.2d 522 (Ill. 2008).

I concurred in an opinion written by Justice Donovan, in *Eagle Marine Industries v. Union Pacific Railroad Co.*, 363 Ill.App.3d 1166, 845 N.E.2d 869 (5th Dist. 2006). We affirmed a lower court's decision upholding an ordinance that allowed the community of Sauget, Illinois to direct the railroad to break a train stopped more than 15 minutes and blocking the only road through that town which is mostly heavy industry. The stopped trains were creating serious safety issues. The Illinois Supreme Court reversed our decision holding that the issue was preempted by federal law and the ordinance was therefore unenforceable.

During my tenure on the Illinois Appellate Court I authored 12 opinions which were published in official legal reporters. The Illinois Appellate Court also issued unpublished opinions under Rule 23. As a Rule 23 opinion, the opinion was not to be cited as authority and was not published in an official legal reporter. The Clerk of the Appellate Court, Fifth District, holds copies of all such opinions.

In Illinois, litigants have a right to substitute a judge one time per case for any reason. The litigant has to exercise that right before the judge has made any substantive ruling. In criminal cases, by operation of the rule, bias is alleged in the Motion for Automatic Substitution, but no grounds are given.

I am aware of three incidents in which a litigant filed a motion to substitute me for cause or for an alleged bias.

In *Foster v. Foster*, 1-D-184 (Cir. Ct. of Saint Clair County, Illinois) the Defendant claimed he was sovereign citizen who had sued other judges in my circuit who had ruled adversely toward him in family law cases. The State of Illinois brought an action against him to enforce his child support obligations for six minor children. I held him in contempt for repeatedly ignoring court orders in the case. He then sued me in Federal Court. Some months after he sued me, his case appeared again on my docket. He filed a motion asking that I be substituted for cause. The basis of the motion was that he had sued me. I denied the motion because he has filed multiple lawsuits against judges he appeared before, and I figured that having some other judge take over the child support enforcement action would only result in him suing another judge. I offered to give him leave

to appeal and test the issue in the Appellate Court. He declined to appeal my order.

In *In re: Guardianship of Autumn Humphrey, a minor*, St. Clair County Circuit Court, No. 15-P-400 (Cir. Ct. St. Clair County). After a hearing where the mother was present, and the alleged father of one of the children elected not to participate, I had granted guardianship of her minor daughter and, later, her minor son, to a neighbor she had abandoned the daughter to many months earlier.

Over a year later, both Karrissa Cox and Dustin Humphrey filed a motion to vacate my judgment and to terminate the guardianship. This time they were represented by an attorney. The lawyer filed his motions and then noticed the matter up for hearing on the first date available, the Friday before Memorial Day weekend. The lawyer did not consult with the Guardian ad Litem of the children to see if he was available on that date. The Guardian ad Litem had left for vacation and was not available. The lawyer said he wanted to have his motions heard in spite of the unavailability of the minors' Guardian ad Litem. I continued the hearing until all proper parties could be present, over the objection of the lawyer.

Thereafter, the lawyer filed a lengthy motion to have me substituted for cause. As it was a motion for cause, the case was immediately transferred to the Chief Judge for assignment. He elected to hear the motion himself and ultimately ruled it to be entirely without merit.

Dribben, et al v. Lurbo, et al 11-CH-581 (Cir. Ct. St. Clair County, Illinois)

This case involved highly contentious and protracted litigation. What began as a boundary line dispute between neighbors escalated drastically to include claims of fraud and tortious conduct. A request for an Order of Protection was also sought in the middle of the litigation.

During a relevant time to this litigation, the Dribbens divorced and the husband, an emergency room physician in St. Louis, was required to pay all the attorneys' fees associated with this litigation. The Dribbens' attorney, Paul Maddox, then began a romantic relationship with Mrs. Dribben. While Dr. Dribben initially waived the conflict he had, I ordered Paul Maddox be removed as counsel on the case for cause because it was apparent that he was hopelessly conflicted in the matter and was pursuing a litigation strategy that was deleterious to Dr. Dribben. It was at that time that Attorney Maddox filed a motion to substitute me off the case for cause. The motion was set before Judge Kievlan in early July, 2015. In June, 2015, I voluntarily recused myself because of my reassignment to Probate from Chancery.

I have recused myself *sua sponte* on all cases assigned to my docket for which my brother was counsel of record.

From 1996-97 through 2005 before I was appointed to the Appellate Court, I also handled a significant amount of aviation and aviation related matters centering around, but not exclusively, Mid-America Airport.

My typical clients from 1987 through 1998 were individuals injured in automobile accidents, industrial accidents, or the result of a defective product. I also represented banking interests and St. Louis National Stockyards. While McGlynn & McGlynn was engaged in the general practice of law and we did not specialize per se in a particular aspect of law, beginning in 1998, I began handling a significant amount of civil rights matters for individuals. I also handled a significant amount of election related legal matters. I also handled more corporate, and aviation-related clients.

I have been unable to locate a copy of the filings in that case.

1. *Jackson v. Casino Queen Inc*, United States District Court for the Southern District of Illinois No. 07-631-MJR

I was lead plaintiffs' counsel representing over 70 individual employees of the Casino Queen who claimed they were discriminated against because of their race. We asserted individuals were fired, passed over for promotion and/or were forced to work in a hostile work environment. During the course of the litigation, we secured sworn testimony by two African-American females who at one time held the position of Personnel Manager at the Casino Queen. Their combined tenure spanned a number of years as the heads of personnel. They testified that they believed black employees were treated unfairly by management. They also testified that they never saw any formal affirmative action plan or program at the Queen.

We established that while the Casino Queen formally pledged to have an affirmative action plan, a requirement to win the gaming license, it never shared one with any one in management, including the Personnel Managers. Each year management reported to the Illinois State Gaming Board that it had, in place, a formal, vigorous affirmative action program, it, in fact, it only ever showed a written affirmative action plan to the Gaming Board.

The litigation was very vigorously fought by the Casino Queen. The case ultimately settled on the eve of trial for a confidential amount. I was appointed a Circuit Judge and sworn in September, 2010. The trial was scheduled for later that Fall. My brother, Michael, took over my role in the litigation when I went on the bench.

2. *Nei'osha Hand, Personal Representative of the Estate of Clayton Harris, Jr., v Village of Brooklyn*, Twentieth Judicial Circuit Court of Saint Clair County, Illinois, No. 03-L-266. Removed to United States Federal Court for the Southern District of Illinois, Cause No. 03-cv-390-WDS.

I represented the Estate of Clayton Harris, a young black man who was killed by a white police officer working for the Village of Brooklyn. The officer, Jeffrey Crisel, had pulled over Clayton Harris for failing to signal a righthand turn. This happened in the early afternoon on February 12, 2003.

After stopping Mr. Harris, the officer learned Harris had an outstanding warrant for failing to appear for traffic court in East St. Louis. He searched Mr. Harris and determined him to be unarmed.

When the officer attempted to take Mr. Harris into custody, Mr. Harris ran away. The officer returned to his squad car and pursued Mr. Harris. He saw that Mr. Harris hiding behind a steel fence. He drove his squad car through the fence, pinning Mr. Harris underneath the fence and the squad car. Mr. Harris suffocated to death under the weight of the cruiser.

3. *Brown v. Marathon Petroleum and Superior Hard-Surfacing Co.*, United States District Court for the Southern District of Illinois Case No. 89-4169

Brown was doing a repair job at a tower at the Marathon Refinery in Robinson, Illinois. He alleged he sustained a catastrophic injury while working on a structural work (back when Illinois had in place the Structural Work Act) and while using tools for which Superior Hard-Surfacing Company was responsible. It was further alleged that Superior Hard-Surfacing was in charge of both the structural work, the job and provided the tool Plaintiff alleged was dangerous for the job at hand. 4. *The Village Bank v. Beelman Truck Co. et al.*, No. 03-L-86 (Cir. Ct. Saint Clair County). Rev.d No. 5-04-0055 (5th Dist. 2005)

This litigation involved a dispute over an irrevocable stand-by letter of credit issued by my client, Village Bank, for its customer, Beelman Truck Company to its Workers' Compensation Insurer, Vanliner Insurance Company. A dispute arose between Beelman and Vanliner over a particular claim a Beelman employee filed for benefits.

Vanliner then tendered the stand-by letter of credit to the bank and demanded payment of the disputed amount. The Village Bank refused to honor the letter of credit saying it had expired. Vanliner sued the Village Bank in the United States District Court for the Southern District of Illinois. The bank was represented by a different attorney in the federal case. Hon. Michael Reagan ruled against the bank on some substantive motions and the parties then settled.

The Village Bank then hired me to represent it in a claim against Beelman Truck Company. I filed complaint for reimbursement and for equitable subrogation against Beelman. Beelman took the position that Village Bank's position in the federal court proceeding, that the letter had expired, collaterally estopped the bank from now trying to enforce it. Judge Cueto agreed and granted summary judgment.

On appeal, the Appellate court reversed the trial court finding that I had advanced a colorable claim for equitable subrogation and remanded the matter back for further proceedings. The cause then settled on terms very favorable to Village Bank.

5. *Southwestern Illinois Development Authority v. Petroleum Fuel and Terminal Company et al.*, 02-ED-6, Twentieth Judicial Circuit Court, Saint Clair County, Illinois.

I represented the City of Saint Louis and Southwestern Illinois Development Authority in litigation to reopen the historic Eads Bridge that spans the Mississippi River between Illinois and Missouri. The bridge had been closed for a number of years to vehicle and pedestrian traffic. A regional compact entered into years prior required that, if certain circumstances were met, the City of Saint Louis would have to reopen the bridge for traffic. East Saint Louis took the position that those condition had been met and the bridge should be reopened. Ultimately, the City of Saint Louis agreed. However, the bridge, built in the 1800s, had right of ways on the Illinois side that were no longer conducive for modern vehicle traffic. I was retained to file a condemnation action to secure the property on the Illinois side of the bridge so that the roads leading to it renovated to make them appropriate for modern vehicle and pedestrian traffic. The owner of the property in question took the position that the proposed taking was for a private use and not for a public purpose. I was successful in establishing the public purpose for the taking and the Court agreed with the valuation of the property we argued at the hearing. The Defendant filed an interlocutory appeal. The judgment of the trial court was affirmed. See No. 5-0200515 (5th Dist. 2002). Thereafter, there was further litigation. However, subsequent attacks on the taking were unsuccessful.

6. *Illinois Department of Natural Resources v. Boyd Brothers, Inc., et al*, First Judicial Circuit, Williamson County, IL. NO. 97-L-49. On appeal, No. 5-00-0094 (5th Dist. 2000)

In my capacity as Special Assistant Attorney General, I filed a claim against Boyd Brothers, Inc. and its bonding company, United States Fidelity and Guarantee Company. The Illinois Department of Natural Resources awarded a bid to Boyd Brothers to engage in an Abandoned Mined Land Reclamation Project at the Peabody Utility Mine site in Williamson County, Illinois.

Boyd Brothers was to clean up a contaminated lake at the site. It repeatedly asked the State to approve cost overruns for “unexpected” difficulties at the site. While the State approved some additional payments above the contract price, it concluded that Boyd Brothers was aware of the challenges associated with clean up of the toxic site, but intentionally under bid the project to secure the project. Once successful as the low bidder, it intended on submitting numerous change orders to swell the ultimate price to be paid by the State.

Illinois Department of Natural Resources refused a substantial amount of change orders sought by Boyd Brothers. After the State refused to increase the amount it would pay Boyd Brothers to remediate the toxic lake, Boyd Brothers went to the site one rainy night, and using a backhoe, compromised the dam holding the water in place. The result was that the lake water poured into an adjoining creek and out to

Crab Orchard Lake. The toxic water caused a large fish kill in Crab Orchard Lake and polluted it.

I sued Boyd Brothers and its surety to pay for the damage Boyd Brothers caused to the environment and to resolve the contract dispute between the parties. Boyd Brothers filed bankruptcy. United States Fidelity and Guarantee Insurance Company took the position that since Boyd Brothers had a judgment against Illinois Department of Natural Resources for work performed on an entirely different project, United States Fidelity and Guarantee Insurance Company could set off that amount against anything it would owe on its surety bond.

The trial court agreed and I filed an appeal. After briefs were filed, but before oral argument, United States Fidelity and Guarantee Insurance Company settled for most of what Illinois Department of Natural Resources was claiming on the Peabody project.

7. *Kaemmerer, et al v. St. Clair County Electoral Board, et al.*, No. 02-MR-124 (Cir. Ct. St. Clair County) *rev.d* 331 Ill.App.3d 956, 776 N.E.2d 900 (5th Dist. 2002)

The St. Clair County Republican Party slated three candidates to fill vacancies for nomination for office. Specifically, the Party slated candidates for Sheriff, County Clerk, and County Treasurer. All candidates were nominated at the same county convention following the same process. The nominations were identical and the

objections thereto were identical. The Electoral Board was made up of office holders who, if they voted to sustain the objections, would face no opponent in the General Election.

I objected to the makeup of the Electoral Board as each challenge was voted on by two out of three members who had a direct interest in the objections being sustained. Judge Alexis Otis-Lewis ruled against the Electoral Board's decision throwing all the St. Clair County Republican Party candidates off the ballot and ordered that they be placed on the ballot. I represented the candidates and argued that the makeup of the Electoral Board violated the Due Process Rights of each of the candidates. Judge Otis-Lewis agreed.

The Appellate Court remanded with instructions that the Electoral Board be reconstituted with unbiased members to hear the objections. However, because the Appellate Court's decision was not issued until October 4, 2002, 30 days before the election, the objections were withdrawn and all candidates appeared on the ballot.

8. *Carol Hull v. Southern Illinois Hospital Services et al.*, No. 03-L-40 (Cir. Ct. Jackson County, Il). See *Hull v. Southern Illinois Hospital Services et al.*, 356 Ill.App.3d 300 (5th Dist. 2005).

Carol Hull filed a medical malpractice case against the defendant after she suffered serious and permanent injuries when hospital staff improperly administered an intravenous injection. A significant amount of the fluid escaped into the surrounding tissue. When Carol Hull brought the strange swelling and burning at the injection site to a healthcare provider, that healthcare provider told her that it was normal and go away in a few days. She suffered permanent nerve damage at the elbow and surgery was required.

The Defendant filed a motion to dismiss challenging the qualifications of the physician who executed an affidavit attesting that he had examined the medical records and believed the hospital failed to meet the requisite standard of care resulting in injury to Mrs. Hull. The trial court granted a motion to dismiss. The issue on appeal was qualifications of the physician opining that there was substandard care resulting in an unnecessary and avoidable injury.

On appeal, the Appellate Court held that the trial court abused its discretion in finding that the physician's affidavit was not sufficient to justify advancing the litigation. The case was remanded back to the Circuit Court. Thereafter, the case settled for a confidential amount.

9. *People of State of Illinois v. Keveyon Allen*, Twentieth Judicial Circuit Court, Saint Clair County, Illinois. No. 07-CF-973

Keveyon Allen was charged with Armed Robbery. He drove the get-away vehicle for an armed robbery that occurred at a McDonald's Restaurant. Keveyon was an 18-year-old high school graduate who was to start college on a wrestling scholarship two weeks after the robbery. The robbery occurred on August 14, 2007. The President of the local chapter of the NAACP called me and asked me to represent the young man as his family believed him to be innocent and they did not want him represented by a young lawyer in the Public Defender's Office. He had the family contact me and I agreed to represent him.

On August 14, 2007, Keveyon attended services at his church. He went home and went to bed. At approximately 10:30pm, he received a call from a high school acquaintance, Recardo Hill, who asked him to drive him to a McDonald's Restaurant about 7 miles away so that he could pick up his pay check. Keveyon agreed to give the young man a ride. In route, Mr. Hill instructed him to pick up another teenager who needed to go with them. As Mr. Allen pulled up to a public housing complex in East Saint Louis, Brandon Company who was waiting for them, got into the car. Mr. Allen knew Brandon Company to be a member of a criminal gang. When Brandon Company got into the car, he displayed a firearm and told them that he was wearing a Kevlar vest. Company and Hill then instructed Mr. Allen to drive them to another location in East Saint Louis where they retrieved a firearm for Mr. Hill.

Mr. Allen then drove the two to a McDonald's located in Swansea, Illinois. Unbeknownst to Mr. Allen, Company and Hill had worked out a plan with another McDonald's employee to rob the restaurant at closing time. That employee's name was Frederick Alford. He left a back door ajar through which Company could gain access. He robbed the night manager of the proceeds of that evening and then pretended to take Alford hostage. They fled in Allen's car. Allen was told to drive a

short distance and let Alford out of the car. He complied with that instruction. While he was driving back to East Saint Louis, an All-Points-Bulletin was issued to be on the look-out for Allen's car. A Sheriff's Deputy spotted Allen and gave chase in a marked police car. Company instructed Keveyon to flee and not pull over. Keveyon was able to lose the pursuing squad car in a very dark residential neighborhood. All the participants ran from the vehicle, once Allen parked it in someone's driveway. Company and Hill took the money with them.

Allen then called 911 claiming he was carjacked by two strangers and forced to drive them to commit the robbery. While in custody, he gave several taped statements in which he held to that story and claimed not to know the identity of either of the occupants in his car. After several days in custody, he found out that Company, Hill and Alford had all been arrested and were in police custody. He then asked to give another interview in which he told the police everything he knew.

Keveyon Allen was charged with the Class X of armed robbery which carries a minimum sentence of six years and up to thirty years in Department of Corrections. Probation is not available in a Class X felony in Illinois.

The State offered a deal to Recardo Hill for a light sentence, if he would testify against my client, Alford and Company. The best offer the State made to Mr. Allen was that it would recommend a six-year jail sentence if he would plead guilty to the Class X felony. We elected to go to trial with a jury.

At trial, Keveyon Allen testified that the reason he lied to the police was because he feared criminal gang member Company more than he feared the police. He believed that if the gang found out he was snitching on Company, they would harm Keveyon's family. The jury returned a verdict of not guilty.

10. *Nathan Headley v. Jerry McVaigh, Village of West Salem*, Illinois, United States District Court for the Southern District of Illinois, 06_cv_4002-GPM

Nathan was a known methamphetamine addict. He inherited some farm property for

a grandparent. The farmland had a vacant, dilapidated house on it. Near dusk on January 2, 2005, Nathan had stopped at the property. Jerry McVeigh was the Chief of Police of the Village of West Salem. He spotted Nathan at his property and pulled into the drive. He approached Headley and asked him what he was doing. Nathan told him it appeared someone had broken the lock of the back door. McVeigh asked if he could help or if Nathan wanted to file a report. Headley told McVeigh that he had just repaired the lock and that nothing in the house had been disturbed.

McVeigh then left the scene. He called dispatch and verified that Headley's driver's license was suspended. He returned to the property. With him was a young Edwards County dispatcher who had no training in law enforcement or in handling firearms, Wesley Kuykendall. As the police pulled back into the driveway, Headley hid beneath an old, derelict truck. McVeigh gave Kuykendall an AR-15 rifle.

The two commenced searching for Headley. They found him hiding and ordered him to come out from under the truck. Headley complied and stood with his hands up and his back toward them. McVeigh determined Headley was unarmed. When Headley turned and saw the young dispatcher aiming a rifle at him, he panicked and began to run across the empty farm field. McVeigh yelled that he should stop running or they will shoot. Kuykendall then shot Headley in the back.

McVeigh asserted that the house was an active methamphetamine manufacturing site, and that justified the arrest and the use of force. Thereafter, someone with the Edwards County Dispatcher's office or McVeigh secreted certain portions of the printed version of the radio traffic between McVeigh and Edwards County Sheriff's Department that would have contradicted that version of events.

I asserted a claim on Nathan's behalf against Edwards County, Illinois. It tendered the limits of its insurance policy before suit had to be filed. I then sued the Village of West Salem and Jerry Joe McVeigh in federal court. The Defendants denied any liability and blamed it all on Kuykendall and the Edwards County Sheriff's Department. The case settled for a confidential amount shortly before trial

a. Kaskaskia Regional Port District

From approximately 1998 through 2003, I was general counsel for the Kaskaskia Regional Port District (K.R.P.D.). It is a Special District created by statute to oversee the navigable waterways of the Kaskaskia River running from the dam at Carlyle Lake down to the Mississippi. K.R.P.D. operates three commercial docks, recreational facilities and, while I was there, a rail line and switching locomotive. I worked with bond counsel to reissue bonds. I negotiated contracts for dock operations. I appeared before the Illinois Commerce Commission regarding our rail crossing and rail line. I worked with the U. S. Corps of Engineers on numerous matters. I advised the Board on all corporate and public governance issues.

b. Tyrone Irish Crystal

McGlynn & McGlynn were national counsel for Tyrone Irish Crystal headquartered in Dungannon, County Tyrone, Ireland, manufactured high quality leaded crystal on par with the more famous Waterford Irish Crystal. As the company grew, it wanted to expand its market throughout the United States. I drafted their national distribution contracts and helped formulate their marketing and sales approach based upon commercial law in the United States. Tyrone Irish Crystal was purchased by Tipperary Crystal in 2000.

c. Banking

McGlynn & McGlynn was general counsel for Bank of Belleville and Magna Bank of Belleville. From 1987 through approximately 1998, I was involved in all aspects of advising and representing the bank on litigation and corporate governance issues. I was either co-counsel or lead counsel in bankruptcy matters, multi-million dollars commercial disputes and several lender liability claims. McGlynn & McGlynn stopped representing the bank when Magna Group was sold to Union Planters.

I served as general counsel to the Village Bank of St. Libory handling mostly corporate governance matters and transactions involving its closely held stock.

I have never served or registered as a lobbyist.

I am vested in the Illinois Judicial Retirement System as a Tier 1 Judge. However, I still have to pay in approximately \$23,000.00 over the next 4 ½ years for previous years of service. Should I be appointed to the Federal bench, or die before that 4 ½ period, I or my spouse has 60 days to pay the balance into Illinois Judicial Retirement Fund to secure full benefits.

I may accept an approved teaching position if one is offered. However, I have no formal plans or commitments to pursue outside employment with or without compensation.

The only conflict of interest I have would be with any litigant represented by my brother, Michael L. McGlynn, who is in active practice in Illinois. While he is admitted to practice in the Federal District Court for the Southern District of Illinois, 95% of his practice is in State Court. I would recuse from any case in which Michael represented a party.

- b. Explain how you will resolve any potential conflict of interest, including the procedure you will follow in determining these areas of concern.

I will recuse myself in any case where there is a clear conflict. If there is not a true contact, but there is a relationship or connection to a party, I inform the attorneys and invite any feedback. I will recuse myself in any case as required by the federal recusal statute, and will consider requests on a case by case basis to maintain an appearance of impartiality.

Beginning in approximately 1997, I began handling legal matters for people who could not afford legal assistance at the request of Rev. Johnny Scott, President of the East St. Louis Chapter of the NAACP. It started out slow, a client or two a month. By 2000, I was on the phone weekly with Rev. Scott and had at least 10 engagements, at any given time, for the poor, indigent or victims of abuse. While I had several civil rights cases that actually resulted in my earning a fee, the vast majority were non-paying matters. I regularly defended individuals for free. In each of the last five or six years of my private practice, I would estimate that I performed well over 200 hours of free legal work for the NAACP and the people it served.

McGlynn & McGlynn also provided free legal work for an Order of Catholic Nuns during my time with the firm.

Sometime in December, 2018, I contacted Congressman Mike Bost's Office to express my interest in being considered for one of the two Federal judgeships opening up in the Southern District of Illinois. A staffer of Congressman Bost forwarded to me the questionnaire that needed to be answered to be considered. In early February, 2019, I provided my answers to the Senate Questionnaire to Congressman John Shimkus' Office. In early April, I was contacted by the Office of White House Counsel to schedule an interview. On April 23, 2019, I interviewed with attorneys from the Office of White House Counsel and the Office of Legal Policy. On May 1, 2019, I received a call from the White House Counsel's Office and participated in an approximately 40 minute interview regarding my background and personal information.

In May, I received a telephone call from Dan Swanson with Senator Dick Durbin's Office to let me know Senator Durbin wanted me to meet with his Screening Committee. In late May, I received a phone conference from Hon. Patrick Murphy (retired) Federal District Judge, Southern District of Illinois. Judge Murphy informed me that he was Chairman of Senator Durbin's Screening Committee and we arranged for me to meet with that Committee at the Federal Courthouse in Benton, Illinois, on June 20, 2019. On June 20, 2019, I met with Senator Durbin's Committee. On July 19, 2019, I was interviewed by Senator Tammy Duckworth concerning my efforts to be nominated to the Federal bench. On July 26, 2019, I met personally with Senator Dick Durbin at his office in Chicago. On Friday, September 20, 2019, I received a call from the White House Counsel's Office informing me that the White House would be moving forward in its consideration of me for appointment to the Federal district bench. Since that time, I have been in contact with attorneys from the Office of White House Counsel and the Department of Justice. On December 23, 2019, the President announced his intent to nominate me to this position.
