Slough*, 677 F. Supp. 112 (D.D.C. 2009). Following reversal in *United States v. Slough*, 641 F.3d 544 (D.C. Cir. 2011), the United States dismissed all charges against one defendant with prejudice, and retried the other defendants. The D.C. Circuit recently vacated the conviction of one of the defendants and remanded his case for a new trial, while remanding for resentencing the cases of three other defendants. *See United States v. Slatten*, 865 F.3d 767 (D.C. Cir. 2017).

On the military side, I have served in numerous capacities – as a legal officer, individual representative of Marines, legal counselor, investigating officer, and commanding officer with non-judicial punishment and convening authority powers and authority over judge advocates – while commanding nearly 1000 Marines and sailors during peace and combat operations. I also have provided legal representation, advice, and counsel while serving as a licensed attorney and Marine. More specifically, I have been actively involved in courts-martial, and offered my analyses of laws, orders, directives, and instructions at Marine Corps Headquarters. I have given my perspectives relating to the law of war and terrorism at the National Defense University relating to the law of war and terrorism and provided counsel to the Department of Defense Chief Information Office relating to cyberwarfare, the defense industrial base, and other classified matters.

On the civilian side, I juggled a full-time legal career with my military service for nearly 20 years.
