Dear Chairman Grassley:

Although it is very rare for the Republican Jewish Coalition to weigh in on judicial nominations, we are pleased to convey our strong support for President Trump's nomination of U.S. Attorney Rebecca Taibleson to serve as a Circuit Judge on the Seventh Circuit

As you know, Senate Democrats have engaged in unprecedented obstruction of President Trump's second term nominees, but remarkable GOP unity has defeated the obstruction time after time. Our continued success depends on GOP Senators continuing to thwart the Left's efforts to splinter us.

In nominating Ms. Taibleson, President Trump highlighted her service as a Clerk for Supreme Court Justices Antonin Scalia and Brett Kavanaugh and said that "Rebecca will make a fantastic Judge who will fearlessly defend the Constitution and strongly uphold the Rule of Law."
