My practice at Legal Source consisted of large-scale analysis of documents and other evidence in connection with Foreign Corrupt Practices Act (FCPA) litigation. This was my first position upon graduation from law school in 2005.

From 2006 to 2011, I was employed by General Dynamics Land Systems where I was heavily involved in all phases of federal government contracting, primarily in connection with United States Marine Corps programs. I was responsible for negotiation and management of federal government contracts relating to a significant military system design and development program and had a lead role in all government contract matters, including interpretation and application of the laws and regulations governing federal government contracts.

I joined Reznick Group in 2011, a national accounting firm with a substantial government practice. My practice expanded to include state and local government contracts, along with various other federal government agencies. I also handled a significant amount of contract drafting and negotiation with respect to private and public sector clients, as well as regulatory and compliance matters affecting public accounting firms. Reznick Group combined with J.H. Cohn in 2012 to create CohnReznick LLP.

At CohnReznick LLP, I provide counsel to the firm's management, partners and business units on a variety of matters. I am lead counsel on all government contracting issues, data security and privacy, and conflicts of interest (including those arising in the government contracting context). With respect to government contracts, I regularly provide counsel regarding government solicitations and proposals and negotiation and management of government contracts at the local, state, and federal levels. After having the benefit of almost a decade in the accounting industry, I have developed an understanding of accounting and financial principles and regularly provide counsel with respect to the laws, regulations, and standards governing public accounting firms. I also handle and provide counsel with respect to all aspects of commercial contracts in connection with the firm's extensive operations, including client contracts, vendor agreements, confidentiality agreements, and release letters. My practice in contracts spans from individual level contracts to extensive master service agreements for Fortune 100 companies. With respect to data security and privacy matters, I lead the firm's privacy committee and provide counsel with respect to compliance with various regulatory schemes governing data security and privacy.

My client throughout my legal career has been the legal entity by which I was employed as in-house counsel. The areas in which I have specialized include government and commercial contracts, regulations and standards governing public accounting firms, data security and privacy, and conflicts of interest.

I have served as lead in-house counsel in relation to disputes under federal and state government contracts and provided support with respect to internal preparation for litigation matters.

While at General Dynamics Land Systems, I served as a lead negotiator of a significant system design and development contract and assumed a lead role in the management of the resultant contract. In my position, I engaged in extensive negotiations with various contracting officers and program officials representing the United States Marine Corps. The subject matter of the negotiations and resultant contract involved complex engineering and technical elements. The negotiations extended for several months and resulted in a contract award.

At CohnReznick, I am regularly called upon to lead negotiations on large and small commercial and public sector contracts for a wide spectrum of services and other business relationships. Such negotiations often involve multiple internal and external parties with adverse interests and complex contractual terms governing liability, regulatory requirements, and dispute resolution. In addition to providing counsel with respect to contract negotiation and formation, I assist with resolution of contractual disputes that arise from time to time and drafting settlement agreements with the objective of avoiding litigation.

I also serve as lead counsel for all matters relating to CohnReznick's government and public sector group. Such matters involve government procurement activities by government agencies at the federal level, as well as in state and local jurisdictions across

the United States. I provide counsel to the firm's management and partners with respect to all phases of the government contracts life cycle, including solicitations, proposals, and contract negotiation and management.

I have not performed any lobbying activities.

2019. Senator Cassidy submitted a letter of recommendation to the White House Counsel's office on November 12, 2019. In March 2020, I interviewed with White House Counsel's Office. In late April 2020, I received a phone call from White House Counsel's Office notifying me that I had been selected as a preliminary candidate for nomination to the United States Court of Federal Claims. I have since been in regular contact with White House Counsel's Office and the Department of Justice Office of Legal Policy.
