In 1994, I was hired as an assistant district attorney and for approximately one year, I was handling mainly misdemeanor and traffic violations. Toward the end of 1995, I began to handle felony cases and participate in jury trials. I continued this work until April 2009 for two different District Attorney's Offices.

In 2009, I was hired as the Director of the Criminal Division at the Louisiana Department of Justice. Although I continued to prosecute some cases, this position was much more of an administrative role. I supervised approximately twenty prosecutors, over fifty investigators and approximately thirty support staff. I approved drafts of attorney general opinions, assigned all of the criminal cases to the various prosecutors, and consulted on various investigations conducted by the Louisiana Department of Justice.

In 2016, I left that office and returned to the 21<sup>st</sup> Judicial District Attorney's Office where I am the Chief Felony Prosecutor. I am now tasked with prosecuting approximately 250 felony cases a year in addition to handling many administrative duties. I assist with human resources issues, handle all asset forfeiture proceedings, consult with the line prosecutors regarding litigation issues and serve as the District Attorney's liaison with our local law enforcement agencies.

- ii. your typical clients and the areas at each period of your legal career, if any, in which you have specialized.

I have not specialized in any particular area. I have handled all types of cases including murder, sex crimes and robberies, as well as public corruption and white-collar crimes. My client throughout my career has been the State of Louisiana.

All of my practice has been involved in litigation and mostly criminal litigation. During the early years of being an Assistant District Attorney (1994-2007) I was in court every day. When I changed offices and went to the 21st Judicial District Attorney's Office, I was in court an average of twice a week. In 2009, when I became the Director of the Criminal Division at the Louisiana Department of Justice, I was in court much less frequently, approximately once a month. However, when I returned to the 21st Judicial District Attorney's Office in 2016, I begin going to court more frequently again, which is typically two or more times each week.

The defendant then fled to Kentucky after stealing their vehicle.

The defendant was found guilty of two counts of First-Degree Murder and was sentenced to two consecutive life sentences without the benefit of parole.

This case involved a contractor who was hired by several families throughout the Baton Rouge region to repair their homes after the historic floods in 2016. The two young daughters, now sixteen and twelve, were extremely grateful to receive justice for their mother's murder.

The defendant was found guilty of one count of Second-Degree Murder and was sentenced to life without parole.

I was lead counsel on this case and handled the majority of witnesses and the opening statements. My co-counsel was relatively inexperienced with these types of cases, so it was an excellent opportunity for me to mentor her and allow her to prepare a case for trial. She also handled some witnesses and gave part of the closing argument.

In my current position as the Chief Felony Prosecutor, I also serve as the drug court prosecutor for the 21st Judicial District Court. We meet weekly with the drug court judge and staff to evaluate how participants are progressing and discuss possible sanctions that the judge may find appropriate. While not everyone succeeds, and some go back to prison, the recidivism rate is much less for those who reach graduation. I have witnessed people who were addicts for decades, reconnect with their families, get stable employment, get their lives back on track, and remain clean and sober. Specifically, a couple of the defendants I referred to drug court have now completed their degrees and have become addiction counselors. This program has had a significant impact on the community.

As for lobbying activities, I have served on the Executive Council for the Louisiana District Attorneys' Association for the past six years. During each legislative session there are dozens of bills that affect the criminal justice system, and the Louisiana District Attorney's Association often wants to take a position on a particular bill. Because I live in Baton Rouge, and am in close proximity to the capital, I have been asked on occasion to travel to the capital to support or oppose various pieces of legislation on behalf of the Louisiana District Attorney's Association. This process mostly consists of filling out a card to submit to a committee to convey either support or opposition for a particular piece of legislation that reflects the Association's position. On one, or perhaps two, occasions I have testified to provide additional information that a legislator might have requested on a particular bill; however, I do not remember the specific topics of discussion.
