Approximately 200 letters were sent by the U.S. Mail system to persons in Lafayette, Louisiana and surrounding areas containing a white powdery substance (that appeared similar to anthrax), bomb threats, and rambling diatribes about politics, child abuse, and terrorism. Ran Mesika, a 22 year-old Israeli student visiting family in the United States, was driving across the country, starting from San Diego, CA, with over \$120,000.00 worth of jewelry he intended to sell as he traveled across the country. He picked up a man that he believed to be a hitchhiker. The "hitchhiker" that Mesika picked up was actually an inmate from a Colorado state prison who had recently escaped. The defendant had spent several days with Mesika in the van before taking control of the van, the jewelry and of Mesika himself. Sometime after the defendant took control of the situation, Mesika was murdered. Prior to trial, I led efforts along Interstate Highway 10 in Louisiana to search for the victim's remains. The defendant was convicted of the carjacking and murder of the student and was sentenced to life imprisonment. After the trial, I assisted in locating the body of the student and the transportation of evidence to the FBI lab.

In this case, I represented the United States in its suit against Ferrand, the owner of "Mr. Ed's Tax Service," and his employees, for preparing and filing fraudulent tax returns and deductions schedules with the Internal Revenue Service ("IRS"). Ferrand, as the owner and operator of Mr. Ed's Tax Service, hired, trained and supervised tax preparers employed at Mr. Ed's, including co-defendant Kennedy. Ferrand, Kennedy and other co-defendants prepared income tax returns and amended prior year returns by inflating Schedule A deductions and creating false Schedule C businesses in order to increase taxpayers' refunds. The defendants prepared more than three thousand returns spanning over 26 states and generating refunds in excess of \$6 million. I tried the case to a guilty verdict from the jury. Ferrand was sentenced to 60 months in prison and ordered to pay \$255,890 in restitution to the IRS; Kennedy was sentenced to 27 months in prison, and ordered to pay \$39,020 in restitution to the IRS.

I provide pro bono criminal defense services. The last case in which I provided pro bono services was *State of Louisiana v. Paul Rice*. The case was opened in March 2017 and closed in May 2018. The charges stemmed from allegations of racketeering by an alleged gang in Abbeville, LA. The State of Louisiana charged Rice and approximately 13 other individuals as members of an alleged racketeering organization that undertook drug trafficking, assaults, and murder. My client ultimately pled guilty to a racketeering count but was released due to time served in custody. I provided 103 hours of representation services pro bono.

Another case in which I recently provided pro bono services was *State v. Kimberly Stinson* (shoplifting). The case involving Kimberly Stinson was relatively minor, requiring me to assist her in meeting her agreed upon conditions of deferred adjudication.

Additionally, I have provided legal advice to those who cannot afford counsel. These pro bono matters are typically persons who call me (based upon a referral from others) for limited advice on a personal legal matter.
