Response of David Weiss to Questions for the Record for U.S. Attorney Nominees From Ranking Member Dianne Feinstein

I did not retain detailed records of the United States Attorney selection process. My best recollection of the process is set forth below.

As of March 2017, I was the Acting United States Attorney for the District of Delaware pursuant to 5 U.S.C. § 3345(a)(1). In June 2017, I received a call from Senator Carper's office asking if I was interested in the United States Attorney position. I interviewed with staff for Senators Carper and Coons on June 28, 2017. On July 21, 2017, I met with Senator Coons. I subsequently spoke with Senator Coons by phone in late August, and with Senator Carper on September 29, 2017. In August 2017, I interviewed at the Department of Justice, including with Deputy Attorney General Rosenstein on August 31, 2017. Thereafter, I cooperated with a background investigation and completed a Senate Judiciary Committee questionnaire, as well as other forms. During the process, I had multiple contacts with Department of Justice employees in order to complete paperwork and handle logistics. On December 1, 2017, President Trump nominated me for the position of United States Attorney for the District of Delaware.

No one involved in the process of selecting me as a United States Attorney nominee has asked me to make any representations or commitments as to how I would handle a particular case, matter or investigation if confirmed as United States Attorney; nor did I make any representations in this regard. No one involved in the process of selecting me as a United States Attorney nominee has discussed with me the investigation led by Special Counsel Mueller, whether I would terminate Special Counsel Mueller as Special Counsel, the firing of James Comey, or the Justice Department's order of succession. No one, at any point during the process, has asked me to commit that I would be loyal to President Trump or Attorney General Sessions, nor have I made such commitment. If I am fortunate enough to be confirmed as United States Attorney for the District of Delaware, my only loyalty will be to the Constitution, the rule of law, and the people of the United States and Delaware.
