Justices on the Supreme Court of Texas are elected in statewide partisan elections to six-year terms. Vacancies on the court are filled through appointment by the Governor and confirmation by the Texas Senate. I was appointed to the Supreme Court of Texas on August 24, 2005 by Governor Rick Perry to fill a vacancy on the Court. I successfully ran for election to the Court in 2006 and reelection in 2012. My current term expires on December 31, 2018.

The Supreme Court of Texas has statewide final appellate jurisdiction in civil and juvenile cases. For the most part, the Court's review is discretionary whereby the Court entertains a petition for review from final judgments of Texas courts of appeal.

Because I have not been a trial judge or Chief Justice of the Supreme Court of Texas, I have not presided over any cases. As a justice on the Supreme Court of Texas I have participated in the disposition of approximately 1,100 cases where the Court has granted a petition for review. Moreover, as of October 10, 2017, the Supreme Court of Texas has granted petitions for review, but has not heard arguments, in approximately 50 cases.

1. *Hegar v. Tex. Small Tobacco Coal.*, 496 S.W.3d 778 (Tex. 2016).

A coalition of cigarette manufacturers, retailers, and distributors brought suit challenging a Texas statute imposing a tax on tobacco companies that did not enter into the settlement agreements that resulted from the nationwide tobacco litigation of the 1990s. The coalition specifically claimed the tax, directed at a particular class of companies, violated the Equal and Uniform Clause of the Texas Constitution and the Equal Protection and Due Process Clauses of the United States Constitution. The trial court held the tax unconstitutional on all three grounds, but the court of appeals affirmed on only the Equal and Uniform Clause ground. The Supreme Court of Texas unanimously held the tax was constitutional under the Equal and Uniform Clause of the Texas Constitution because the classification of non-settling tobacco companies and settling tobacco companies was rational, and the tax scheme was reasonably related to the goals of recovering healthcare costs and reducing underage smoking. The settling companies, for example, bore a financial burden for health-related costs caused in part by the actions of the non-settling companies. The settling companies also operated under restrictions the non-settling companies escaped by avoiding settlements with the State of Texas. Thus, the Court explained, the classifications created by the tax scheme were not unconstitutionally arbitrary or unreasonable.

2. *Morath v. Tex. Taxpayer & Student Fairness Coal.*, 490 S.W.3d 826 (Tex. 2016).

A plaintiff group comprised of Texas school districts, charter schools, and various individuals brought suit to challenge the constitutionality of the Texas school finance system. The plaintiffs alleged the system violated state adequacy and suitability requirements, imposed an unconstitutional *ad valorem* tax, and violated the financial and qualitative efficiency requirements of the Texas Constitution. Applying decades of precedent on the issue, the Supreme Court of Texas upheld the constitutionality of the state's legislatively created school finance system. First, the Court reversed the trial court's adequacy and suitability findings, holding that the petitioners did not present sufficient evidence to demonstrate that the finance system was, as a constitutional matter, inadequate for failing to achieve a general diffusion of knowledge or unsuitable in its design for achieving such diffusion. Next, the Court held that petitioners failed to proffer evidence demonstrating either that the system was so financially inefficient as to be unconstitutional or that it imposed a statewide *ad valorem* tax. Finally, the Court upheld the trial court's rejection of the qualitative efficiency claims.

J & D Towing sued American Alternative Insurance Corporation for loss-of-use damages when a motorist struck the company's sole tow truck, rendering it a total loss. The insurance company argued that, under Texas law, loss-of-use damages were recoverable for partially destroyed property but not for property that had been totally destroyed. The trial court rendered judgment in favor of J & D and awarded loss-of-use damages. The appeals court, however, reversed and rendered judgment for the insurance company, holding Texas law did not permit the recovery of such damages. The Supreme Court of Texas surveyed precedent throughout the country before adopting the rule that loss-of-use damages are indeed recoverable in total-destruction cases. The unanimous Court adopted this rule in accordance with the modern trend, explaining that the ultimate goal of tort damages is to make the plaintiff whole.

Individuals practicing commercial eyebrow threading and the salon owners employing them brought a declaratory judgment action asserting that, as applied to them, Texas's licensing regime for eyebrow threaders violated the Texas Constitution's due course of law provision. They claimed that most of the 750 hours of training Texas required were unrelated to public health and safety. The trial court and court of appeals ruled for the State. The Supreme Court of Texas reversed and remanded for further proceedings, holding that the threaders had met the high burden under the Texas Constitution of demonstrating that Texas's licensing requirements, as applied to them, were "not just unreasonable or harsh," but "so burdensome as to be oppressive." The Court concluded the licensing regime was "so unreasonably burdensome that it becomes oppressive in relation to the underlying governmental interest." I wrote a concurring opinion to discuss the Court's "rational basis with bite"-type test. "Nobody seriously disputes a state's omnibus power to safeguard its citizens' health and safety via economic regulation," I wrote. Such police power is broad and valid, and under the Texas Constitution, the burden rests on those asserting unconstitutionality to show that the means chosen lack a rational relationship to a legitimate government interest.

In this libel case about allegedly defamatory statements published on a website, the court of appeals held that because a website's "primary business" was not reporting the news, it did not qualify as "electronic media" under Texas law. The electronic media classification is significant because it provides a right to immediately appeal orders that burden free-speech or free-press rights. Absent a direct statutory definition, however, Texas courts of appeals had split on how to determine whether a website counts as electronic media. Some courts had used a multi-factor test, while the court of appeals in this case focused on whether news reporting was the website's "primary business." Petitioners and several amici curiae argued that because the statute aimed to protect those "engaged in disseminating news to a mass audience via electronic means," the electronic media designation should not turn on a website's primary or profit-driven purpose. Noting that digital news outlets are increasingly integral to how citizens consume news, I dissented from the Court's denial of the petition for review. I urged the Court to bring uniformity to an important, fast-changing area of law by clarifying who qualifies as a member of the electronic media: "We should not countenance vague and varying approaches that invite inconsistency and thus unpredictability—not when free-speech and free-press rights are implicated."

6. *El-Ali v. State*, 428 S.W.3d 824, 825 (Tex. 2014) (Willett, J., dissenting to the denial of the pet. for review).

El-Ali still held title to his Chevy Silverado when its buyer – who was making payments on the truck – was arrested for driving it while intoxicated, as well as for evading arrest and possessing cocaine. Following the arrest, the State seized the Silverado and filed a civil-forfeiture action. Under Texas law, the State may seize private property if it demonstrates by a preponderance of the evidence that the property is contraband. A property owner may then recover the property only if he proves he “did not know or should not reasonably have known of the [allegedly criminal] act or omission.” El-Ali argued that a property-owner’s heavy burden to prove innocence in a civil forfeiture case violates due process under the Texas Constitution, but the Texas Supreme Court denied his petition for review. I dissented from the Court’s denial of the petition for review and urged the Court, which had last considered a forfeiture case in 1957, to determine whether modern forfeiture practice comports with the Texas Constitution.

7. *Strickland v. Medlen*, 397 S.W.3d 184 (Tex. 2013).

The owners of a mistakenly euthanized dog brought suit against the employee of an animal shelter for causing the dog's death, seeking to recover "sentimental or intrinsic value" damages. The trial court dismissed the suit on the grounds that Texas bars the recovery of such damages. The court of appeals, however, reversed, holding for the first time that a dog owner may recover intangible loss-of-companionship damages in the form of intrinsic or sentiment-based damages. The Supreme Court of Texas unanimously reversed and held that, in the absence of legislation to the contrary, recovery in pet-death cases is limited to economic loss and does not include loss of relationship. The decision rested on a long line of Texas precedent that classifies pets as property, and notes input from various animal welfare experts that expanding tort liability in such cases would impose unintended harmful consequences and actually have negative effects on animal health in Texas communities.

8. *In re Reece*, 341 S.W.3d 360, 377 (Tex. 2011) (Willett, J., dissenting).

Participating as a witness in a civil proceeding, Reece lied under oath during a deposition, was held in criminal contempt, and sentenced to confinement. Reece petitioned for a writ of habeas corpus, which he pursued up to the Texas Court of Criminal Appeals (Texas's court of last resort for criminal matters). The Court of Criminal Appeals declined to act on Reece's petition, reasoning that, while it had jurisdiction to grant relief, the Supreme Court of Texas was the proper tribunal because the underlying matter (in which Reece committed perjury) was civil. Reece then filed a mandamus petition with the Supreme Court of Texas, arguing the trial court's order of contempt deprived Reece of due process. The Supreme Court of Texas noted mandamus relief requires showing (1) the trial court abused its discretion, and (2) the relator has no adequate remedy by appeal. The Court held that the trial court abused its discretion because perjury committed in a deposition is punishable by contempt only if the perjury obstructs the Court in the performance of its duties, and Reece's perjury did not do so. The Court also held Reece had no adequate remedy on appeal under the circumstances. I dissented, arguing that because the Court plainly lacked jurisdiction to hear Reece's habeas petition stemming from the contempt order, the Court should not hear the same habeas petition restyled as a mandamus petition. I further reasoned that Texas precedent dictated that (1) habeas, not mandamus, is the proper vehicle for challenging a contempt order, and (2) mandamus is especially improper for challenging a criminal contempt order involving confinement. I concluded that the criminal high court, which had earlier acknowledged it "does have the authority to act in this case," should decide matters of criminal confinement.

9. *Robinson v. Crown Cork & Seal Co., Inc.*, 335 S.W.3d 126, 150 (Tex. 2010) (Willett, J., concurring)

Barbara Robinson filed suit against Crown Cork & Seal Co. under a theory of successor liability, alleging that her husband had contracted mesothelioma from workplace exposure to asbestos products. Crown did not initially contest its successor liability, and a trial court granted Robinson's motion for partial summary judgment on that issue. But around the same time, the Texas Legislature enacted Chapter 149 of the Texas Civil Practice and Remedies Code, limiting certain corporations' successor liability for asbestos claims. In light of this legislation, Crown moved to have the court's order establishing successor liability vacated and moved for summary judgment on that issue. The trial court granted the motion. On appeal, Robinson contended that Chapter 149 was a retroactive law prohibited by the Texas Constitution. But the court of appeals affirmed the trial court's summary judgment grant, explaining that the law was a valid exercise of the Legislature's police power to safeguard the public safety and welfare. The Supreme Court of Texas reversed, concluding that Chapter 149 could not overcome the Texas Constitution's ban on retroactive laws. I agreed with the majority and wrote in concurrence to emphasize that the case raised important issues of how the Texas Constitution allocates governing power, including the ban on retroactive laws enshrined in our state Bill of Rights.

Reynolds sued Bennett and Bennett's company for wrongly selling thirteen Reynolds sued Bennett and Bennett's company for wrongly selling thirteen head of Reynolds's cattle, and a civil jury found against Bennett on a conversion count. The jury assessed roughly \$5,000 in actual damages and an additional \$1.25 million in exemplary damages. Bennett and his company appealed, arguing that the exemplary damages were not justified and that, even if they were, the ratio of exemplary damages to actual damages was so great as to constitute a deprivation of due process under the Fourteenth Amendment to the United States Constitution. The Supreme Court of Texas unanimously agreed with the court of appeals that the exemplary damages were justified but, applying United States Supreme Court precedent, held that the amount of exemplary damages was unconstitutional. The Court reached this result by applying a three-part test articulated by the United States Supreme Court for determining whether the disparity between actual damages and punitive damages is grossly excessive and therefore tantamount to a deprivation of due process. Applying Texas civil practice rules, the Court also held the corporation, as such, could be assessed exemplary damages.

When I first joined the Supreme Court of Texas, I did not participate in a number of cases that were ready for disposition because I did not want to delay issuance.

In considering whether to recuse myself, I review each matter to ensure I do not have an actual or apparent conflict of interest. A list of cases where I recused myself *sua sponte* is supplied at Appendix 14.

Where a party requests the recusal of a justice of the Supreme Court of Texas, my Court's practice is to send the recusal motion to the pertinent justice first. Only if the justice declines to recuse does the full court discuss the motion and vote (with the justice subject to the motion out of the room).

My recusal has been sought by motion in two cases. In *Grigson v. Farmers Grp., Inc.* (15-0775) the petitioner requested that I and a colleague recuse ourselves because related proceedings had involved the Attorney General's Office during our service there roughly a decade earlier. Both my colleague and I agreed to recuse.

In *Barr v. City of Sinton* (06-0074), the respondent moved that I recuse myself because: (1) the case involved religious liberty issues, and I had spent part of my pre-judge legal career on such issues; (2) the case involved a statute I was tasked with shepherding ten years earlier as a lawyer for then-Governor Bush, my client; and, (3) I was friends with petitioner's counsel. I applied customary recusal and disqualification guidelines, looking to the letter and spirit of all relevant authorities, and also researched my court's historical practice, as well as recusal policy and practice at the United States Supreme Court. I declined to recuse myself. The remaining justices denied the motion.

I have contributed to several significant non-litigation matters, on both the state and federal levels, while serving in the Governor's Office, the White House, the Justice Department, and the Texas Attorney General's Office:

Texas Governor's Office: I helped advance Governor Bush's priorities across a wide range of legal and policy issues. One significant example is the Texas Religious Freedom Restoration Act, a 1999 religious liberty bill backed by ideologically disparate groups and passed by overwhelming bipartisan majorities in both chambers.

White House: I served on the Domestic Policy Council and, as Director of Law and Policy in the White House Office of Faith-based and Community Initiatives, advised President Bush and the White House principally on religious liberty matters, including the President's effort to strengthen the nation's philanthropic sector and to promote the indispensable work of neighborhood helpers and healers.

Justice Department: My chief responsibility was assisting with President Bush's judicial selection and confirmation efforts. I also helped supervise various civil and criminal justice policy initiatives, including what became the Prosecutorial Remedies and Other Tools to end the Exploitation of Children Today Act of 2003 (the "PROTECT Act"). The PROTECT Act "comprehensively strengthens law enforcement's ability to prevent, investigate, prosecute, and punish violent crimes committed against children." Finally, I assisted administration efforts to expedite the naturalization process for noncitizen military service members.

Texas Attorney General's Office: I served as chief legal counsel to the state's chief legal officer, advising the Attorney General on the full array of major legal issues confronting Texas. While in private practice, I was privileged to qualify for membership in the Pro Bono College of the State Bar, which "recognizes attorneys who

have far exceeded the State Bar's aspirational pro bono goal in their efforts to address the vast unmet legal needs of the poor." The most significant pro bono matter I helped handle was the interracial adoption case discussed above in response to question 17.

On February 3, 2017, I received a call from Noah Phillips, Chief Counsel to U.S. Senator John Cornyn, asking if I would like to be considered for a vacancy on the Fifth Circuit. On February 17, I interviewed with the Texas Federal Judicial Evaluation Committee. On March 1, I interviewed with Senator Cornyn in Washington, D.C. On March 2, I interviewed with Senator Cruz in Washington, D.C. Later in March, I spoke with the White House Counsel's Office, and then again in April I spoke with the White House Counsel's Office. Since then, I have had periodic communications with that office, the Office of Legal Policy at the Department of Justice, and the offices of Senators Cornyn and Cruz. On September 22, I received a call from the Vice President informing me that the President intended to nominate me. On October 3, 2017, the President submitted my nomination to the Senate. I have communicated regularly with the Office of Legal Policy in the preparation of my answers to this questionnaire and the completion of other related materials.

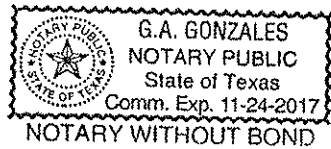
