I have served as a judge on the Court of Common Pleas of Philadelphia County since January 1996 after being elected by the citizens of Philadelphia County to serve a ten-

year term in November 1995. I was retained in November 2005. Courts of Common Pleas are the trial courts of the Commonwealth of Pennsylvania and they have general jurisdiction over a wide variety of civil and criminal matters. Judicial service in the Philadelphia Court of Common Pleas is divided into three divisions: the Trial Division, which handles both civil and criminal matters; Family Court, which includes all domestic relations and juvenile justice; and Orphans Court, which handles all matters dealing with estates. I have served in the Trial Division during all of my time on the Common Pleas Court and have presided over a variety of civil and criminal matters.

I have presided over approximately 2,300 cases. Ms. Roscioli suffered from a stroke that caused paralysis, leaving her wheelchair bound, speech impaired, and legally blind. She then hired a home healthcare aide who became her primary caretaker and the caretaker of her two children. This home healthcare aide was ultimately arrested and convicted of fraud perpetrated against the plaintiff in a separate criminal case.

Ms. Roscioli then brought a personal injury action against the home healthcare aide, alleging that she had been abused and manipulated into remaining silent while the home healthcare aide committed fraud and stole from her. She also brought an action against Maxim Healthcare Services, Inc. and Jewish Employment and Vocational Services, Inc., alleging that these entities failed to supervise and develop an adequate care plan.

After a four-day jury trial, the jury found in favor of the defense. The plaintiff filed a motion for post-trial relief arguing that the verdict was against the weight and sufficiency of the evidence and that the verdict was inconsistent. I denied the motion. The superior court affirmed on appeal.

I sentenced the defendant to 20 ½ to 41 years' incarceration, and I denied the defendant's post-conviction motion. The conviction and sentence were affirmed on appeal.

Taylor v. L.A. Fitness International LLC, 16 Pa. D. & C.5th 491 (C.P. Phila. August 30, 2010). Plaintiff sued L.A. fitness after suffering an injury during a personal training session. I granted summary judgment for the defendant, upholding the validity of an exculpatory clause contained within an application for membership and for personal training services. The Superior Court reversed, holding that the warnings regarding waiver of rights contained within the agreement were not sufficiently highlighted. A copy of the unpublished Pennsylvania Superior Court opinion is supplied.

Commonwealth v. Rodriguez, CP-51-CR-0005228-2007 (C.P. Phila. March 8, 2010). A jury convicted the defendant and his co-defendant of sexually assaulting a woman on a baseball field. The Superior Court reversed my decision excluding evidence of the victim's prior charge for retail theft and ordered a new trial on remand. Copies of my opinion and the unpublished Pennsylvania Superior Court opinion are supplied.

Commonwealth v. Bookard, Nos. 0774 & 0775, 2001 WL 36125866 (C. P. Phila. December 19, 2001); 2005 WL 6067917 (C. P. Phila. November 10, 2005), *rev'd*, 1643 EDA 2005 (Pa. Super. Ct. August 14, 2006), *on remand*, Findings of Fact Conclusions of Law denying PCRA petition (C.P. Phila. July 17, 2007), *rev'd*, 1557 EDA 2007 (Pa. Super. Ct. July 29, 2008), *aff'd*, 978 A.2d 1006 (Pa. Super. Ct. 2009) (affirmed on reargument), *appeal denied*, 605 Pa. 706 (2010). After I denied the defendant's petition for Post-Conviction Relief Act without a hearing, the defendant appealed. The Pennsylvania Superior Court reversed and remanded for an evidentiary hearing on the petition. After conducting the evidentiary hearing, I again denied the petition for post-conviction relief and the petitioner again appealed to the Pennsylvania Superior Court. Although a three-judge panel reversed my decision, the Pennsylvania Superior Court affirmed my decision en banc. The Pennsylvania Supreme Court denied the petitioner's appeal. Copies of my July 2007 Opinion and the unpublished Pennsylvania Superior Court opinions are supplied.

Gallagher v. Hyster Co., No. 002875, 2008 WL 7898824 (C. P. Phila. September 24, 2008); Opinion for appeal (C.P. Phila. July 14, 2009). The plaintiff was a warehouseman who was injured when he was struck by a forklift. He brought a product liability action against the manufacturer and distributor. I granted summary judgment in favor of the defendants based on the holding of *Arnoldy v. Forklift L.P.*, 927 A.2d 257 (Pa. Super. Ct. 2007) (applying the preemption doctrine to a similar forklift accident). On appeal, the Superior Court reversed based upon the recent overruling of *Arnoldy*. Copies of my opinion and the Pennsylvania Superior Court opinion are supplied.

Myers v. Centralized Comprehensive Human Services, No. 003864, 2009 WL 7115055 (C. P. Phila. July 15, 2009); 2010 WL 497392 (C. P. Phila. January 11, 2010). I granted summary judgment in favor of defendant landlord out of possession, finding insufficient evidence for the case to proceed to trial. The Superior Court reversed and remanded the case for trial. A copy of the unpublished Pennsylvania Superior Court opinion is supplied.

Tabron v. Rite Aid Corp., No. 2914, 2008 WL 2090800 (C. P. Phila. February 15, 2008). The plaintiff filed suit against the defendant for false imprisonment and assault following an incident wherein he was charged with shoplifting by a security guard. Judge Patricia A. McInerney was assigned to rule upon pre-trial motions in the case. She granted partial summary judgment, preventing plaintiff from proceeding on certain grounds. The case was then assigned to me for trial on the remaining issues. The jury found in favor of the defendant, and I denied plaintiff's motion for post-trial relief. The Superior Court vacated the judgment, holding that the prior judge's grant of partial summary judgment was in error, and remanded for new proceedings. A copy of the unpublished Pennsylvania Superior Court opinion is supplied.

Morris v. DiPaolo, No. 2236, 2005 WL 4979128 (C. P. Phila. November 3, 2005); 2006 WL 6655967 (C. P. Phila. May 12, 2006), *rev'd*, 930 A.2d 500 (Pa. Super. Ct. 2007). This lawsuit between two attorneys involved an allegation of the wrongful use of civil proceedings. Prior to trial, another judge granted the plaintiff's motion for partial summary judgment on the issue of liability. I held a trial to assess damages. The jury issued an award of \$47,000 to plaintiff, and I assessed further damages pursuant to a prior order and outstanding contempt petition. I then denied defendant's motion for post-trial relief. On appeal, the Superior Court vacated the previous judge's grant of summary judgment and remanded for a new trial on all issues.

Hall v. Schwartz M.D., March Term, 2002 No. 1933 (C.P. Phila. November 8, 2004). The plaintiff brought a medical malpractice action against a doctor and an incorporated medical care facility arising from a hysterectomy. The jury found in favor of the defendants and the plaintiff appealed. The Superior Court held that I erred by allowing the defendants—through their witnesses and counsel—to refer to plaintiff's subsequent physical ailments and conditions. Copies of my opinion and the Pennsylvania Superior Court opinion are supplied.

Vitetta v. Wackenhut, May Term, 2002 No. 3787 (C.P. Phila. June 9, 2004). The defendant was a private corporation retained by the Delaware County Board of Prison Inspectors to develop and renovate prison facilities. The plaintiff, an architectural firm, filed a contract claim against the corporation. I ordered the matter transferred to Delaware County. The Superior Court reversed, holding in part that the defendant failed to request transfer to Delaware County when it filed its first preliminary objections. Copies of my opinion and the Pennsylvania Superior Court opinion supplied.

Commonwealth v. Fletcher, March Term, 1992 No. 6001-6004 (C.P. Phila. June 9, 2004), *rev'd*, 896 A.2d 508 (Pa. 2006), Opinion on remand (C.P. Phila. February 4, 2008), *aff'd*, 986 A.2d 759 (Pa. 2009). The defendant was sentenced to death for murder. I granted the defendant's Post-Conviction Relief Act petition and awarded a new trial based on the failure of trial counsel to present compelling exculpatory testimony from Dr. Park, the pathologist who performed the decedent's autopsy, and the failure to expose a critical error by the testifying pathologist, Dr. Hood. The Pennsylvania Supreme Court reversed on appeal and remanded for consideration of remaining issues. I denied the remainder of defendant's claims, and the Pennsylvania Supreme Court affirmed. Copies of my opinions are supplied.

Commonwealth v. Dillon, July Term, 2001 No. 0626 1/1 (July 22, 2002), *rev'd*, 863 A.2d 597 (Pa. Super. 2004), *aff'd*, 925 A.2d 131 (Pa. 2005). This case involved allegations of rape and molestation of a teenage victim by her mother's paramour. I granted defendant's motion in limine to exclude evidence of the victim's subjective fear of the defendant to explain the victim's delay in reporting the sexual abuse, unless the defendant raised the lack of a prompt report in his case in chief, whereupon the Commonwealth could elicit this evidence in rebuttal. The Commonwealth appealed. The Superior Court reversed and the Supreme Court of Pennsylvania affirmed the reversal. A copy of my opinion is supplied.

Commonwealth v. Watts, Nos. CP-51-CR-0711931-2000 & CP-51-CR-0712001-2000, 2008 WL 7242061 (C. P. Phila. August 22, 2008); *aff'd*, 981 A.2d 325 (Pa. Super. Ct. June 1, 2009), *rev'd*, 23 A.3d 980 (Pa. 2011). Following a capital murder trial, the defendant was convicted of first degree murder and sentenced by the jury to life imprisonment. He filed a timely direct appeal which was not acted upon when his counsel failed to file a docketing statement. The defendant filed a *pro se* Post-Conviction Relief Act petition seeking reinstatement of his appeal rights. I appointed new counsel and then dismissed the petition as untimely. A Superior Court panel affirmed. The defendant did not appeal that decision. Instead he filed a second petition for post-conviction relief. I denied this petition as untimely. A different Superior Court panel reversed and remanded this case for further proceedings. The District Attorney's Office then appealed to the Supreme Court, which reversed the Superior Court, thereby reinstating my decision. A copy of my November 2, 2004 opinion and the unpublished Pennsylvania Superior Court opinions are supplied.

Mager v. Salmons & Falco, No. 1532, 2000 WL 35500670 (C. P. Phila. November 8, 2000), *rev'd sub nom.*, *Mager v. Bultena*, 797 A.2d 948 (Pa. Super. Ct. 2002). A former law firm brought a claim for breach of contract and quantum meruit against a former employee's new law firm and its former client that had discharged the former law firm and transferred the case file. The former law firm claimed entitlement to counsel fees received by the former employee's new law firm as a result of the former employee's representation of the former client in

settlement of a qui tam case. I heard the matter in a non-jury trial and denied recovery on the breach of contract claim but did award damages on the quantum meruit claim, based upon a percentage of the contingent fee agreement that had originally been agreed to with the former client. Upon appeal, the Superior Court agreed that plaintiff could recover on the quantum meruit claim, but reversed because it disagreed with the manner in which I had calculated damages. The Superior Court found that plaintiff's award should have been calculated by the number of hours devoted by the plaintiff's firm to the cause of the former client, a position I considered but disregarded because the former employee did not keep credible time records. The Superior Court indicated that plaintiff had the burden of pleading and proving fraud in the calculation of hours by its former employee and in absence of such proof, the correct calculation was based upon the number of hours devoted to the cause of the client.

The overwhelming majority of my opinions are unpublished and do not appear in an official bound publication. In the Pennsylvania Court of Common Pleas, judges only author opinions in cases when an appeal is filed. After completion of the opinion, it is filed with the Appeals Unit of the Office of the Prothonotary of the Court of Common Pleas of the First Judicial District of Pennsylvania and maintained in the case file as part of the official record. Occasionally the Pennsylvania District and County Reports or the Philadelphia Legal Intelligencer or some other publication may decide to select one of my opinions for publication in their official bound volumes. Additionally, the Philadelphia Law Library or other electronic databases have on occasion uploaded and collected electronic versions of some of my opinions.

The civil trial division to which I am assigned employs a case management system whereby cases ready for trial are assigned by a team leader. After assignment, if a party asks me to recuse myself, I will consider the request in light of the provisions of the Pennsylvania Code of Judicial Conduct governing the disqualification of judges. If warranted, I will hold a hearing to further consider the matter before making my ruling. If for some reason I discover that a potential conflict exists in the course of my handling of a matter, my practice is to disclose the potential conflict to all counsel and allow them the opportunity to make a motion for recusal. If I recuse myself from handling a matter, I will send the case back to the team leader. I will not, however, keep a record of the case. I have not received many recusal requests.

Although I do not recall the name of the cases or parties, I have listed below those cases that I recall in which a request was made or in which I decided to recuse *sua sponte*.

In approximately 2011, a case was assigned to me that involved a parishioner who had filed suit against her pastor and her church, claiming the pastor had taken advantage of her. Although I thought I could have fairly presided over the matter, I recused myself in light of my position as a deacon at a church where a former parishioner had filed a similar suit which was then pending (*Bellamy v. Sharon Baptist Church*, No. 03399).

In approximately 2011, I was assigned to preside over a bench trial involving the Philadelphia Redevelopment Authority. I sent the case back to the civil trial division because I felt my prior employment as deputy executive director and general counsel of the Philadelphia Redevelopment Authority might be viewed as a conflict of interest.

In approximately 2010 an automobile accident case was assigned to me for trial by jury. Defense counsel joined an additional defendant who was represented by an attorney who had previously represented me in claims relating to an automobile accident. It was not clear at that point that joinder was permissible, nor was it clear the additional defendant would remain in the case. I immediately disclosed the potential conflict to counsel. Defense counsel requested that I recuse myself and I returned the case to the team leader.

On two separate occasions in 2000, a case was assigned to me where I was approached by defense counsel, who advised that my cousin had recently separated from employment with counsel's firm. Counsel advised me that my cousin had ultimately sued the firm and that this situation presented a conflict for me in presiding over the cases. Although I had no knowledge of the litigation or that my cousin had even been involved in a controversy with the firm, I immediately sent the cases back to the team leader.

I was appointed General Counsel of the Philadelphia Redevelopment Authority in 1990 by its board of directors, with the approval of Philadelphia Mayor W. Wilson Goode. I held this position until 1995.

I have been an unsuccessful candidate for the Pennsylvania Superior Court three times: in the May 2009 primary election, the November 2007 general election, and the May 2007 primary election. In the May 1983 primary election, I was an unsuccessful candidate for the Philadelphia City Council, Third District.

In 1984, I was elected to the position of committeeperson for the Philadelphia Democratic City Committee, Ward Executive Committee, Third Ward, Seventeenth Division, during the closed primary election. As a committeeperson, I distributed campaign literature and advised voters of Democratic Party candidates on Election Day. I resigned in 1985 upon commencement of my employment with the Philadelphia Redevelopment Authority.

From 1982 to 1985, I had a solo law practice. I concentrated in criminal law, family law, and providing legal counsel to small non-profit organizations.

From 1985 to 1990, I handled all manner of services for the Philadelphia Redevelopment Authority ("the Authority"), including answering routine questions for the board of directors and the executive director, negotiating with condemnees, representing the Authority before the Board of View, drafting contracts, handling litigation in the court of common pleas, and negotiating and managing tax credit real estate deals, among other legal activities. From 1990 to 1995, I supervised legal operations in my capacity as deputy executive director and general counsel.

From March to December 1995, I was of counsel at Vance, Jackson, Simpson and Overton. I handled general real estate and contract matters for a small law firm.

- ii. your typical clients and the areas at each period of your legal career, if any, in which you have specialized.

As a solo practitioner from 1982 to 1985, my typical clients were individuals and small non-profit corporations. From 1985 to 1995, my sole client was the Philadelphia Redevelopment Authority, which I advised on a range of matters relating to local governmental property issues for small corporation clients. From March to December 1995, I handled real estate and contract matters for small corporate clients of the Vance, Jackson, Simpson and Overton law firm.

As a solo practitioner, my entire practice was in state court. Roughly half of my practice involved criminal matters. The other half was equally split between family law and non-profit law. At the Philadelphia Redevelopment Authority, my entire practice involved civil and administrative matters, with 95% of my work in state court and 5% before the Board of View, a quasi-judicial board that sets values of properties in eminent domain proceedings.

As a judge, I may not provide legal advice to anyone whether paid or pro bono. However, as part of my involvement with the Sharon Baptist Church, where I serve as a deacon and a member of the board of trustees, I have helped to organize events held by the Legal Ministry, which is comprised of members of the church who are lawyers and paralegals. This group generally holds a monthly legal night wherein volunteers will meet with church members and others to answer questions about issues of concern or to present free educational seminars. On occasion, the group will provide referrals to lawyers in the community who handle particular legal issues. My role has included attending events and welcoming guests, but not personally meeting with them.

From 2011 to 2013, I served as co-chair of the Philadelphia Bar Association Advancing Civics Education ("A.C.E.") Committee. This program coordinates volunteer teams of judges and lawyers that go to Philadelphia public high schools once a month to teach students about civics in our society.

In February 2013, I was advised by e-mail from the Advisory Panel's co-chairs that I was still under consideration and was invited to update any relevant information, which I did. In August 2013, I received a call from Senator Casey's office informing me that my name would be submitted to the White House for further consideration. Since August 7, 2013, I have been in contact with officials from the Office of Legal Policy at the Department of Justice. On September 11, 2013, I was interviewed by Senator Toomey in Washington, D.C. On February 11, 2014, I interviewed with attorneys from the White House Counsel's office and the Department of Justice in Washington, D.C. On July 30, 2015 the President submitted my nomination to the Senate.
