We are prosecutors in the U.S. Attorney's Office for the Southern District of California. We write to offer our wholehearted support for the nomination of the Honorable Linda Lopez to the United States District Court for the Southern District of California.

Prior to Judge Lopez's appointment as a U.S. Magistrate Judge in 2018, she served as a trial lawyer with Federal Defenders of San Diego. Each of us handled multiple criminal cases with Judge Lopez as opposing counsel. Judge Lopez was a vigorous advocate for her clients and a talented trial lawyer. But what stood out as much as Judge Lopez's legal skills was her commitment to civility and professionalism inside and outside the courtroom. Judge Lopez recognized that prosecutors and defense lawyers are essential to the rule of law and the functioning of our criminal justice system and that the zealous representation of one's client – whether the United States or an individual defendant – was worthy of respect.
