Re: Letter in Support of Kristen Clarke, nominee for the United States Assistant Attorney General for the Civil Rights Division

Dear Majority Leader Schumer, Minority Leader McConnell, Chairman Durbin, and Ranking Member Grassley:

We write in enthusiastic support of Kristen Clarke, the President's nominee to serve as the Assistant Attorney General for the Civil Rights Division of the U.S. Department of Justice.

We served as Senior Officials in the U.S. Department of Justice and as United States Attorneys in federal districts across the country in multiple Republican and Democratic Administrations. We understand the importance of being able to work closely with Justice Department leadership, and especially with the Civil Rights Division, in order to protect some of the most important rights of the people in both civil and criminal cases. This includes the enforcement of federal civil rights laws, including disability rights, education rights, employment rights, housing rights, and voting rights.

In our roles, we saw firsthand the importance of building broad coalitions across state and local law enforcement, as we worked together to bring down human trafficking rings and apprehend fugitives. The Justice Department and U.S. Attorney community need an effective leader at the helm of the Civil Rights Division, someone with immense credibility, who is capable of building partnerships and trust with state and local law enforcement, with community organizations and leaders, and with our offices.

Ms. Clarke is one of the leading civil rights lawyers in America, and she is uniquely suited to carry on this work of coalition-building as the head of the Civil Rights Division. She has not only vigorously fought against discrimination in all forms, including housing discrimination and

religious discrimination, but she has also developed a national reputation as someone who is principled, dedicated, and faithful to the rule of law.

Ms. Clarke began her career in the U.S. Department of Justice's Civil Rights Division where she first served as a trial attorney in the Voting Section and then moved on to become a federal prosecutor handling law enforcement misconduct cases, hate crimes, human trafficking, and other criminal violations. Much of this work involved partnership and collaboration with U.S. Attorney's Offices. She then became the Co-Director of the Political Participation Group at the storied NAACP Legal Defense Fund in 2006. This was followed by her groundbreaking work at the New York State Attorney General's Office where she served as the Chief of the Civil Rights Bureau. While leading that venerable office, Ms. Clarke achieved long-lasting results, tackling issues such as tenant harassment, registration barriers faced by students who had limited English proficiency, disability access, religious discrimination, sexual harassment in blue-collar industries and more. She further led, and skillfully handled, a variety of cases dealing with voting rights, fair housing, and education equity.

Ms. Clarke was then tapped to become the President and Executive Director of the Lawyers' Committee for Civil Rights Under Law, which was founded in 1963 following a call from President John F. Kennedy for lawyers to mobilize to combat discrimination in the deep south. That call from President Kennedy followed a summer in 1963 when protests over illegal discriminatory practices and segregation in education, employment, voting participation, and public accommodations were occurring in Alabama, but then-Governor George Wallace vowed to disobey court-ordered desegregation at its state university, leading attorneys to call for the Governor and elected officials to adhere to the rule of law.

Ms. Clarke has skillfully led the Lawyers' Committee since 2016. This national, non-partisan organization has championed a wide range of civil rights litigation, such as on voting rights, hate crimes, fair housing, and educational opportunities. Ms. Clarke has led a Board composed of over 200 of the nation's most preeminent lawyers, brought together thousands of legal volunteers, and partnered with hundreds of private law firms to commence (and defend against) legal proceedings to promote the rule of law and civil rights, just as President John F. Kennedy envisioned over 57 years ago. Ms. Clarke has pioneered this nationwide effort as its leader, and she has been at the forefront of harnessing the legal community to uphold the rule of law on behalf of vulnerable populations. This enterprising work, in addition to the depth and breadth of Ms. Clarke's legal experience, make her supremely qualified to lead the dedicated professionals of the Civil Rights Division of the U.S. Department of Justice.

Since the Justice Department's Civil Rights Division was created in 1957, it has dramatically grown in both size and scope, and its work is now carried out by eleven different sections, including its criminal section, employment litigation section, housing and civil enforcement section, and its voting section. This is a critical time in our nation's history, when violent extremism is on the rise, hate crimes against vulnerable communities are more commonplace, and our institutions have been undermined by disinformation and chaos. The Civil Rights Division will play a key role in addressing these pressing issues and protecting the rights of vulnerable populations. Ms. Clarke's experience, in addition to her high character, make her a superior choice to lead that important Division.

We urge the Committee to quickly process Ms. Clarke's nomination and the Senate to expeditiously vote to confirm her.
