We are the former law clerks for Ramon E. Reyes, Jr., U.S. Magistrate Judge for the U.S. District Court for the Eastern District of New York in Brooklyn. We write to enthusiastically support his confirmation as a judge for the U.S. District Court for the Eastern District of New York.

He is an outstanding jurist. We each witnessed firsthand Judge Reyes' sharp intellect, analytical skills, and resolute commitment to impartially applying the law. each hearing before he takes the bench. Before hearing any argument on an issue, Judge Reyes works tirelessly to understand both the particular facts of the case before him and the nuances of the law that apply to each issue on which he will render a decision. He approaches each case with an open mind, listens intently to the evidence and argument presented by each side, and faithfully applies the applicable rules, statutes, and precedent. Judge Reyes works tirelessly to resolve matters before him, regardless of what that answer may be or the number of drafts needed to reach it. He is committed to equity and justice.
