The nature of my practice has evolved over time and is much different now than when it began. In the early years, I served as an assistant prosecutor in Ohio County, West Virginia and then in Brooke County, West Virginia. In Ohio County, I first worked as a VAWA-funded domestic violence prosecutor. I handled the assignment for three years and was in court nearly every day, trying many cases to verdict, and quickly learning how to proceed with a case when the victim was not cooperative. In 2001, I was named Chief Assistant Prosecutor in Ohio County and was tasked with handling drug and violent crime cases along with supervisory duties. In addition to a full felony docket, I handled asset forfeiture matters and appellate work, appearing before the West Virginia Supreme Court on eight occasions. In 2007, I accepted an offer to work for the Brooke County Prosecutor's Office, where I handled felonies and the juvenile docket until 2010.

For the first 13 years of my legal career, I was also employed by a small law firm. There, I handled a great deal of real estate work, bankruptcy, and consumer protection cases, to include complex consumer finance cases.

In 2010, I became the United States Attorney for the Northern District of West Virginia. In addition to overseeing the day-to-day operations of the office, I handled cases of my own, with a focus on white-collar and drug trafficking matters. I presented matters to federal grand juries, handled pleas and sentencings, tried cases to verdict and appeared before the Fourth Circuit Court of Appeals.

Dr. Barton Adams committed healthcare fraud at his pain management clinic in Vienna, West Virginia by billing for procedures he did not perform. Adams neglected to pay taxes on the revenue generated and laundered the money through accounts with HSBC Bank. With the help of his wife Josephine, he deposited his ill-gotten gains into accounts in the United States before moving the money to Canada, China, and the Philippines. This discovery led to a spinoff investigation into HSBC that spanned the globe and led to the bank facing charges of its own (See Section 16). Dr. Adams pled guilty to health care fraud and tax evasion and paid more than \$3 million in restitution while forfeiting an additional \$4 million. Dr. Adams was sentenced to 50 months prison. Josephine Adams went to trial and was convicted of assisting her husband in the laundering of healthcare fraud proceeds. I supervised the investigation, negotiated the plea agreement with Dr. Adams, handled hearings involving Dr. Adams, and served as lead counsel in the Josephine Adams trial. At trial, I questioned many of the witnesses on direct and cross, argued motions, gave the closing argument, and gave the rebuttal to the defendant's closing argument.

In April 2004, Jeffrey Woods and Williams Spears conspired to rob and murder a Triadelphia, West Virginia family of three. Using subterfuge, the two gained entrance to the victims' home and stole cash and jewelry before shooting each of them in the head, execution-style. The suspects fled to the State of Ohio where they changed their appearance and hid the fruits of the crime before being captured. After separate jury trials, the Defendants were each convicted of first-degree murder and sentenced to life in prison without parole. Yasser Abdelhaq traveled from Cleveland, Ohio, to Wheeling, West Virginia with his girlfriend Dana Tozer in November 1999 where they checked into a Hampton Inn. When they stayed long past checkout time, hotel staff became concerned. Upon trying to contact the occupants of the room, they discovered that Abdelhaq had barricaded himself inside of it. Police were called and ultimately determined that Abdelhaq had stabbed Ms. Tozer, a paraplegic, over two hundred times, causing her death. I handled the prosecution on retrial after the original conviction had been reversed by the West Virginia Supreme Court. After a lengthy jury trial, Abdelhaq was convicted of first-degree murder and sentenced to life in prison without the possibility of parole. CEO Bernie Metz of the Center Valley Federal Credit Union engaged in a sophisticated scheme to embezzle funds from the accounts of her customers. She used the stolen money to fund an opulent lifestyle for herself, to build a new restaurant and tavern, and to purchase automobiles for family members. The scheme caused tremendous financial harm to the credit union's customers, adversely affecting their credit, and causing them to become upside down on automobile loans. Metz pled guilty to embezzlement and money laundering, was sentenced to nine years in prison, and ordered to repay nearly \$5 million in restitution. I supervised the handling of the case, I personally met with many of the victims, and I served as lead counsel for the sentencing phase of the case. For many years, Ronald Reed engaged in sexual relations with his daughter and other adolescent females who were under his care, custody and control. Robert Padelski was in a relationship with a woman who had a young daughter. He was frequently left alone with the kindergarten-aged child and engaged in sexual relations with her on multiple occasions. At the week-long trial, Padelski was convicted of 40 counts of sexual assault and sexual abuse. In addition to handling the pre-trial motions practice, I served as lead trial counsel, questioned most of the witnesses on direct and cross, made the closing argument and gave the rebuttal. Convicted felon Jordan Laudermilt was involved in a domestic dispute with his girlfriend and her family on Justice Lane in Ohio County, West Virginia. He demanded a cash payment from her and when she refused, he threatened to kill her, her father, and her brother with a .22 caliber rifle that was in his possession. Sheriff's deputies responded and eventually arrested him, recovering the rifle during a protective sweep of the home. Laudermilt challenged the legality of the search and the U.S. District Court ruled in his favor. We appealed the decision, and I successfully argued to the Fourth Circuit Court of Appeals that the ruling should be overturned. The case was remanded for a jury trial, in which I served as co-counsel. I questioned many of the witnesses on direct and cross, argued motions, and made the opening statement. Laudermilt was convicted by the jury of being a prohibited person in possession of a firearm and sentenced to 120 months in prison.

However, he failed to get Charlie out, resulting in the child dying from smoke inhalation and thermal burning. I personally handled the jury trial, working with witnesses, arguing motions, and handing the opening and closing statements. Pharmacist Mario Blount of Bridgeport, West Virginia filled prescriptions that were contraindicated, potentially lethal, and excessive. Occasionally, he dispensed pills without any prescription at all. Blount's pharmacy had a system that would alert him to these improper prescriptions, but he would manually override the system and fill them anyway. He was one of the primary beneficiaries of Dr. Edita Milan's malfeasance, a doctor who was convicted of improper prescribing. Blount was convicted of the illegal distribution of Schedule II drugs and of falsifying records and sentenced to 36 months in prison. I supervised the entire case and personally handled the sentencing phase, working with witnesses, arguing enhancements, and advocating that an appropriate sentence be imposed.

Michael John Jones took photos and videos of young girls who slept at his Follansbee, West Virginia home as guests of his own children. His conduct was discovered when the West Virginia State Police learned Jones shared a video he had produced with a man in North Carolina. A search warrant was obtained for Jones' home where thousands of images and videos were recovered, including images and videos that were produced by Jones. He was convicted of "Sexual Exploitation of a Child" and sentenced to 300 months in prison, to be followed by lifetime supervision. I personally handled this case from the beginning, working with witnesses, guiding the investigation, negotiating with defense counsel, and handling the plea and sentencing hearings.

While serving as United States Attorney, I had significant involvement in the investigation and prosecution of HSBC Bank. It was a case that began with an investigation of a doctor from a small town in West Virginia and ended with one of the world's largest banks admitting that it had violated the Bank Secrecy Act. Our team of prosecutors and federal agents in West Virginia uncovered how the bank had permitted money laundering to occur at extraordinary levels, with Mexican drug cartels among the primary beneficiaries. It was also proven that HSBC conducted transactions on behalf of customers in countries that were subject to U.S. sanctions. The bank ultimately paid nearly \$2 billion for its failure to establish proper procedures to prevent money laundering by drug cartels and terrorists. My involvement included prosecuting the doctor and his wife in federal court in West Virginia, coordinating with federal partners to try and hold the bank and its executives accountable. It was the very first case I worked on as United States Attorney and carried with it great significance for a variety of reasons.

Another important case was the investigation of McKesson, a large pharmaceutical wholesaler that filled suspicious orders of narcotics for pharmacies in West Virginia and elsewhere. Considering that my state was at the epicenter of the opioid crisis, this matter was a top priority for me and my colleagues. The enormous quantities of pills that were being shipped to small towns in West Virginia helped to fuel the problem and cause the deaths of thousands of our citizens. I worked closely with the Assistant United States Attorneys in my office to broker an agreement that would ensure accountability. In December 2016, we finalized a deal requiring McKesson to pay a \$150 million penalty along with other sanctions.

In 2011, I oversaw the investigation of hospitals in my region involving improper compensation arrangements with physicians. The challenge was not so much proving the illegal conduct but rather determining an appropriate punishment. The Assistant United States Attorneys in my office and I worked hard to strike the right balance to avoid closure of these critical facilities. The hospitals ultimately were required to pay \$3.8 million to settle the claims, an amount that provided accountability while allowing them to stay open and continue to provide medical care to area residents.

The case of Mark Cowden, a sheriff's deputy who used excessive force against an

arrestee, was also significant. The matter had gone unreported until one day when I was in the car with a friend headed to a meeting. In the course of conversation during a fivehour drive, he mentioned an incident involving Deputy Cowden and the details provided caused me great concern. I immediately called the FBI and agents began investigating, collecting evidence to include a video depicting Deputy Cowden slamming the victim's head into a brick wall and into an elevator wall. Cowden was indicted and the case was tried by an Assistant U.S. Attorney in my office, after which Cowden was convicted and sentenced to prison.

In private practice, my most important efforts involved helping consumers who were victimized by big banks, including one case where a large lender force-placed insurance onto consumer loans and another where appraisers were pressured to overstate the value of homes. I am also proud of the many smaller consumer cases which I helped to resolve for individuals. They may not be of the same scale as some, but they were certainly significant for my clients.

More recently, I have represented domestic violence victims pro bono, helping them to navigate protective order proceedings, and attending criminal court with them.

I presently serve on the Board of Directors for the West Virginia Coalition Against Domestic Violence and for the Upper Ohio Valley Sexual Assault Help Center and provide free legal assistance to each organization. I previously served on the board of the Seeing Hand Association and provided pro bono legal help to that group as well.
