I also provide legal guidance and resource to law enforcement on case development, changes in law and trial strategy.
 - 1999 2007: The general character of my practice was criminal defense with some minor civil litigation. I estimate my practice was 70 percent criminal defense and 30 percent civil (divorce, property disputes, collections, etc.).

 - 2007 present: I prosecuted over a thousand felony cases on behalf of the State of Wisconsin. I prosecuted several thousand more misdemeanor cases. I tried a myriad of cases to jury including: First Degree Intentional Homicide, OWI Homicide, Hit and Run Causing Death, Sexual Assault to Minors, Incest, Drug Distribution, Reckless Endangering Safety, Operating While Impaired, Battery, among others. As the elected District Attorney, I absorbed the felony caseload while managing the office.
 - 1999 2006: My typical clients were persons charged with felony and misdemeanor offenses, including, but not limited to, property crimes, controlled substances and impaired driving. I tried cases to jury including: Possession With Intent to Deliver, Sexual Assault,

Burglary, Operating While Impaired. Over time I gravitated to drug and operating while impaired offenses but retained a plurality of cases.

The balance of my time is primarily spent meeting with detectives, charging new cases or drafting warrants and subpoenas. To the best of my estimation, I spend 65% of my time in court and 35% of my time in case development/office management.

 - One of the most significant legal activities I pursued was a "John Doe" Investigation I opened under Wis. Stats 968.26 in calendar year 2012. My jurisdiction was overwhelmed with heroin, and we suffered a series of overdose deaths. I opened a John Doe investigation after all other investigative avenues failed. The investigation was open for approximately two months and resulted in felony cases being filed on approximately 12 people. Through this process we solved two Reckless Homicide cases (Wisconsin's applicable statute for providing controlled substances resulting in death) giving closure to families. We also deconstructed a heroin network that was bringing the statutory maximum level of heroin into my jurisdiction every two weeks. This case drew attention to the depth of the heroin problem we had in our county and began a trend where law enforcement began to go on the offensive against this dangerous drug.

In 2013, I worked in cooperation with my judiciary to create the first Drug Treatment Court in Waushara County. Together we developed the functional components of the program including its controlling panel, coordinator position, treatment and sanction platforms. A grant was awarded and the Drug Court remains a viable entity to this day. This program has provided numerous non-violent substance abusers the ability to regain their lives without need for prison.
