I was required to attend all court proceedings on my cases, conduct legal research, review pleadings and draft legal analyses during my one-year clerkship. I did not have clients during this period.

In 1992, my clerkship ended, and from 1992-1997 I took a position as a Trial Attorney through the Department of Justice Honors Program, and then as Acting Deputy Chief, in the Civil Rights Division, Criminal Section. As a Trial Attorney, I handled complex criminal civil rights cases nationwide from the investigative phase, through grand jury presentation, to trial. Those cases included, among others, numerous matters involving hate crime and violent extremists as well as police misconduct investigations. I was also appointed to serve as the national Involuntary Servitude and Slavery Coordinator, in addition to handling a full caseload. Later, I was named Acting Deputy Chief, and I oversaw the office's work in one-third of the nation. My exclusive client was the United States.

As an attorney in the Civil Rights Division, I worked with AUSAs in the Central District of California, the INS, and the FBI to investigate and prosecute what became known as the Thai Slavery Case (or the El Monte Slaver Case). This matter involved what was, at that time, the largest human trafficking case brought in United States history. Approximately, 70 Thai women were found in a pre-dawn INS raid in El Monte, California, just outside Los Angeles, being held against their will in conditions amounting to captivity. The investigation included significant

coordination between state, federal, and international law enforcement agencies, including extensive activity in Thailand. Nine defendants were charged, two fled, and seven were convicted on charges including slavery, kidnapping, labor violations, and immigration fraud. As part of their plea agreements, the defendants agreed to upward departures from the then-lower sentencing guidelines.

In December of 2009, Kevin Dye firebombed the Municipal Building and Courthouse in Mansfield, Ohio. Specifically, Dye, who had a significant criminal history and ties to white supremacist groups, made and threw Molotov cocktail devices through the window of a judge in that court on the night before Dye had scheduled hearings. Additional investigation by the ATF proved that Dye had also torched Belcher's House of Rock, a local bar with which he had a grievance. The Municipal Center, including the court and police department, suffered millions of dollars of damage as a result of Dye's attack and was closed for an extended period. In Mansfield, Ohio, this attack caused a major disruption in their community. I chose to co-lead the trial team, and was personally involved in all aspects of the case and the Sixth Circuit appeal. As a result, Mr. Dye made what the U.S. Marshal Service judged were credible death threats to me and my family (as well as to others, including his own attorney at one point). I led the one-week trial, which resulted in a conviction of Mr. Dye, and Judge Sara Lioi sentenced him to 60 years imprisonment. In addition, I personally argued the Sixth Circuit appeal, which resulted in an affirmance.

I personally helped represent the United States on the appeal in this case, where the defendants challenged the constitutionality and breadth of the Shepard-Byrd Hate Crimes Act ("SBHCA"). The underlying case was a hate crime and obstruction of justice prosecution that our office pursued along with the Civil Rights Division and the FBI at the request of local law enforcement officials. It was related to the home invasions, assaults and ritualistic hair sheerings of numerous Amish people by others in a breakaway and violent sect. The case resulted in the convictions of 16 perpetrators, including the sect's leader, who the government alleged had ordered the attacks based upon the Amish church leadership's differences with him on religious matters.

I argued the appeal because of its potential significance to the survival of the new statute. While the statute was not struck down, the Sixth Circuit ruled that a narrower jury instruction should have been applied. The case was not retried

because there were still numerous counts of conviction that were unaffected by the appeal.

This case involved extensive work in the Mississippi penal system with inmates and guards as well as the handling of DNA evidence, which essentially proved the case, when that technique was relatively new. I did not handle the appeal.

The most significant legal activities that I have pursued are the legal representation of clients in cases and controversies. Many of those matters are described in detail in the answer to question 15.

In addition, I consider the additional legal activities that I performed during my time as

United States Attorney for the Northern District of Ohio to have been significant. In my role as United States Attorney, I had several functions. Following is a summary of those activities.

First, I managed, supervised, and supported the dedicated career prosecutors and staff in the performance of their duties. This work involved thousands of investigations and cases, both criminal and civil, which are handled in a large U.S. Attorney's office.

Second, I served as a liaison between the U.S. Attorney's Office and the federal, state, and local law enforcement community in the Northern District of Ohio. This involved working together to meet the most pressing public safety and legal issues facing the six million residents of the District. It included helping to lead and serve on numerous law enforcement task forces and other joint anti-crime initiatives, as well as collaborating on specific stand-alone cases and investigations. Among the most pressing issues the facing the District during my service as United States Attorney were: terrorism (both domestic and international based); violent crime; opioid and other drug related crime and addiction; civil rights and corruption issues; and financial fraud in the wake of the Great Recession.

Third, as United States Attorney, I was part of a larger team at the Department of Justice. In that capacity, I helped, along with many others, to identify and implement the priorities and policies set by the Attorney General and departmental leadership. I served on the Attorney General's Advisory Committee under both Attorneys General Holder and Lynch as part of that work, helping also to connect and represent the interests of the U.S. Attorney community within the larger Department of Justice.

Fourth, as U.S. Attorney, I served as a partner with community groups and citizens in Northern Ohio to deal with the public safety threats in collaborative and creative ways, in addition to the litigation of specific cases. In that respect, for example, I carried onward the work of my predecessors in pursuing a broad community approach to preventing and addressing violent crime. The STANCE (Stand Against Neighborhood Crime Everyday) program was an example of this effort. STANCE was an effort to coordinate prevention, enforcement, and re-entry efforts to combat violent crime, and involved convening frequent meetings and initiatives with anti-violence community groups and federal, state and local law enforcement. We also established an anti-opioid task force in the District, including law enforcement, healthcare leaders and treatment groups, among others, which served as a national model. We met with leaders in the business community on assisting in ethics and anti-corruption efforts as well as with civil rights and legal aid groups to assist in addressing the public safety and legal problems facing their clients and members.

In private practice, I have been active in efforts to mentor young attorneys and our firm's efforts to increase diversity and inclusion (I serve on the Diversity and Inclusion Committee of my office at the firm), both of which I consider to be the responsibility of more experienced lawyers. I have also been involved in pro bono work, which is described in the response to Question 23.

For instance, I represented, with co-counsel, the Jewish victims of an Anti-Semitic hate crime in Columbus, Ohio. Federal hate crimes charges were filed against the perpetrator, who pleaded guilty and was sentenced to prison. This *pro bono* case is part of my participation in a national pilot program Hate Crime and Extremism Legal Assistance Project organized by the Anti Defamation League (ADL), aimed at ensuring that the victims of hate crimes have adequate legal representation. It is consistent with my career long commitment to assist crime victims. I also have assisted in voter protection and education efforts, also on a pro bono basis during my time in private practice, consistent with my commitment to civil rights.
