In 1989, Rotary International adopted a worldwide policy eliminating the male membership policy for all Rotary clubs. To the best of my knowledge, none of the other organizations listed above currently discriminates, or formerly discriminated, on the basis of race, sex, religion or national origin, either through formal membership requirements or the practical implementation of membership policies.

The opinion I authored, applying jurisprudence from my circuit, vacated the defendant's guilty plea and remanded the case to the trial court for further proceedings. The defendant had entered the plea reserving his right to seek appellate review of the trial court's ruling on a motion to suppress evidence; however, the trial court failed to complete the hearing on the motion and to rule thereon. The defendant appealed. My opinion found that the plea should be vacated because it was entered on a condition that could not be met, that is, the trial court had made no ruling that could be reviewed on appeal. By *per curiam* opinion, the Louisiana Supreme Court granted the writ and reversed. The Supreme Court reinstated the plea, but it remanded the case to the trial court with instructions to conduct the hearing on the motion to suppress and to rule thereon.

Writing for the appellate panel, my opinion affirmed the trial court's judgment and held that the debtor's failure to make a timely objection to the default judgment against him required the trial court to confirm the arbitration award in light of the documentary evidence entered in the record. The appellate court panel granted rehearing and consolidated the case with two similar cases to be heard by the court *en banc*. On rehearing *en banc*, the majority reversed my opinion and vacated the trial court's judgment. The rehearing majority, noting the issue was *res nova*, held that the validity of the underlying arbitration award rests on whether there is a valid arbitration agreement and the 90-day time limit imposed by the Federal Arbitration Act for the debtor to modify the arbitration award does not come into play unless there is a valid written agreement to arbitrate. The rehearing majority found the creditors in all three cases had failed to prove sufficiently the existence of a binding agreement to arbitrate. The dissenting opinion, which I joined, reasoned that the consolidated cases were factually distinguishable and that my original authored opinion had correctly affirmed the trial court's judgment in that case. The dissenting opinion further reasoned that



the debtor in that case was deemed to have admitted the existence of the arbitration provision in the credit agreement and had failed to raise the issue timely by first raising it on appeal. The Louisiana Supreme Court, in a 5-2 decision, denied writs.

I have served as a Board Member for New Orleans Catholic Charities and a member of my local church's council. Both of these positions involved providing pro bono services.

I have also enjoyed unique opportunities to benefit the public as a judge by helping oversee certain programs. These programs include Louisiana's drug courts and other specialty courts. These courts provide an alternative to incarceration in non-violent, non-sex offense cases. The participants are closely supervised and necessary services are made available to them. These specialty courts have significantly lowered the recidivism rate in Louisiana and allowed many participants to return to a productive life.

Other programs in which I have participated include the Court Appointed Special Advocates program, The Families in Need of Services program, and the Louisiana Protective Order Registry. The Court Appointed Special Advocates program provides volunteer assistance for children as they navigate through our court system. The Families in Need of Services program works to connect families at risk with the services and programs designed to help them succeed. The Louisiana Protective Order Registry is a database of domestic abuse orders accessible to law enforcement.

In addition, I have periodically communicated with their staff members.

I interviewed with a selection committee created by Senator Cassidy on two occasions in approximately May and August of 2017. I also met with members of the White House Counsel's Office and Department of Justice in June 2017.

In June 2018, I was notified by the White House Counsel's Office and Senator Cassidy that my name was being advanced for further consideration. Since then, I have periodically communicated with individuals in the White House Counsel's Office and the U.S. Department of Justice.
