25. <u>Pro Bono Work</u>: An ethical consideration under Canon 2 of the American Bar Association's Code of Professional Responsibility calls for "every lawyer, regardless of professional prominence or professional workload, to find some time to participate in serving the disadvantaged." Describe what you have done to fulfill these responsibilities, listing specific instances and the amount of time devoted to each.

From 2010 to the present, I have been a member of the Criminal Justice Act ("CJA") Panel for the Western District of Tennessee. As a member of the CJA Panel, I have served the disadvantaged by representing criminal defendants who cannot afford attorneys. I have handled approximately 70 appointed cases through the CJA Panel. From 2008 to 2013, I also handled appointed criminal cases in the Shelby County Criminal Court and Tennessee Court of Criminal Appeals for criminal defendants who could not afford an attorney.

Additionally, since 2020, I have served as pro bono co-counsel with the Tennessee Innocence Project seeking to overturn the convictions for attempted murder and aggravated robbery of a criminal defendant sentenced to 49 years of imprisonment. We contend that our client was misidentified as the person that committed the crimes in question. To date, we have filed a petition for DNA analysis of certain evidence presented at trial pursuant to the Tennessee Post-Conviction DNA Analysis Act of 2001, as well as a petition for fingerprint analysis pursuant to the Tennessee Post-Conviction Fingerprint Analysis Act of 2021. Approximately five percent of my time has been dedicated to this case.

From 2012 to 2019, I represented pro bono a criminal defendant who was charged with first degree murder after killing his mother. The defendant suffered from intellectual disability and had been diagnosed with paranoid schizophrenia. The primary issue in the case was whether the defendant was competent to stand trial. After the trial court found that my client was not competent to stand trial and that continued detention would violate my client's speedy trial rights, the State agreed to dismiss the case. During the time that I represented the defendant, I dedicated approximately five percent of my time to the case.

From 2007 to 2010, I handled order-of-protection cases through Memphis Area Legal Services for women who sought to obtain orders of protection against their current or former significant others. While in law school, I participated in a domestic violence clinic, which is when I began handling those cases. I continued to handle the cases when

I began practicing law. I dedicated approximately five to ten percent of my time to handling order-of-protection cases during this period.

Since 2006, I have served as a volunteer board member for the Boys and Girls Clubs of Memphis (2006 to 2018) and Streets Ministries, Inc. (2018 to present). Both entities serve disadvantaged youth. I have dedicated approximately five percent of my time to work performed for these boards.

On March 3, 2021, Congressman Stephen Cohen contacted me regarding a potential vacancy on the United States Court of Appeals for the Sixth Circuit; he asked if I was interested in being considered for nomination for such a vacancy and, if so, to submit a letter of interest to him. I advised Congressman Cohen that I would be interested in being considered for nomination to the Sixth Circuit. On March 7, 2021, I submitted my letter of interest to Congressman Cohen. On May 21, 2021, the White House Counsel's Office asked whether I was interested in being considered for nomination to the Sixth Circuit. On May 24, 2021, I interviewed with attorneys from the White House Counsel's Office. Since June 2, 2021, I have been in contact with officials from the Office of Legal Policy at the United States Department of Justice. On June 17, 2021, I interviewed with counsel for Senators Marsha Blackburn and Bill Hagerty. On November 18, 2021, my nomination was submitted to the Senate.
