Superior Court Judge (2012 – 2013; 2015 – 2018) County of Imperial, State of California

I was appointed by California Governor Edmund G. Brown as a Superior Court Judge in Imperial County, California on February 29, 2012 and served from March 2012 to January 2013. In June 2012, I ran to retain my seat and lost the election. As outlined below, in January 2013, I was unanimously appointed as the Family Support Commissioner by the Superior Court Judges and served in that position from January 2013 to January 2015. In June 2014, I ran for an open seat for Superior Court Judge in Imperial County, California and was elected to a six-year term.

The California Superior Courts have general jurisdiction in criminal, civil, juvenile delinquency, and family law matters. My primary criminal assignment included felony and misdemeanor jury trials, arraignments, and other proceedings such as pre-rial motions, preliminary examinations, probation/sentencing, bail reviews, extraditions, and

grand jury indictments. Civil assignments included handling habeas and prisoner civil rights actions, and civil litigation cases where the judges who had a primary civil assignment had a conflict. Additionally, I presided over more than 100 small claims and infraction court trials.

Family Support Commissioner (2013 – 2015) Superior Court of California, County of Imperial

In January 2013, I was unanimously appointed as the Family Support Commissioner by the Superior Court Judges and served in that position from January 2013 to January 2015. I presided over parentage actions and child support cases brought and enforced by the Department of Child Support Services related to the establishment and collection of child support and related spousal support, along with health insurance for minor children, including the enforcement of out-of-state support orders and support orders from Mexico. Additionally, on assignment, I handled small claims and infraction cases including presiding over the court trials.

United States Magistrate Judge (2018 – present) United States District Court for the Southern District of California

In August 2018, I was appointed as a United States Magistrate Judge by the District Court Judges of the Southern District of California. The District Court has jurisdiction over civil matters raising federal questions, civil matters with diversity of citizenship, and federal criminal matters. As the sole magistrate judge in Imperial County, I preside over all preliminary proceedings in criminal cases arising in Imperial County, which is a significant portion of the criminal cases in the Southern District of California (approximately 40 percent pre-COVID-19). I oversee criminal cases in full when they involve petty offenses and misdemeanor charges. I also oversee pretrial proceedings in civil cases, including discovery, non-dispositive motion practice, and settlement negotiations referred to me by District Judges. Where all parties consent to magistrate judge jurisdiction, I am authorized to preside over the entire civil case. Additionally, I preside over naturalization proceedings.

Ms. Cano, an employee with the United States Postal Service (USPS) for 26 years, filed a complaint against her employer for sexual harassment by a supervisory-level employee, Postmaster Gonzalez, under Title VII of the Civil Rights Act, 42 U.S.C. § 2000e-2(a)(1). As to the incident at issue, Ms. Cano alleged Mr. Gonzalez "took his hand and forcefully grabbed Plaintiff's [private area]" and then proceeded to make a lewd statement while she was in his office picking up supplies. Ms. Cano alleged that USPS had knowledge of Mr. Gonzalez's propensity to sexually harass both employees and customers, and cited evidence of at least three other employees who were victims of harassment by Mr. Gonzalez over the past decade. I conducted an early neutral evaluation of the case on October 15, 2019, mandatory settlement conference on May 28, 2021, and facilitated a settlement of the case on June 2, 2021, after conveying a mediator's proposal. Thereafter, the parties stipulated to dismissal with prejudice which rendered a pending motion for summary judgment moot.

Mr. Cruz Noguez was charged with conspiracy to bring aliens to the United States outside a port of entry causing serious bodily injury/placing a life in jeopardy in violation of 8 U.S.C. § 1324(a)(1)(A)(i), (v)(I), and (B)(iii), bringing in aliens without presentation for financial gain in violation of 8 U.S.C. § 1324(a)(2)(B)(ii), and aiding and abetting in violation of 2 U.S.C. § 2. The charges are in connection with a March 2, 2021, smuggling event that led to the deaths of 13 Mexican and Guatemalan nationals in a vehicle crash near Holtville, California. Mr. Cruz Noguez made an initial appearance before me on March 30, 2021. I subsequently presided over a detention hearing on April 5, 2021, where Mr. Cruz Noguez stipulated to detention. Thereafter, I presided over an arraignment on indictment on April 28, 2021, where Mr. Cruz Noguez entered a plea of not guilty. The case is currently pending before District Judge Cathy Ann Bencivengo.

Plaintiff Mr. Stevenson alleges his rights have been violated by the California Department of Corrections and Rehabilitation's (CDCR) implementation of a new regulation which required state prison law libraries to provide computer legal research materials from Lexis-Nexis rather than Westlaw and eliminated a standing order to update West Publishing books. Mr. Stevenson contends this change, coupled with Centinela State Prison's policies regarding inmate computer use for legal research, have deprived him of his due process rights. I have presided over this case since taking the federal bench in 2018 and have handled various pretrial matters. The case is currently pending. I have issued three orders on motions to compel filed by Mr. Stevenson, wherein he sought discovery relating to the content of prison law libraries operated by CDCR. Mr. Stevenson filed a motion for reconsideration of the March 12, 2021, discovery order and objections to the May 17, 2021, discovery order. District Judge Todd W. Robinson overruled Mr. Stevenson's objections, finding no clear error in either discovery order. Mr. Stevenson also filed a motion for preliminary injunction seeking to stop CDCR from implementing a proposed amendment to its regulation which only requires legal research materials in digital format. On March 29, 2021, I issued a Report and Recommendation (R&R) on the motion which recommended that it be denied. Mr. Grizzle alleges he was placed in ad-seg without due process and the daily routine in ad-seg caused him sleep deprivation and forced him to choose between sleep and exercise. I have presided over this case since taking the federal bench in 2018 and have handled various pretrial matters. The case is currently pending. The County Defendants filed a motion to dismiss portions of Mr. Grizzle's third amended complaint. On July 10, 2020, I issued a Report and Recommendation (R&R) on the motion which recommended it be granted in part and denied in part. I recommended dismissal of the first cause of action against Sheriff Gore and Sergeant Boorman in their individual capacity for failure to allege any personal participation, acquiescence, or culpable indifference to the adseg classification decision. I recommended denial of the motion to dismiss the conditions of confinement claims against Lieutenant Lovelace and Sergeant Boorman in their individual capacity finding the complaint plausibly established Lovelace's ad-seg classification decision and Sergeant Boorman's notice of that decision set in motion a series of unlawful conduct of which they both were aware and/or knowingly refused to terminate. District Judge Janis L. Sammartino adopted the R&R in its entirety on August 17, 2020. Most recently, I handled a discovery dispute between the parties, including convening an informal discovery conference and issuing an order granting in part and denying in part the County Defendants' motion to compel.

The plaintiff sought review of a final decision of the Commissioner of Social Security denying her applications for disability insurance benefits and supplemental security income. I exercised full jurisdiction over the case pursuant to the parties' consent. Ms. V alleged disability due to carpal tunnel syndrome and a mental impairment. The administrative law judge (ALJ) found Ms. V had a severe physical impairment but not a severe mental impairment. Despite the severe physical impairment, the ALJ determined Ms. V had the residual functional capacity to perform light work, and found her capable of performing past relevant work as an office manager. The parties filed cross-motions for summary judgment. On January 6, 2020, I issued an order on the motions and remanded the ALJ's decision, finding that the ALJ improperly assessed Ms. V's mental health impairment on two grounds: (1) the ALJ failed to ask the vocational expert about limitations imposed by Ms. V's mental health impairment; and (2) the ALJ failed to account for psychiatric treatment notes which supported a finding of severe mental impairment. I subsequently issued an order granting in part Ms. V's motion for attorney fees, costs, and expenses under the Equal Access to Justice Act.

The First Amendment claims include an allegation that an officer retaliated against Mr. Williams for filing an administrative grievance against that officer and it also alleges various staff members violated his right of access of the courts. The Fourteenth Amendment due process claims includes allegations that Plaintiff was subjected to significant hardships by the inability to contact his attorney. I issued Reports and Recommendations (R&R) on the motion and addendum which recommended that the motion be denied based upon Mr. Williams' failure to show any actual injury as a result of being denied unlimited law library access. District Judge Dana M. Sabraw adopted the R&Rs in their entirety. Defendants subsequently filed a motion to dismiss various causes of action from the first amended complaint. District Judge Sabraw dismissed the denial of showers aspect of the Eighth Amendment claim, the First Amendment access to court claims, and the Fourteenth Amendment due process claims. Mr. Williams then filed a motion for sanctions against Defendants related to Defendants' conduct in filing their motion to dismiss. Mr. Williams contended Defendants intentionally misconstrued and misquoted the allegations in his first amended complaint. I denied the motion. After a vehicle was sold to a third party, Mr. Rios claimed he owned the vehicle and added the vehicle to his insurance policy. Mr. Rios reported the vehicle stolen and filed a claim with his insurance carrier. A jury convicted Mr. Rios of felony insurance fraud (Cal. Penal Code § 550(a)(4)), making a false report of a criminal offense (Cal. Penal Code § 148.5(a)), and attempting to induce false testimony (Cal. Penal Code § 137(c), § 664). I presided over the jury trial. Mr. Rios received a grant of probation. On appeal, Mr. Rios argued he was denied his Sixth Amendment right to confrontation. He also alleged ineffective assistance of counsel and challenged a job-related condition of probation. Mr. Rios argued admission of the vehicle purchase agreement between buyer and seller was inadmissible testimonial hearsay because the seller was not called to testify at trial and Mr. Rios never had an opportunity to cross-examine. The Court of Appeal rejected this argument since Mr. Rios never objected to the admissibility of the purchase agreement at trial. Alternatively, Mr. Rios argued ineffective assistance of counsel based upon counsel's failure to object to the purchase agreement's admissibility. The Court of Appeal found Mr. Rios did not show that it was reasonably probable he would have received a more favorable result had his counsel objected. The Court of Appeal furthermore upheld a condition of probation prohibiting Mr. Rios from personally handling monies in the course of employment. Judgment was affirmed by the Court of Appeal, Fourth District, Division One.

On March 10, 2011, while incarcerated at Calipatria State prison, Mr. Johnson's cellmate was released from his cell to shower and subsequently initiated a fight with a correctional officer. The officer used pepper spray and dropped the cellmate to a prone position. In the meantime, Mr. Johnson exited the cell without authorization and began punching the officer. The officer then hit Mr. Johnson on the head with an empty pepper spray can. Another officer sprayed Mr. Johnson, dropping him to a prone position. Mr. Johnson asserted claims of excessive force. A jury found Mr. Johnson guilty of battery on a nonconfined person by a prisoner (Cal. Penal Code § 4501.5). The jury also found true the allegation that Mr. Johnson had suffered a prior strike conviction. I presided over the jury trial and I sentenced Mr. Johnson to six years in state prison to run consecutively to the term he was serving. Mr. Johnson appealed and requested independent review of records in connection with his *Pitchess* motion seeking discovery of personnel information disclosing alleged prior misconduct by several correctional officers. After a hearing on the Pitchess motion and conducting an in camera review, I determined only two complaints were discoverable. The Court of Appeal independently reviewed the records and found no abuse of discretion in my ruling regarding Mr. Johnson's Pitchess motion.

A jury convicted Mr. Martinez of one count of felony assault with a deadly weapon (Cal. Penal Code § 4501.5). I presided over the trial and sentenced Mr. Martinez to a four-year state prison term. Mr. Martinez timely appealed, alleging prejudicial error concerning two self-defense jury instructions. One self-defense instruction stated, in part, "[s]elf-defense is a defense to assault with a deadly weapon." Mr. Martinez argued that this instruction misstated the law because it erroneously led the jury to believe that a defendant is "entitled to use of selfdefense to defend himself only if he was assaulted with a deadly weapon." The Court of Appeal disagreed with Mr. Martinez on this point. Additionally, Mr. Martinez argued that the evidence did not support a related self-defense/mutual combat instruction, and that the instruction misstated the law. The Court of Appeal found the evidence supported my instructions and rejected Mr. Martinez's arguments that the instructions contained an incorrect or misleading statement of law.

Produce Pay, Inc. v. FVF Distributors, No. 20-cv-517-MMA-RBM, 2021 WL 1978089 (S.D. Cal. May 18, 2021); *aff'd and modified in part*, No. 20-cv-517-MMA-RBM, 2021 WL 2366078 (S.D. Cal. June 9, 2021). This is a federal question action arising under the Perishable Agricultural Commodities Act (PACA), 1930, as amended, 7 U.S.C. §§ 499a-499t. Produce Pay is a Delaware corporation in the business of buying at a discount produce-related accounts

receivable that are subject to PACA. Defendant FVF Distributors, Inc. (FVF) is a California corporation in the business of trading fresh fruit and vegetable commodities subject to PACA and Defendant Mr. Avila was an employee, officer, and director of FVF (collectively FVF Defendants). Produce Pay's complaint against the FVF Defendants asserted claims for breach of contract, interference with receipt of trust assets subject to PACA, conversion, and breach of a malfeasance agreement. After settling the case at an early neutral evaluation conference. Produce Pay filed a motion to enforce settlement agreement based upon the FVF Defendants' failure to abide by the terms of the parties' agreement. I issued a report and recommendation (R&R) on the motion, recommending that it be granted and that the Court enter judgment pursuant to the terms of the parties' agreement. I found the settlement agreement complete and binding as to all material terms, and therefore, subject to enforcement. I also found Produce Pay entitled to recover attorney's fees in seeking to enforce the agreement. District Judge Michael M. Anello adopted the R&R to the extent that it recommended granting the motion to enforce the settlement agreement and recommended the award of attorney's fees to Produce Pay's counsel. Judge Anello declined to enter judgment against the FVF Defendants for the total amount of the settlement agreement plus attorney's fees, finding Produce Pay's request for judgment to be premature. Accordingly, Judge Anello modified the R&R in this respect and denied Plaintiff's request for judgment. This case is ongoing. Plaintiff has since filed a motion for judgment pursuant to California Code of Civil Procedure section 664.6, which is pending a ruling.

People v. Crawford, No. D074088, 2019 WL 1552563 (Cal. Ct. App. Apr. 10, 2019). A jury convicted Mr. Crawford of battery with serious bodily injury (Cal. Penal Code § 243(d)), assault by means of force likely to cause great bodily injury (Cal. Penal Code \S 245(a)(4)), and elder abuse with injury (Cal. Penal Code \S 368(b)(1)). The jury found true an allegation of personal infliction of great bodily injury as to each count. The jury also found true an allegation that Mr. Crawford suffered a prior strike conviction as well as a serious felony prior. I sentenced Mr. Crawford to eight years in prison for the assault count based on the strike prior, plus three years for the injury enhancement, and five years for a serious felony prior conviction, for a total term of 16 years. Mr. Crawford appealed, alleging the three-year great bodily injury enhancement was unauthorized as a matter of law. He also sought remand for purposes of allowing the trial court to exercise discretion to strike the serious felony prior provided by the new amendment to section 1385 which became effective January 1, 2019. As to striking the serious felony prior, the prosecution and Mr. Crawford agreed that section 1385 was retroactive to cases not final on appeal. Regarding the great bodily injury enhancement, the prosecution and Mr. Crawford agreed that application of the enhancement to the battery with serious bodily injury charge was unauthorized pursuant to California Penal Code section 12022.7(g). The Court of Appeal, Fourth District, Division One, remanded with directions to allow Mr. Crawford to bring a motion to strike the serious felony prior conviction and to take such action as it deemed appropriate in its discretion. The Court of Appeal

also remanded for resentencing, directing the trial court to strike the enhancement in count one. I did not handle this case on remand, as I was no longer serving as a Superior Court judge.

People v. Zavala, No. D067821, 2016 WL 1648917 (Cal. Ct. App. Apr. 25, 2016). Mr. Zavala entered a plea of no contest to one count of assault with a deadly weapon other than a firearm (Cal. Penal Code § 245(a)(1)) in exchange for a grant of three years of probation, restitution, a stay away order, and dismissal of the remaining counts. On appeal, Mr. Zavala challenged a condition of probation ordering him not to affiliate/associate with gang members. He also challenged a protective order prohibiting him from having contact with a named victim for ten years. The prosecution conceded the issue involving the criminal protective order and did not object to modifying the gang condition to include an express knowledge requirement. The Court of Appeal, Fourth District, Division One, affirmed the judgment in all respects, except that it struck the ten-year criminal protective order pursuant to the prosecution's concession and remanded with directions to modify the gang affiliation condition to add an express knowledge requirement.

People v. Zamudio, No. D067818, 2015 WL 8542756 (Cal. Ct. App. Dec. 11, 2015). Mr. Zamudio entered a plea of no contest to one felony count of inflicting corporal injury (Cal. Penal Code § 273.5(a)) in exchange for three years of formal probation. A condition of probation included abiding by a criminal protective order barring any contact with the victim or any member of her family. On appeal, Mr. Zamudio argued the "any member of her family" language was unconstitutionally vague because the language was not limited to individuals he knew. He requested modification of the order to include a knowledge requirement. The Court of Appeal, Fourth District, Division One, affirmed the judgment in all respects, except that it remanded with directions to modify the criminal protective order to include an express knowledge requirement.

People v. Lewis, No. D063121, 2014 WL 1761673 (Cal. Ct. App. May 5, 2014). Mr. Lewis was convicted of eight counts of insurance fraud in connection with workers' compensation benefits and one count of grand theft of personal property. The jury further found that Mr. Lewis had taken benefits exceeding \$65,000. On appeal, Mr. Lewis argued that the court failed to give a unanimity instruction, erroneously admitted evidence of past workers' compensation claims, and did not instruct on the meaning of "common scheme or plan." The Court of Appeal, Fourth District, Division One, reversed the judgment, finding the trial court erred in not giving a unanimity instruction.

The District Court has an automated conflict check system. I have provided to the Clerk of the Court the names of entities as well as the names of persons who cannot appear before me due to close personal/family relationships which would preclude me from presiding over those matters. The system automatically flags any conflict so that the case may be reassigned. In addition, my clerks and I review each case for potential conflict of interest. As a United States Magistrate Judge, I have recused myself in two cases. One criminal case on the basis that the defendant had familial ties to my husband: *United States v. Montenegro*, Case No. 3:21-cr-00611-GPC; and one civil case where the plaintiffs are close friends: *Singh et al. v. Ditech Financial, LLC, et al.*, Case No. 3:18-cv-01539-WQH-KSC.

As a state court judge, I reviewed each case to determine whether there was a basis for recusal or disclosure. I recused myself sua sponte for all matters involving family, close friends, colleagues, court employees, and persons with whom I interacted on a frequent basis, such as school parent volunteers.

Additionally, I recused myself from hearing matters where my brother-in-law, a then Imperial County deputy public defender, served as defense counsel. I also recused myself as to attorneys (and their firm) who served on my campaign election committee. Although I provided these names to the Clerk of the Court, frequently these cases were nonetheless assigned to me. The court does not have an automated conflict check system wherein these conflicts are flagged and assigned to another judge.

Further, if there was an attorney who appeared before me who endorsed me and/or provided me with a financial contribution to my campaign, I disclosed such on the record to provide parties an opportunity to request recusal. To the best of my recollection, I was never asked to recuse myself on any case where I disclosed such information.

California Code of Civil Procedure § 170.6 gives litigants a process by which they may disqualify a state court judge without a showing of cause. Such disqualifications are fairly routine in Imperial County and the requests are processed as a matter of course. The court does not maintain complete and accurate data on such requests. I never had any blanket disqualifications from the District Attorney's Office, the Public Defender's Office or any other agency, firm, or counsel.

California Code of Civil Procedure § 170.1 sets forth the procedure to challenge a judge for cause. Under this section, the party must file a written motion stating the grounds for the recusal. The judge must respond within ten days in writing or the recusal must be granted. A judge outside of the county decides the motion. One attorney filed a challenge for cause in two of his cases claiming that I was biased or prejudiced against him and his office because his former law partner, who had no involvement in these cases, ran against me for Superior Court Judge during the June 2012 election. In County of Imperial v. Cera, Case No. EFS313473, I timely filed and served a Chamber Order denying the allegations as set forth in the challenge for cause. Because the Chamber Order was not verified, it was not considered. Given that the Chamber Order was not verified and that the time to file a response had passed, by operation of law it was deemed to me having consented to the disqualification. The Court did not address the merit of the challenge for cause. In Messick v. Bach, Case No. EFL03831, I filed an answer stating that I am not biased or prejudiced in favor of or against the respondent and also denied that I am biased against counsel or that the respondent cannot have a fair and impartial hearing before me. The Court found that based upon the evidence there was no legal basis for the Court to conclude that I should be disqualified and counsel's challenge was

denied. Thereafter, I presided over the matter.

In 2002, the El Centro Elementary School District Board of Trustees appointed me as Assistant Superintendent for Human Resources and Administrative Services. I resigned from this position in 2011 to serve as Assistant County Counsel for the County of Imperial.

In 2000, the Imperial Community College District Board of Trustees appointed me as Interim Director of Human Resources and in 2001 as permanent Director of Human Resources. I resigned from this position in 2002 to serve as Assistant Superintendent for Human Resources and Administrative Services for the El Centro Elementary School District.

I have not had any unsuccessful nominations for appointed office. However, as stated in response to Question 13, in June 2012, I ran to retain my seat as a Superior Court Judge in Imperial County, California, and lost the election.

Prior to my appointment to the bench in 2012, I had over 19 years of a combination of direct civil litigation experience and litigation management experience for public entities, including overseeing the work of outside counsel.

From 1993 to 2000, I worked as an associate attorney at Horton, Knox, Carter and Foote, LLP, a full-service law firm in El Centro, California. My areas of practice were in employment, school, healthcare, and municipal law, which included employment contracts, negotiations, employee discipline and dismissal, Board policies, Brown Act issues, leases, and other general labor matters. I represented many public agencies. I also worked with senior partners in numerous litigation matters and participated in all phases of litigation, including preparation numerous pleadings, discovery, and conducting depositions and trials. As to the transactional portion of my practice, I prepared numerous documents related to the incorporation process and various contracts and documents related to various types of transactions.

In 2000, I served as Deputy County Counsel IV at the Office of County Counsel, County of Imperial, where I prepared pleadings, legal opinions, memoranda, and agreements on a variety of legal matters. I also conducted numerous juvenile dependency/child welfare court trials and hearings.

The El Centro Elementary Teachers Association (ECETA) alleged the El Centro Elementary School District (District) violated the Educational Employment Relations Act (EERA) when it altered terms regarding health benefits for retirees in the parties' collective bargaining agreement. The Public Employment Relations Board (PERB) found that retirees, because they are no longer employees as defined by the EERA, are not subject to the protection of EERA. PERB found it is not an unfair practice for an employer to repudiate a contractual provision containing a permissive subject of bargaining because the employer does not have a duty under EERA to negotiate that term. PERB dismissed the unfair practice charge without leave to amend. This case has been cited over the years for the proposition that a permissive subject is not transformed into a mandatory subject solely on the basis of past bargaining or even agreement. It has also been cited for the proposition that retirees do not have standing to challenge issues related to current employee collective bargaining agreements.

As a judicial officer, two of my highest and best missions have been to increase access to justice and broaden civics education and opportunities for our youth. In 2019, I was tasked by former Chief District Judge Larry A. Burns to spearhead the "El Centro Project" along with Senior District Judge John A. Houston, which expanded the Criminal Justice Act panel to include experienced criminal lawyers based in Imperial County. This project freed San Diego-based appointed counsel in criminal cases from making a 240-mile roundtrip drive from San Diego to El Centro to make preliminary appearances. This resulted in providing local attorneys the opportunity to practice in federal court and improved the quality and efficiency of providing justice for all. Implementation of this project established a balance of good stewardship, effective use of taxpayer monies, and ensured the excellent representation of indigent clients for which our District is known, resulting in saving the District approximately \$500,000 each year.

In 2012, following my appointment as a Superior Court judge, I began establishing court community outreach programs. Since then, I have hosted student groups and hundreds of K-12 and college students from throughout Imperial County for visits to the courthouse. I served as a community partner with the Brawley K-12 Civic Learning Initiative Committee and worked with members to add a civics education component to the curriculum of all grade levels in the City of Brawley public schools. In 2017, I co-founded the Imperial County Superior Court Academy Summer Fellows Program, a mentorship program for college students and law students pursuing a career in law. This began as a six-week program where students shadow judges, observe court proceedings, conduct research, and attend trainings conducted by community justice partners. Most recently, I partnered with a United States Bankruptcy Judge to provide a two-part series on civics education and financial responsibility to high school students. This year, I also partnered with the Imperial County Superior Court to provide a federal court component to the Summer Fellows program. This was a four-week virtual program, and two of the weeks included courtroom observation at the federal courthouse and presentations from federal personnel.

As an attorney, my most significant and fulfilling work included representing public agencies in Imperial County throughout the course of my career. These agencies include but are not limited to the County of Imperial, Pioneers Memorial Healthcare District, Imperial Community College District, Imperial Valley Housing Authority, Imperial Irrigation District, the City of Brawley, El Centro Elementary School District, and the Calexico Unified School District. My work for these agencies included the adoption of antidiscrimination and sexual harassment workplace policies and complaint procedures, successfully negotiating numerous collective bargaining agreements with various bargaining units that establish fair compensation and benefits packages, and the adoption of my proposed modifications to a health benefits program that resulted in millions of dollars in yearly savings for the largest public entity in Imperial County.

I served as President and board member of the Imperial County Bar Association (ICBA). As an active ICBA member, I organized and participated in free legal services clinics in Imperial County. I assisted indigent community members with unlawful detainer actions, debt collection matters, small claims actions, and various other legal matters in my capacity as an ICBA member and as an individual.

As a judicial officer, I served as a Board member and Chairperson of the Scholarships Committee for the California Bar Foundation, a nonprofit organization that works to improve access to justice for the underserved and under-represented in California. In my last year of service with the organization, we awarded 60 scholarships and supported 21 diversity pipeline and legal services non-profit organizations across the state. We partnered with funders statewide to bolster the availability of legal services to the most vulnerable communities, including victims of fire disasters.

Outside of the legal arena, I am passionate about serving the youth in my community which I have done for more than 27 years. I have served as a keynote/motivational speaker at Imperial Valley College, San Diego State University-Imperial Valley, and various public school districts in Imperial County. I mentor students by reviewing and editing college, law school, and scholarship applications, and preparing them for interviews with college admissions officials. I volunteer as a judge and keynote speaker with the Imperial County Mock Trial Program and the Imperial County Migrant Education Program (MEP) Student Speech and Debate Competition.

I submitted an application for the United States District Court for the Southern District of California to Senator Dianne Feinstein on January 30, 2021, and to Senator Alex Padilla on February 10, 2021. I was interviewed by the selection committees for Senator Feinstein on March 12, 2021, and Senator Padilla on April 13, 2021. After my initial interview with each of the selection committees, I interviewed with the statewide Chair of Senator Padilla's selection committee on April 30, 2021, and the statewide Chair of Senator Feinstein's selection committee on June 30, 2021. On May 28, 2021, I interviewed with Counsel for Senator Padilla. On June 17, 2021, I interviewed with Senator Padilla.

In July 2021, Counsel for Senator Padilla informed me that my name was being passed onto the White House for further consideration. On July 29, 2021, I interviewed with attorneys from the White House Counsel's Office. On August 3, 2021, I was advised that I had been selected for Justice Department vetting. Since that date, I have been in contact with officials from the Office of Legal Policy at the Department of Justice. On November 3, 2021, my nomination was submitted to the Senate.
