An electric utility filed a motion for a preliminary injunction seeking to enforce two different right-of-way agreements against a landowner as part of a planned infrastructure upgrade. This matter involved an agricultural parcel and a separate residential parcel in a mountainous area, where the landowner resided with his wife and children. The electric utility asserted that it had the right to access, from a township road, its power lines on the agricultural parcel. However, the electric utility also asserted rights to traverse over the residential parcel to access and construct on the right-of-way on the agricultural parcel. The landowner testified that the proposed construction activities would risk injury to his family and his animals and would disrupt his home-based small business. The right-ofway agreements themselves were executed by the predecessor utility and previous landowners in the 1920s and the agreement governing the residential parcel was once part of a much larger tract. After a hearing where the parties took different positions on the language of the right-of-way agreements and after a complicated series of land transactions were reviewed, I granted the utility's injunctive relief in part and denied in part. One right-of-way agreement granted the utility the right to access and reconstruct its power lines on the agricultural parcel from a township road. The other right-of-way agreement granted the utility the right to enter upon a specifically delineated area that was now on a neighboring parcel, not the landowner's residential parcel. As such, I determined that the utility was unlikely to succeed on the merits as to its claim for ingress and egress over the residential parcel, but was likely to succeed on the merits as

to its rights over the agricultural parcel. The other factors governing injunctive relief weighed against access through the residential parcel but weighed in favor of access through the agricultural parcel. The injunction, as issued, prevented the landowner from interfering with the utility's rights to reconstruct the transmission lines on the agricultural parcel or its rights to enter the right-of-way from the property of a neighboring landowner or from the township road. However, I denied the utility's request for an injunction regarding ingress and egress through the residential parcel. The utility was also required to post a \$100,000 injunction bond as the result of testimony by the landowner that the utility's previous vegetation management activities interfered with his ability to grow corn on the agricultural parcel.

This matter involved a proposed class action against a developer of lead generation software for websites alleging violations of the Pennsylvania Wiretapping and Electronic Surveillance Control Act, 18 Pa. C.S. § 5701, et seq. Plaintiff alleged that the lead generation software began recording her interactions with the website from the moment she started browsing and before she could assent to any terms and conditions of the website. Defendant filed preliminary objections to Plaintiff's complaint asserting that, based on Pennsylvania law and decisions from the Third Circuit Court of Appeals and from various United States District Courts, Plaintiff's claims were legally insufficient. I denied Defendant's preliminary objections. Following the close of pleadings and with discovery responses pending to Plaintiff, Defendant filed a motion to compel arbitration and a motion to stay, arguing that the matter should be submitted to binding arbitration pursuant to the website terms of service maintained by the third-party website operator. I denied Defendant's motions, determining that Defendant availed itself of the judicial process in the Lackawanna County Court of Common Pleas and only moved to compel

arbitration after receiving an adverse ruling on its preliminary objections seeking to dismiss the complaint. Defendant had also filed a responsive pleading asserting nine affirmative defenses but did not raise the existence of the arbitration clause despite reference to the website terms and conditions. I determined, based on precedent from the Superior Court of Pennsylvania, that Defendant waived any claim to arbitration by not asserting its right through preliminary objections or in raising affirmative defenses. I also determined that the website terms were available to both parties at all relevant times and that Defendant had previously attached exhibits containing other website terms in support of its preliminary objections and cited the website terms in its answer and new matter. I noted as well that compelling arbitration at that stage would have unfairly disadvantaged Plaintiff and given Defendant an undue advantage by precluding the parties from being heard on whether Defendant waived the arbitration clause's class action waiver. The Defendant then appealed my decision to the Pennsylvania Superior Court and later discontinued the appeal as the parties settled the matter.

PSN Realty Inc. filed petitions for preliminary injunctions against the City of Scranton to stop demolition of two properties, one in a residential neighborhood and one in a mixed residential and commercial district. I held a hearing on the two matters. The City of Scranton responded during the hearing with evidence that the properties were long-blighted and that Plaintiff had failed to take the appropriate legal steps at the appropriate times over the previous years to challenge the condemnation and demolition of the structures such that it was unlikely that the Plaintiff would prevail on the merits of its claims. I denied the petitions for preliminary injunctions as Plaintiff had not established all required elements to obtain the preliminary injunctions, specifically Plaintiff's likelihood of success on the merits.

4. Lackawanna County v. Correctional Care, Inc., 2021-CV-147, 2021 WL

1115282 (C.P. Lacka. Cnty. Feb. 5, 2021), aff'd, 274 A.3d 778, 2022 WL 468540 (Pa. Commw. Ct. Feb. 16, 2022)

Lackawanna County filed an application for a mandatory preliminary injunction against the former medical services provider for Lackawanna County Prison, seeking to enforce a provision in their agreement that Defendants would secure tail insurance to cover medical malpractice claims. Under the insurance contract, only Defendants could secure the tail insurance to cover both parties after the agreement between the parties ended. Defendants refused to comply with the agreement and purchase the tail insurance to cover these claims. The matter went to a full hearing before me. I found that the Plaintiff established a clear right to mandatory injunctive relief. Specifically, Plaintiff proved the following: that it would sustain immediate and irreparable harm if the injunction was not issued as a lack of the tail insurance would expose both parties to unlimited number of potential claims without insurance coverage such that the harm would be irreversible once the deadline to procure the insurance passed; that greater harm would occur in refusing to issue the injunction as it would leave the county open to innumerable medical malpractice claims without insurance coverage resulting in a risk in the county's insolvency and/or loss of services to the detriment of the citizens of Lackawanna County; that entry of the injunction would restore the parties to their status quo prior to Defendants' refusal to obtain tail insurance as the parties were previously covered by insurance for professional liability claims; their likelihood of success on the merits, that the Defendants violated the agreement by not procuring the tail insurance and further that Plaintiff did not have an adequate remedy at law as the damages the county would incur if such claims became judgments was not able to be adequately computed or ascertained; that issuance of the injunction was reasonably suited to abate the offending activity; and lastly that the injunction would not adversely affect the public interest since denying the Plaintiff's prayer for relief would potentially jeopardize county services to the public and risk potential insolvency of the county. As such, I granted the preliminary injunction. Defendants appealed the decision to the Commonwealth Court and my decision was affirmed.

Father filed a petition for protection from abuse on behalf of his minor child against mother's fiancé related to a contentious dispute over physical custody between the father and mother. A Guardian ad Litem was appointed to represent the minor child's best interest and the minor child was interviewed at a children's advocacy center as part of a law enforcement investigation. The case went to a full hearing before me. I found that the father failed to sustain his burden of proof with competent, credible evidence to justify an order of protection, and therefore denied his petition. My decision was then appealed to the Pennsylvania Superior Court, which affirmed.

7. Commonwealth v. Efthimou, 2018-CR-853 (C.P. Lacka. Cnty.)

Mr. Efthimiou was charged by the Pennsylvania Attorney General with involuntary deviate sexual intercourse relative to alleged incidents occurring while he was a corrections officer at Lackawanna County Prison. Upon agreement of the Commonwealth and the defendant, Mr. Efthimiou pled nolo contendere to one count of official oppression, a misdemeanor, and all other charges were withdrawn by the Commonwealth. At the plea hearing, the victim was present with her private counsel. The Commonwealth and the defense requested an immediate sentence. The victim through her attorney objected to an immediate sentence and requested a full opportunity to address the court. I denied the request for an immediate sentence and ordered a presentence investigation and a sentencing hearing. I indicated that the victim would be given a full opportunity to be heard through her communication with the probation office during the presentence investigation and through her oral statement at the time of sentencing if she wished. However, the victim ultimately chose neither. I sentenced Mr. Efthimiou to the maximum sentence allowed under the sentencing guidelines, 24 months of probation. I also added 100 hours of community service to his sentence.

### 8. Commonwealth v. Johnson, 2018-CR-638 (C.P. Lacka. Cnty.)

Mr. Johnson was charged by the Pennsylvania Attorney General with institutional sexual assault, involuntary deviate sexual intercourse, indecent assault, and harassment relative to alleged incidents occurring while he was a corrections officer at Lackawanna County Prison. The Commonwealth filed pretrial motions seeking to admit evidence of other crimes or acts pursuant to Pa. R. Evid. 404(b) for the purpose of proving motive, intent, plan, or absence of mistake, including a request to admit testimony of other victims. I granted the Commonwealth's request for one of the victims to testify as I found that the circumstances were substantially similar to and consistent with the instant case. I denied the request to admit testimony of another victim, however, as I found the circumstances not substantially similar to or consistent with the instant case. On another issue in the Commonwealth's motion, I granted their request and permitted prior testimony of a deceased victim, who had been murdered in an unrelated matter during the pendency of the instant case, finding that the deceased victim had fully testified at the preliminary hearing in the instant case and that defense counsel had a full and fair opportunity to cross examine her and did in fact cross examine her at that time.

Closer to trial, defense counsel filed motions *in limine*, the most significant of which was a motion to preclude testimony of an expert witness, a forensic psychologist who was offered by the Commonwealth to explain how victims react in terms of reporting their victimization and to testify about the reporting delay in the instant case. I denied the defense motion. I allowed the psychologist to testify and ordered the Commonwealth to immediately tender to the defense the psychologist's report and *curriculum vitae*, before testimony. Mr. Johnson was acquitted by the jury after a four-day trial.

# 9. Commonwealth v. McHale, 2018-CR-780 (C.P. Lacka. Cnty.)

Mr. McHale was charged by the Pennsylvania Attorney General with institutional sexual assault and indecent assault relative to alleged incidents occurring while he was a corrections officer at Lackawanna County Prison. The Commonwealth filed a motion to admit certain evidence of other crimes pursuant to Pa. R. Evid. 404(b) for the purpose of proving motive, intent, plan, or absence of mistake. The Commonwealth's evidence concerned testimony from other victims of sexual assault by defendant. The Commonwealth withdrew their request for the testimony of one victim. As to another victim, I denied their request, finding the proposed testimony inadmissible as it was too remote in time with circumstances too dissimilar from the instant case.

Defense counsel filed motions to compel the Commonwealth to immediately produce before trial the criminal record of the victim along with non-medical and medical prison records of the victim. I granted the motions to compel the criminal record and the non-medical records but I denied their request for medical records. Defense counsel also requested transcripts of any testimony in the Commonwealth's possession of any other alleged victim. I granted the request to the extent that the Commonwealth was in possession of same. Reciprocally, I ordered defense counsel to provide the Commonwealth with copies of any transcripts in their possession concerning any other alleged victim. Other motions by defense counsel included requests for specific information about the prison cell, an inspection of the prison block and cell, and a jury view of the cell block and the actual cell. I granted the motions requesting information about the cell and allowed an inspection. I denied the defense request for a jury view as I concluded it would be too disruptive and a security concern. All documents and information which I allowed through the motions were ordered to be immediately turned over. Mr. McHale was acquitted by the jury after a four-day trial.

The Lackawanna County Office of Youth and Family Services ("OYFS") filed a dependency petition in regard to the minor child and her sibling alleging a lack of parental care and control under the Juvenile Act. OYFS also petitioned for a finding of abuse against the parents under the Child Protective Services Law. The minor child was initially removed from the parents' home and was alleged to have sustained more than three dozen rib fractures while in her parents' care. During this lengthy proceeding, there was extensive testimony which included multiple medical experts offered by both parties. I adjudicated the minor child to be dependent, that the child was without parental care, control, and supervision, and ordered the agency to continue to oversee the custody and care of the minor child temporarily while returning the minor child to the parents. However, I denied OYFS's petition seeking a finding of abuse of the minor child by the parents because, on the record before me, I was unable to rule out a natural medical defect regarding the stability and fragility of the child's bones. The minor child's sibling was not adjudicated dependent, as there was no issue concerning the parents' care of that minor child. OYFS appealed and my decision was upheld.

C.L. v. M.P., 2019-FC-41210, (C.P. Lacka, Cnty. Dec. 17, 2019), aff'd, (Pa. Super. Ct. July 8, 2020), rearg. granted, (Aug. 25, 2020), aff'd in part, rev'd in part, 255 A.3d 514 (May 26, 2021). Mother and Father cross-filed emergency petitions for custody regarding an infant and I held an emergency hearing. After significant testimony of the parties and their witnesses was completed, I appointed a Guardian ad Litem to represent the best interests of the minor child. Mother objected to the release of her mental health treatment records to the Guardian ad Litem. On reconsideration and based on the testimony, I ordered a mental health examination of both parties and the release of three years of mental health records of both parents to the Guardian ad Litem as part of the Guardian ad Litem's factgathering to make a report and recommendation under the Child Custody Act. I also sealed the record to protect the privacy of the parties. There was no existing appellate precedent on point at the time of my decision regarding whether there was any conflict between the provisions of the Child Custody Act and the Mental Health Procedures Act and the interpretation of the two. I proceeded in a manner that attempted to balance the competing statutes and Rules of Civil Procedure and to harmonize same. I determined that the mental health records could be released to the Guardian ad Litem in a manner that protected the parties' privacy rights under the Mental Health Procedures Act and that satisfied the obligations of the Child Custody Act where the safety of the minor child and the mental health conditions of the parties were critical components of the best interests analysis, and which are mandated considerations contained in the statutory child-custody factors. Mother appealed to the Pennsylvania Superior Court. A three-judge panel

affirmed my decision. Mother moved for reargument, and the Pennsylvania Superior Court granted her motion and retracted its panel opinion. A nine-judge panel affirmed in part and reversed in part. The provisions of my order directing the parties to a mental health examination were affirmed. The provisions of my order directing the release of mental health records were reversed.

The Lackawanna County Court Administrator's office automatically assigns matters involving Munley Law, P.C. to other judges due to my partnership with that firm while in private practice. Similarly, the Lackawanna County Court Administrator's office automatically assigns to other judges matters for which my husband is counsel.

I issued recusal orders following assignment in the below cases.

Arpino v. Goffer, 2019-FC-40143 (C.P. Lacka. Cnty.). I recused *sua sponte* from this case due to my professional relationship with the plaintiff. Upon assignment, I confirmed the identity of the parties and determined, pursuant to Pennsylvania Rule of Judicial Conduct 2.11, that my impartiality might be reasonably questioned on an objective basis, and therefore that recusal was warranted.

Comerford v. Fanelli, 2018-FC-40342 (C.P. Lacka. Cnty.). I recused following a motion for recusal and after hearing from defendant and her counsel that she believed I had a close personal relationship with plaintiff's family. Although I believed I could be fair and impartial, I recused on the basis that defendant had sincerely held concerns that I could not be fair and impartial. I considered testimony from the defendant and determined that the case should be reassigned to another judge based on the defendant's concerns. Pursuant to Pennsylvania Rule of Judicial Conduct 2.11, I recused.

Commonwealth v. Hazzouri, MD, MJ-45102-CR-0000227-2021. I recused sua sponte because my family members have an ongoing professional relationship with the defendant. I determined that my impartiality might be reasonably questioned on an objective basis pursuant to Pennsylvania Rule of Judicial Conduct 2.11.

Dragann v. Florey Lumber Co., 2020-CV-4118 (C.P. Lacka. Cnty.). I recused sua sponte on the basis that I had a professional relationship with defendants. I determined that my impartiality might be reasonably questioned on an objective basis pursuant to Pennsylvania Rule of Judicial Conduct 2.11.

Gerrity v. Adamo, M.D., et. al., 2020- CV-2782 (C.P. Lacka. Cnty.). I recused sua sponte on the basis that I had a personal and professional relationship with both a plaintiff and a defendant. I determined that my impartiality might be reasonably questioned on an objective basis pursuant to Pennsylvania Rule of Judicial Conduct 2.11.

In re: Name Change of J.A.C., 2021-CV-4320 (C.P. Lacka. Cnty.). I recused sua sponte because my family members provided legal representation to petitioner's husband's immediate family members on more than one occasion. I determined that my impartiality might be reasonably questioned on an objective basis pursuant to Pennsylvania Rule of Judicial Conduct 2.11.

Italian Congregation of St. Francis D'Assisi, Eynon, PA, Inc. v. Smargiassi Construction, Inc. and the Borough of Archbald, 2015-CV-3579 (C.P. Lacka. Cnty.). I recused sua sponte on the basis that Archbald, Pennsylvania is my hometown and members of my family resided in Archbald for generations. confirmed the identity of the plaintiff corporation and its principal shareholders and determined that my impartiality might be reasonably questioned on an objective basis pursuant to Pennsylvania Rule of Judicial Conduct 2.11.

4. Cooke v. Pennsylvania Department of Transportation et al., 984 C.D. 2011 (Pa. Commw. Ct. Jan. 27, 2012)

My client in this matter had been a passenger in a motor vehicle operated by another minor who was under the legal driving age. The vehicle went off the roadway and struck a tree. # 5. Shenosky v. Hazelton General Hospital, 2007-CV-1688 (C.P. Luz. Cnty.)
