In March 2015, I was appointed to serve as a United States Magistrate Judge in the Alexandria Division of the United States District Court for the Eastern District of Virginia. I was selected by the district judges of the Alexandria Division to serve an eight-year renewable term.

The district court has jurisdiction over civil matters raising federal questions, civil matters with diversity of citizenship, and federal criminal matters. As a magistrate judge, my jurisdiction is governed by 28 U.S.C. § 636. I preside over civil lawsuits by consent of the parties, decide civil discovery disputes and non-dispositive motions referred to me by district judges, and conduct settlement negotiations. I conduct initial appearances and bail hearings in felony criminal cases and oversee criminal cases in full when they involve petty offenses and misdemeanor charges. I review applications for search and arrest warrants.

Plaintiffs, federal pretrial detainees held in a state-run detention facility in Baltimore, filed this class action lawsuit alleging constitutional violations based on the conditions of their confinement and exposure to COVID-19. After a severe outbreak of COVID-19 among inmates and staff at the detention facility, plaintiffs alleged that the conditions at the facility, specifically protocols for testing, quarantining, vaccinating, and cleaning, were insufficient and that injunctive relief was required to address the health and safety of the inmates. The case was originally filed in the United States District Court for the District of Maryland, but it was transferred following the recusal of the District Judges in Maryland. This matter was reassigned to Judge Ellis, who referred all matters related to discovery and settlement to me. After a ten-hour settlement conference and follow-up discussions, the parties successfully reached agreement as to terms to ensure the safety and health of detainees.

Plaintiffs brought this class action lawsuit against Dominion Dental Services and other providers of dental and vision benefits following the disclosure of a data breach of customers' personal information over a period spanning nine years. Judge Brinkema referred all discovery matters to me. Plaintiffs filed a motion to compel production of the cybersecurity report produced in response to the data breach. Defendants opposed the motion, arguing that the report was protected by the work product doctrine. I ordered the production of the report. Plaintiffs also brought a motion to compel complete answers to interrogatories, which I granted in part and denied in part. Judge Brinkema granted in part the defendants' motion to dismiss for lack of standing and rejected the class action claims of the plaintiffs. Plaintiffs filed an interlocutory appeal before the Fourth Circuit Court of Appeals. The parties subsequently submitted a joint motion for preliminary approval of class action settlement, which Judge Brinkema granted. Mr. Yerman was charged in a two-count criminal information with carrying a concealed weapon, in violation of assimilated state law (18 U.S.C. § 13, assimilating Va. Code § 18.2-308(i)), and unlawful possession of a firearm in a federal facility, in violation of 18 U.S.C. § 930(a). Mr. Yerman approached the United States Marine Corps Base Quantico with a firearm in his vehicle and was stopped at the gate under a large canvas awning that covered the sidewalk and roadway. Defendant filed a motion to dismiss, arguing that he possessed a valid permit to possess a concealed firearm and that the statute prohibiting possession in a federal facility required the government to prove Mr. Yerman entered a "building or part thereof." The government opposed the motion and maintained that the awning covering the roadway constituted a part of the "building" housing the government did not appeal.

Plaintiff, a former high school student, brought this action under Title IX against the Fairfax County School Board alleging deliberate indifference following her claim of sexual assault by a fellow student during a school band trip. Plaintiff alleged that the school failed to investigate her claims or follow its own procedures, and then threatened her with discipline while permitting the alleged perpetrator to remain in school. Judge O'Grady referred the case to me for all discovery matters, and I resolved numerous discovery disputes, including a motion to compel an independent mental examination, a motion to compel production of text messages, and several motions to quash. I granted sanctions against the defendant for spoliation of evidence, including witness statements, interview notes, and text messages. Petitioner was convicted of nine counts of incest in state court following a trial and sentenced to a term of imprisonment of twenty years. He filed a petition for a writ of habeas corpus pursuant to 28 U.S.C. § 2254 seeking collaterally to attack his conviction based on ineffective assistance of counsel, arguing his counsel failed to challenge the admissibility of the victim's "recovered" memories. Respondent filed a motion to dismiss, and Judge Ellis referred the matter to me. Defendant embezzled more than \$19.4 million from his employer over a ten-year period. He entered a plea of guilty to one count of wire fraud, in violation of 18 U.S.C. § 1341, and was sentenced to 78 months of imprisonment and ordered to pay \$19,440,331 in restitution. The government filed an application for a writ of garnishment seeking to garnish his 401(k) retirement accounts in partial satisfaction of his restitution obligations. Defendant opposed the application on the grounds that the account was inalienable. Judge Brinkema referred the matter to me. I recommended granting the application and, in footnote 11, noted with approval the government's offer to allow defendant to retain ten percent of the funds to pay any tax penalties associated with the early liquidation of the account. Upon review, Judge Brinkema adopted my findings and recommendations and, noting that the government had confirmed its offer to allow defendant to retain ten percent of the funds, granted permission to do so. The matter is currently pending before the Fourth Circuit Court of Appeals.

Plaintiff brought this action against a law firm that had sued him in a state court collection action for failure to pay a credit card debt. Petitioner sought a writ of coram nobis to overturn a conviction for possession of marijuana in violation of 18 U.S.C. § 844. The defendant entered a plea to one count of possession of marijuana. Tyrone B. v. Saul, No. 1:19-cv-1367-LMB-MSN (Dkt. No. 23) (E.D. Va. Nov. 30, 2020), rev'd, 1:19-cv-1367-LMB-MSN (Dkt. No. 24) (E.D. Va. Feb. 16, 2021): After his application for Disability Insurance Benefits was denied by the Social Security Administration, plaintiff appealed. The Commissioner moved to remand for further administrative proceedings and directed the ALJ to consider additional information from the Veterans Administration. The ALJ found no disability a second time after plaintiff failed to appear at his hearing. Plaintiff raised several issues on appeal, including whether the Acting Commissioner of the Social Security Administration was an unlawful acting official at the time the ALJ denied his claim. I recommended granting summary judgment in favor of the defendant on procedural grounds, based upon plaintiff's failure to appear at his second hearing before the ALJ. I also found that the Acting Commissioner's authority was proper. Judge Brinkema rejected the report and recommendation and found sua sponte that the ALJ's review on remand had not followed the instructions of the Appeals Council. Judge Brinkema remanded the case to the ALJ for further review. Copy supplied.

Bunk, et al. v. Birkart Globistics, et al., No. 1:02-cv-1168-AJT-MSN (Dkt. No. 1395) (E.D. Va. Jan. 8, 2016), rev'd, 1:02-cv-1168-AJT-MSN (Dkt. No. 1479) (E.D. Va. Aug. 22, 2017): This matter involved the government's effort to enforce a \$24 million judgment under the False Claims Act. The Court issued a Writ of Continuing Non-Wage Garnishment over a foreign corporation in an effort to collect that judgment. One of the defendants sought to quash the writ on the grounds it was not properly served. I found that the writ was properly served under the Federal Rules of Civil Procedure. Judge Trenga sustained the defendant's objection and found that personal jurisdiction could not be established. Accordingly, he quashed the writ. The United States appealed Judge

Trenga's decision. The appeal was voluntarily dismissed after full satisfaction of the judgment was made. Copy supplied.

ExxonMobil Oil Corp. v. Black Stone Petroleum Inc., No. 1:16-cv-148-TSE-MSN (Dkt. No. 15) (E.D. Va. Aug. 10, 2016), *rev'd in part*, 221 F. Supp. 3d 755 (E.D. Va. 2016): This matter involved a contract dispute over a roadside service station in New Jersey. Exxon sued Black Stone Petroleum and FDD Realty for rebranding its service station and violating its contract. I recommended entry of default judgment against Black Stone but recommended dismissal of FDD Realty, finding that plaintiff was not an intended beneficiary of the contract between Black Stone and FDD Realty. I also recommended denial of pre- and post-judgment interest. Copy supplied. Judge Ellis affirmed in part and reversed in part, concluding that Exxon was a third-party beneficiary of the contract and that post-judgment interest should be awarded. Judge Ellis adopted the recommendation with respect to denial of pre-judgment interest.

Sectek, Inc. v. Diamond, No. 1:15-cv-1631-AJT-MSN (Dkt. No. 97) (E.D. Va. July 12, 2016), *rev'd*, No. 1:15-cv-1631-GBL-MSN, 2016 U.S. Dist. LEXIS 140098 (E.D. Va. Oct. 6, 2016): This case involved a dispute over the execution of a Stock Purchase Agreement. During pretrial proceedings, the parties filed cross-motions as to the application of the claw-back provisions regarding inadvertent disclosure of documents protected by the attorney-client privilege. I denied both motions and directed the parties to bring any dispute regarding specific disputed documents to the Court's attention immediately following depositions. Copy supplied. Diamond appealed and Judge Lee reversed, finding that that the privilege had been waived because Sectek failed to produce its privilege log in a timely manner, failed to meet its burden to establish the privilege, and failed to promptly rectify the inadvertent disclosure. Following trial of the matter, the parties settled all claims, vacating the final judgment and dismissing the appeal.

In the following cases, my recommendation was modified in part:

Douglas v. Sentel Corp., No. 1:18-cv-1534-TSE-MSN, 2020 U.S. Dist. LEXIS 149928 (E.D. Va. Mar. 11, 2020), *adopted in part*, No. 1:18-cv-1534-TSE-MSN, 2020 U.S. Dist. LEXIS 89421 (E.D. Va. May 21, 2020): In this motion for default judgment, plaintiff sought damages under Title VII of the Civil Rights Act for failure to accommodate his religion, creation of a hostile work environment, and retaliation, and also advanced state law claims of tortious interference with business expectancy, defamation, and conspiracy. I granted the motion in part and denied in part, finding that plaintiff had established violations under Title VII and one instance of defamation but had not established the remaining claims. I recommended damages in the form of lost wages (\$282,814 plus an additional \$98,985 to offset tax payments) and compensatory damages (\$50,000), but no future pay or punitive damages, and also recommended granting the request for attorneys' fees and costs. On review, Judge Ellis adopted my findings of fact and

the report and recommendation, except that he did not award the \$98,985 for income tax disparity and he added an additional \$1,000 in punitive damages. In all other respects, Judge Ellis agreed with my findings and recommendations.

United States v. Frank, Case No. 1:17-cr-114-LMB-MSN (Dkt. No. 76) (E.D. Va. Mar. 4, 2020), adopted in part, No. 1:17-cr-114-LMB-MSN (Dkt. No. 83) (E.D. Va. May 11, 2020): The government filed an application for a writ of garnishment seeking to garnish defendant's 401(k) retirement accounts in partial satisfaction of his restitution obligations. Defendant opposed the application on the grounds that the account was inalienable. Judge Brinkema referred the matter to me, and I recommended granting the application but, in footnote 11, noted with approval the government's offer to allow defendant to retain ten percent of the funds to pay any tax penalties associated with the early liquidation of the account. Copy previously supplied in response to Q13c. Upon review, Judge Brinkema adopted my findings and recommendations and, noting that the government had confirmed its offer to allow defendant to retain ten percent of the funds, granted permission to do so. Copy supplied.

Doe v. Fairfax Cty. Sch. Bd., Case No. 1:18-cv-614-LO-MSN (Dkt. No. 178) (E.D. Va. June 28, 2019), *adopted in part*, No. 1:18-cv-614-LO-MSN (Dkt. No. 253) (E.D. Va. July 23, 2019): Plaintiff, a former high school student, brought this action under Title IX against the Fairfax County School Board alleging deliberate indifference following her claim of sexual assault by a fellow student during a school band trip. I granted sanctions against the defendant for spoliation of evidence, including witness statements, interview notes, and text messages. Copy previously supplied in response to Q13c. Defendant appealed, and Judge O'Grady granted the objection in part and denied in part. He found no clear error or any analysis contrary to law and agreed that there was a duty to preserve the documents, the documents existed, and the documents were relevant. Judge O'Grady further agreed sanctions were warranted but withheld ruling on the appropriate form of jury instruction until after evidence on the loss or destruction of documents was presented at trial. Copy supplied.

Aslani v. Curry, No. 1:16-cv-01398-LMB-MSN (Dkt. No. 18) (E.D. Va. Dec. 15, 2016), adopted in part, No. 1:16-cv-01398-LMB-MSN (Dkt. No. 35) (E.D. Va. Jan. 25, 2017): This matter came before me on both a motion for default judgment and a motion to set aside default, following improper service on the defendant. Plaintiff sought damages under Title IX of the Civil Rights Act, claiming violation of Title IX, retaliation, defamation per se, false light, and intentional infliction of emotional distress. I recommended dismissal of the case under 28 U.S.C. § 636(b)(1)(B) based on a lack of personal jurisdiction. The defendant had no ties to the state of Virginia, was a resident of Illinois, and the alleged violation took place in Illinois. Copy supplied. On review, Judge Brinkema adopted my findings that service was not proper and that the Eastern District of Virginia was not the proper venue. However, instead of dismissing the case, she transferred it to the Northern District of Illinois, Eastern Division. Copy supplied.

I also prosecuted misdemeanor offenses for the Town of Herndon.

From 2002 to 2015, I worked in the Office of the Federal Public Defender for the Eastern District of Virginia. As First Assistant Federal Public Defender from 2002 to 2005, I represented hundreds of clients in preliminary hearings, competency hearings, detention hearings, plea hearings, sentencing hearings, pretrial motions, bench and jury trials, probation violations, supervised release hearings, and appeals. These cases involved a wide range of federal offenses. I also had numerous supervisory responsibilities. Mr. Brehm, a South African citizen, was charged with assault with a dangerous weapon and assault resulting in serious bodily injury, in violation of 18 U.S.C. §§ 113(a)(3) and (a)(6), following an altercation with a British national on a NATO base in Kandahar, Afghanistan. I served as lead counsel and worked on all aspects of the defense investigation, pretrial motions practice, conditional plea, and appeal. Mr. Brehm entered a plea of guilty to one count of assault resulting in serious bodily injury. Judge Trenga sentenced him to 42 months of imprisonment.

I briefed and argued the appeal before the United States Court of Appeals for the Fourth Circuit (*United States v. Brehm*, 691 F.3d 547 (4th Cir. 2012)), in which Mr. Brehm challenged the constitutionality of the Military Extraterritorial Jurisdiction Act on the grounds that two foreign nationals engaged in illegal conduct on a multinational military base did not have a sufficient nexus to the United States to be subject to jurisdiction in federal court. 2. United States v. Mohamadi, 1:09-cr-179-LO (E.D. Va.)

This case involved Hobbs Act robbery, firearms offenses, solicitation to commit murder for hire, murder for hire, and witness tampering, in violation of 18 U.S.C. §§ 1952, 924(c), 373, 1958, and 1512. 3. United States v. Ayala, 1:08-cr-474-CMH (E.D. Va.)

Mr. Ayala was charged with second degree murder following the killing of an Afghan national outside of Kandahar, Afghanistan while serving as a contractor with a Human Terrain Team working with the U.S. military. He apprehended an individual who he learned had set his colleague on fire minutes earlier and shot him at point-blank range while the individual was in handcuffs. I served as lead counsel and supervised the investigation, defense, and mitigation strategy as well as the plea negotiation and sentencing of this emotionally-charged case. 4. *Kimbrough v. United States*, 552 U.S. 85 (2007)

While I had been supervising the general strategy of challenging the crack/powder disparity following the decision in *Booker v. United States*, 543 U.S. 220 (2005), my specific involvement in this case arose after certiorari was granted. I argued before the United States Supreme Court on behalf of the petitioner, Mr. Kimbrough, regarding the racial disparity of the 100:1 crack/powder ratio and the authority of district courts to impose below-guidelines sentences in light of *Booker*, based upon a categorical rejection of the advisory guideline range. I presented the oral argument, assisted in drafting the briefs to the Supreme Court, and supervised the team effort of the federal defender and indigent defense community regarding sentencing litigation strategy. The Supreme Court ruled in favor of Mr. Kimbrough, reversed the Fourth Circuit's rejection of the district court for imposition of the original sentence.

In addition to my work in the courtroom, I have pursued a variety of legal activities that do not directly involve litigation. I have devoted substantial time and effort to the pursuit of criminal justice reform as a national advocate for the federal defender program. These activities included testifying before the following congressional and judiciary committees on a variety of topics: the Senate Judiciary Subcommittee on Bankruptcy and the Courts (2013) (federal defender funding crisis), the House Judiciary Subcommittee on Crime, Terrorism, and Homeland Security (2008) (crack/powder disparity), and the United States Sentencing Commission (2009, 2010, 2011, and 2012) (25th Anniversary Regional Hearings, Mandatory Minimum Report, crack retroactivity, and *Booker* Hearing).

I assisted numerous incarcerated clients with concerns related to the conditions of their confinement, including access to mental health and other treatment programs, the correct calculation of release dates, and other post-conviction issues through non-litigation advocacy and outreach to the Bureau of Prisons. Finally, as a judge, I have also developed substantial expertise outside the courtroom in the area of mediation, having resolved numerous cases through settlement covering the full spectrum of civil litigation that arises in the Eastern District of Virginia.

I have dedicated a substantial portion of my career to providing legal services to the most vulnerable people in Northern Virginia charged with federal crimes. As an attorney in private practice, I joined the Criminal Justice Act Panel for the Eastern District of Virginia and sought out opportunities to provide pro bono assistance to clients who could not afford to hire our law firm. As Federal Public Defender, I represented people who faced the most severe consequences the criminal justice system can impose. Many of them had been alienated from their families and from society or suffered from mental illness. I have also sought to serve the disadvantaged by speaking on behalf of the federal defender community as a witness before several congressional and judicial committees. In 2008, I co-founded the Frank Dunham Federal Criminal Defense Conference to honor the memory of Frank Dunham, my law partner and the first Federal Public Defender for the Eastern District of Virginia, and to provide CJA panel members from across Virginia with continuing legal education specializing in federal criminal defense issues.
