This case was brought by a plaintiff who alleged that he had contracted HIV because of a blood transfusion. The lower court (Judge Robert A. Lanier) dismissed plaintiff's suit after he failed to issue process within the time prescribed. The Tennessee Court of Appeals (Judges Highers, Farmer, and Lillard) upheld the trial court's ruling, noting the

court's broad discretion over procedural matters. I was lead counsel for the hospital at the trial and appellate levels.

Serving in public office for 23 years has included some of the most significant legal activity of my career. My years as a member and officer of the Senate Judiciary Committee were formative and led to appointments to the Senate Ethics Committee and the Senate Rules Committee, as well as to my election to the office of Senate Majority Leader. In each of these positions, I have relied on the skills and insights that I developed during my career as a trial and appellate litigator to serve the people of Tennessee. These roles also afforded invaluable opportunities to interact with members of the judiciary, as well as elected officials, helping me to gain important perspective on the operation of the legal system. Finally, I have sponsored and enacted more than 1,400

laws during my time in the Senate. My legislative drafting work has given me insight and appreciation into the finer points of precise legal drafting, and has exposed me to many important fields of the law that had been outside my experience as a commercial litigator, such as criminal and juvenile justice.

As a Senator, I am not lobbyist, nor have I acted as a lobbyist in the past. My firm provides government relations services to firm clients, which are disclosed in annual filings with the State of Tennessee. Each year, I document in my employment agreement with Adams and Reese the parameters and prohibitions pertaining to my dual status as a lawyer and a legislator. Furthermore, consistent with the rules governing the Tennessee Senate, I make a declaration when any matter that comes before the Senate involves clients for whom Adams and Reese has lobbied.

Prior to my election to public office in 1994, I provided pro bono assistance to several nonprofit organizations. During my State Senate service, I frequently receive requests for assistance which might either be requests for legal services or assistance in my capacity as a public official which always requires careful disclosure on my part. Often times, I am able to assist so that constituents do not have to retain counsel typically in matters

involving unemployment, disability, or veterans benefits, health insurance and housing needs.

Tennessee Supreme Court Rule 8, Rule of Professional Conduct 6.1, Pro Bono Public Service, provides that a lawyer should aspire to render at least 50 pro bono hours per year, and I do. Last year, I estimated that I had provided at least 100 pro bono hours. In addition, I served on the Tennessee Supreme Court's Access to Justice Court System Advisory Committee from April 2009 – April 2010 and the Resources Committee from April 2010 through 2013. In 2009, I sponsored and enacted legislation amending state law to allow certain attorney-employees of the State of Tennessee to perform pro bono legal service (Public Chapter 7, effective July 1, 2009).

On February 17, 2017, Senator Lamar Alexander contacted me to determine my interest in being considered for one of the vacancies on the United States District Court for the Western District of Tennessee. Later that day, I wrote to Senators Alexander and Corker to confirm my willingness to serve. On March 24, 2017, I was contacted by the Office of White House Counsel to schedule an interview. On March 31, 2017, I interviewed with lawyers from the White House Counsel's Office and the Office of Legal Policy of the Department of Justice. On April 24, 2017, I was notified by the White House Counsel's Office, and Senators Alexander and Corker, that I had been selected as the preliminary candidate for one of the vacancies, pending the completion of the requisite background checks.

Since April 24, 2017, I have been in contact with officials from the White House Counsel's Office and the Office of Legal Policy. On July 13, 2017, the President submitted my nomination to the Senate.
