I presented to an audience of individuals about how it will take a coordinated effort between the community and law enforcement to address issues of drugs, violence and blight. I reinforced to the group that they must assist the United States Attorney's Office and other entities in building community trust in the youth. I used some notes on a small piece of paper; however, I did not keep them. I do not remember any press coverage of the event. There is also no recording or transcript of the event which I am aware.

March 2019: Remarks, Cincinnati USA Regional Chamber of Commerce Honoree, Cincinnati Regional Chamber, 3 East 4th Street, Cincinnati, Ohio 45202. I gave remarks made in humble acknowledgement of being recognized as a leader in the Greater Cincinnati area. I provided remarks on behalf of the United States Attorney's Office welcoming the new attorneys to the federal bar and reminding them of their duties to be zealous advocates for the clients and respectful to their fellow peers. I spoke without notes and there was no press coverage, recording or transcript of which I am aware.

January 8, 2019: Presenter, Federal Bar Association Continuing Legal Education, Potter Stewart U.S. Courthouse, 100 East Fifth Street, Cincinnati, Ohio 45202. I provided a CLE presentation on federal criminal practice to individuals seeking to become admitted to the Southern District of Ohio. I did not retain the outline or notes and there is no transcript which I am aware. Press coverage for the event is attached.

May 17, 2018: Remarks, Madisonville Community Council General Body Meeting, 6111 Madison Road, Cincinnati, Ohio 45227. I spoke to community residents about the ways individuals can continue to work with local, state and federal law enforcement to address issues of drug trafficking and violence. I reinforced to the audience how the community of Madisonville was a gem site for the Department of Justice's Weed and Seed program and that the residents must continue to build on that great foundation. I spoke without notes and there was no press coverage, recording or transcript of which I am aware.

March 23, 2018: Speaker, Dayton, Ohio Police Department 107th Recruit Class Graduation Ceremony, Sinclair Community College, Smith Auditorium, 301 West Fourth Street, Dayton, Ohio. I gave the keynote speech to the Dayton Police Department's recruit class, their families and community guests regarding the honor and high responsibility of being a law enforcement officer. I presented to a group of students from the Cristo Rey High School about the makeup, functions and procedures of the United States Attorney's Office. I did not retain the outline or notes and there was no press coverage, recording or transcript of which I am aware.

February 25, 2017: Speaker and Panelist, Black Unity Conference, Sinclair Community College, 444 West Third Street, Dayton, Ohio 45402. I provided remarks to a group of men and later to a larger audience during a panel session, focusing on personal accountability and the power of individuals coming together to build positive things in the community. I did not retain the outline or notes and the press coverage is supplied.

January 22, 2017: Speaker, The Opioid Epidemic and Its Impact on the Jewish Community at the Golf Manor Synagogue, Golf Manor Synagogue Social Hall, 6442 Stover Avenue, Cincinnati, Ohio 45237. At the symposium, I provided a presentation on the opioid scourge from the view of the federal authorities and, as requested, its impact on the local Jewish community in Cincinnati. I remember the audience being comprised of members of the community and law enforcement and state and local government officials. I did not retain the outline, notes or slides and there was no press coverage, recording or transcript of which I am aware. January 10, 2017: Welcoming Remarks, Federal Bar Admission Ceremony, U.S. District Court for the Southern District of Ohio, Potter Stewart U.S. Courthouse, 100 East Fifth Street, Cincinnati, Ohio 45202. I provided remarks on behalf of the United States Attorney's Office welcoming the new attorneys to the federal bar and reminding them of their duties to be zealous advocates for the clients and respectful to their fellow peers. I did not retain the outline or notes and there was no press coverage, recording or transcript of which I am aware.

October 29, 2016: Speaker, A Few Good Men Organization's Luncheon at the St. John's Lodge #3, 817 Windham Avenue, Cincinnati, Ohio 45220. I provided a speech about the importance of honoring the elders in the community and those who seek to better society. I did not retain the outline or notes and there was no press coverage, recording or transcript of which I am aware.

I gave a presentation to the IACP State and Provincial Planning Officers Section about the national impact of the opioid scourge with a focused view regarding the Southern District of Ohio. The audience was comprised of local, state and federal law enforcement officers. I did not retain the outline used and there was no press coverage or recording of my particular session that I am aware.

September 22, 2016: Panelist, Metropolitan Area Religious Coalition of Cincinnati (MARCC) Let's Talk Session at 632 Vine Street, Suite 606, Cincinnati, Ohio 45202. I served on a panel, presenting remarks to an interfaith coalition comprised of 15 denominations about the intersection of the Second Amendment and federal statutes so that members would better understand how to address issues of violence in the community. I spoke without notes and there was no press coverage, recording or transcript of which I am aware.

July 21, 2016: Speaker, National League of Cities (NLC) - National Black Caucus

of Local Elected Officials (NBC-LEO), 2016 Summer Conference Opening Plenary Luncheon Keynote Address: The Role of Prosecutors in the Criminal Justice System, Renaissance Hotel, 50 North 3rd Street, Columbus, Ohio 43215. I gave a speech to a number of conference attendees about the role of the prosecutor in seeking accountability in the criminal justice system. The substance of my speech was to reinforce that it is the prosecutor's duty and responsibility to ensure the defendant is treated fairly during each part of the criminal justice. Furthermore, I emphasized that the prosecutor should seek a just verdict, and not hold a "win versus a loss" mentality. I spoke with notes, however I cannot find them. There was no press coverage, recording or transcript of which I am aware.

July 12, 2016: Presenter, Federal Bar Association Continuing Legal Education Presentation, Potter Stewart U.S. Courthouse, 100 East Fifth Street, Cincinnati, Ohio 45202. I gave a presentation entitled: *Changing Drug Landscape – Federal and State Courts*. I made the presentation with a state court prosecutor to a group of primarily state law enforcement and other officials about the changing drug landscape in Ohio due to the opioid scourge. To the best of my knowledge and based on what I was told, the summit was the first of its kind in the nation to bring stakeholders together to learn about and discuss drugged driving. I did not retain the outline or notes and the press coverage for the event is supplied.

April 26, 2016: Brief Remarks, Hamilton County, Ohio Office of Re-entry Event, Great American Ballpark, 100 Joe Nuxhall Way, Cincinnati, Ohio 45202. The defendants, Christopher Stegawski, M.D. and John Randy Callihan operated fraudulent pill mill businesses in Dayton and Lucasville, Ohio. Initially, Callihan owned the businesses and Stegawski served as the doctor. Fueling the opioid scourge that was occurring in Ohio, hundreds of people traveled from all over the Midwest and South to the defendants' pill mills to illegally obtain illegal prescriptions. Serving as the lead prosecutor, I facilitated the investigation and prosecution. I handled both defendants' plea negotiations. Although Stegawski chose to proceed to trial, Callihan plead guilty to the charges against him and agreed to testify in Stegawski's case. During the trial, I handled the opening statement, the direct examinations of a number of government witnesses, and the government's closing argument and rebuttal. A jury convicted Stegawski of conspiracy to distribute and dispense prescription drugs, conspiracy to launder money and maintaining a place for illegal distribution of drugs. The Court sentenced Stegawski to 160 months imprisonment on each count and Callihan to 60 months in prison.

 United States v. Clarence Remble et al. Case No. 05-CR-00113-1 United States District Court for the Southern District of Ohio The Honorable Sandra Beckwith 2005-2011

The investigation involved a major California street gang that was establishing drug trafficking cells throughout the United States. I facilitated the prosecution of more than twenty people with most of them charged in the Southern District of Ohio. The prosecution was in accordance with the mission of the Ohio High Intensity Drug Trafficking Area (HIDTA). I handled all of the plea negotiations in the case. Clarence Remble, the leader of the Los Angeles Crips organization, was the only defendant who went to trial. During Remble's trial, I handled the voir dire, opening statement, direct examination of a number of government witnesses, the government's Rule 29 Response, and part of the government's closing arguments, including rebuttal and the forfeiture arguments. The jury found Remble guilty on all counts. Remble was sentenced to life in prison. The sentences for Remble's co-conspirators ranged from time served to 240 months imprisonment.

After the trial, Remble's mother, Betty Birl, claimed that she was the actual owner of palatial estate he had built in Los Angeles with drug proceeds. Although Remble had duped his mother into placing her retirement assets into the building of the residence, the amount was nominal (\$16,000) compared to the hundreds of thousands of dollars cost to build the home. I traveled to California to depose a number of Remble's family members and the builder. Through the depositions, I showed that Remble's mother only held a named interest in the residence. The United States successfully seized the property and returned Remble's mother's life savings to her.

> This case involved the prosecution of two members of a drug trafficking organization that spread over several states, with Chicago and Atlanta being the main "distribution centers" and "branch offices" operating in Cincinnati, Philadelphia, New York City, Raleigh, and elsewhere. In total, the larger drug trafficking network moved more than 600 kilograms of cocaine (plus heroin and marijuana) out of Atlanta, regularly generating more than an estimated \$5 million in profits per month. Reginald Myers was the leader of the Cincinnati drug distribution operation. He used a hair care business as a "front" for his drug distribution operation. Reginald's brother, George Myers, transported the cocaine from Atlanta and Chicago to Cincinnati for Reginald. I charged both Reginald and George with narcotics violations. I handled George Myers' plea negotiations, whereby he agreed to plead guilty and testify at Reginald's trial.

During Reginald's trial, I handled the voir dire, opening statement, direct examination of a number of government witnesses, including George, the government's Rule 29 Response, and the government's closing rebuttal argument. The jury found Reginald guilty on all counts. He was sentenced to 232 months imprisonment and ten years of supervised release. George Myers was sentenced to 121 months imprisonment.

> Working with the FBI and Warren County Drug Task Force, I successfully sought the indictment of eleven people operating a drug trafficking organization between

the Southern District of Ohio (Butler, Montgomery and Warren Counties) and the State of Arizona. The investigation culminated with the seizure of approximately \$3.6 million dollars in narcotics, more than \$680,000 in cash, as well as a large number of vehicles, motorcycles and other items. Law enforcement officers apprehended the ringleader, Justin Bach, in Arizona where he attempted to change his identity and hide.

I negotiated pleas with all of the members of the drug trafficking organization. The initially indicted federal defendants received sentences ranging from time served to 360 months. As the initial federal case was concluding, a twist arose when one of the defendant's sons began plotting to harm the FBI agent handling the case. I facilitated the investigation of those allegations and, ultimately, charged the son with conspiring to harm a federal officer. Although the son's plan was very "amateurish" in nature, his actions could not be tolerated. I negotiated a plea with him, and he was sentenced to 42 months imprisonment.

Through my work with our federal and state law enforcement partners, the investigation also resulted in solving the murder-for-hire of Jeff Thomas in Dayton, Ohio. Because Thomas' murder was peripheral to the drug trafficking organization's activities, I presented the homicide portion of the investigation to the County Prosecutor to address on the state level. The County Prosecutor charged the triggerman and his accomplice for Thomas' murder. A number of the plea agreements I negotiated in the federal case required the defendants to testify in the state court proceedings to the circumstances surrounding Thomas' murder. The triggerman received a state sentence of life in prison and the accomplice received a sentence of 21 years.

Case No. 1:07CR00148 United States District Court for the Southern District of Ohio The Honorable Sandra Beckwith 2007-2015 I successfully prosecuted twelve defendants who were involved in a drug trafficking conspiracy that stretched from Cincinnati, Ohio to Atlanta, Georgia. The drug trafficking organization was bringing in approximately \$4 million per month in revenues. One of the defendants was a Cincinnati fireman who assisted the group in laundering large amounts of money through real estate ventures.

I negotiated the pleas of each member of the drug trafficking organization. The defendants pled guilty in federal court and their sentences ranged from time served to 290 months of imprisonment. Through proffers, I solidified information that at least two members of the drug trafficking organization had been involved in a violent incident that occurred following a concert at a nightclub. The incident resulted in the death of a young man on Interstate 75. I negotiated plea agreements with two co-conspirators that required them to testify in Hamilton County Common Pleas Court regarding the killing of the young man on I-75. The testimony of the two federal defendants in my case at the killer's state trial resulted in him being convicted of murder and receiving a 66-year term of imprisonment.

> Robert Wells was a Franklin Township police officer who used excessive force against an individual he was arresting after a police chase in 2018. Specifically, while acting in his official capacity, Wells kicked the arrestee in the head while the person was on the ground being handcuffed. The victim suffered concussionlike symptoms. Wells then made misleading statements on the police report. Wells resigned from his post, believing that the matter would just go away. I successfully sought charges against him for a violation of 18 U.S.C. § 242: Deprivation of Rights Under the Color of Law. I negotiated the plea agreement in this case and made arguments on behalf of the government at sentencing. The Court sentenced Wells to 12 months and one day of prison for his actions.

> The prosecution involved a drug trafficking organization that stretched from Arizona to the Southern District of Ohio. The drug trafficking operation was unknown to law enforcement for quite some time and the organization's leader, Fred Reed, used the proceeds of the drug sales to purchase numerous pieces of real estate in and around Allen County (Lima), Ohio. Reed believed that he could use the real estate properties as rentals to launder his drug money. He then began renting out a number of the properties to make additional money.

> Reed came to realize that the numerous parcels of real estate required upkeep and continuous maintenance. However, instead of using any more of his illegal drug proceeds to ensure the property was sufficiently maintained, Reed then conspired with a number of other individuals to steal millions of dollars in merchandise from building and commercial supply stores (Home Depot, etc.) in Ohio, Indiana, Alabama, Kentucky, Arkansas, Tennessee, Florida, Pennsylvania, Illinois, Kansas, Nebraska, New York, Georgia, North Carolina, South Carolina, Texas, Washington, Missouri, and elsewhere to use for his properties. Therefore, a commercial theft ring grew from the foundation of a large drug trafficking organization. If the individuals did not steal the commercial merchandise outright for use on the property, they would return unneeded items for "gift" cards that Reed could then use to purchase other store material. Reed also brought his wife into the group as a co-conspirator.

I successfully sought charges against Reed and members of his organizations for violations relating to conspiracy to distribute controlled substances and/or conspiracy to transport and transfer in interstate commerce any merchandise and money of a value of \$5,000 or more, knowing said merchandise and money had been stolen to defraud the United States.

I negotiated pleas with all of the members of the organization. Reed admitted that the drug trafficking organization was responsible for the distribution of at least 33,000 pounds of marijuana and cooperated with the United States. Unfortunately, Reed was diagnosed with a terminal cancer during the prosecution of the case. He was sentenced to 120 months imprisonment just prior to his death. Rocco Evangelista, who worked as a U.S. Postal Service Union Representative in Ohio, was sentenced to 46 months imprisonment for his role in the drug trafficking conspiracy. Evangelista also had to forfeit a parcel of real estate he acquired with drug proceeds. Other co-conspirators that were primarily used to facilitate Reed's theft ring and their sentences ranged from probation to 72 months imprisonment. I also successfully sought a separate charge against Fred Reed's wife. I negotiated a plea with her to an Information, charging her with conspiring to transport and transfer in interstate commerce any merchandise and money of a value of \$5,000 or more, knowing said merchandise and money had been stolen. Although she only received a sentence of three years of supervised release, I successfully sought a personal money judgment of \$3,694,700 being included as a part of her sentence.

In addition, I successfully sought the forfeiture of approximately 41 pieces of real estate in Lima and Port Clinton, Ohio from Reed and his wife.

It should be noted that this case is related to the investigation and circumstances surrounding the case of United States v. Jose Silveyra, below.

I negotiated the plea agreement of all 11 members of the drug trafficking organization, determining who would testify to earn any consideration from the government for their cooperation. Each member of the organization pled guilty to the narcotics violations and received sentences ranging from time served to 210 months imprisonment.

This investigation ultimately led to the identification and dismantlement of the Fred Reed drug trafficking organization mentioned above.
