In 1996, I became a staff attorney at the Farmworker Program of Community Legal Services, Inc., a non-profit law firm funded in part by the federal Legal Services Corporation. My work included community outreach, mostly in Spanish and often in Yuma County. I also litigated housing, employment, and consumer disputes. My clients were migrant and seasonal farmworkers who irrigated, harvested, and packed the crops grown on Arizona's farms.

In 1999, I was hired as an Assistant Attorney General in the Civil Rights Division of the Arizona Attorney General's Office. My work included community outreach and litigation of discrimination claims arising out of housing, employment, public accommodations, and barriers to access. I also coordinated the Office's efforts to develop statewide protocols and training to address racial profiling in law enforcement. My client was the Attorney General, as the relator for the State.

In 2003, I was hired as an Assistant United States Attorney in the U.S. Attorney's Office for the District of Arizona. My work includes prosecution of federal crimes. I was detailed in 2009-2010 to work on public corruption matters with the Public Integrity Section of the Department of Justice in Washington. I also served as a Supervisory Assistant United States Attorney in 2008-2009, and again from 2012-2016, when I was the Phoenix Criminal Chief. My client is the United States.

As a lawyer representing farmworkers from 1996-1999, civil litigation was a major part of my practice. I filed complaints on behalf of our clients, appeared in state and federal courts regularly, and handled civil discovery. I also handled several matters in front of administrative law judges, including challenges to the receipt of food stamps, unemployment benefits, and workers' compensation.

As a civil rights attorney with the State of Arizona from 1999-2003, civil litigation was a major part of my practice. I filed complaints in civil rights cases, appeared in court regularly, handled civil discovery, and tried several cases in state court. I also tried a public accommodations denial-of-service case before an administrative body, the Arizona Civil Rights Advisory Board.

As a prosecutor with the U.S. Attorney's Office since 2003, prosecution of criminal matters has a been a major part of my practice. I regularly appear before a federal grand jury to seek indictments, and I try cases in federal court and handle appellate matters in the Ninth Circuit.

I have tried 24 cases to verdict. (This number includes four administrative hearings). In my seventeen federal criminal trials, I was sole counsel six times; lead counsel in a trial team seven times; and on four occasions I second-chaired other attorneys.

2006-2017

I was part of the team that investigated and prosecuted former Congressman Richard Renzi and his business partner, Jim Sandlin, for honest services wire fraud, money laundering and extortion, among other crimes, arising out of proposed land exchange legislation for southern Arizona. Following an interlocutory appeal to address the scope of the Speech or Debate Clause, the case proceeded to trial, and the jury returned guilty verdicts against each in the summer of 2013 after a six-week trial. The Court sentenced Mr. Renzi to 36 months' imprisonment, and Mr. Sandlin to 18 months' imprisonment. On January 19, 2021, one of the defendants (Mr. Renzi) received a pardon.

The investigation and prosecution were a partnership between the U.S. Attorney's Office for the District of Arizona and the Public Integrity Section in Washington. I coordinated the efforts of a number of attorneys and law enforcement officers through a lengthy pretrial investigation and trial process. I guided the strategic development of the case, engaged in extensive pretrial motion practice and arguments, presented numerous witnesses at trial, and gave the closing argument. I assisted others in the appellate advocacy by contributing to the briefs and mooting the arguments.
