I was retained for a second ten-year term in 2009. The Court of Common Pleas is a court of general jurisdiction. I have served by assignment of the Pennsylvania Supreme Court in three divisions: Juvenile, Adult Family, and Civil.

In August 2012, I was appointed by unanimous order of the Pennsylvania Supreme Court to the Court of Judicial Discipline of Pennsylvania. The Court of Judicial Discipline is a

constitutionally mandated, independent, state-wide court responsible for trying jurists charged by the Pennsylvania State Judicial Conduct Board with violations of the Canons of Judicial Conduct. My tenure on the Court of Judicial Discipline expired in August 2016.

In January of 2017, I was designated supervisor of the Complex and Commercial Litigation Center of the Civil Division of Allegheny County. In that capacity, I oversee and manage, at any one time, approximately 80-120 active, large, and complex cases that are either explicitly commercial in nature or otherwise “will likely require the involvement of more than one judge and the expenditure of a substantial amount of judicial resources, and will benefit significantly from case management,” including specifically all class action suits filed in the County. In January of 2017, I was designated Special Motions Judge. In that capacity, I decide all discovery, and a variety of other specially designated, motions filed in Allegheny County.

I believe that I have presided over 400 civil trials to final verdict, not including the hundreds, perhaps thousands, of civil case dispositive motions, and thousands of juvenile and family judgments.

This ongoing case involves a wrongful death claim by the family of a nursing home resident who alleged that, due to inadequate staffing by the nursing home and improper management by the nursing home's parent corporation, plaintiff's decedent became dehydrated and ultimately died. The trial court denied plaintiff's punitive damages claim against the nursing home and dismissed the

direct liability (corporate negligence) claim against the parent corporation.

The jury awarded a compensatory damages verdict for plaintiff. The award was appealed by all parties. The superior court reversed the trial court's decisions denying a punitive damages claim and a direct liability/corporate negligence claim as to the parent corporation. The Pennsylvania Supreme Court affirmed the reversal as to the direct liability of the parent corporation on other grounds, directing that the trial court make a specific finding as to the duty of the parent corporation. On remand, the trial court found no duty. A punitive damages retrial resulted in a verdict for the defense. The trial court's finding of no duty and the defense punitive damage verdict are the subject of a pending appeal.

Yenchi v. Ameriprise Express Financial Corp., GD 01-006610, Allegheny County, filed June 12, 2014. Another judge at the trial court level dismissed plaintiff's claims for bad faith, negligent supervision, and breach of fiduciary duty on a motion for summary judgment. Based upon the dismissal of the breach of fiduciary duty claim, this court granted the defendants' motion in limine, which excluded evidence of the suitability of the insurance policy that plaintiffs purchased. On appeal, the Superior Court reversed the dismissal of the breach of

fiduciary claim and the exclusion of the suitability evidence. The Superior Court held that the suitability evidence was also relevant to plaintiffs' fraudulent misrepresentation and unfair trade practices and consumer protection law claims. Defendants appealed to the Supreme Court, which reversed the Superior Court's decision on the breach of fiduciary duty claim, but upheld the remainder of the Superior Court's opinion. Reversed and remanded on appeal at 123 A.3d 1071, 1080-83 (Pa. Super. 2015). Reversed in part at 161 A.3d 811, 823 (Pa. 2017).

Scampone v. Grane Healthcare Co., GD-05-024806, Allegheny County, filed April 9, 2015; August 10, 2015; October 7, 2015; and October 20, 2015. Following remand by the Supreme Court, the trial court conducted argument regarding defendant Grane's Motion for Compulsory Nonsuit with respect to plaintiff's direct corporate liability and vicarious liability claims against Grane. This court entered compulsory nonsuit in favor of Grane with respect to direct corporate negligence on the basis that Grane did not owe a non-delegable duty to the decedent. The court further reentered compulsory nonsuit in favor of Grane with regard to plaintiff's vicarious liability claim, holding that the record did not support the conclusion that Grane's conduct caused the decedent's injuries. This court also conducted a jury trial with respect to plaintiff's claim for punitive damages against defendant Highland, which resulted in a verdict for Highland. The court denied plaintiff's post-trial motion with respect to this claim. The Superior Court held that Grane did owe a duty to the decedent, and further held that plaintiff had introduced sufficient evidence of a causal connection between the decedent's death and the actions of Grane. The Superior Court remanded the case to the trial court to conduct a trial with respect to compensatory damages on plaintiff's claim for vicarious liability against Grane. The Superior Court further remanded to the trial court to conduct a trial on punitive damages for both Grane and Highland, holding that plaintiff submitted sufficient evidence such that a trial was appropriate as to Grane, and that the trial court's evidentiary rulings during the original trial warranted a new trial on this issue as to Highland. The Superior Court affirmed this court's denial of plaintiff's motion for sanctions seeking to strike Highland's affirmative defenses, but remanded for the trial court to determine what lesser sanction is appropriate for Highmark's conduct. The Superior Court further affirmed this Court's denial of plaintiff's motion for recusal, and also affirmed this court's order staying plaintiff's ability to execute on a judgment entered by the court following the original trial. Reversed and remanded on appeal at Scampone v. Grane Healthcare Co., 169 A.3d 600 (Pa. Super. 2017), reargument denied (Oct. 11, 2017), appeal denied, 188 A.3d 387 (Pa. 2018), and appeal denied, 188 A.3d 388 (Pa. 2018).

POPS PCE TT, LP v. R&R Restaurant Group, LLC, GD-15-011052, Allegheny County, filed April 11, 2016. A defendant tenant appealed this court's November 13, 2015 order denying defendant's petition to open judgment entered by confession. The court held, *inter alia*, that the doctrines of *res judicata* and collateral estoppel barred defendant tenant from asserting defenses before this court that were, or should have been, raised before the magistrate judge who

presided over plaintiff landlord's possession action. The Superior Court of Pennsylvania held that, because plaintiff landlord's complaint before the magistrate sought only possession, these doctrines should not have been held to preclude defendant tenant from asserting meritorious defenses in its petition to open confessed judgment with respect to monetary damages before this court, and remanded the case to this court to consider defendant tenant's asserted meritorious defenses. The Superior Court also held that this court erred in finding that defendant tenant had admitted facts in plaintiff landlord's answer and new matter by failing to timely file a response thereto, and deemed the defendant tenant's reply to new matter timely filed. Following briefing and oral argument upon remand, this court ultimately issued a Memorandum and Order of Court on April 6, 2018 denying defendant tenant's motion on the basis that defendant tenant failed to set forth a meritorious defense that warranted opening the judgment. Both the April 11, 2016 and April 6, 2018 opinions are attached hereto. Vacated and remanded on appeal at No. 1944 WDA 2015, 2016 WL 6820524 (Pa. Super. Nov. 18, 2016).

Mazur v. Cuthbert, AR-17-000057, Allegheny County, filed May 11, 2017. The court sustained the defendant's preliminary objections to plaintiff's amended complaint and dismissed plaintiff's complaint with prejudice on the basis that plaintiff's claim for defamation was barred by sovereign immunity, citing Yakowicz v. McDermott, 548 A.2d 1330, 1333 (Pa. Cmwlth. 1988), appeal denied, 565 A.2d 1168 (Pa. 1989). Plaintiff appealed to the Commonwealth Court of Pennsylvania, arguing that defendant's alleged behavior fell outside the scope of her employment, and that defendant was thus not protected by sovereign immunity. The Commonwealth Court affirmed in part and reversed in part, distinguished Yakowicz, and held that defendant would not be entitled to sovereign immunity if plaintiff could establish that defendant knowingly made false statements to third parties in the course of conducting an investigation for her employer. Defendant's employer has a policy against making false statements, and the Commonwealth Court concluded that defendant would take herself out of the scope of her employment if she directly violated this policy.

Affirmed in part and reversed in part on appeal at 186 A.3d 490 (Pa. Commw. Ct. 2018), reargument denied (June 11, 2018); Defendant seeking allowance for appeal to Supreme Court of Pennsylvania at 272 WAL 2018.

Sommers v. UPMC, GD 12-012901, Allegheny County, filed May 12, 2017. The court partially decertified the class as to nurses who had not received retroactive payments from UPMC on the grounds that these nurses lacked commonality and that individual issues would predominate over common issues. Plaintiffs appealed, and the Superior Court held that the court should not have revisited the issue of certification because there were no new evidentiary developments, and that there was no need to distinguish the nurses who were not retroactively paid. Reversed and remanded on appeal at 2018 Pa. Super. 108 (Pa. Super. 2018).

Rupert v. King, GD 12-007664, Allegheny County, filed August 15, 2017. The court granted defendant's motion for summary judgment based upon *Muhammad v. Strassburger, McKenna, Messer, Shilobod & Gutnick*, 587 A.2d 1346 (Pa. 1991), which held that plaintiffs are barred from pursuing legal malpractice suits following settlement absent an allegation of fraud. On appeal, the Superior Court found that the amended fee agreement, the basis for plaintiff's malpractice claim, was not a part of the settlement negotiations, and concluded that *Muhammad* did not apply. Reversed and remanded on appeal at 2018 WL 2474081.

Preferred Contractors Insurance Co., RRG, LLC, v. Sherman, GD 12-020228, Allegheny County, filed August 16, 2017. The court denied the plaintiff's motion for summary judgment, which asserted that Sherman was not entitled to coverage on the grounds that the insurance policy had not been delivered to Sherman and that Sherman had not made any misrepresentations in his application. The court also granted Sherman's motion for summary judgment on the grounds that plaintiff breached its duty to indemnify Sherman in the underlying suit. Finally, the court granted the Brown Agency's motion for summary judgment as to plaintiff's negligence claim on the grounds that the Brown Agency owed no legal duty to plaintiff. On appeal, the Superior Court affirmed the court's grant of the Brown Agency's motion for summary judgment and upheld the trial court's determination that the policy was not effectively "delivered." The Superior Court vacated the court's denial of plaintiff's motion for summary judgment as to coverage concluding that there were genuine issues of material fact as to whether Sherman had made material misrepresentations on his application and as to whether plaintiff's failure to deliver the policy precluded them from excluding coverage. The Superior Court also vacated the court's denial of plaintiff's motion for summary judgment as to breach of duty because plaintiff defended Sherman in the underlying case, and plaintiff was allowed under Montana law to file a declaratory judgment action as to policy exclusions. Affirmed in part and vacated in part on appeal at 2018 Pa. Super. 215 (Pa. Super. 2018).

Hargrove v. Koppers, Inc., GD-05-015942, Allegheny County, filed September 25, 2017. The court granted summary judgment in favor of defendants in seven of fourteen latent disease cases on the basis that either there existed record evidence of a plaintiff's actual, subjective awareness of the possibility, if not likely probability, that plaintiff's occupational exposure contributed to his disease, or that there existed evidence that a plaintiff had information available to him from which he reasonably should have suspected that occupational exposure was a contributing factor in the cause of his disease. The Superior Court *sua sponte* considered the issue, which was not raised before this court or the Superior Court, of whether this court had subject matter jurisdiction over this particular case because plaintiff Clyde Hargrove died prior to the entry of this court's Order (a fact not known to this Court), and nothing in the record indicated that: 1) Hargrove's attorney of record filed a notice of Hargrove's death; 2) any qualified

party filed for letters of administration/testamentary; and/or 3) a personal representative was substituted in Hargrove's place. The Superior Court held that this Court lacked subject matter jurisdiction to enter its order granting summary judgment, vacated this court's order granting summary judgment, and remanded so that this Court could make a determination as to whether this action should be dismissed for want of jurisdiction, or whether a reasonable explanation exists for the failure to: 1) file a notice of death, 2) take out letters of administration, or 3) substitute a personal representative. Vacated and remanded on appeal at 1583 WDA 2017 (a copy of this Opinion is attached hereto).

Weiss v. Rehabilitation and Pain Specialists, No. GD 10-024404, 2013 WL 5976053 (C.P. Allegheny March 19, 2013). Plaintiff appealed from a jury verdict in favor of the defendant physician in this medical malpractice, lack-of-informed-consent case. Plaintiff asserted that the trial court errantly sustained the objection to plaintiff's expert's proffered testimony regarding what a reasonable patient would want to know about the risks and alternatives. The Superior Court agreed, and reversed the trial court in an unpublished opinion. See 87 A.3d 382 (Pa. Super. Ct., Sept. 13, 2013).

Keystone Dedicated Logistics v. JGB Enterprises, No. GD08-021389, Allegheny County, filed May 18, 2012. In this breach of contract case, I entered judgment awarding \$70,000 in damages to the plaintiff after a jury trial. Defendant appealed on multiple grounds. The appellate court upheld that sufficient evidence supported the verdict for the plaintiff, but found that the damages award was based upon invoices admitted without proper authentication at trial. The court therefore vacated the judgment and remanded for a new trial. 77 A.3d 1 (Pa. Super. Ct. 2013).

Babcock & Wilcox, ARCO v American Nuclear Insurers, No. GD 99-011498 & GD 99-016227, Allegheny County, September 19, 2011 (jury verdict). This case involved an alleged breach of contract on a nuclear risks insurance policy that provided coverage for claims asserted in relation to the Apollo/Parks community radiation contamination. The plaintiff/insured settled the contamination claims decades ago without the defendant/insurer's consent. I presided over a trial held to determine whether the settlement amount was reasonable. On September 19, 2011, the jury determined that \$80 million dollars plus interest was a fair and reasonable settlement value. Appeals were taken from pretrial rulings of another jurist (see Opinion at 2012 WL 11943702), resulting in a reversal before the Superior Court at 76 A.3d 1 and a re-reversal of the Superior Court decision (affirming the pretrial rulings) by the Supreme Court at 2015 WL 4430352. I issued no written opinion in the matter and none of my trial rulings were the subject of appeal.

Petrina v. Allied Glove Corp., No. GD08-008333, 2011 WL 8792215 (C.P. Allegheny September 2, 2011). In this asbestos action, I granted summary

judgment for the defendant on product identification grounds, after determining that evidence proffered by the plaintiff to defeat the motions (third party interrogatories from cases in other jurisdictions) was inadmissible hearsay. Plaintiff appealed, and the appellate court reversed, holding that the interrogatories were admissible evidence in response to a motion for summary judgment. 46 A.3d 795 (Pa. Super. Ct. 2012).

Venne v. Union Carbide Corp., No. GD03-011247, 2011 WL 8317601 (C.P. Allegheny Mar. 15, 2011) & 2011 WL 8317603 (C.P. Allegheny August 12, 2011). In another asbestos action, I held that interrogatories and other evidence were inadmissible to defeat defendant's motion for summary judgment. The appellate court reversed, citing its previous decision in Petrina v. Allied Glove. Decision supplied.

Marlette v. State Farm Mut. Auto. Ins. Co., No. GD06-015333, Allegheny County, filed July 6, 2009. Decision previously supplied in response to Q13d. This matter constituted the first "Koken" case (insured's direct suit v. UM/UIM insurer) to be tried before a jury in the Commonwealth of Pennsylvania. Following a judgment in favor of the plaintiff, both parties appealed this court's determination that delay damages were available for recovery up to the amount of the available insurance coverage limits. The trial court was initially reversed in part on appeal, 10 A.3d 347 (Pa. Super. Ct. 2010), but the Pennsylvania Supreme Court reversed the superior court and reinstated the trial court verdict, 57 A.3d 1224 (Pa. 2012).

Landis v. AW. Chesterton Co., No. GD08-002317 & Tooev v. AK Steel Corp., No. GD08-005721, 2008 WL 8161402 (C.P. Allegheny July 29, 2008). In these asbestos actions, the trial court denied defendants' motions for summary judgment, which sought dismissal based upon the exclusivity provision of the Pennsylvania Workers' Compensation Act. The trial court concluded that where injury (asbestos-related disease) does not manifest itself within 300-week period prescribed by the statute, the exclusivity provision does not apply. The superior court reversed the trial court, 11 A.3d 1046 (Pa. Super. Ct. 2010), but the Pennsylvania Supreme Court reversed the superior court and reinstated the ruling of the trial court, 81 A.3d 851 (Pa. 2013).

Scampone v. Highland Park Care Center, No. GD 05-24806, Allegheny County, filed February 8, 2008. Decision previously supplied in response to Q13c. The trial court upheld a jury verdict in favor of the plaintiff for the wrongful death of a nursing home resident. Plaintiff appealed, challenging the court's denial of plaintiff's punitive damages claim and dismissal of a claim against the parent corporation. Defendant appealed the trial court's ruling permitting a corporate negligence claim against the nursing home. The superior court reversed in part as to the punitive damage claim and direct corporate negligence liability theory, 11 A.3d 967. The Pennsylvania Supreme Court affirmed the superior court in part, but on other grounds, and remanded to the trial court for further proceedings with instructions to make a specific finding as to the duty of the parent corporation, 57

A.3d 582. Following a punitive damages retrial with a verdict for the defendant, the case is again pending appeal.

ISR Solutions Inc. v. Vern's Electric, Inc., No. GD-03-14488, 2007 WL 5479453 (C.P. Allegheny August 16, 2007). Both parties appealed following a commercial construction contract dispute jury trial, asserting multiple evidentiary errors and improper verdict calculation in light of jury findings. The superior court reversed in part, holding attorney's fees were not required under a contract indemnification provision, and remanded for further proceedings on the judgment valuation issue. Decision previously supplied in response to Q13c. The parties settled on remand.

Vogelsberger, v. Owens-Illinois, Inc. (In re: Toxic Substance Cases), No. A.D. 03-000319, 2006 Pa. Dist. & Cnty. Dec. LEXIS 581 (C.P. Allegheny August 17, 2006). Following the conclusion of an extensive hearing challenging the scientific reliability of plaintiff's expert witnesses' testimony, the court precluded the plaintiff's experts from offering opinion testimony causally attributing the plaintiff's asbestos related disease to exposure to any specific defendant's asbestos containing friction products. The court concluded that the expert's opinion that "each and every exposure to an asbestos product was a proximate cause of a subsequently diagnosed asbestos-related disease" in the absence of plaintiff-specific exposure evidence was not supported by a generally-accepted scientific methodology in the relevant scientific field, as required by precedent. The trial court was initially reversed by the superior court, Betz v. Pneumo Abex, 998 A.2d 962 (Pa. Super. 2010), but the Pennsylvania Supreme Court reversed the ruling of the superior court and affirmed the reasoning of the trial court. 44 A.3d 27 (Pa. 2012).

DeOrio v. Juliano, No. GD03-006316, 2006 WL 5999773 (C.P. Allegheny May 24, 2006). The trial court sustained a jury verdict on behalf of the plaintiff and against the defendants, a drunk driver, the driver's employer, and the tavern that served alcoholic beverages to the driver. The trial court rejected several of defendants' evidentiary arguments and the driver's employer's argument that the employer's act of permitting its employee to utilize his employee credit line in order to purchase drinks for himself and clients was not a sufficiently proximate cause of the plaintiff's injuries to impose liability upon the employer. The superior court reversed in part with respect to the trial court's ruling that the use of the credit card was an adequate use of a "chattel" or "instrumentality" provided by the driver's employer to permit liability against the employer. Appellate decision supplied.

Beckwith Machinery Co. v. Asset Recovery Group, No. GD01-007450, 2005 WL 5006223 (C.P. Allegheny March 16, 2005). The trial concluded that a contractor's payment bond covered major repairs entailing replacement of major components of heavy equipment used in a demolition project, finding such to constitute ordinary repairs in the factual context presented. The superior court reversed in part, finding that the repairs were more in the nature of capital improvements to

the equipment, a contractor would be expected to take the repairs with him on the completion of the work, and the repairs simply could not be classified as ordinary maintenance performed for consumption over the course of the project. 890 A.2d 403 (Pa. Super. Ct. 2005).

In Re: Adoption of S.C and S.C., No. CYF 301 Of 2001, Allegheny County, filed March 4, 2002. The trial court held that the Office of Children, Youth and Families had proven by clear and convincing evidence that grounds for termination of the parental rights of biological parents to dependent children were satisfied. The superior court remanded the case for further proceedings, with instructions to develop a more complete record regarding the evidence supporting each of the statutory factors. Appellate decision supplied.

The Court granted plaintiff's motion for reconsideration with respect to this Memorandum Opinion on September 4, 2018 based upon the Superior Court of Pennsylvania's decision in Webb-Benjamin, LLC v. Int'l Rug Grp., LLC, 2018 PA Super 187 (June 28, 2018), reargument denied (Aug. 28, 2018). Both the November 8, 2017 Memorandum Opinion and the September 4, 2018 Memorandum Opinion are attached hereto.

Martel v. Allegheny Cnty., GD-17-010704, Allegheny County, filed March 29, 2018
Appeal Pending.

Judicial recusal in Pennsylvania is governed by the Pennsylvania Code of Judicial Conduct, principally Canon 2.11, 2.7 (and former Canon 3C), and decisional law applying the same. I am also aware that the Fifth Judicial District/Allegheny County Court of Common Pleas administratively recuses itself (through administrative order issued by the administrative judge following notice to all members of the court) from any matter directly involving a fellow judge of the district. I have infrequently recused myself, sua sponte, from matters scheduled before me, but I do not maintain records of such incidents and I am unable to recall specific instances. I do not recall ever being presented with a motion from a party to any matter requesting that I recuse myself due to an asserted conflict of interest.

Topka v. Toyota Motor Corp., GD-12-006928, Allegheny County. Plaintiff in this action presented a Motion for Reconsideration and/or Motion to Vacate and Recuse on December 15, 2017. Plaintiff requested that I recuse on the basis of an asserted conflict of interest due to my disclosure, in open court during argument on plaintiff's Motion for

Terminating Sanctions on or about April 7, 2017, of my work for the law firm of Pietragallo Bosick & Gordon, a predecessor firm of Pietragallo Gordon Alfano Bosick & Raspanti, LLP, and specifically my representation of Toyota Motor Corporation, the defendant in this action, during my time as an associate there approximately 20 years ago. I advised counsel that this representation happened many years ago, that my representation was limited in both scope and subject matter, and that it would not impact my decision-making in the present case. Neither party moved for my recusal at that time, but I invited counsel to consult with their clients and to contact my chambers in the event that they intended to move for my recusal. Many months later, I ultimately denied Plaintiff's Motion for Terminating Sanctions on November 27, 2017, which led to the presentation of the aforementioned Motion for Reconsideration and/or Motion to Vacate and Recuse. After consideration of this request and the mandates of the Pennsylvania Judicial Code of Conduct, I denied this Motion because my impartiality in this matter could not be reasonably questioned on the basis of this limited representation in the past. Further, plaintiff's Motion for Recusal was presented in the alternative to a Motion for Reconsideration, i.e. Plaintiff would not seek my recusal if I were to change my holding with respect to plaintiff's Motion for Terminating Sanctions. While not a factor in my decision to deny the Motion for Recusal, as recusal was not warranted in any event, this buttressed my confidence in my impartiality in this matter. This matter was ultimately resolved via settlement.

Yenchi v. Ameriprise Express Financial Corp., GD 01-006610, Allegheny County.

Plaintiffs presented a motion for recusal asserting that, because I made findings of fact and determinations of credibility at the first trial, I should not re-try the case on remand. I denied plaintiff's motion on January 22, 2018, as my prior involvement in this matter did not give rise to a reasonable question respecting my impartiality in the retrial. It is typical in Allegheny County for judges to keep cases on remand, unless a real question of the judge's impartiality is raised. While I did not recuse myself, this matter was transferred to another judge for retrial based upon purely administrative considerations.

In coordination with administrative judges, I created and modified applicable case management orders to modernize the asbestos dockets in Allegheny County. I created a new expedited docket for asbestos cases that has nearly supplanted the existing general docket and serves to resolve important asbestos matters within a seven- to nine-month timeline from placement on the expedited docket to trial. I also created a backlog docket in order to resolve cases pending over three years, thereby resolving thousands of cases – some over nine years old.

In 2012, I was appointed by unanimous order of the Pennsylvania Supreme Court to the Court of Judicial Discipline. The Court of Judicial Discipline is a constitutionally mandated, independent, state-wide court responsible for trying jurists charged by the Pennsylvania State Judicial Conduct Board with violations of the Canons of Judicial Conduct.

In addition to my work on the bench, I served as an original voting member on the Pennsylvania Supreme Court's Juvenile Court Procedural Rules Committee for the first seven years of that Committee's existence. During my tenure, the Juvenile Court Rules Committee developed, from nothing, new rules governing juvenile dependency and juvenile delinquency matters to be applied throughout the Commonwealth's sixty-seven counties. I served for seven years as an officer of the Pennsylvania Conference of State Trial Judges, including one year as its President, from 2009 to 2010. The Conference is the professional association that, among many functions, provides ongoing judicial education to state trial court judges and coordinates efforts of the Administrative Office of Pennsylvania Courts and the Supreme Court in their efforts to maintain competence, professionalism, collegiality, and ethical conduct among the over 400 judges of Pennsylvania's trial courts. In addition to my responsibilities as an officer, I have participated in the preparation and delivery of ongoing judicial education programming through the Conference. As a judge, I am not permitted to perform pro bono legal work; however, I do perform substantial extra-judicial work in a variety of respects in an effort to promote justice (most notably with the Juvenile Court Rules Committee, as an officer of the Pennsylvania Conference of State Trial judges, on the Court of Judicial Discipline, and currently with the State Trial Judges Ethics Committee). For many years as a practicing lawyer, I regularly performed pro bono legal representation of victims of domestic violence in protection from abuse hearings, typically at a rate of four cases per quarter year.

Through media reports, I became aware of vacancies on the United States District Court for the Western District of Pennsylvania following the untimely death of one judge and the decisions of two others to request senior status. I submitted an application and personally presented myself for an interview before a judicial selection committee convened in Pittsburgh, Pennsylvania in the fall of 2013 by Senators Toomey and Casey. That committee's considerations were, to my knowledge, conducted confidentially; accordingly, I do not know if I received its recommendation. In late May 2015, I was contacted by Senator Casey's staff, and I confirmed my continued interest in the position. I met with Senator Casey and staff in Washington D.C. on June 15, 2015 and Senator Toomey and staff in

Washington D.C. on June 25, 2015. On July 30, 2015, President Obama submitted my nomination to the Senate. On December 9, 2015, I appeared before the Senate Judiciary Committee for a hearing. Following that hearing, Senators Grassley, Sessions, Flake, and Tillis submitted Questions for the Record. I provided written responses to those questions within three days. The Senate Judiciary Committee did not hold a vote on my nomination. On January 3, 2017, at the close of the 114th Congress, my nomination expired and was returned to the President pursuant to Senate Rule XXXI paragraph 6 of the Standing Rules of the Senate.

On approximately August 6, 2018, I was contacted by the White House Counsel's Office requesting that I meet with White House Counsel in Washington D.C. I met with members of the White House Counsel's Office on August 22, 2018. On approximately September 10, 2018, I received a telephone call from the White House Counsel's Office informing me that President Trump had authorized the background investigation and vetting process for my potential nomination to proceed. Since that date, I have been in contact with officials from the Office of Legal Policy at the Department of Justice regarding the paperwork required for the new nomination process and for this Committee. On March 5, 2019, President Trump submitted my nomination to the Senate.
