In 1979, I became a Law Clerk to Honorable Anne E. Thompson. I drafted bench memoranda and opinions for this federal district court judge on a range of issues, predominantly in civil but sometimes in criminal cases. The range of issues included many federal statutes, federal constitutional issues, state law issues, federal jurisdiction and rules of procedure and evidence.

In 1980, I became an Associate at Donovan Leisure Newton & Irvine where I handled a variety of litigation, mostly anti-trust litigation in federal courts around the country. The clients were generally large corporations.

In 1981, I became an Assistant United States Attorney in New Jersey. I served in the Criminal Division where I handled a variety of federal criminal cases. The majority of cases were international narcotics- related cases involving the importation of large quantities of heroin, cocaine and marijuana. I also handled cases under federal tax, RICO, Continuing Criminal Enterprise, hijacking and other criminal statutes. My client was the United States of America.

In 1984, I became a partner with Sills Cummis Radin Tischman Epstein & Gross where I handled a variety of litigation in federal and state courts, mostly in New Jersey. The cases were brought under the federal and state environmental statutes, federal and state criminal and civil securities and mail fraud statutes, class actions, and a wide range of common law theories. The cases involved federal and state rules of evidence and procedure. The clients included entrepreneurs, small businesses, mid-cap companies, a few large corporations, and Sills Cummis itself.

In 2002, I became a Shareholder at, and founded the New Jersey office of Greenberg Traurig. I have handled a wide variety of cases in federal and state courts throughout the country involving, a) federal statutes including, but not limited to: RICO, ERISA, Sherman Act and other antitrust statutes, Telephone Consumer Protection Act, Magnuson-Moss Warranty Act, Securities Exchange Act and related securities statutes, Fair Labor Standards Act, Superfund, Clean Water Act, Toxic Substances Control Act, Clean Air Act, Resource Conservation and Recovery Act, Fair Debt Collection Practices Act, Fair Credit Reporting Act, and Computer Fraud and Abuse Act, b) federal constitutional issues, including, but not limited to, equal protection, due process, first amendment and takings; c) issues of federal jurisdiction including federal diversity, federal question, Class Action Fairness Act, federal removal and remand, and multi-district litigation; d) federal evidence and procedure rules, and e) issues arising under state statutes and common law throughout the country. My entire career has been devoted exclusively to litigation. I appear in court often and have usually served as the lead lawyer in my cases since 1982.

In three years as an Assistant United States attorney, I tried thirteen cases. For my first 20 years in private practice, I usually tried one to three cases every year. More recently, as the stakes in the cases has grown substantially larger, the cases have gone to trial less often, but I appear regularly in court at hearings and arguing motions and often take and defend depositions as well as trying cases.

At Sills Cummis (1984-2002), my practice was approximately 50% in federal court and 50% in state court. I spent a small amount of time in administrative proceedings. At Greenberg Traurig (2002-Present), my practice has been approximately 70% in federal court and 30% in state court. In 2020-21, however, approximately 5-10% of my practice was in a case before the New Jersey Board of Public Utilities, an administrative agency, culminating in a 10-day trial.
